#### **MISSION**

The Office for Civil Rights (OCR) enforces federal civil rights laws and other provisions that prohibit discrimination by recipients of federal financial assistance from the Office of Justice Programs (OJP), the Office on Violence Against Women (OVW) and the Office-of Community Oriented Policing Services (COPS), and other covered entities.

Our goal is to obtain voluntary compliance through collaborative enforcement approaches that benefit the recipient of U.S. Department of Justice (DOJ) funds or covered entity and the beneficiaries of the program or activity.

### **CIVIL RIGHTS LAWS**

Civil rights laws, including Title VI of the Civil Rights Act of 1964 and Section 504 of the Rehabilitation Act of 1973, require recipients of federal financial assistance from DOJ to give assurances that they will comply with those laws.

Taken together, these and other civil rights laws prohibit recipients and other covered entities from discriminating in services and employment because of race, color, national origin, religion, disability, and sex. Recipients are also prohibited from discriminating in services because of age. These laws also prohibit retaliation against any person for prior civil rights activity.

Some grant awards from DOJ have additional obligations to comply with equal-opportunity regulations.

#### **COMPLIANCE**

OCR vigorously enforces federal nondiscrimination laws, regulations and other non-discrimination requirements that apply to entities receiving federal financial assistance and other covered entities through complaint investigations; proactive compliance reviews; and by providing technical assistance to grantees, subgrantees, and beneficiaries.
