



Overview: The OVC PMT is a Web-based reporting system where Vision 21 grantees can electronically submit quantitative and qualitative program performance data. Performance measures are developed to collect meaningful data so that grantees can show the progress they have made toward meeting OVC program goals and objectives. Grantees report quantitative data quarterly, or every 3 months following the Federal fiscal year, and report qualitative (narrative) data semiannually. After completing data entry in the PMT for two quarters, grantees must create a semiannual performance report in the PMT and upload it as an attachment to their annual progress reports in the Grants Management System (GMS) in January and July of each year.

A grantee is the direct recipient of funds from OVC. A subgrantee receives federal award funds from the grantee. All subgrantee data should be reported in the narrative questions.

Data Entry Steps

1. Log in, and select **OVC PMT**. *If you do not have an assigned PMT login, contact the OVC PMT Help Desk.*

2. Refer to the **Performance Measures** and other training materials on the *Need Help* page.
3. Go to the *Enter Data* page, and select a reporting period.
 - a. Enter data, and **Save**
Please be aware that your session will time out after 30 minutes of inactivity. To avoid losing or having to reenter data, click Save before leaving the system unattended or when finished entering data.
4. Review data:
 - a. Review and address any errors.
5. **Mark Data as Complete** or approve the report for submission.
6. Create a Report:
 - a. **Add Comments** to further explain the information in your report.
 - b. **Export as a PDF file**
 - c. Save the report to your computer.
7. Upload or attach the Semi-Annual Performance Report to your progress report in the GMS (when it's due in January and July).

July 1–Sept 30	Program Performance Measures	November 15	No
