JUDICIAL DISTRICT DATA BOOK, 1983: [UNITED STATES] (ICPSR 8439)

The Federal Judicial Center contracted with Claritas Corporation to produce the three data files in this collection from the Census Bureau's 1983 County and City Data Book. The data, which are summarized by judicial units, were compiled from a county-level file and include information on area and population, households, vital statistics, health, income, crimes, housing, education, labor force, government finances, manufacturers, wholesale and retail trade, service industries, and agriculture. The data are in three files. The first file, which provides data for Federal judicial districts, has 92 cases; the second file, Federal administrative divisions, has 204 cases; and the third file, Federal jury divisions, has 320 cases. The logical record length of each file is 2751 characters. Class IV

File Description

The Federal Judicial Center contracted with Claritas Corporation to produce three data files from the U.S. Census Bureau's 1983 County and City Data Book summarized by judicial units, as defined by sets of counties. Each file contains a single record for each judicial unit.

The data for each judicial unit were compiled from the Counties file of the Data Book tape file which includes information for the following general areas: area and population, households, vital statistics, health, income, crimes, housing, education, labor force, government finances, manufacturers, wholesale and retail trade, service industries, and agriculture.

The Federal Judicial Districts file includes 91 records.
 The Administrative Divisions file includes 204 records.
 The Jury Divisions file includes 317 records.
 Record length in all three files is 2,751 characters.

Each file is sorted by State, Circuit Number, District Code, District Prefix, and Division or Jury Number.

Name. Each item has been assigned a unique 8-character label, e.g., HHLD8001. The first four characters of the label indicate the subject category; Appendix D is a guide to abbreviations used for the subject categories. The fifth and sixth characters indicate the reference year. The last two characters are arbitrary numbers added to uniquely identify the data item series.

Begin Position. This is the location in the record of the first character of a data item.

Description. In addition to describing the item, this description in a few cases denotes items subject to copyright restrictions. Permission to reproduce copyright material should be obtained directly from the copyright owner as listed in Appendix C, Source Notes and Explanations.

Unit/Dec. The unit of measure is abbreviated as follows:

"DEC" indicates the number of implied decimals. Only integers are shown on the data files. Note that there are a few items for which the unit of measure and number of implied decimals must be considered together, thus ML\$ (millions of dollars) with 1 implied decimal indicates that the effective unit of measure is hundreds of thousands of dollars.

Size. The size column notes the number of characters allocated for each field. All data items are 12 digits. Judicial unit names vary in size with each file; the numbers shown indicate maximum size.

TECHNICAL CONVENTIONS:

Negative Numbers. A minus sign [-] precedes a negative number. In such instances, the minus sign is located in the left-most character of the data field. For example, -1000 is represented by "-000000001000."

Missing Data. Some items could not be calculated from aggregation of the Counties file to judicial units. These items are documented in Appendix A. Data fields for these items are 9-filled on all three judicial unit files.
