## INTRODUCTION

The following tables show characteristics of Youth Authority wards in institutions and camps and on parole as of June 30th of each year from 1975 through 1984.

Certain types of cases are excluded:

- o wards in institutions on contract or temporary detention status;
- o wards in Department of Mental Health facilities;
- o wards in county jails on revoke status;
- o wards awaiting delivery to institutions;
- o wards who are absent from institutions for various reasons, i.e., out-to-court, furlough, escape, etc.;
- o wards on parole from other states who are residing in California.
- o Department of Corrections inmates assigned to CYA under Welfare and Institutions Code 1731.5(c)

In order to provide uniformity over the years, the following adjustments were made in the data:

1. Because they have housed only a small number of wards, separate tables for Southern Community Drug Center, SPACE, Department of Corrections and federal institutions are not shown. However, these data are included in the totals (Tables 1, 2, and 3) for the applicable years of operation.

**ACQUISITIONS**

2. Only one table (Table 3) is included for females in institutions. Since 1973, Ventura has been the only institution housing female wards except the few wards which may have been in NRCC, CDC, SCDC, SPACE and federal institutions.
  
3. The commitment offense groups shown in the tables are composed of the following offenses:
  - (a) Violent type offenses: homicide, robbery, all types of assaults, rape (violent), and kidnap/extortion;
  
  - (b) Property type offenses: burglary, theft (including auto), forgery and check offenses, and arson;
  
  - (c) Narcotic and drug offenses: all offenses relating to narcotics and dangerous drugs;
  
  - (d) Other offenses: all offenses not specifically mentioned above.

The following tables appear in this report. In some instances the percents may not add to 100 because of independent rounding.

Table 1 Characteristics of Youth Authority Wards in Institutions:

Includes all wards in institutional status: reception centers, training schools, camps, and Department of Corrections and Federal institutions.

Table 2 Characteristics of Youth Authority Male Wards in Institutions:

The same information as Table 1 for male wards only.

The same information as Table 1 for female wards only.

This is a series of supplemental tables. There is a total page for males in Youth Authority schools and camps which is followed by individual tables for each school and for camps combined, as in the past (SPACE does not have a separate table but is included in the total).

## HIGHLIGHTS

1. The proportion of minorities in institutions increased from 59.4 percent in 1975 to 73.7 percent in 1984.
2. The proportion of wards in institutions on criminal court commitments fluctuated between 42.9 and 48.4 percent during 1975 through 1981. In 1982 through 1984 it dropped from 39.6 to 26.0 percent as a result of the Department's rejection policy and Proposition 8, both of which barred criminal court commitments for serious offenses from the Youth Authority.
3. For males, the violent type offense percentages increased since 1975 from 49.2 percent to 61.0 percent in 1982, and then declined to 53.6 percent in 1984. Female wards in institutions for violent type offenses rose from 37.7 percent in 1975 to 65.4 percent in 1983, then decreased to 59.3 percent in 1984. The increases in the prior years resulted from increasing numbers of violent offenders being committed to the Youth Authority (prior to 1981) and rising length of stay for those offenders. The decreases in 1983 and 1984 reflect the affects of the rejection policy and Proposition 8.

## SUMMARY

This 10-year summary includes the fiscal year ending figures for the period June 30, 1975 through June 30, 1984. Some very distinct changes have occurred in the nature of the ward population over the last decade.

### SEX

Female wards have comprised from 3.7 to 5.0 percent of the institutional population throughout the period from 1975 through 1984.

The parole population was about 10.7 percent female in 1975 and has since decreased to approximately 4.5 percent female.

### COURT OF COMMITMENT

The proportion of wards in institutions on criminal court commitments fluctuated between 42.9 and 48.4 percent during 1975 through 1981. In 1982 it dropped to 39.6 percent and has since dropped to 26.0 percent in 1984 as a result of the rejection policy and Proposition 8.

### AREA OF COMMITMENT

In 1975 the Southern California area contributed approximately 63.9 percent of the institutional population. This percentage fluctuated between 60.6 and 67.0 percent over the decade, but the 1984 percentage was a record high at 68.1 percent. Los Angeles County had 36.9 percent in 1975; by 1984 its percentage had increased to 49.5 percent.

### COMMITMENT OFFENSE

The commitment offense perhaps best illustrates the changing characteristics of Youth Authority wards. Since 1975, the proportion of wards in institutions for violent type offenses (homicide, robbery, assault, violent rape, and kidnapping) increased from 48.6 percent to 55.8 percent in 1983, then decreased to 54.0 percent in 1984. The proportion of wards in institutions for property offenses (burglary, theft and arson) has fluctuated between 34.1 percent and 40.9 during the past ten years.

Wards under commitment for narcotic and drug offenses, which reached their peak in the early seventies, have receded to where they are a minor contribution to the total, although there has been a slight upturn since 1982.

### ADMISSION STATUS

The proportion of first commitments in the institutional population gradually from 72.2 percent in 1975 to 85.5 in 1981. It has fallen over the past three years because of the significant increases in parole revocations.



### ETHNIC GROUP

In 1975 the percentage of White male wards in institutions was 39.6 percent; it has since dropped to 26.4 percent in 1984. In contrast, there has been an upward trend in the proportion of minority wards in institutions. Blacks comprised some 36.5 percent in 1975 and rose to 39.7 percent in 1982, then declined to 38.6 percent in 1984. The Hispanic ethnic group rose gradually over the years from 21.2 percent to 32.6 percent.

### FULL BOARD STATUS

The percentage of wards in institutions with Full Board designations has increased over the 10-year period almost parallel to the increase in the proportion of wards with violent type offenses. On June 30, 1984, those in institutions on Full Board status represented 54.1 percent of the population.

### AGE

The average age in institutions started the decade at 18.9 years. Since then, it has declined to 18.5 in 1978 and 1979, then rose to 18.7 in 1981, and has remained unchanged the past four years.
