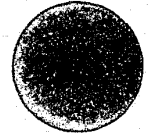

### Abstract

This report is the first of two reports on recidivism rates of offenders released from Department of Correction facilities during 1983. Some highlights from this report are:

- The recidivism rate in 1983 was 21%. This is lower than the rates for 1982 (23%) and 1981 (24%).
- The decline in recidivism rates occurred at the same time that the number of releases increased, from 1032 in 1981 to 1221 in 1982 and 1726 in 1983.
- The recidivism rate varied by the security level of the institution from which the offender was released: 28% for maximum, 27% for medium, 20% for minimum, 18% for minimum/pre-release, 14% for state pre-release and 12% for private pre-release.
- The recidivism rate for offenders with no furloughs prior to release was 27% and the recidivism rate for individuals with furloughs prior to release was 10%.
- The recidivism rate for males was 20% and the rate for females was 26%.
- Among males, the recidivism rate was 18% for those serving a Walpole sentence and 21% for those serving Concord sentence.

## Introduction

This report presents a statistical description of offenders released to the street from Massachusetts correctional facilities during 1983 with corresponding recidivism rates. For purposes of this report, institutions with a pre-release component are collapsed into the "pre-release" category. Another report (Number 291) provides the information for all pre-release facilities. This report presents statistics for maximum security facilities (MCI-Walpole), medium security facilities (MCI-Concord, MCI-Norfolk, MCI-Framingham, SECC and NCCI), and minimum security facilities (MCI-Plymouth, MCI-Warwick, Bay State C.C. and N.C.C.). Statistics for state pre-release facilities (MCI-Shirley, MCI-Lancaster, Boston State PRC, South Middlesex PRC, Park Drive PRC, and Norfolk PRC), three drug rehab programs (Meridian House, Spectrum House and Boston VA Hospital), and seven contract pre-release facilities (Brooke House, Coolidge House, Coolidge II, THP, 577 House, Charlotte House and Hillside PRC) are presented in report Number 291. Four institutions actually combine minimum and pre-release. For purposes of these reports MCI-Plymouth and MCI-Warwick are considered minimum, MCI-Shirley and MCI-Lancaster are considered pre-release. A total of 1,726 offenders (1382 males and 344 females) were released from the correctional facilities listed above. The follow-up period is one year from the date of the offender's release to the community. A recidivist is defined as any offender who returns to a state or federal correctional institution, or to a house of correction or jail for 30 days or more and includes parole violators as well as those offenders sentenced for new crimes.

Information contained in this report includes statistics on recidivism rates associated with individual characteristics with regard to release variables, nature of present offense variables, personal background variables, criminal history variables, furlough participation variables, and release follow-up variables. The tables which follow

contain two types of information: (1) statistical data describing characteristics of offenders released from each institution during 1983 and (2) the rates of recidivism cross tabulated with each of the categories of the statistical data for these offenders.

In reading tables in this report, the reader should note the following: (1) the release population is divided according to the institution of release; (2) N represents the number of offenders who fall into the corresponding category in the table; (3) P represents the percentage of the number of offenders in a particular category to the number of offenders released from that institution (column percents); and (4) RR (Recidivism Rate) represents the percentage of offenders in that category who have recidivated. For example, upon referring to the first table on pages 8 and 9, the variable "Type of Release" is presented and the following kinds of information may be obtained: (1) the total number of releases broken down by specific institution is labeled and presented horizontally across the head of the table; (2) the type of release (parole or discharge) is labeled and presented vertically; (3) of the 1,726 offenders released during 1983, 1373 were released on parole (80%) and 353 were released on a discharge (20%); (4) those offenders released from Norfolk who were released on parole had a recidivism rate of 29% while those offenders released from Norfolk on a discharge had a recidivism rate of 12%.

The material was derived from the computerized data base developed by the Correction and Parole Management Information System (CAPMIS) and was produced on the Regent's Computer Network (RCN).
