Abstract

This report provides a statistical description of the 9,511 offenders committed by the courts to a Massachusetts county facility (jail or house of correction) during 1985. The report presents information on institution committed to, court committed from, month of commitment, offense, sentence length, sentence type, age, sex, race, marital status, education, place of birth and residence.

Some highlights of the statistics presented in this report are:

- In 1985 there were 9,511 commitments to county facilities. This represents an increase of 114 (one percent) over the number of commitments in 1984.
- The most common offenses for which offenders were committed were Operating Under the Influence (O.U.I.) (22 percent), motor vehicle violations (13 percent), and burglary (10 percent).
- The median sentence length was two months. Eleven percent were committed in lieu of payment of a fine. Four percent were serving week-end sentences.
- The median age of offenders committed to county facilities was 26 years.
- Eighty percent of the offenders were white, 14 percent were black and 6 percent were hispanic or other races.
- The median educational level was eleventh grade.
- Seventy percent of the offenders were single, 18 percent were married and 12 percent were separated, divorced or widowed.
- Seventy-one percent were born in Massachusetts, 19 percent were born in other states, 6 percent were born in U.S. territories and 4 percent were foreign-born.

Introduction

This report provides a statistical description of offenders committed to Massachusetts county facilities (jails and houses of correction) during 1985. This report includes information about average daily population and operating expenditures for the various county facilities. The report includes information on institution committed to, month of commitment, court committed from, offense, sentence length, sentence type (week-end and jail sentences), sex, age, race, marital status, education, place of birth, and residence. The tables in this report were derived from information submitted by each county facility to the Operations Research Unit of the Research Division in the Department of Correction and were produced on the Regent's Computer Network.

Upon referring to the statistical tables in this report, the reader should note the following: (1) the total population is sub-divided by committing institution; (2) the top number in each cell represents the total number of offenders committed to a particular institution who fall into the corresponding category in that row of the table; (3) the bottom number in each cell (the number contained in parentheses) is the percentage of the number of individuals in the category to the total number of individuals from that institution (column percents). For example, on page fifteen, Month of Commitment is presented and the following types of information can be obtained:

- (1) The total number of offenders is broken down by commitment institution, and these are labeled and presented horizontally across the top of the table;
- (2) The specific months are labeled and presented vertically;
- (3) Of the 9511 offenders committed during 1985, 1916 were committed to the Middlesex County facility;
- (4) Of the 1916 offenders committed to Middlesex County, 194 (10 percent) were committed in January.

County Facilities in Massachusetts

There are fourteen counties in Massachusetts. All counties except for Nantucket county have at least one county correctional facility administered by the county sheriff. These facilities usually contain a jail for pre-trial detainees, and a house of correction for sentenced inmates. The location and administrators of all facilities are shown in Figure 1. Suffolk county has a separate facility for its jail (Charles Street) and its house of correction (Deer Island). The Deer Island House of Correction is administered by the Penal Commissioner of Boston. Middlesex county has two facilities, a combined jail and house of correction in Billerica and a jail in Cambridge. Essex county has two jails and houses of correction, one in Lawrence and one in Salem. Three counties have specialized facilities for sentenced offenders: Essex County has the Correctional Alternative Center (CAC) in Lawrence; Hampden county has the Western Massachusetts Correctional Alcohol Center (WMCAC) facility in Springfield; and Norfolk county has the Braintree Alternative Center.

The nineteen county facilities include ten nineteenth century facilities and nine built in the twentieth century. The oldest facility is the Essex county facility in Salem built in 1813.

The average population in the county facilities during 1985 was 3,770. This included an average of 2,578 house of correction inmates, 1,001 jail inmates, 10 awaiting booking into DOC facilities, 88 DOC inmates and 93 federal inmates. The average daily population statistics are shown in Figure 2. The facilities ranged in size from 12 in the Dukes county facility to 640 in the Middlesex county facility.

The operating expenditures for each county facility for the fiscal year ending June 30, 1985 are shown in Figure 3. These include expenses for salaries, food, utilities and other expenses.

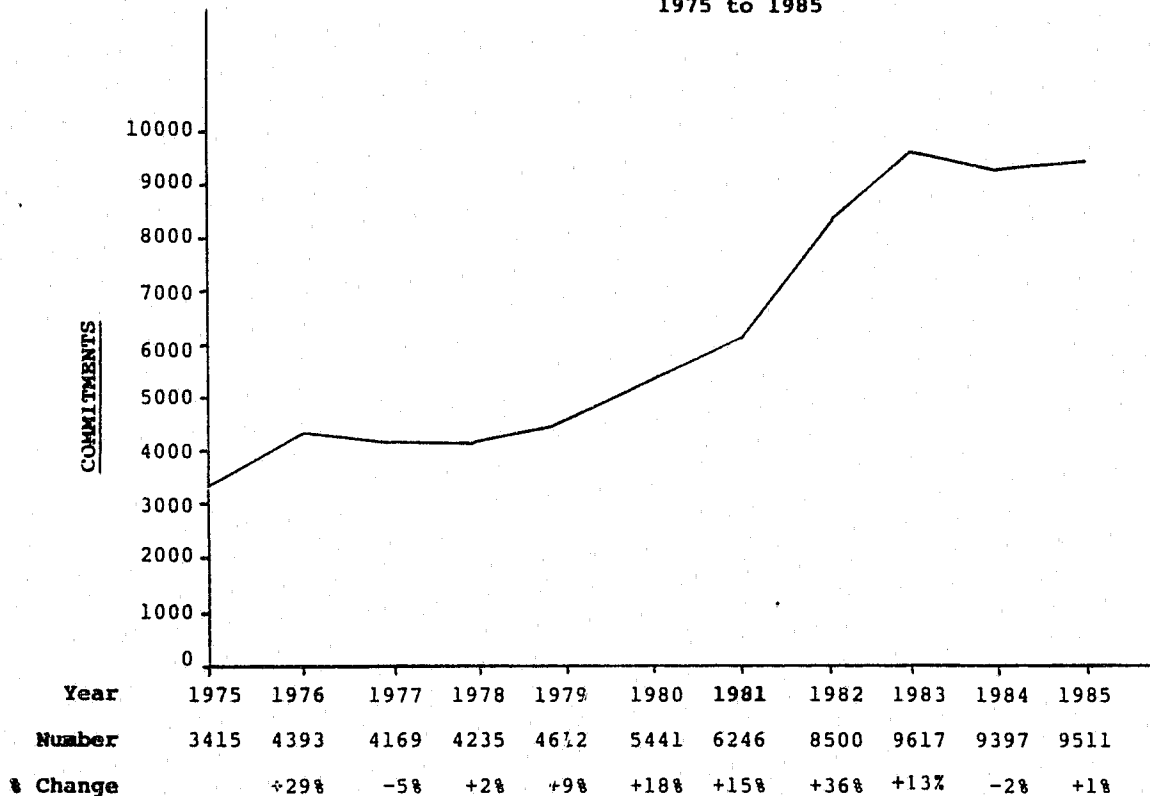

Number of Commitments

During 1985 there were 9,511 commitments to county facilities. This is a one percent increase from the 9,397 commitments in 1984 and a one percent decrease from the 9,617 commitments in 1983. Commitments to county facilities for the last eleven years are shown in Figure 4. Compared with the rapid rise in the number of commitments from 1975 to 1983, the level of commitments from 1983 through 1985 has been relatively constant.

A Description of 1985 Commitments

In this section the 9,511 offenders committed to county facilities will be described in more detail. First, characteristics of the present offense will be discussed and second, personal background characteristics of the county offender population will be discussed. Information for each institution for these variables can be found in the following tables.

Present Offense Characteristics

Institution Committed To. The number of commitments ranges from a low of 62 to Dukes County to a high of 1,916 to Middlesex County. Three counties received in excess of 1,000 commitments in 1985: Middlesex (N=1,916), Worcester (N=1452), and Suffolk - Deer Island (N=1,064). These three counties accounted for almost half (47 percent) of all county commitments in 1985.

Present Offense. Most offenders committed to county facilities were sentenced for non-violent offenses (87 percent). Only 13 percent were committed for violent offenses, those against the person or sex offenses.

Eleven percent of the commitments were for offenses against the person. Most of these were for armed assault (assault and battery with a dangerous weapon or assault with a dangerous weapon) or unarmed assault (assault or assault and battery). There were 64 commitments for vehicular homicide.

Two percent of the commitments were for sex offenses including 38 for rapes and 136 for assaults with intent to rape (which includes indecent assault and battery).

Thirty-one percent of the commitments were for property offenses. The most common property offenses were: burglary (N=966), larceny (N=635), motor vehicle theft (N=323), receiving stolen property (N=247) and injury to property (N=213).

Eight percent of the commitments were for drug offenses. Most of these were for violation of the controlled substance act with Class A, Class B, or Class D substances.

Forty-eight percent of all commitments were in an "other" offense category. Most of these commitments are for O.U.I. (N=2118) and other motor vehicle violations (N=1225).

Sentence. Sentences to county facilities range from fines up to two and one half years. The median sentence length for 1985 commitments was two months. In general, offenders sentenced for less than two months will serve their entire sentence, and offenders sentenced for two months or more will be eligible for parole after half their sentence is served.

There were 1,085 (11 percent) committed in lieu of payment of a fine. Fines were used extensively at Dukes county, accounting for 64 percent of all commitments.

Some sentences are served only on week-ends. Four percent of all commitments were week-end sentences. Week-end sentences were used most extensively in Middlesex county where 10 percent of all commitments were served on weekends.

Most offenders are sentenced to houses of correction, but some offenders are committed to jails. In 1985 there were 133 such jail commitments (about one percent of all commitments). Almost all of these were to the Suffolk County Charles Street facility and were generally for illegitimacy (i.e. child support), non-support, violating a court order or contempt of court.

Court from Which Committed. Most offenders committed to county facilities are sentenced in the lower courts in the county to which they are committed. Ninety-three percent were from lower courts and 7 percent were from Superior courts.

Personal Background Characteristics

Sex. Of the 9,511 commitments to county facilities there were 20 females and 9,491 males. Females are only accepted at three county facilities: Berkshire, Dukes and Franklin. All other females receiving a county sentence are sent to the state correctional facility for female offenders, MCI-Framingham.

Race. The majority of offenders were white (80 percent). Fourteen percent were black and 6 percent were hispanic. There were 35 individuals (less than one percent) in other racial groups.

Age. The age of offenders ranged from 16 years to 75 years. The median age was 26 years. There were 1,820 offenders (19 percent) age 20 years or younger and 71 (1 percent) age 60 and over.

Marital Status. Most offenders were single (70 percent). Eighteen percent were married at the time of commitment and 12 percent were separated, divorced or widowed.

Education. The median educational level was eleventh grade. Ten percent had only a grade school education (first through eighth grade), 41 percent completed some high school and 49 percent were high school graduates. Ten percent had at least some college education and 2 percent report having a college degree.

Place of Birth. Seventy-one percent of all county commitments were born in Massachusetts, 19 percent were born in other states, 6 percent were born in U.S. territories and 4 percent were foreign-born. Bristol county had the highest proportion of foreign-born (11 percent); Hampden county had the highest proportion of offenders born in U.S. territories (20 percent); Dukes county had the highest proportion born in other states (56 percent); and Berkshire county had the highest proportion born in the same county as the facility (58 percent).

Residence. All but 245 offenders committed to county facilities were residing in Massachusetts at the time of commitment. In most cases the offenders were residing in the same county as the facility to which they were committed. The Suffolk county jail at Charles Street had the highest proportion of county residents (93 percent) and Dukes county had the lowest proportion of county residents (40 percent).
