# A RECIDIVISM STUDY ON INTENSIVE SUPERVISION, SPECIALIZED CASELOADS, AND RESTITUTION CENTERS FOR 1985-1987

In December, 1987, the House Select Committee on Sentencing and Recidivism held an organizational meeting. At that time, a study of revocations to TDC from adult probation was provided to the Committee. The Committee instructed the Texas Adult Probation Commission, the Board of Pardons and Paroles and the Texas Department of Corrections to do a three year recidivism study on respective populations. The individual studies should be structured to have parallel information. A format was provided by Representative Granoff to be used in reporting data. Recidivism is defined as "incarceration in TDC". For probation, the definition applies to those probationers revoked to TDC from probation or subsequently rearrested and placed in TDC.

Staff of the TAPC met with staff of the BPP, TDC, Criminal Justice Policy Council and Sam Houston State University in developing the design for the study. TAPC selected sample of persons in the Intensive Probation, Specialized Caseload and Restitution Center Programs for the study. The sample consisted of persons who were placed in the programs during the months of September, October and November for the years 1985, 1986 and 1987. TAPC then requested Computerized Criminal Histories from the Texas Department of Public Safety on all probationers in the sample who had not been revoked to TDC or died.

TAPC maintains a sample of regular probationers for purposes of describing the population. The information however had not been updated through collections of subsequent samples. Further it contained cases for the time period 1979 through 1985. It was determined through consultation with the Criminal Justice Center of Sam Houston State University and the Criminal Justice Policy Council research staff that the sample was not appropriate for the study. A new sample on regular probation will be collected within the next two months and data entered. At that time, the new sample and the census data collected in FY87 can be used in a recidivism study on regular probation.

The following tables show recidivism rates for the three special programs in the study according to age groups, type of offense and prior felony history.

Table I is read as follows: The 12 month data provide information on probationers who were placed in a Special Program in the first quarter of FY87. For persons in ISP in the 17-25

age range during that time period, 56 were revoked from ISP to TDC and 25 were arrested and sentenced to TDC after discharge

from ISP for a recidivism rate of 16%. Under TOTAL: New Offense, 95 persons, or 13%, from all three Special Programs were incarcerated in TDC for committing a new offense. It should be noted that all subsequent offenses are assumed to be at the felony level.

The 24 month data are for the FY86 group. The 36 month data are for the FY85 group.

Table II displays information on the rate of recidivism by offense. Again the 12 month data are for FY87, 24 month data for FY86 and the 36 month data for FY85. In FY87, 1, or 7% of those who were placed in ISP for the offense of homicide, was revoked to TDC. The numbers of persons placed in Specialized Caseloads for homicide was less than on ISP so when the rate was calculated for 1 person, it comprised 33% of the category.

Table III shows recidivism rates in terms of prior felony history. During FY87, 25 persons were revoked from ISP who had a prior felony history. Sixteen persons were incarcerated after discharge from the program. These two figures combined result in a recidivism rate of 13% of the persons with prior felony histories.
