Residents in Wisconsin  
Adult Correctional Facilities  
on December 31, 1984  
With Five-Year Trends for 1980-1984

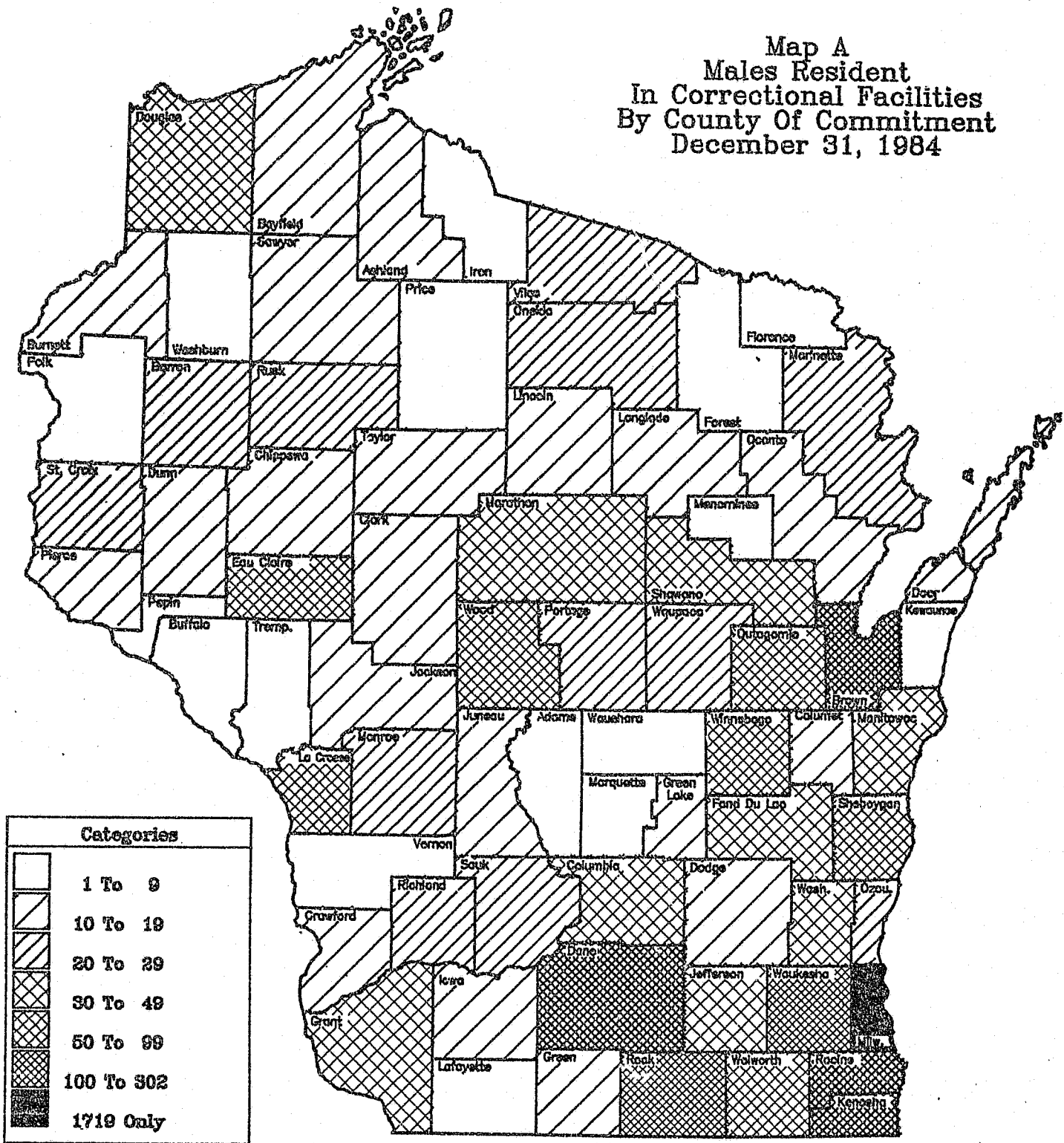
On December 31, 1984 Wisconsin's Division of Corrections was responsible for an adult offender resident population of 4,845 persons, 4,632 males and 213 females, a slight increase (3.1 percent) over the previous year when 4,700 persons were present. The majority (90.9 percent) were confined in facilities operated by the Division of Corrections with a small portion (3.1 percent) in the Wisconsin Resource Center which is operated by the Division of Care and Treatment Facilities. The remainder (6.0 percent) were housed, under contract, in correctional facilities operated by the state of Minnesota, the Federal Bureau of Prisons, the Milwaukee County House of Corrections, and other county jails in Wisconsin. The map and key which precede this text will provide the reader with information about the location and security level of the various facilities operated by the Division of Corrections.

Information about the admission status (new adult sentence, adult mandatory release violator, etc.) can be found in Table 1 while Tables 2 through 15 are designed to provide the reader with information about the social and demographic characteristics of those in residence. Seventy four persons noted in Table 1 have been excluded from the remainder of the tables and the discussion. These include 46 males and 1 female institutionalized to await the outcome of probation, parole, or mandatory release revocation hearings, 1 male who voluntarily returned from parole supervision, and 26 males serving alternative to revocation contracts. Trend data for the period 1980-1984 can be found in Tables A and B and the resident population by county of commitment is depicted in Maps A and B.

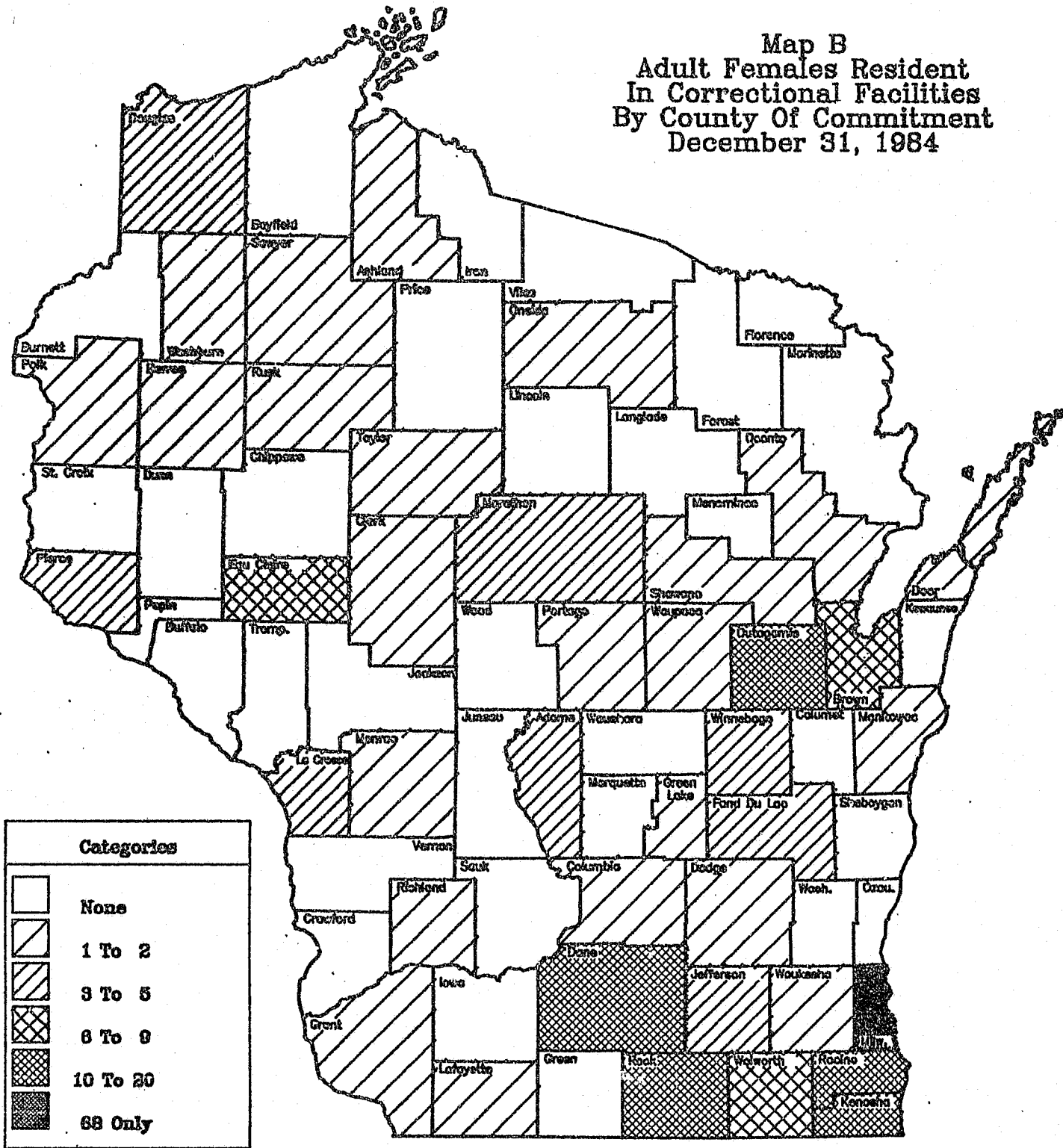

Two hundred and thirteen females were in residence on December 31, 1984; an increase of 4.9 percent over 1983 levels as well as a high for the five-year period. Nine of 10 (89.1 percent) of the females in residence on December 31, 1984 had been received at the institutions as new admissions. Over two-thirds (68.6 percent) were sent to the institution from counties in the Southern, Southeastern, and Milwaukee Regions; i.e., the southern one-third of the state. Thirtytwo out of the state's 72 counties (44.4 percent) had no representation in the December 31, 1984 resident population. (See MAP B and Table 6.) Slightly more than on-half (54.3 percent) of the residents were reported to be white including 9 (4.3 percent) who came from Hispanic ethnic and cultural backgrounds. The proportion of females reported to be from non-white backgrounds decreased to a five-year low of 45.7 percent on December 31, 1984. The average (median) age which stood at a low of 27.0 years in 1981 increased steadily reaching a high of 29.0 years in 1984. An increase was also noted in the average (median) length of sentence from a low of 3.8 years in 1982 to a five-year high of 4.8 years in 1984.

The proportion of females who were not assaultive, sex, or drug offenders dropped from a five-year high of just over one-half (51.2 percent) on December 31, 1983 to 45.2 percent on the same day in 1984. Those considered as being solely sex offenders made up less than one percent of the December 31, 1984 resident population while those institutionalized only because of drug offenses made up less than one-tenth of the population; an increase over the five-year low of 6.0 percent recorded on December 31, 1983. Females designated exclusively as assaultive offenders accounted for somewhat over two-fifths (43.4 percent) of the December 31, 1984 resident population; a high for the five-year period.

The adult male resident population rose to a five-year high of 4,632 on December 31, 1984; an increase of 3 percent over the previous year when 4,497 residents were present. The smallest increase during the five-year period was 1 percent, from 4,456 to 4,497, between December 31, 1982 and December 31, 1983; the largest, the 12.0 percent from 3,655 on December 31, 1980 to 4,093 a year later. Eight out of 10 males in residence on December 31, 1984 were reported to be new admissions, a proportion that has remained constant since 1980. This group includes males who received new sentences from the court, juvenile aftercare violators who were given new adult sentences, and adult probation violators admitted with or without new sentences. Almost three-fourths (72.2 percent) of the residents had been committed to the institution from the 19 counties that comprise the Southern, Southeastern, and Milwaukee Regions. All of the states 72 counties were represented in the resident population with commitments from five counties, Milwaukee (1,719 cases), Kenosha (302 cases), Racine (293 cases), Dane (283 cases), and Rock (221 cases) accounting for just over three-fifths (61.8 percent) of the population. See MAP A and Table 6 for further information about the geographic origins of the resident population.

Approximately two-fifths (39.9 percent) of the males in residents on December 31, 1984 were reported as being from non-White family backgrounds; a low for the five-year period. The proportion of residents with Hispanic ethnic and cultural backgrounds remained very small, less than one-tenth (5.9 percent) on December 31, 1984. The average (median) length of sentence remained at 6.0 years while the average (median) age rose slightly from 26.7 years on December 31, 1983 to the current 27.0 years.

The proportion of males who were not categorized as assaultive, sex, or drug offenders dropped from a five-year high of 40.2 percent in 1983 to a low of 37.7 percent on December 31, 1984. As in previous December 31 male resident populations, those considered to be solely sex offenders made up less than one percent of the population while those categorized only as drug offenders accounted, as in the past, for less than one-tenth (4.8 percent) of the group. Assaultive offenders, or assaultive offenders who also happened to be sex and/or drug offenders made up almost three-fifths (57.0 percent) of those in residence on December 31, 1984. Those regarded solely as assaultive offenders accounted for somewhat less than two-fifths (37.7 percent) of the population; a decrease from the high of 40.2 percent reported the previous December. The proportion of males found to be sexual as well as assaultive offenders rose from the five-year low of 13.7 percent recorded in 1983 to 16.1 percent in 1984. As in the year just preceding, less than one percent (0.2 percent) of the population on December 31 was reported to be made up of males considered to be assaultive, sex, and drug offenders.
