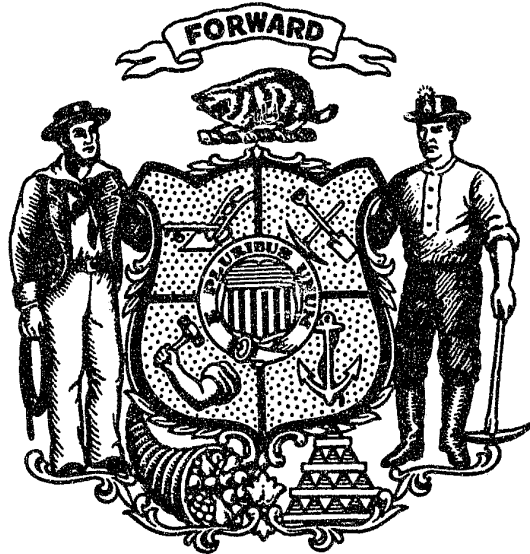

H I G H L I G H T S

- ° Eight out of 10 males (80.2 percent) and 9 out of 10 females (90.9 percent) in residence on June 30, 1988, were classified as new admissions. New admissions include offenders received with new sentences, probation violators with or without a new sentence, and juvenile aftercare violators sentenced as new adult offender. (See Table 1, pps.1-3, 29-30)
- ° More than one-half (54.5 percent) of the adult male resident population were White while over a third (37.1 percent) were Black. Over two-fifths (45.8 percent) of the females in residence were classified as White while nearly the same were Black (44.7 percent). (See Table 2, p.4, p.31)
- ° The major offenses most often reported for males in residence were unarmed burglary (22.7 percent), armed robbery (10.3 percent), and first degree sexual assault (8.2 percent). Females were found to have most often been sentenced for forgery (15.3 percent), theft (14.5 percent), and other drug violations (8.8 percent). (See Table 3, pps.5-7, pps.32-33)
- ° Over one-half (55.5 percent) of the males in residence were classified as assaultive or assaultive sex offenders while than two-fifths (43.1 percent) of the females in residence were classified as assaultive or assaultive sex offenders. (See Table 4, p.8, p.34)
- ° Males in residence were serving an average (mean) sentence of 10.5 years; females, an average (mean) sentence of 6.9 years. Offenders serving life sentences were excluded from these considerations. (See Table 5, p.9, p.35)
- ° Commitments from Milwaukee County accounted for about two-fifths of the males (38.1 percent) and females (41.2 percent) in residence. One-fourth (24.4 percent) of the males were committed from Dane, Kenosha, Racine, and Rock Counties as were one-third (34.6 percent) of the females with the addition of Winnebago County. (See Table 6, pps.10-14, pps.36-38)
- ° The average (mean) age for males was 30.4 years; for females, 32.2 years. (See Table 7, p.15, p.39)
- ° Over one-half (55.1 percent) of the males and somewhat less than one-half (45.0 percent) of the females were born in Wisconsin. (See Table 8, p.16, p.40)
- ° Four-fifths (79.8 percent) of the males and about three-fourths (73.3 percent) of the females were found to be without physical, emotional, or developmental disabilities. (See Table 9, p.17, p.41)
- ° A record of military service was noted for approximately one-fifth (18.1 percent) of the males. Eight (3.1 percent) women were reported with military experience. (See Table 10, p.18, p.42)
- ° High School Diplomas or GED or HED certificates were held by over two-fifths (45.4 percent) of the males and three-tenths (29.4 percent) of the females. Almost one-fifth (19.8 percent) of the females as contrasted with less than one-tenth (8.5 percent) of the males had a record of some college training. (See Table 11, p.19, p.43)

- ° One-fifth (20.0 percent) of the males and one-fourth (24.4 percent) of the females were found to have a tested grade level of twelfth grade or more. (See Table 12, p.20, p.44)
- ° The average (mean) institution stay for males in residence on June 30, 1988, was 26.5 months; for females, 20.9 months. Four out of 10 males (39.6 percent) and females (45.4 percent) had been institutionalized for less than one year. (See Table 13, p.21, p.45)
- ° Three out of 10 (34.1 percent) of the males in residence were classified as maximum or close security, almost two-fifths (37.0 percent) were classified as medium or medium out and about one-fourth (24.4 percent) were classified as minimum. The female population was divided into thirds; 28.2 maximum, 32.1 medium or medium out and 32.4 percent minimum. (Note: The presence of individuals with maximum or medium security classifications in minimum security institutions is due to a time lag in reporting changes to the information system.) (See Table 14, p.22, p.46)
- ° A moderate or serious need for treatment relating to problems with the use of alcohol was noted for almost three-fifths (57.6 percent) of the males and one-fifth (21.2 percent) of the females in residence. Information was obtained from the inmate needs assessment system. (See Table 15, p.23, p.47)
- ° Over one-half (56.6 percent) of the males and almost two-thirds (62.6 percent) of the females were found to be in at least moderate need of treatment for problems relating to the use of drugs. Information was obtained from the inmate needs assessment system. (See Table 16, p.24, p.48)
- ° Three-fourths of the males (78.0 percent) and females (75.6 percent) were found to be in need of treatment for problems involving the use of alcohol and/or other drugs. Information was obtained from the inmate needs assessment system. (See Table 17, p.25, p.49)
- ° Records indicated that one-fifth (20.2 percent) of the males and one-third (32.1 percent) of the females were in need of some type of treatment for problems relating to mental health. Information was obtained from the inmate needs assessment system. (See Table 18, p.26, p.50)
- ° Five out of 10 males (52.4 percent) and 6 out of 10 females (62.6 percent) were found to be in need of at least moderate participation in some type of educational programming. Information was taken from the inmate needs assessment system. (See Table 19, p.27, p.51)
- ° Eight out of 10 males (79.3 percent) and females (80.5 percent) were found to have at least a moderate need for some type of vocational training. Information was taken from the inmate needs assessment system. (See Table 20, p.28, p.52)
