Offenders Admitted to
Wisconsin Adult Correctional Institutions
Calendar Year 1988

H I G H L I G H T S

- ° The majority of the males (70.1 percent) and females (80.4 percent) admitted to Wisconsin's correctional facilities for adult offenders during calendar year 1988 were classified as new admissions. This category includes offenders who were not under any type of supervision at the time of sentencing as well as those who violated the terms of probation and were incarcerated with or without additional sentences. (See Table 1.)
- ° Unarmed burglary (23.9 percent), theft (7.8 percent), and other drug violations (7.0 percent) were the offenses for which males were most frequently sentenced. Females were most often sentenced for forgery (22.4 percent), theft (17.8 percent), and other drug violations (10.9 percent). (See Table 2.)
- ° The average (mean) length of sentence for all offenders admitted during 1988 was 72.4 months. Males were sentenced to an average (mean) of 73.1 months; females to 51.9 months. Twenty-eight males and one female admitted to serve life sentences were excluded from these computations. (See Table 3.)
- ° One-third of the males (33.2 percent) and females (33.3 percent) were committed from Milwaukee County. Commitments from Racine, Kenosha, Dane, and Rock Counties accounted for just over one-fourth (26.2 percent) of the males and just under two-fifths (37.3 percent) of the female admissions. (See Table 4.)
- ° The average (mean) length of sentence received by males convicted of unarmed burglary, theft, and other drug violations were 63.2 months, 45.8 months, and 43.3 months. Females sentenced for forgery, theft, and other drug violations were given average (mean) sentences of 53.2, 39.0, and 36.1 months. (See Table 5.)
- ° Males classified solely as assaultive offenders made up one-fourth (25.9 percent) of the admissions; an additional one-tenth (13.8 percent) were also categorized as sex offenders while 1.2 percent were also classified as drug offenders. One-fifth (20.7 percent) of the females were considered to be assaultive offenders. Males and females regarded solely as drug offenders made up one-tenth (10.2 percent) of the total 1988 admissions. (See Table 6.)
- ° Almost one-fifth (17.2 percent) of the males were under the age of 21 at the time of admission as were less than one-tenth (7.4 percent) of the females. The average (mean) age for all offenders was 28.0 years, which was also the average (mean) age for males. Females, with an average (mean) age of 29.0 years, were somewhat older. (See Table 7.)

- ° Almost three-fifths (55.9 percent) of the males and one-half (50.0 percent) of the females were from White racial and ethnic backgrounds. (See Table 8.)
- ° Six out of 10 males (62.8 percent) and five out of 10 females (48.9 percent) were found to have never been married. (See Table 9.)
- ° One-half (49.7 percent) of the males and somewhat less than three-fifths (56.3 percent) of the females had no record of felony convictions other than that associated with this admission. A record of at least two prior felony convictions was noted for just under three-tenths (27.0 percent) of the males and almost one-fourth (23.5 percent) of the females. (See Table 10.)
- ° Over one-half (52.2 percent) of the males and two-thirds (65.5 percent) of the females had no prior record of confinement in a penal institution. Prior incarceration in a Wisconsin penal institution was noted for over one-third (35.2 percent) of the males and over one-fourth (28.7 percent) of the females. (See Table 11.)
- ° Over one-fourth (26.8 percent) of the males had a record of prior stay in a juvenile institution. This was also true for slightly more than one-tenth (13.2 percent) of the females. (See Table 12.)
- ° Two-fifths of the males (40.4 percent) and females (41.4 percent) had not earned high school diplomas prior to admission. However, GED or HED certificates had already been earned by one-third (32.2 percent) of the males and one-fifth (20.1 percent) of the females. (See Table 13.)
- ° One-fourth (24.3 percent) of the males and over one-third (35.1 percent) of the females were found, after testing, to rank at least at the twelfth grade level. (See Table 14.)
- ° Eight out of 10 males (77.5 percent) and six out of 10 females (59.8 percent) were found to be without physical, developmental, or emotional disabilities. Less than one-tenth (7.5 percent) of the males as contrasted with just under one-fourth (23.6 percent) of the females were reported to have developmental and/or emotional disabilities. (See Table 15.)
- ° Less than one-fifth (17.3 percent) of the males and four females (2.3 percent) were reported to have a record of military service. (See Table 16.)
- ° Upon completion of security assignment procedures over one-half (54.6 percent) of the males and over two-fifths (43.1 percent) of the females received an initial custody classification of medium or medium-out. (See Table 17.)
- ° After completion of the assessment and evaluation process almost one-half (47.0 percent) of the males were placed in maximum security facilities, almost three-tenths (28.8 percent) in medium security facilities, and one-fifth (19.1 percent) in minimum security facilities. Seven tenths (71.3 percent) of the females were initially placed in maximum - medium

security facilities while one-fourth (25.8 percent) were placed in minimum security settings. (See Table 18.)

- ° Slightly less than two-fifths (37.9 percent) of the males and one-fourth (24.7 percent) of the females were found to be in serious need of treatment for problems relating to the use of alcohol. (See Table 19.)
- ° Three out of 10 males (30.7 percent) and four out of 10 females (40.2 percent) were seriously in need of treatment for problems caused by drug usage. (See Table 20.)
- ° One-fifth of the males (18.3 percent) and females (19.5 percent) were found to be without a need for treatment relating to the use of alcohol and/or other drugs. (See Table 21.)
- ° A need for involvement in some type of education programming was noted for over one-half of the males (53.4 percent) and females (55.1 percent) admitted during 1988. (See Table 22.)
- ° One-fourth (26.7 percent) of the males and one-third (32.8 percent) of the females were found to be in serious need of some type of vocational training. (See Table 23.)
- ° Assessment and evaluation procedures indicated that about one-fifth of the males (17.9 percent) and females (20.1 percent) had at least a moderate need for treatment of some type of problem relating to mental or emotional health. (See Table 24.)
- ° Participation in drug and/or alcohol (82.7 percent), therapy (51.3 percent), or education (42.3 percent) programs was recommended for males admitted in 1988. Further evaluation was recommended for 6.2 percent of the males. It was recommended that one-half (49.4 percent) of the females become involved in some type of therapy program, two-fifths (39.1 percent) in drug and/or alcohol programs, and one-third (34.4 percent) in education programs. Further evaluation of two-fifths (38.5 percent) of the females was recommended. (See Table 25.)
