Releases from the institutional system is defined as "the sum of mandatory releases; expiration of sentence; paroles by the paroling authority; discharges by the paroling authority; releases of Safekeepers and Pre-dispositionals; transfers to another state's correctional system, as well as, to the Federal Correctional System; releases to Regulated Community Assignment (RCA) and deaths.
