INTRODUCTION

This report has been developed to provide information regarding selected characteristics for offenders under the jurisdiction of the New Jersey Department of Corrections who are on parole. The data compiled in this report are based on information contained in the Department of Corrections computer files as of December 31, 1988. The selected characteristics compiled in this report are Base Offense at Admission, Race/Ethnicity, Age and County of Commitment.

In this edition, note that the District Offices have been divided into four regions, with the Northern Region representing Districts 1, 4 and 12 (Clifton, Jersey City and Paterson), the Metro Region representing Districts 2 and 9 and 13 (East Orange and Newark), the Central Region representing Districts 3, 5 and 11 (Red Bank, Elizabeth and New Brunswick) and the Southern Region representing Districts 6, 7, 8 and 10 (Trenton, Camden, Atlantic City and Vineland).

Out-of-State: The out-of-state designation represents offenders convicted in New Jersey but who are under active parole supervision out of state because of family ties or job location.

"NOT CODED" are records on offenders in the Correctional system in which admission characteristic data have not been entered into the computerized information system as of this date.

Total parole population includes Prison, Young Adult and Juvenile parolees. Also included in the total parole population are 853 female offenders.

The Bureau of Parole, in addition to supervising state parolees, is also responsible for the supervision of parolees who have served county sentences, usually of a year or less. These cases <u>are not</u> included in this report.

HIGHLIGHTS

Forty-one percent of the total parole population consisted of persons who had committed crimes of a violent nature. Of these violent offenders, 49% or 3542 were on parole for robbery, 13% or 966 were on parole for homicide, 24% were on parole for assault, 12% were on parole for sexual assault and other sex offenses.


More than one half of the total parole population was black, with District Offices #2 and #13 in East Orange and District Office #9 in Newark accounting for 34% of the black parolee population.

Approximately 95% of the total parolee population was 21 years of age or older. Forty percent are aged 21-29 and 36% are 30-39 years of age.

Forty-one percent of all offenders on parole were committed from the four (4) Northeast Counties of Bergen, Essex, Hudson and Passaic. Twenty percent (3,458) were committed from Essex.

Offenders on Parole in New Jersey on December 31, 1988 by BASE OFFENSE

In these tabulations, the Base Offense for an offender is that which is the most serious offense at the time of admission. These figures reflect base or controlling offense at admission only, and do not include offenses in addition to the base offense in the case of multiple sentences at admission, nor are additional sentences imposed following initial admission to the State Correctional System included in the data.

Violent Crimes include homicide, sexual assault, aggravated assault, robbery, and other sex offenses i.e. incest, carnal abuse, sodomy and impairing the morals of a minor.

Other Persons Offenses include simple assault, weapons offenses, coercion, larceny from a person and negligent manslaughter.

Property Offenses include burglary, arson, breaking and entering, theft, forgery, embezzlement, auto theft and receiving or possessing stolen property.


Public Policy Offenses include racketeering, gambling, violation of probation, prostitution, corruption, perjury, escape, bail jumping, juvenile or family-related offenses and conspiracy.

Narcotics Violations include distribution, manufacture and possession/use of drugs.

Almost one half (44% or 7785) of the total parole population consisted of offenders who had committed crimes of a violent nature or other person offenses. Of the 7785 violent offenders, 46% or 3542 were on parole for robbery, 12% or 962 were on parole for homicide, 22% or 1684 were on parole for assault, 11% or 865 were on parole for sexual assault and other sex offenses and 8% or 621 were on parole for other person offenses.

Forty-four percent of all offenders on parole were convicted of a crime of a violent nature (includes other person offenses). More than half of the offenders on parole from District Offices 2 and 13 (East Orange) and District Office 9 (Newark) were convicted of violent crimes and other person offenses.

Of the total New Jersey parole population, the most common commitment offenses were property offenses (27%), robbery (20%) and narcotics violation (19%).





More than one half (55%) of the total parole population were black, with the Metro region accounting for 34% of the black parole population.

Twenty-eight percent (4976) of the total parole population were white, with the Southern region accounting for the largest proportion of the white parole population (37%).

Two thousand nine hundred twenty-nine (17%) of the total parole population were Hispanic, with the Northern region supervising 44% of the Hispanic parole population.

The largest number of Hispanics on parole (391) were from District Office 4 (Jersey City).


