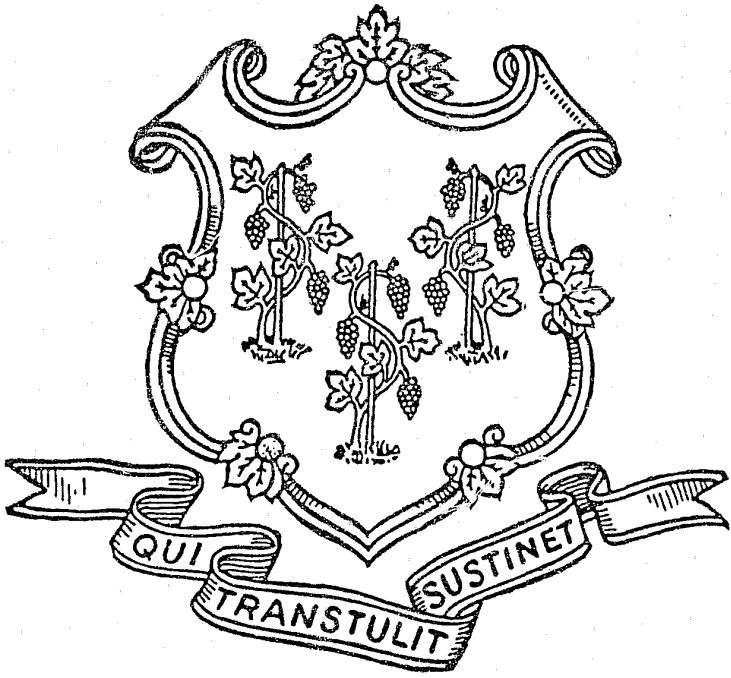

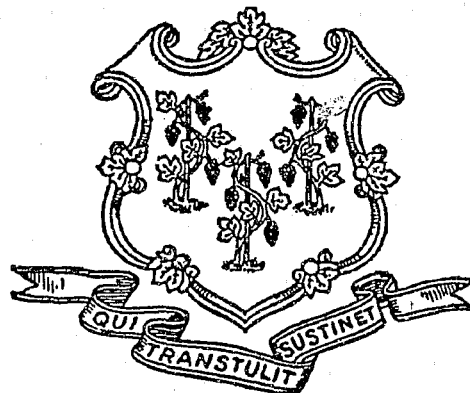

This publication reports the information contributed by every municipal and university police department in the state, as well as the Connecticut State Police. Although many police departments have been affected by budget cuts due to the economic problems in Connecticut, we are pleased that they have continued their excellent participation in the Uniform Crime Reporting program.

The statistics reported in this publication show that the very slight decline in crime, which began in 1991, has continued into 1992 and is now 5.9 percent lower than that reported in the previous year.

While a trend toward fewer crimes is a hopeful indicator for the future, we should continue to support all law enforcement professionals in their efforts to protect the public.

FACTS AT A GLANCE

CRIME CLOCKS

In 1992, an Index Crime occurred on the average of one every 3.2 minutes, a violent crime every 32.1 minutes and property crime every 3.5 minutes.

INDEX CRIME

There were 166,589 Index Offenses reported in 1992, a decrease of 10,424 from the 1991 total. This is a much larger decrease than 1991 which showed a decrease of only 72 index crimes from the previous year.

CRIME RATE

The Crime Rate for the State of Connecticut was determined to be 5077.4 Index Offenses for every 100,000 residents. The 1992 population is estimated at 3,281,000 persons. This figure is provided by the Federal Bureau of the Census.

The Rate of Violent Crime decreased from 542.5 offenses per 100,000 residents in 1991 to 499.1 per 100,000 residents in 1992, a decrease of 8.0%. The previous year there had been a smaller decrease of 2.1%.

The Rate of Property Crime also showed a decrease this year, from 4,836.2 offenses per 100,000 to 4,578.3 per 100,000 residents which is a decrease of 5.3% from 1991.

VIOLENT CRIME

The Crimes of Murder, Rape, Robbery and Aggravated Assault make up the Violent Crime category. Collectively, Violent Crime decreased by 1,477 offenses, an 8.3% decrease from 1991.

Decreases were observed in every violent crime: Murder decreased by 10.2%, Rape by 6.3%, Robbery by 6.2% and Aggravated Assault by 10.0%.

PROPERTY CRIME

Property Crime consists of Burglary, Larceny and Motor Vehicle Theft. In 1992, Property Crime decreased by 8,947 offenses. This was a decrease of 5.6% from 1991.

All Property Crime decreased from the previous year. Burglary decreased 6.8%, Larceny by 4.0% and Motor Vehicle Theft by 9.6%. This is the first year since 1984 that there has been a decrease in Motor Vehicle Theft from the previous year.

CLEARANCE RATE

Law Enforcement Agencies cleared 21.1% of all Index Offenses.

**STOLEN/
RECOVERED
PROPERTY**

In 1992, Law Enforcement Agencies reported \$192,608,434 worth of property stolen during the commission of Index Crimes. \$98,422,956 was recovered for a 51.1% recovery rate.

**ARREST
DATA**

During 1992, there were 185,066 persons arrested for all criminal activities, a decrease of 5.7% under the previous year. Of the total arrests, 20.7% were females. 14.6% of all arrests were persons under 18 years of age.

Total arrests for drug abuse violations increased from 15,804 in 1991 to 17,005 in 1992, an increase of 7.6%.

**LAW
OFFICERS
ASSAULTED**

There were 1,299 Law Officers assaulted during 1992. Of these, 465 received injuries. In addition, an officer was deliberately shot and killed while on routine patrol.

The Uniform Crime Reporting Program

Purpose

The Uniform Crime Reporting Program periodically measures crime in the United States by counting those offenses brought to the attention of law enforcement agencies. The program's objective is to produce reliable crime statistics for Law Enforcement administration, operation, and management. Criminal Justice professionals, legislators, scholars, and others concerned with crime problems make frequent use of UCR-generated statistics.

National Program

Uniform Crime Reporting was initiated in 1929 when the International Association of Chiefs of Police (I.A.C.P.) standardized procedures for crime data collection. On June 11, 1930, Congress enacted legislation authorizing the Federal Bureau of Investigation to collect nationwide crime counts and to serve as the clearinghouse for such data. The Committee on Uniform Crime Records of the I.A.C.P. continues to advise the F.B.I. in the operation of the UCR Program and offers them a valuable link to local police departments.

State Program

In July, 1977, Connecticut began its own Uniform Crime Reporting Program. By August of the same year, data collection began with the recruitment and training of 70 agencies. Today, Connecticut has 100 full-time police departments participating in its UCR Program.

The State Program ensures quality control and uniformity of the crime and arrest reports submitted. The centralized state collection agency streamlines the time-consuming process of resolving questions between contributors and verifiers. Upon completion of the quality control process, the returns are forwarded to the F.B.I.

Types of Data Collected

Every month law enforcement agencies throughout the state submit UCR data. They indicate the number of offenses brought to their attention through such sources as victim, police, or witness reports. The UCR Program defines Crime Index offenses as the following: Murder and Non-negligent Manslaughter, Forcible Rape, Robbery, Aggravated Assault, Burglary, Larceny-Theft, Motor Vehicle Theft, and Arson.

After counting Crime Index offenses reported, minus any unfounded complaints, contributors provide the number of "actual offenses" and the number of crimes cleared. For a criminal offense to be "cleared," one of the following situations must prevail: (1) at least one person is arrested, charged, and turned over to the court for prosecution; or (2) some element beyond police control precludes the physical arrest of the offender (e.g. death of offender, victim refuses to cooperate, confession by offender already in police custody), resulting in the offense being cleared by "exceptional means." Contributing agencies also include data on the value of property stolen and recovered in connection with the aforementioned offenses, plus specific information regarding homicides and arson.

UCR arrest data is collected for all crimes except traffic violations. The age, sex, and race of arrestees are reported for all crime categories.

Reporting Procedure

Contributing agencies are responsible for submitting their own crime reports to the State UCR Program. A field representative offers training in Uniform Crime Reporting procedures to ensure quality and uniformity in the data submitted to the State Program. Contributors also receive the Uniform Crime Reporting Handbook which provides a detailed outline of offense classifying and scoring procedures.

Verification Procedure

UCR reports are set up with numerous internal cross-checks to achieve reporting accuracy of the data. It is standard operating procedure to examine each incoming report for arithmetical accuracy. Reports are then subjected to logical tests of reasonableness, which are of key importance to confirming validity. Logical errors resulting from misinterpretations of what is to be measured can then be corrected. UCR personnel correct minor errors without contacting contributors, but necessary arithmetical adjustments or unusual variations are brought to the attention of the submitting agency.

UCR Limitations

There are inherent limitations in current crime reporting practices. Of primary importance is the question of how much crime is being reported. The degree to which crimes are being reported varies from area to area. A considerable volume of crime is not reported to law enforcement agencies because the victims consider the offenses against them to be of very little consequence or that the likelihood of apprehending the suspect is small. They may also fear retaliation from offenders, or are reluctant to reveal their own involvement in the offense or in other crimes. Consequently, information concerning some offenses is never entered into the reporting system.

Even with these given limitations, the UCR Program provides the best network of State and National crime figures currently available.

Crime Factors

Because not all factors that have an impact on crime problems are measured or considered by the UCR Program, superficial conclusions are sometimes drawn from its crime and arrest data, particularly when attempts are made to compare jurisdictions. Local ordinances and criminal justice administrative policies, record keeping practices, and the degree of adherence to Uniform Crime Reporting standards all affect the number of crimes and arrests reported. Additionally, socio-economic conditions and the characteristics and attitudes of the local population influence the extent and nature of criminal behavior in a community. The following factors must be taken into consideration before an informed assessment of crime data can be made:

- * Density and size of the community population and its surrounding area.
- * Variations in the composition of the population, particularly its age, sex, and race composition.
- * Stability of population with respect to such factors as commuters, seasonal residents, and other transient types.
- * Economic conditions, including unemployment.
- * Cultural conditions, such as educational, recreational, and religious characteristics.
- * Climate.
- * The trafficking and abuse of drugs in the community.
- * Effective strength of law enforcement agencies.
- * Administrative and investigative efficiency of the local law enforcement agency.
- * Policies of other components of the criminal justice system, such as prosecutorial, judicial, correctional, and probational.
- * Attitudes of citizens toward crime.
- * Crime reporting practice of citizens.

Future of the UCR Program

The Department of Public Safety has successfully completed the purchase of hardware and software for participation in the National Incident Based Reporting System (NIBRS). This purchase will allow the UCR Program to start collecting NIBRS data from local police departments and the State Police.

Many police departments are planning to submit reports in the NIBRS format in the near future. As of this date, several vendors have forwarded NIBRS test tapes. Currently a majority of police departments are working with their vendors to make them NIBRS capable.

With the successful implementation of NIBRS, police managers will have a clearer picture of crime in their locale. By combining this data on a regional, statewide and national basis, law enforcement can optimize its usage for operational and management decision-making.

INDEX CRIME

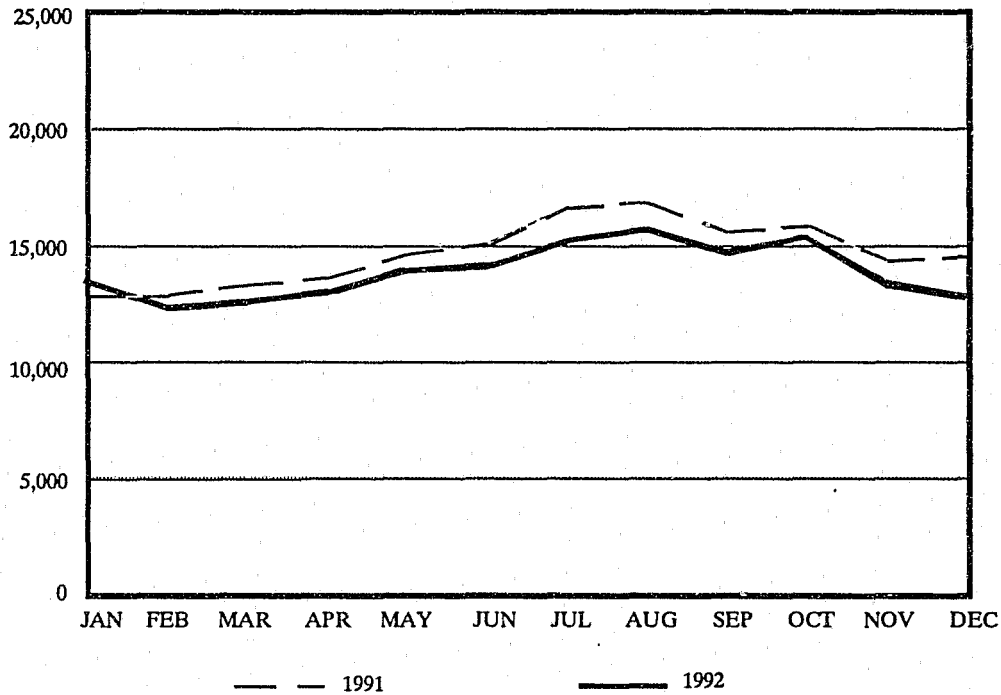

MURDER

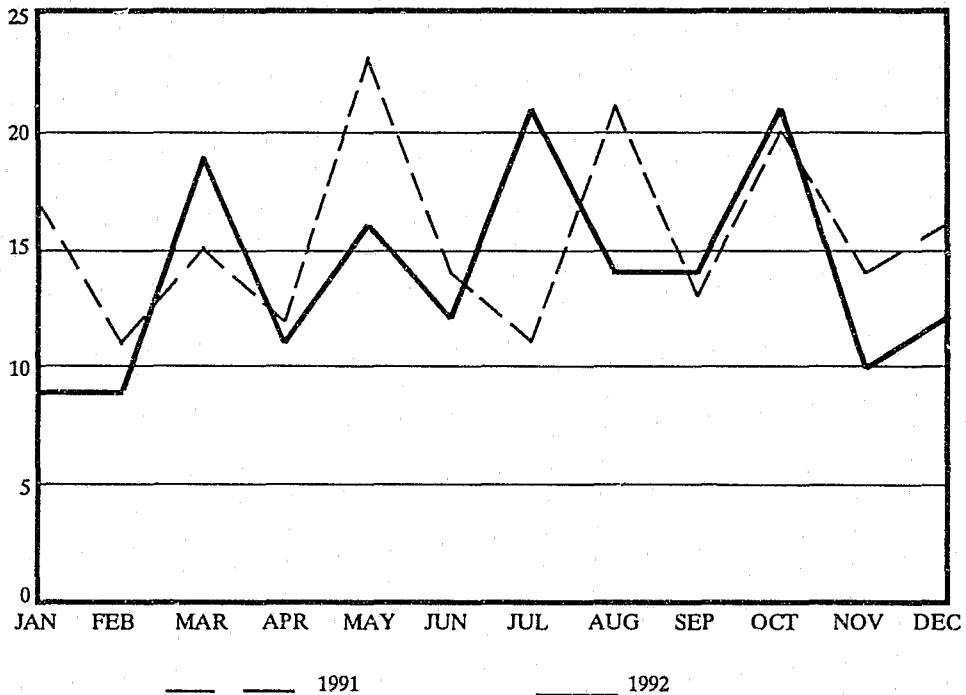
Murder is defined in the Uniform Crime Reporting Program as the willful (non-negligent) killing of one human being by another. Any death due to a fight, argument, quarrel, assault, or commission of a crime is included. Attempts to kill and assaults to kill are counted under aggravated assault. Suicides, accidental deaths, and justifiable homicides are not counted in this category.

Traffic deaths caused by the negligence of someone other than the victim are counted under arrests for Manslaughter by Negligence according to age, sex, and race.

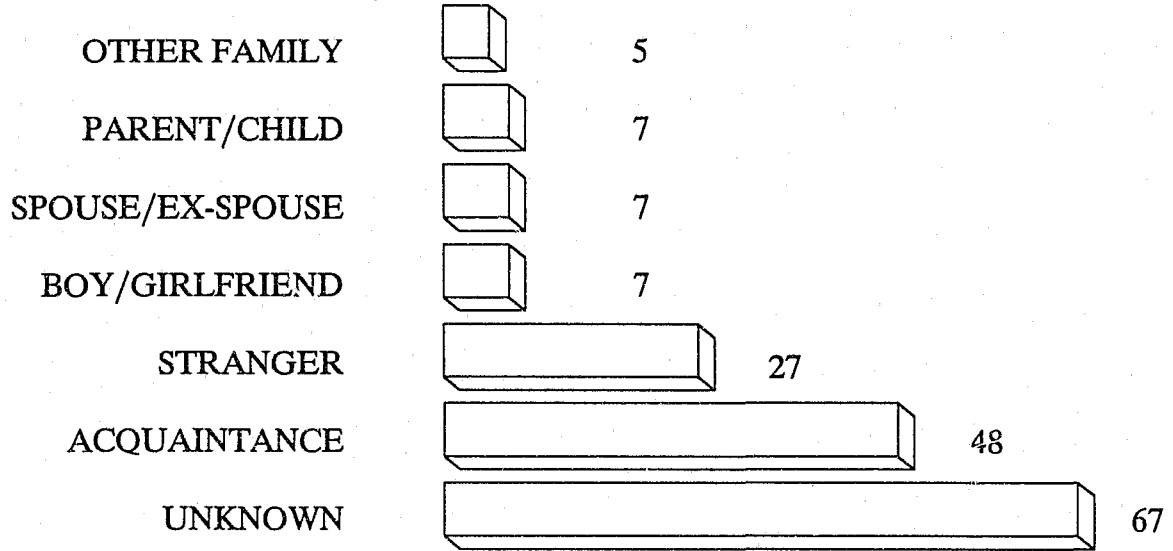

VICTIM / OFFENDER RELATIONSHIP



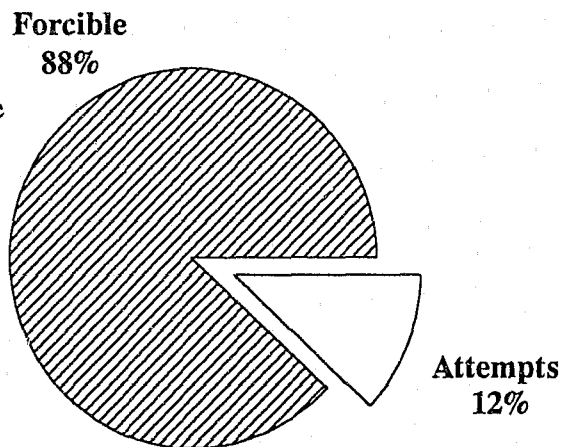

RAPE

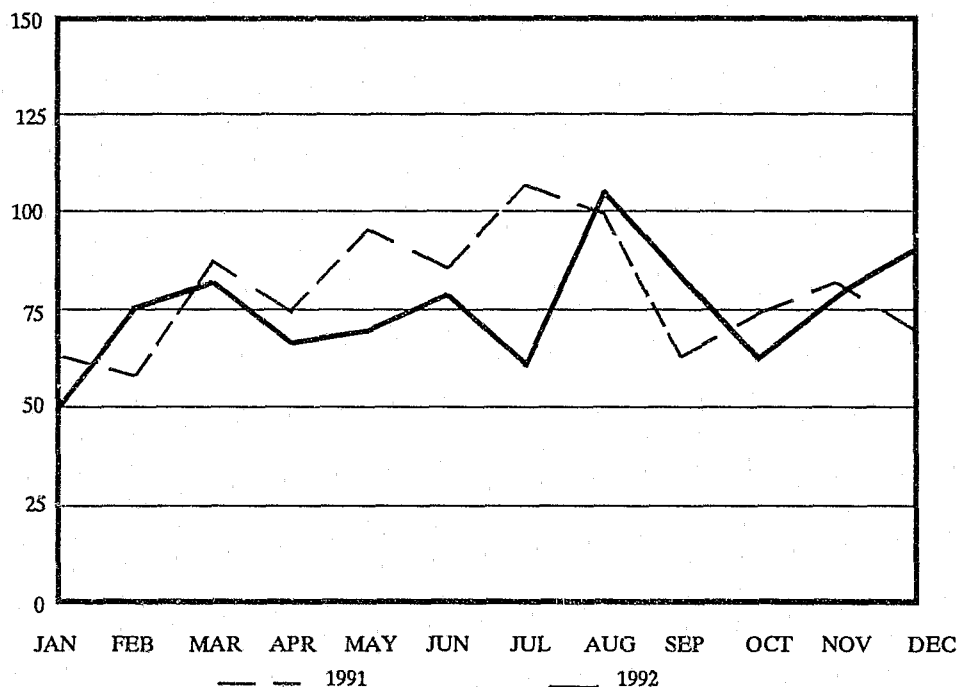
Forcible rape is defined as the carnal knowledge of a female forcibly and against her will. For UCR purposes, this offense is divided into two categories: Forcible Rape and Attempted Rape. Statutory Rape and other sex offenses are not included in this classification.

ROBBERY

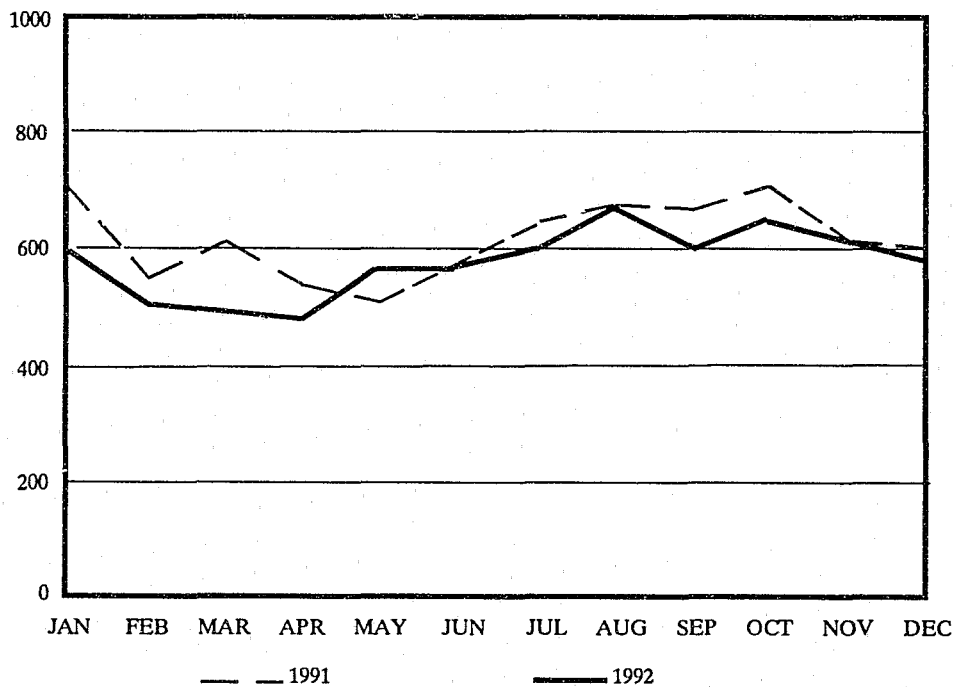
Robbery is defined as the felonious and forcible taking of property of another against his will by violence or by putting him in fear. The element of personal confrontation is always present in this crime. In the UCR Program, all attempts to rob are included in this classification.

Robberies are reported in four categories: firearms, knife or cutting instrument, strong-arm and other dangerous weapons.

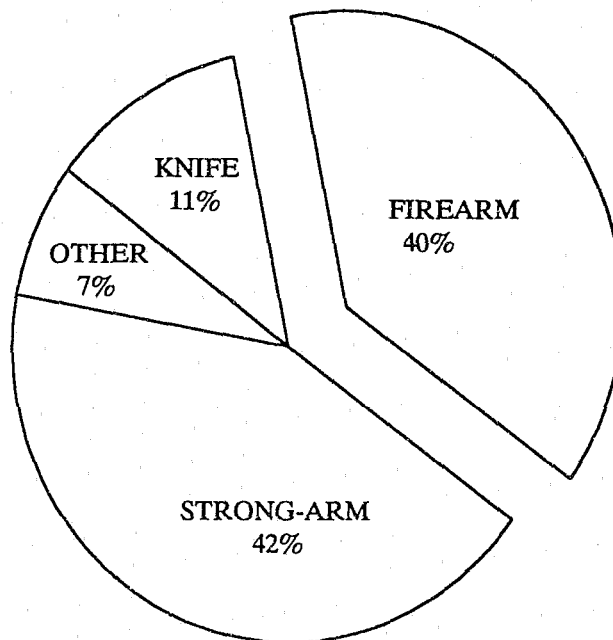

WEAPONS DISTRIBUTION



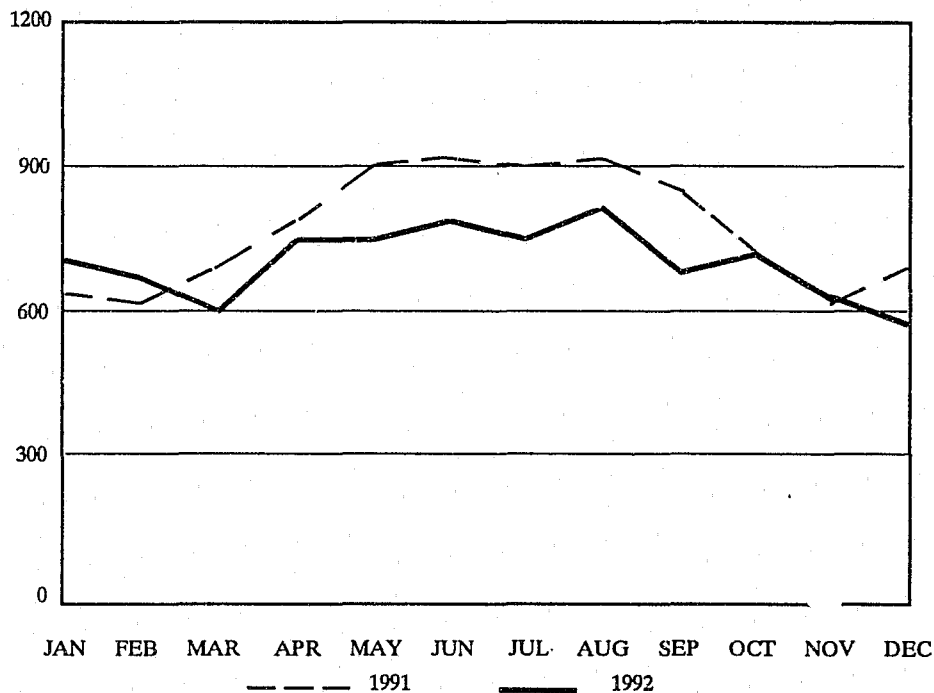
AGGRAVATED ASSAULT

Aggravated Assault is defined as the unlawful attack by one person upon another for the purpose of inflicting severe bodily injury, usually accompanied by the use of a weapon or other means likely to produce death or great bodily harm. Attempts to commit Aggravated Assault are included under this classification. Simple Assaults are excluded.

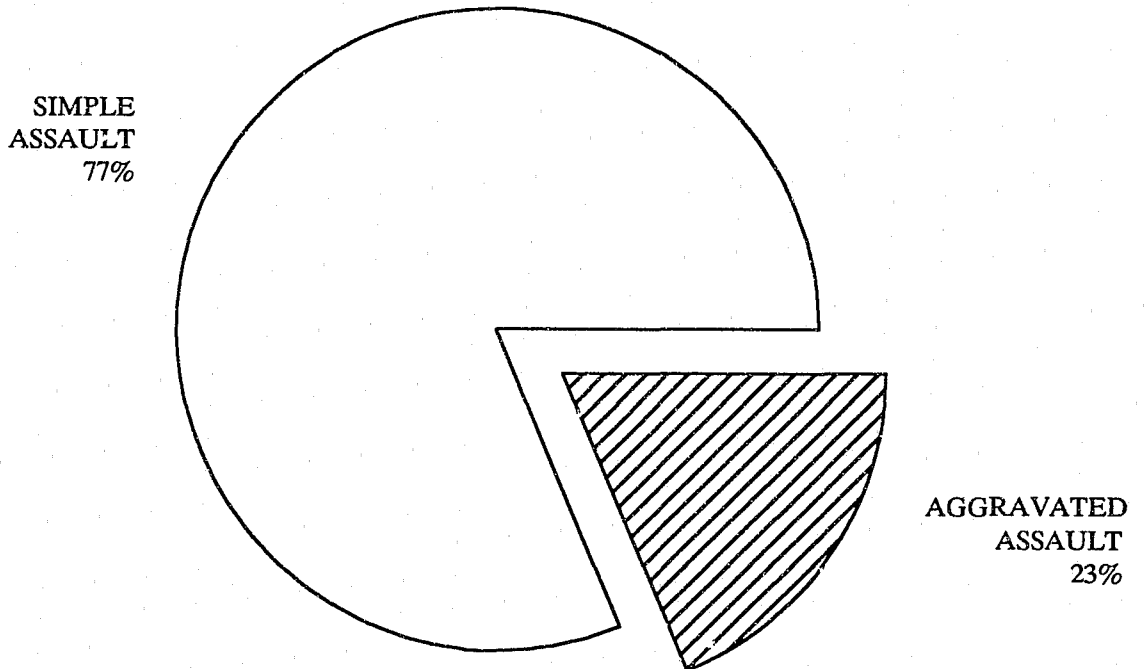
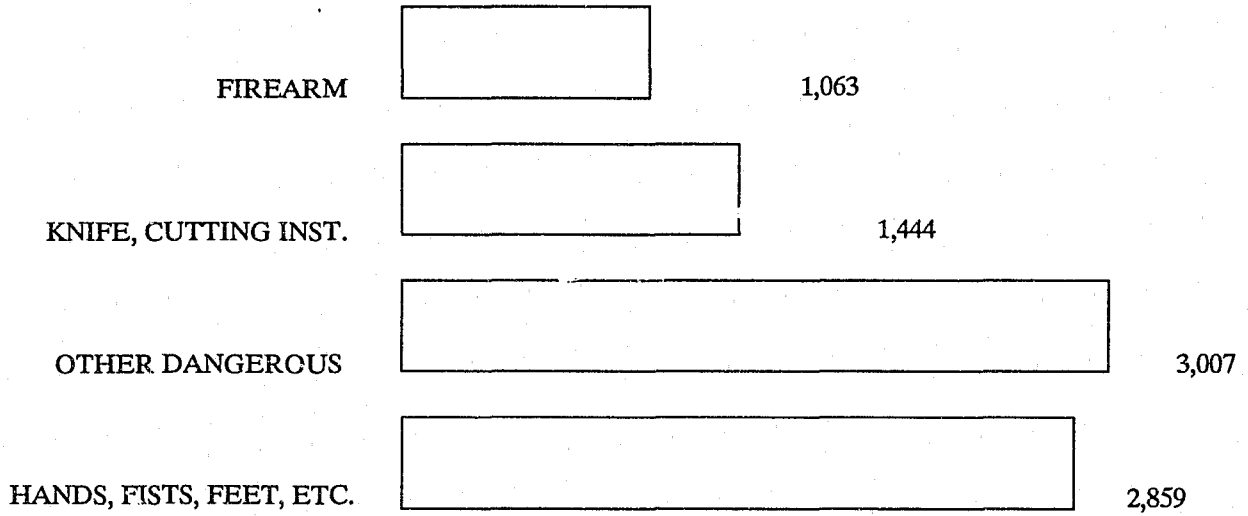

WEAPONS USED



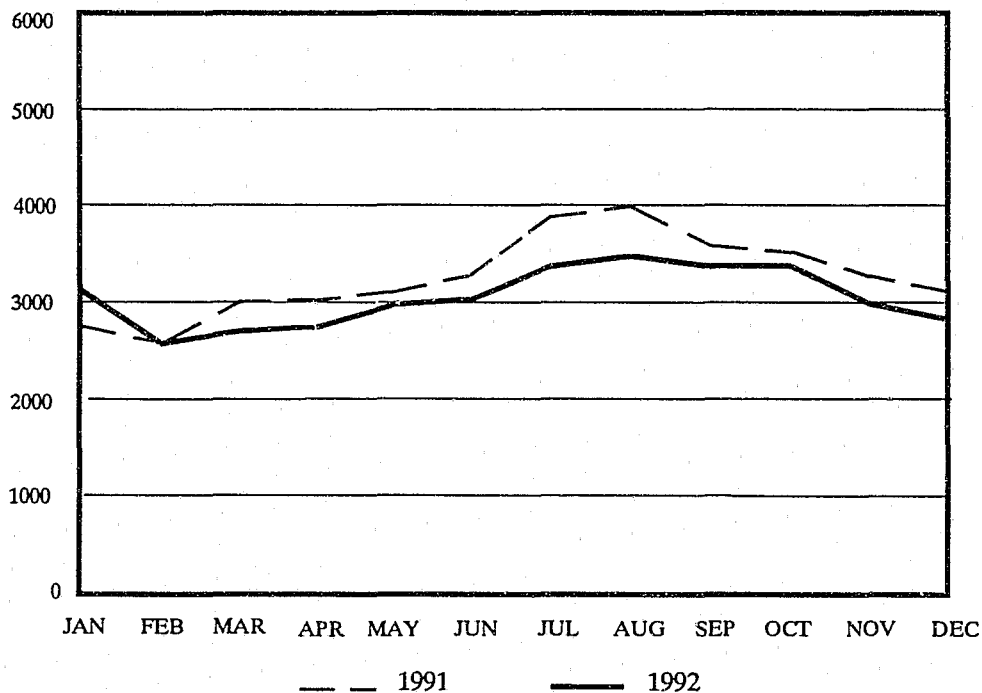
BURGLARY

Burglary is defined as the unlawful entry of a structure to commit a felony or theft. The use of force to gain entry is not required as an element for this crime. Burglary is reported under three categories: Forcible Entry, Unlawful Entry - No Force, and Attempted Forcible Entry.

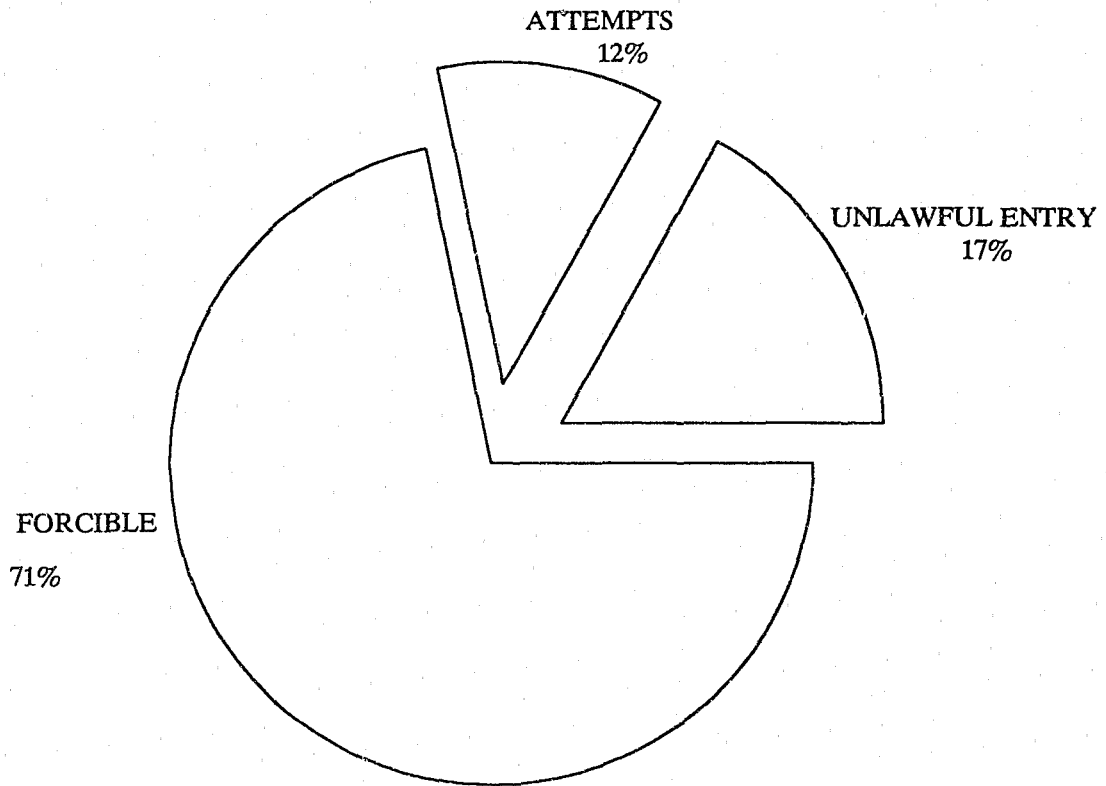

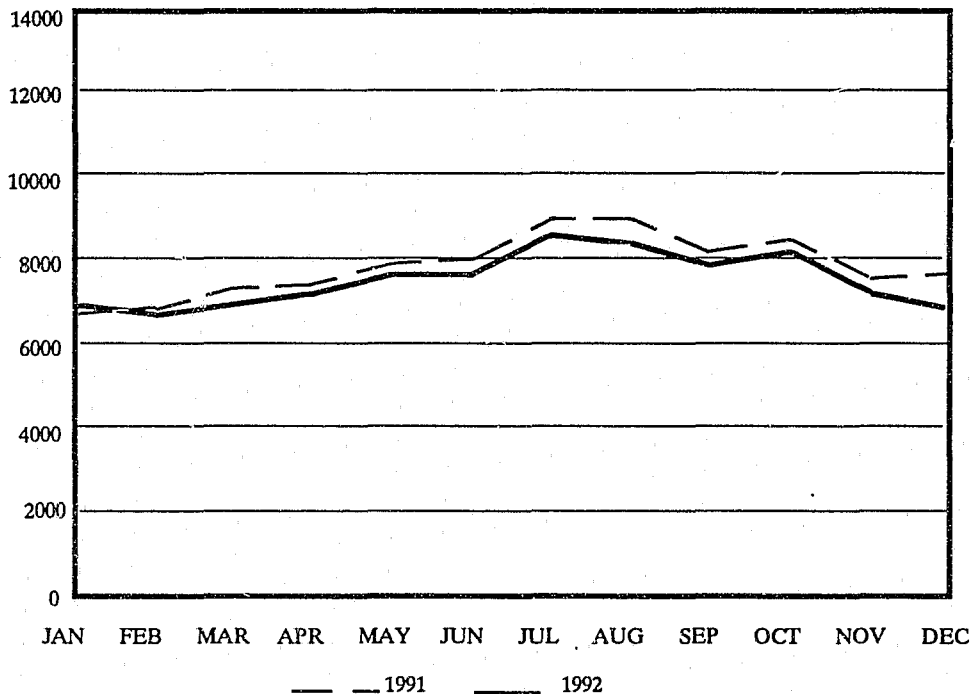
LARCENY

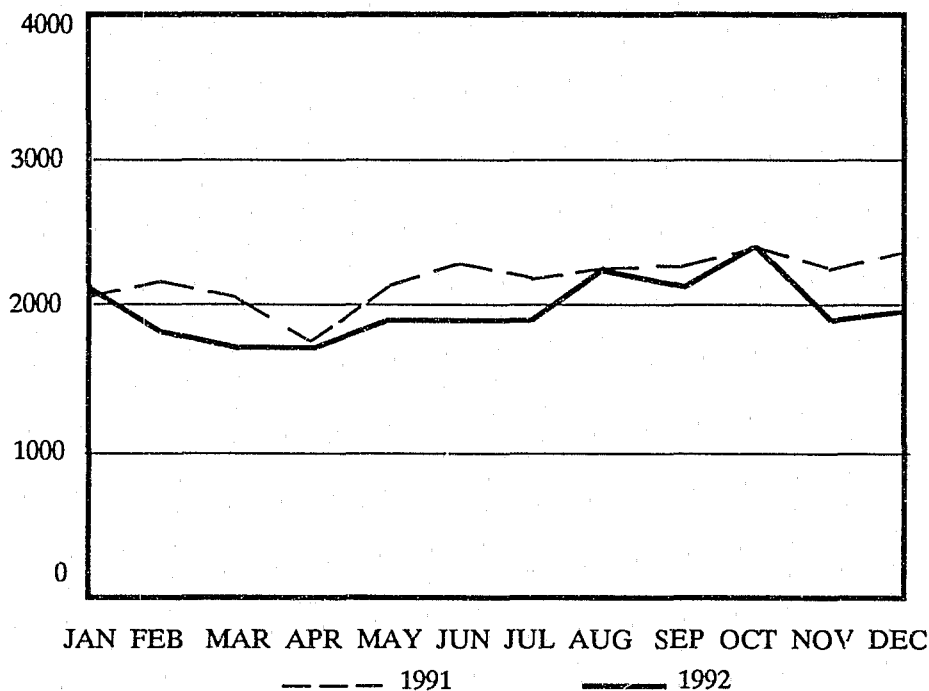

ARSON

Arson is defined by the Uniform Crime Reporting Program to include any willful or malicious burning, or attempt to burn with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc. Only fires determined through investigation to have been willingly or maliciously set are classified as arsons. Fires of suspicious or unknown origin are excluded.

Since Arson offenses frequently occur in conjunction with other Index Crimes; e.g., Burglary, the Hierarchy Rule has been modified specifically for Arson. Arson, regardless of its occurrence in conjunction with another crime against person or property has to be reported.

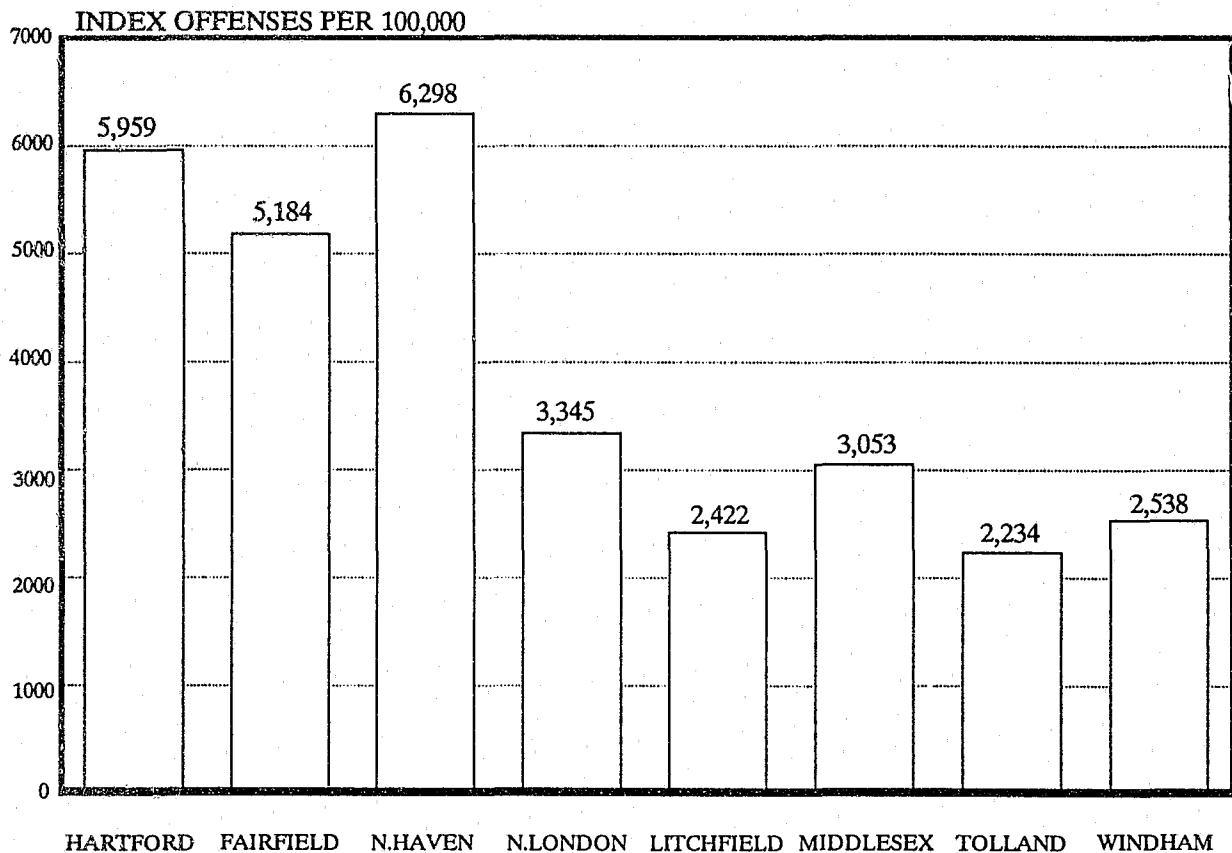

In 1983, Connecticut began compiling County data. Caution must be taken in attempting to make direct comparisons between counties. Many demographic factors including density and size may affect criminal behavior and the reporting thereof.

According to population figures supplied by the F.B.I., Connecticut's eight counties in descending order of population are: Hartford (850,167), Fairfield (826,140), New Haven (802,695), New London (254,529), Litchfield (173,760), Middlesex (142,924), Tolland (128,456), and Windham (102,329).

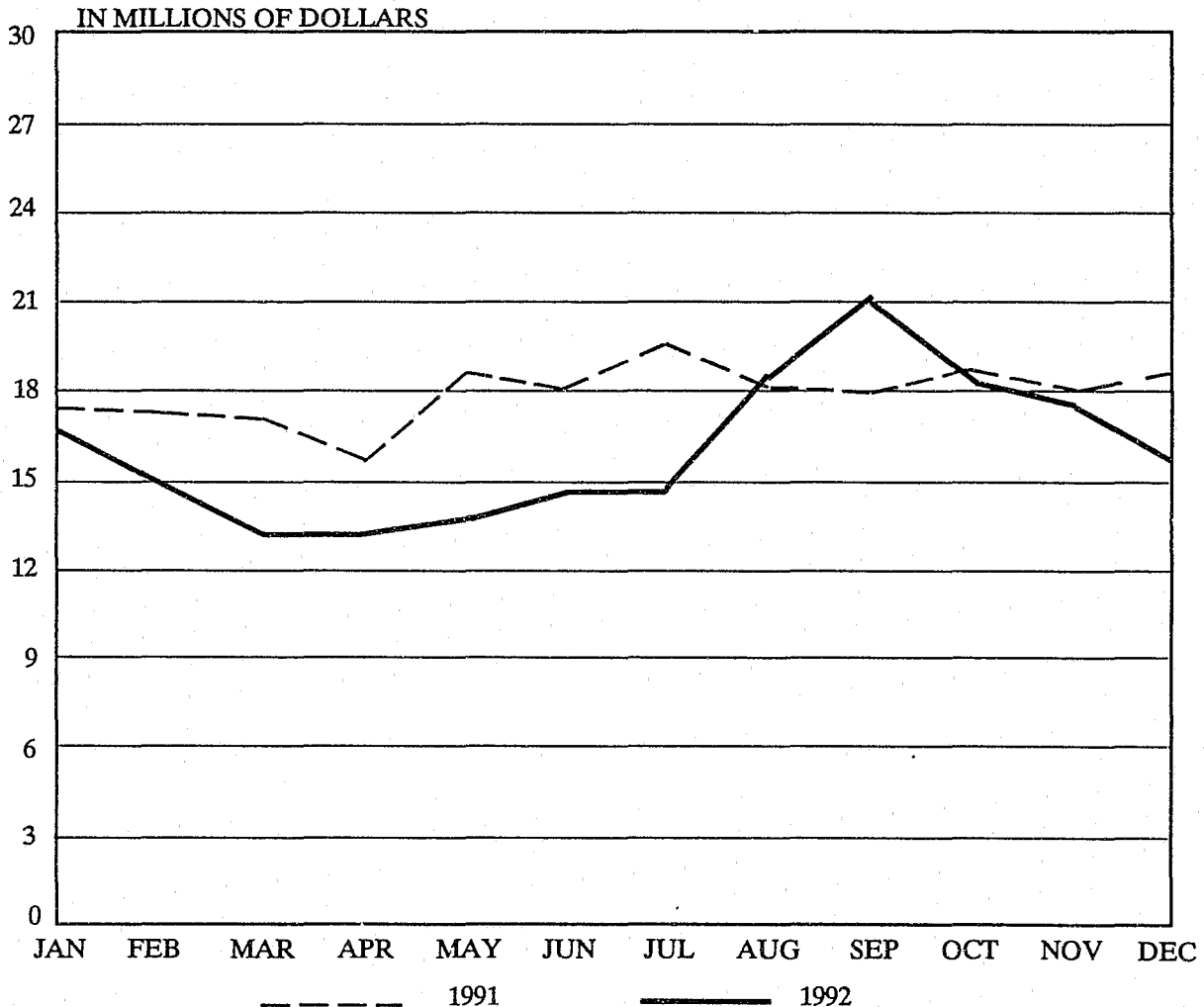
PROPERTY STOLEN AND RECOVERED

For further analysis of crime, the Uniform Crime Reporting Program collects supplementary reports relating to properties stolen and recovered by type and value.

Although Connecticut law enforcement agencies recovered approximately 51% of the property stolen, the net loss was over \$98 million dollars. Property loss, excluding motor vehicles, had a recovery rate of 12.5% which was a net loss of \$66 million dollars.

The reader should take note that these values relate only to Index Crime. Property lost or damaged as a result of crimes such as fraud, vandalism, etc., are not included in these totals.

ARREST DATA

The Connecticut Uniform Crime Reporting Program requires the submission of monthly reports concerning persons arrested in the state. A record of total arrest activity for criminal acts in both Part 1 and Part 2 crime classes is received from UCR participants according to the Age, Sex and Race of persons arrested. Traffic arrests, except driving under the influence, are not reported.

The Age, Sex, and Race of Persons Arrested Forms are designed to collect data on the number of persons arrested and not the number of charges lodged. For example, a person may be arrested on several charges at one time; only one arrest would be scored. For UCR purposes, a juvenile is counted as "arrested" when circumstances are such that if he or she were an adult, an arrest would result.

The Part 2 offenses are as follows:

9. OTHER ASSAULTS - Assaults and attempted assaults which are simple or minor in nature and where no weapon is used.
10. FORGERY AND COUNTERFEITING - Offenses dealing with the making, altering, uttering or possessing, with the intent to defraud, anything false in the semblance of that which is true.
11. FRAUD - Fraudulent conversion and obtaining money or property by false pretense. Includes bad checks, confidence games, etc., except forgeries and counterfeiting.

12. EMBEZZLEMENT - Misappropriation or misapplication of money or property entrusted to one's care, custody, or control.
13. STOLEN PROPERTY; BUYING, RECEIVING, POSSESSING - Offenses of buying, receiving, and possession of stolen property, as well as all attempts to commit any of these offenses.
14. VANDALISM - Willful or malicious destruction, injury, disfigurement or defacement of any public or private property, real or personal, without consent of the owner or person having custody or control. This offense covers a wide range of malicious behavior directed at property.
15. WEAPONS; CARRYING, POSSESSING, ETC. - Violations of regulations or statutes controlling the carrying, using, possessing, furnishing and manufacturing of deadly weapons or silencers. Attempts are included.
16. PROSTITUTION AND COMMERCIALIZED VICE - Sex offenses of a commercialized nature, such as: prostitution, keeping a disorderly house, pandering, and all attempts to commit the above.
17. SEX OFFENSES - (Except Forcible Rape, Prostitution, and Commercialized Vice) offenses against chastity, common decency, morals, and the like. Attempts are included.
18. NARCOTIC DRUG LAWS - Narcotic drug law arrests on the basis of the narcotics used. Includes arrests for violation of State and Local ordinances, specifically those relating to the unlawful possession, sale, use, growing, manufacturing and making of narcotic drugs.
19. GAMBLING - Charges which relate to promoting, permitting or engaging in gambling.
20. OFFENSES AGAINST THE FAMILY AND CHILDREN - Includes all charges of non-support and neglect or abuse of family and children.
21. DRIVING UNDER THE INFLUENCE - Limited to the driving or operating of any vehicle while drunk or under the influence of liquor or narcotic drug.
22. LIQUOR LAWS - With the exception of "Driving Under the Influence", Liquor Law violations, State or Local, are placed in this class. Includes: manufacturing, sale, transporting, furnishing, possessing, etc.

23. DRUNKENNESS - Not reported in Connecticut.
24. DISORDERLY CONDUCT - All charges of breach of peace including affray, unlawful assembly, disturbing the peace, disturbing meetings, refusing to assist an officer, or any attempts of the above.
25. VAGRANCY - Vagabondage, begging, loitering, etc.
26. ALL OTHER OFFENSES - Includes every other State or Local offense (except traffic violations) not included in classes 1 through 25.
27. SUSPICION - Not reported in Connecticut.
28. CURFEW AND LOITERING LAWS (JUVENILE) - Arrests made for violations of local curfew or loitering ordinances.
29. RUNAWAY (JUVENILE) - Apprehensions for protective custody as defined by Connecticut State Statute. Arrests for runaways from one jurisdiction by another agency should be counted by the home jurisdiction.

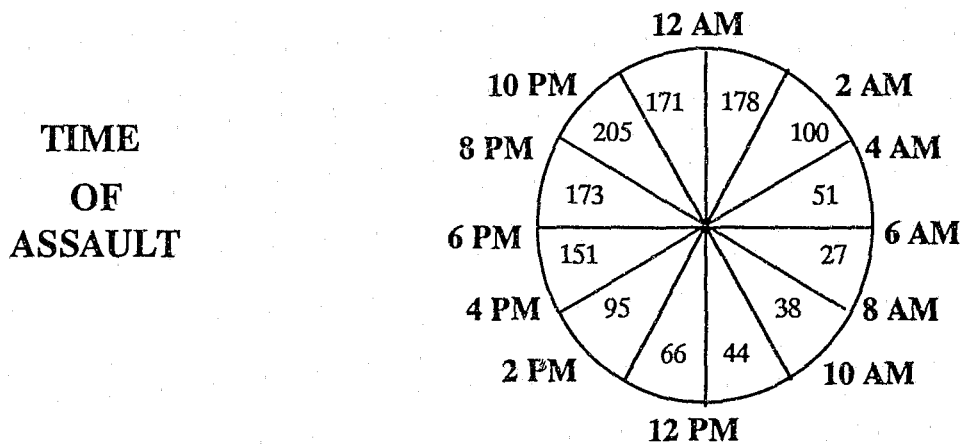

POLICE EMPLOYEE DATA

As of October 31, 1992, 100 agencies covering 3,281,000 Connecticut residents reported a total of 7,151 full-time law enforcement officers. When full-time civilians are included, the total is 8,810 law enforcement employees.

Before making comparisons in police strength from one municipality to another, serious consideration should be given to the many factors that affect the need for police service. For example, the need for law enforcement service in a seasonal or highly mobile community differs from a locale whose population is stable. Other factors that affect police service are geographic location, density of population, nearby urban areas, and community interest in law enforcement.

1992 SUMMARY ANALYSIS

Law enforcement agencies in the state reported a total of 8,810 full-time police employees for 1992.

There were 7,151 sworn police officers employed by law enforcement agencies, 81.2% of the total law enforcement employees.

Full-time civilian employees were reported at 1,659; 18.8% of total law enforcement employees.

94.1% of all full-time law officers were male; 5.9% were female.

68.8% of all full-time civilians were female; 31.2% were male.

Of the 7,151 full-time sworn police officers, 2.8% were employed at Universities, 83.6% were Municipal Officers and 13.6% were State Police.

ANNUAL REPORT**

Statistical Summary

1992 Family Violence Arrest Cases

There were 20,322 incidents of family violence in which at least one person was arrested during 1992. This represents a 6.4% decrease in the number of incidents since 1991.

Nearly nine in ten cases involved an arrest for assault, breach of peace or disorderly conduct. In 40.9% of cases the most serious offense for which an arrest was made was assault. Breach of peace was the most serious offense in 23.2% of cases and disorderly conduct was the most serious offense in 23.0% of cases.

81.9% of victims were female and 86.8% of offenders were male.

For forty-eight percent of victims their relationship to the offender was "live-in" (live together, ever lived together, share a child). Half (48.9%) of "Both Arrestees" were live-ins.

More than half (58.2%) of the participants were between the ages of twenty-one and thirty-five.

Physical force was the most serious weapon used in 71.7% of the incidents.

Incidents in which serious injury occurred declined 3.1% since 1991. Serious injury has declined for six consecutive years.

Prior court orders (either Temporary Restraining or Protective Orders) existed in 18.4% of the incidents in which that history was known.

Liquor/drugs were involved in half (48.8%) of the incidents in which that information was known.

Thirty-five percent of incidents occurred on Sunday (18.1%) or Monday (16.6%).

Forty-four percent of incidents occurred during the six hour period between 6:01 p.m. and midnight.

Children were present or directly involved in 44.9% of incidents. Specifically, children were involved in 11.4% of cases and present in 33.5% of cases.

Definitions

ARREST INCIDENT: An occurrence of family violence in which at least one arrest has been made. One arrest incident is counted for each Family Violence Offense Report submitted; regardless of the number of parties arrested.

BREACH OF PEACE AND DISORDERLY CONDUCT: Crimes of threatening; harassment and reckless endangerment may be reported under either breach of peace or disorderly conduct.

BOTH (ALL) PEOPLE ARRESTED: An individual is assigned the status of BOTH when involved in a family violence incident in which all parties were arrested. Each participant who has been coded as BOTH has committed an offense involving family violence, and therefore cannot be considered a "pure" victim. However, an individual classified as BOTH cannot be classified as a "pure" offender either, since s/he has also been the target of a violent domestic crime. Note that these incidents frequently involve more than two people.

FAMILY OR HOUSEHOLD MEMBERS: Spouses; former spouses; parents and their children; persons eighteen years of age or older related by blood or marriage; persons sixteen years of age or older who are presently residing together or resided together in the past; and persons who share a child in common regardless of their marital status or living arrangement.

FAMILY VIOLENCE: An incident resulting in physical harm; bodily injury or assault; or an act of threatened violence that causes fear of imminent physical harm; bodily injury or assault between or among family or household members. Verbal abuse or argument alone does not constitute family violence. Nor are acts of parents or guardians in disciplining their minor children classified as family violence unless such acts constitute abuse. In order for an offense to be classified as family violence, there must be present danger, the likelihood that physical violence will occur and the relationship between the parties conforms to the definition of "Family or Household Members."

FAMILY VIOLENCE CRIME: A crime as defined in section 53a-24 of the Connecticut General Statutes which contains as an element an act of violence directed at a family or household member.

HIERARCHY OF OFFENSES: Although multiple offenses are frequently reported, particularly for multiple arrest incidents, only one offense code is accepted into the computer system. When there are multiple offenses, the offense code highest in the following list is accepted: homicide; assault; kidnapping; sexual assault; criminal mischief; risk of injury to a minor; breach of peace; disorderly conduct; and other.

INJURY: A serious injury is a physical injury which creates a substantial risk of death; or which causes serious disfigurement; serious impairment of health or serious loss or impairment of the function of any bodily organ. A minor injury means impairment of physical condition or pain. Non-physical injuries include threats and attempts to cause harm.

LIVE-IN: Persons presently residing together or who have resided together in the past; and persons who share a child in common.

"OTHER" CRIME: Offenses included under the classification of "Other" include all family violence crimes which are not covered by the offense types listed. "Other" crimes include, but are not limited to: robbery; burglary; arson; and criminal trespass.

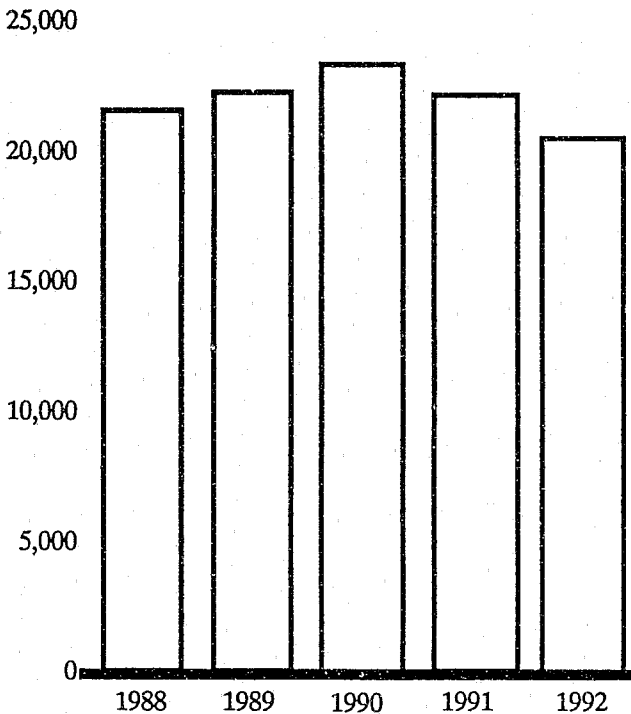
RELATIVE (SAME/OTHER HOME): Includes parents and children; brothers; sisters; aunts; uncles; in-laws; cousins; etcetera.

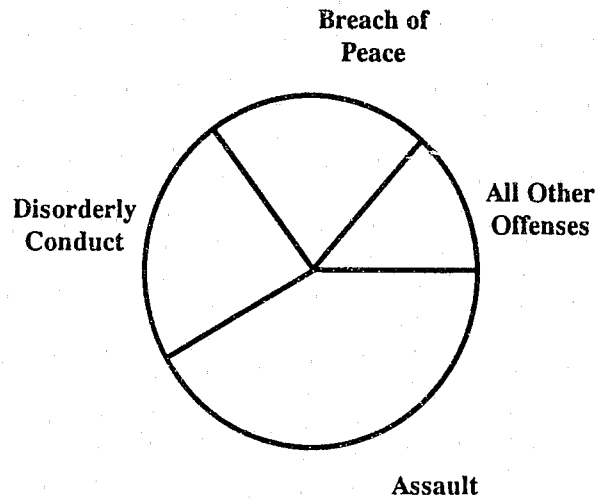

Arrests by Most Frequent Offense



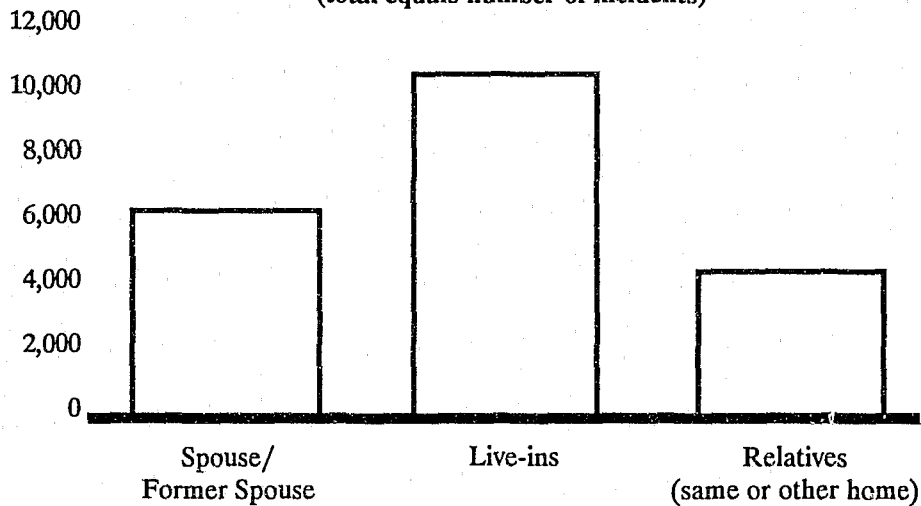

Relationship of Participants (Victim to Offender and Both Arrestees to Each Other)

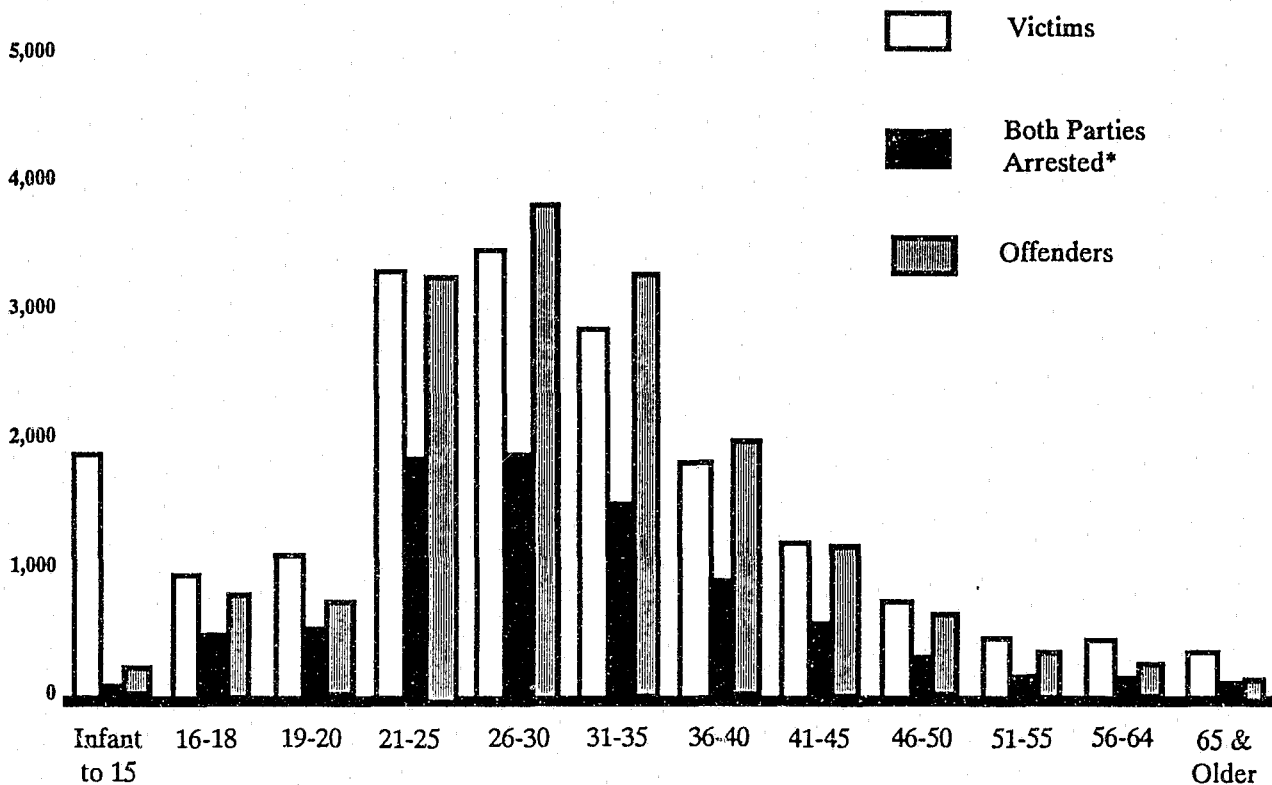

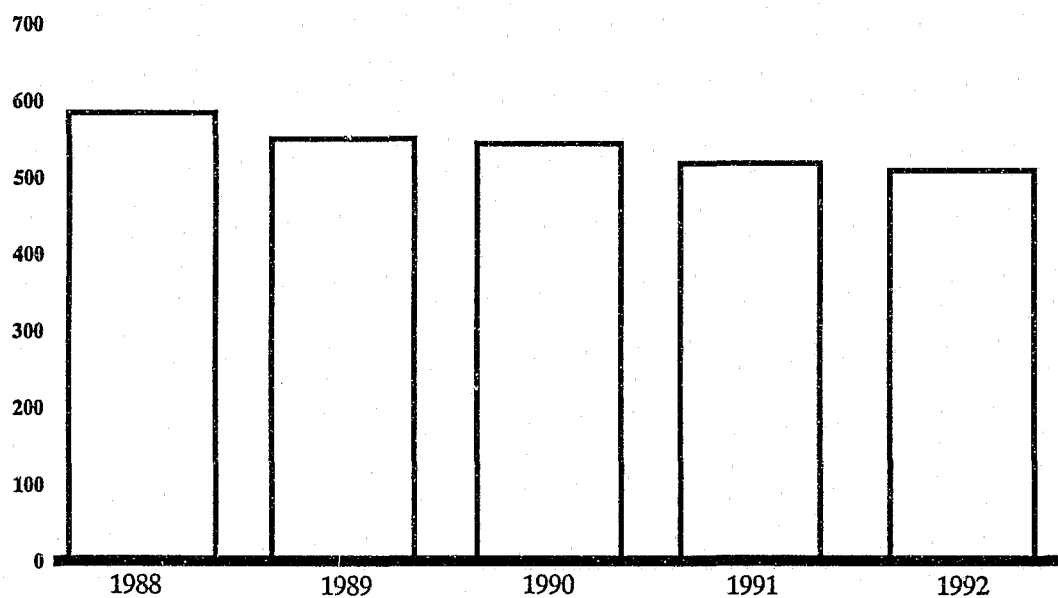

Serious Injury 1988-1992



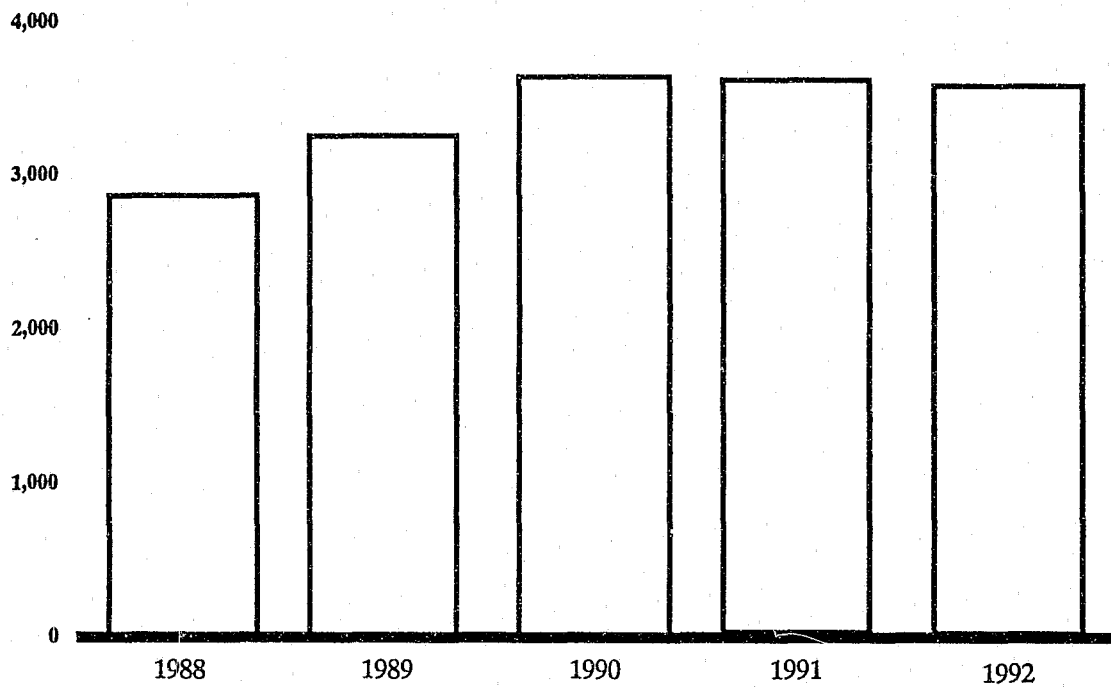

Cases with Prior Court Orders

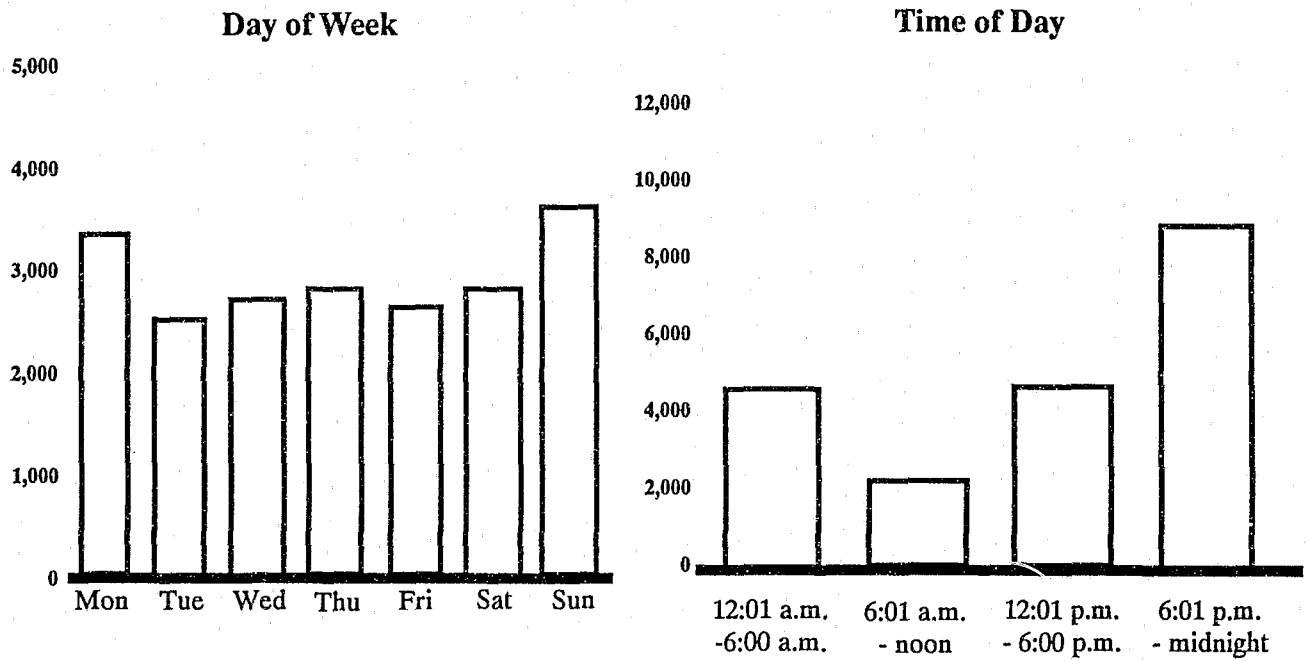

Family Violence Homicide

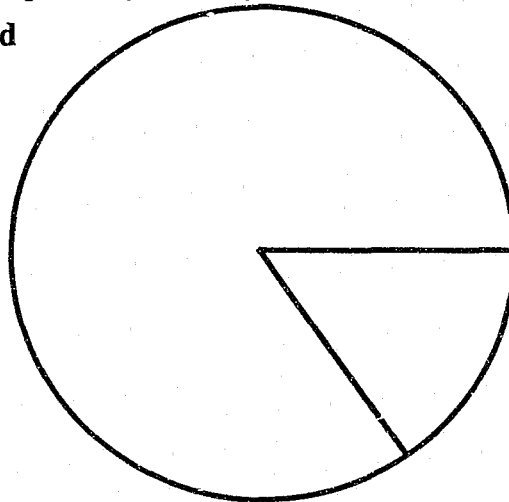
Introduction

The following summarizes cases of family violence homicide which occurred during 1992. Homicides were chosen for rigorous analysis because the small number of incidents allow examination of each piece of descriptive information available concerning the act and the parties involved. Such close scrutiny would not be possible for other types of family violence offenses such as assault due to the great number of offenses and the character of data available.

Family violence homicides for this portion of the report include both the arrest incidents discussed earlier and incidents during which the offender committed suicide ("murder-suicide"). Information on arrest cases was taken from Family Violence Offense Reports submitted to the Family Violence Reporting Program and verified as homicides through the reporting agency and/or the Uniform Crime Reporting Program (UCR). Murder-suicide information was taken from UCR records.

There were twenty-four homicides committed during 1992 which were verified as conforming to the definition of "Family or Household Member" as set forth in the Connecticut General Statutes (Title 46b, Section 38a(2)).* This represents an increase in family violence homicides of 14.3% from the number committed during 1991. Of the 168 homicides reported to UCR during 1992, twenty-four (14.3%) were verified as conforming to Connecticut's definition of family violence. In the previous year, family violence homicides made up 11.2% of homicides reported to UCR.

Of the twenty-four family or household members who were victims, eighteen were female. Fifty percent of the victims were relatives (parents, children, grandparents, etc.), thirty-three percent lived with, formerly lived with or had a child in common with the offender, and seventeen percent were spouses of the offender.

Nineteen of the twenty-four offenders were male. Females accounted for five (20.8%) of the family violence homicide offenders while, overall, females accounted for 5.6% of all the homicides reported during 1992 for which the sex of the offender was known (information taken from UCR reports). There were ten homicides reported statewide which were known to have been committed by females-- five of those homicides were identified as family violence. Guns or knives were used 83.3% of the family violence homicides.

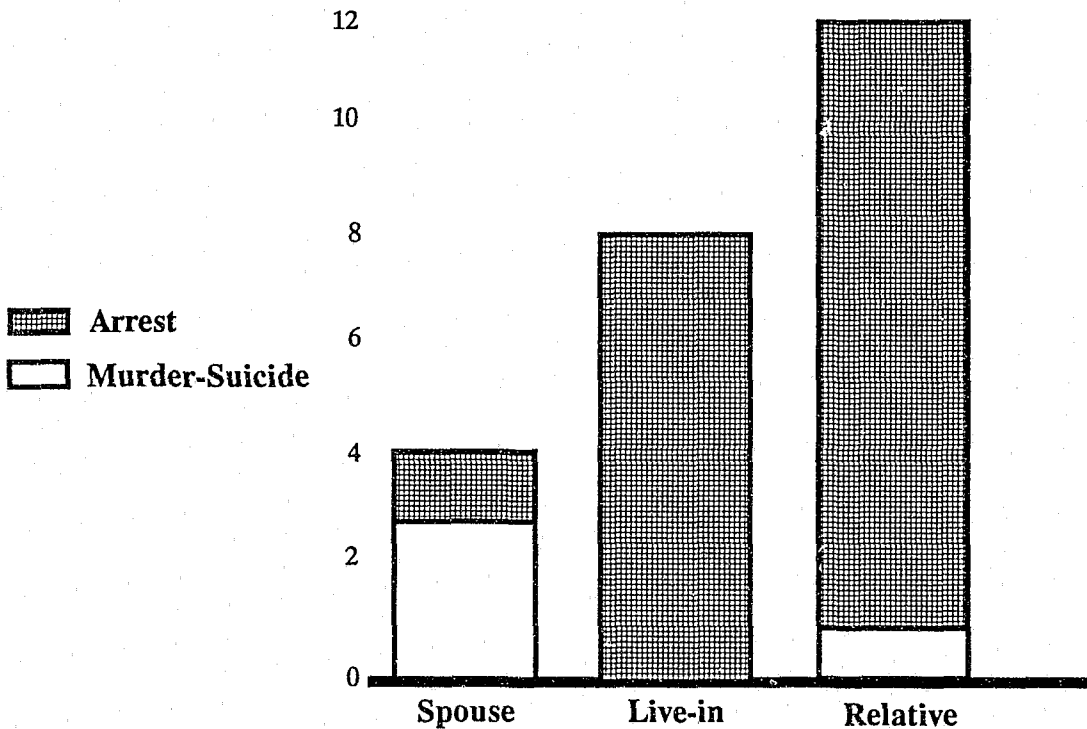
* Note that while the total number of UCR homicides includes offenses which may have occurred in prior years and were not reported until 1992, the incidents identified as family violence only include offenses committed during 1992. Also, the definition of "Family or Household Member" can be found in the definitions at the beginning of the family violence section.

Murder-Suicide

In four of the homicides the offender committed suicide. One of the four offenders were previously arrested for family violence.* None of the other three offenders had been previously arrested for family violence in Connecticut. All four of the victims were female and all four of the offenders were male. Three of the four victims were the spouse of the offender and one victim was the relative of the offender. Guns were used as the murder weapon in two incidents, a knife was used in one incident and an other dangerous weapon was used in the fourth murder-suicide.

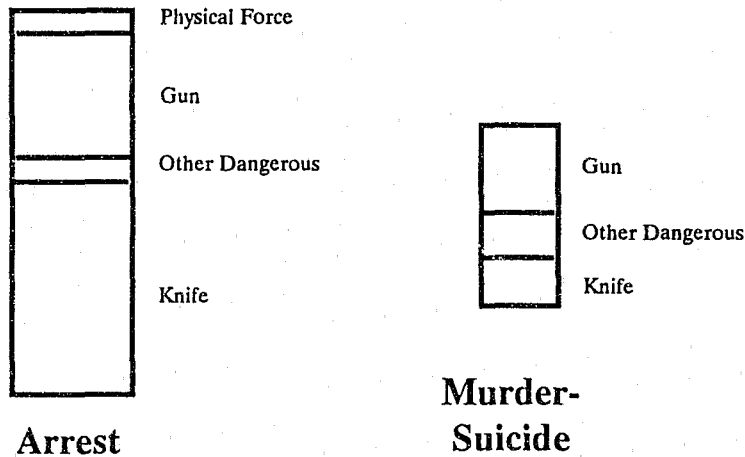

Arrest

During 1992, there were twenty homicides for which a family or household member was arrested. Fourteen victims were female and six were male. Eleven of the victims were relatives, eight were live-ins and one was the spouse of the offender.

Murder Weapon



Fifteen of the twenty offenders were male and five were female. Eleven offenders used knives, one used other dangerous weapons, six used guns and two used physical force.

Prior court orders (Temporary Restraining or Protective Orders) had not been issued in any of the nine incidents for which that information is known.

Four children were involved as victims and children were present as witnesses in three of the remaining twenty homicides for which that information is known.

Liquor/drugs were involved in seven of the eleven incidents for which that information is known.

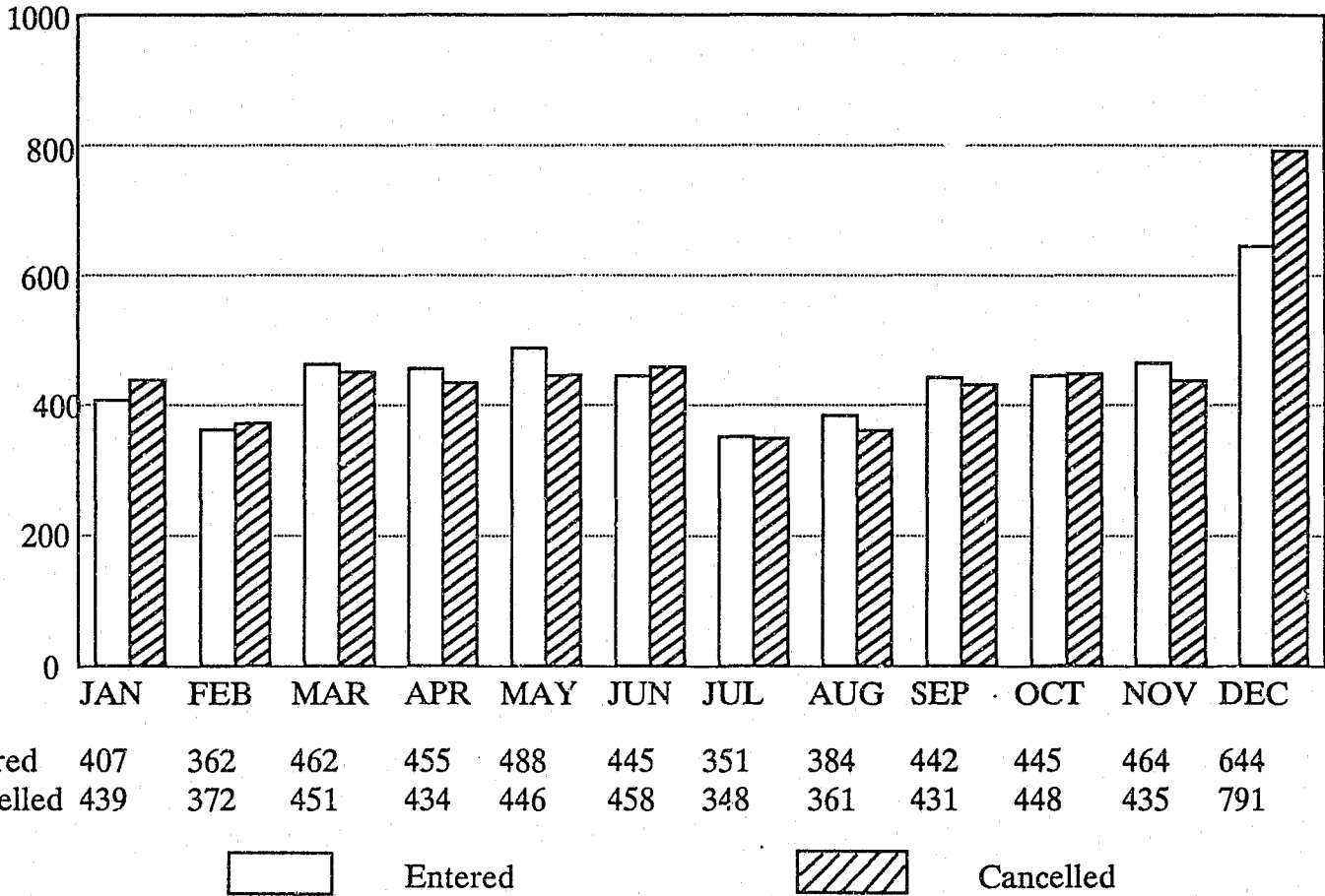

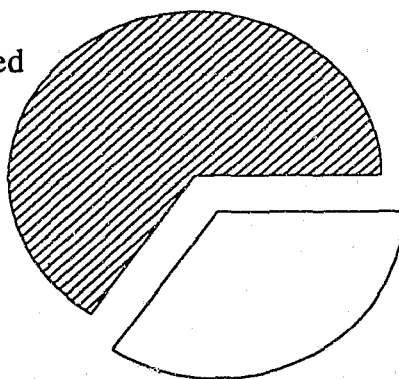

TOTAL REPORTS ENTERED

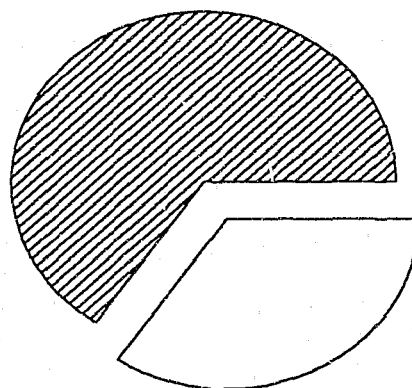

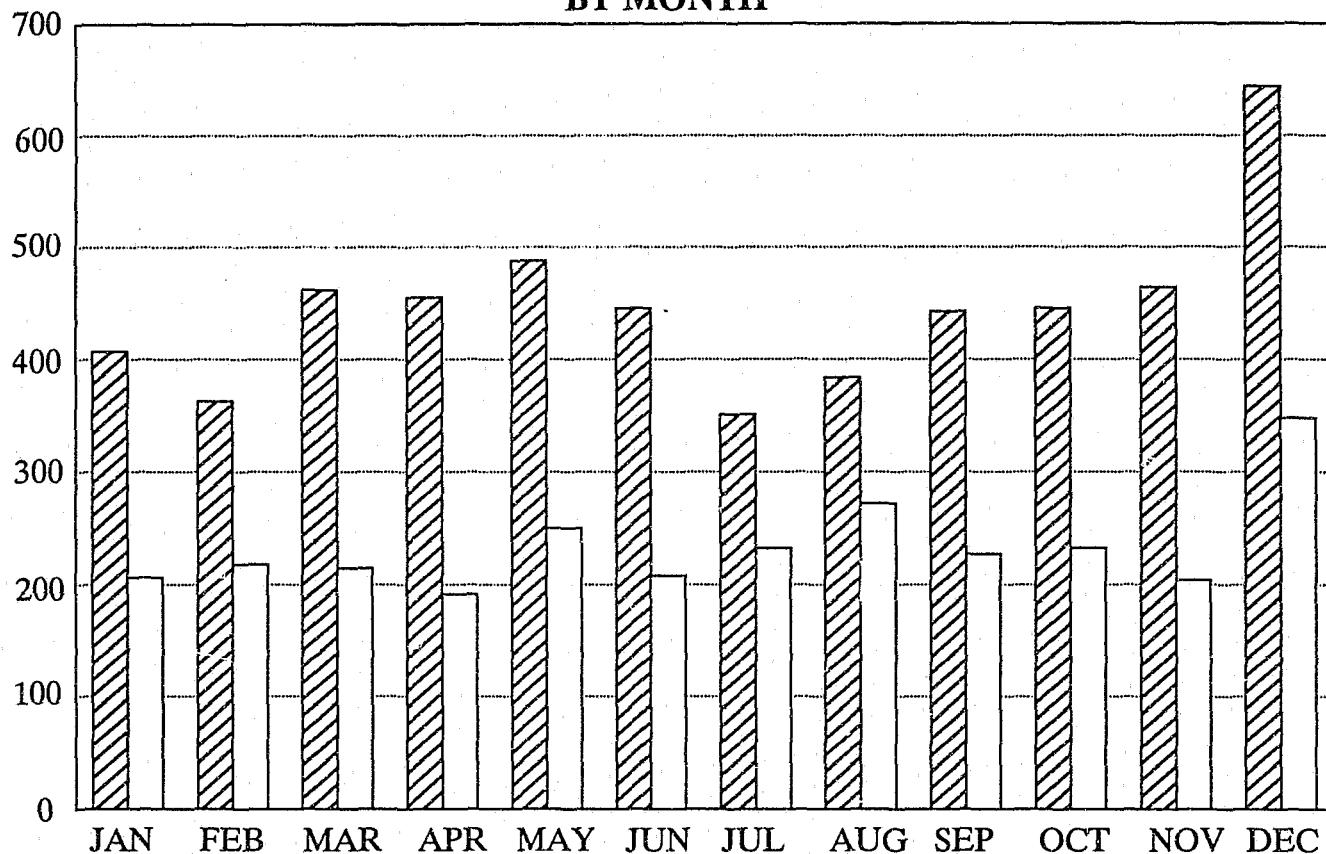
TOTAL REPORTS CANCELLED
