Control Release Authority Decisions for Habitual Offenders:

A Pilot Simulation

INTRODUCTION

This report documents a pilot test of early prison release decisions the Control Release Authority (CRA) would make if certain types of Habitual Offenders were statutorily eligible for early release. The significant increase in the number of offenders in Florida statutorily declared as Habitual Offenders under FS:775.084 (1) (a) and (b) is well documented. The number of scarce prison beds required to house habitual offenders is increasing dramatically due to the following reasons. First, the number of new habituals entering prison continues to increase. Second, habitual offenders receive significantly longer sentences than non-habituals. Third, early release through the Control Release Authority is statutorily denied. Fourth, only Incentive Gaintime reduces a habitual's sentence, resulting in an average percentage of sentence served of 75%. The current forecast indicate that the habitual offender population will increase to 24,000 inmates by FY96-97 if existing policy and practices continue.

The study presented here was conducted to determine the number of habitual offenders the Control Release Authority would release early from prison if statutory authority to do so existed. The analysis will indicate the number of habituals selected for early release and the offense and prior criminal record of these cases. The criteria for selecting 201 habitual offenders sentenced to prison and the Control Release Authority process is detailed in Appendix A. Additionally, Appendix B contains detailed information about twelve habitual offenders designated for early release.

FINDINGS

Table 1 displays the final results of the Control Release Authority's (CRA) release decision and the results of the salient factor scoring recommendations. The figures reveal that:

Of the 201 habitual offenders reviewed by the CRA, 100 (49.8%) would have been released early through the CRA.

- The objective scoring results using the eight salient factors recommended early release for 89 of the 201 (44.3%) of the habituals.
- There were 15 or 7.5% of the habituals in which the scoring instrument recommended early release but the CRA denied early release.
- Early release was granted over the recommendation of the scoring results in 26 cases, (12.9%).

Table 2 describes those habitual offenders designated for early release by the CRA (n=100). The significant findings from these data include:

- 1. Drug offenders account for 43.0% of the 100 habitual offenders.
- 2. Property offenders made up 53.0% of the early release habituals.
- 3. Third degree felons made up 41.0% of the habituals.
- 4. One in four (27.0%), of the habituals determined to be appropriate for early release were third degree property offenders.
- 5. 75 of the habituals had no prior violent convictions.

Table 3 displays the results of the salient factor scoring procedure for the entire sample of 201 habitual offenders. These statistics indicate the following about these offenders:

- 1. 120 (59.7%) of the offenders had four or more prior convictions.
- 2. 104 (51.7%) had no prior convictions for violent crimes.
- 3. Most habituals were 18 to 25 years of age when they committed the first offense resulting in incarceration.
- 4. 69.7% of the offenders had one or more prior revocations.
- 5. The vast majority (88.1%) had no prior escapes.

CONCLUSION

This analysis of the early release decisions the Control Release Authority would have made on 201 habitual offenders if given the statutory authority to do so suggests that one-half would have been released early. Those offenders determined to be suitable risks for early release were likely to be third degree offenders without extensive prior criminal records and have a low probability of having violence in their past.

Based on the sample examined, 19.0% of the habitual offenders currently entering prison would be designated for early release by the Control Release Authority. The Department projects that 3,770 habituals will be sentenced to prison in FY1992-93. If Control Release Review were possible, 716 of these habituals would have advanceable release dates.

APPENDIX A

METHODOLOGY

The following selection criteria were used to randomly sample from all offenders sentenced to prison under the habitual offender statute:

1. Admitted to prison from January 1, 1991 to June 30, 1991.
2. Primary offense not in guidelines categories 1 to 4.
3. Habitualization as the only reason for Control Release ineligibility.
4. Prior record information was contained in the inmate file.

During the period January 1, 1991 to June 30, 1991, 1,436 habitual offenders entered prison. Of this total, 549 (38.2%) could have been selected for inclusion in this study. The final random sample of 201 cases was therefore a 36.3% sample.

Staff of the Control Release Authority scored the 201 cases selected in the same manner that statutorily eligible offenders are currently scored. The following Salient Factor indicators were scored:

1. Number of Prior Criminal Convictions
2. Number of Prior Violent Convictions
3. Number of Prior Incarcerations
4. Total Prior Sentences in Years
5. Age at Time of Offense Which Led to the First Incarceration
6. Number of Revocations
7. Number of Prior Escape Convictions
8. Burglary or Breaking and Entering as the Present Offense of Conviction

The scores of all the salient factors were summed to derive a total salient factor score. The salient factor score, statutory seriousness of the primary offense, and whether the primary offense was violent, property, or drug related were used to place the offender in the "Control Release Matrix Grid". This grid determines if this objective scoring exercise designates an offender as eligible or ineligible for early release.

The objective portion of the control release process was followed by a Parole Commissioner evaluating the case and making the final decision.
