INTRODUCTION

The purpose of the 1991 U.S. Marine Corps Crime Statistics Annual Report is to consolidate the crime statistics reported by individual installations as required by MCO 1630.4A.

Direct comparisons between installations should be avoided because of many and varied factors such as population density, culture, geography, income spreads, number of law enforcement personnel, etc., affect the statistics. Additionally, an increase in the crime rate aboard an installation does not necessarily reflect a specific crime problem. All factors should be reviewed carefully when faced with what appears to be a substantial increase or decrease in crime, but may actually be the result of a concentrated enforcement effort, better reporting or some other factor such as extremely small sample in some statistical categories.

This report addresses the issue of the safety of persons and property aboard Marine Corps installations. Crimes committed by Marines on the installations of other services, and in the civilian community are not included. Information on numbers, rates and trends of courts martial convictions of Marines are available from the Judge Advocate General of the Navy (Code 40), DSN 288-7449.

Installation Commanders are guided in their crime prevention programs by MCO 5500.18 and OPNAVINST 5530.14B. Although crime prevention problems are sometimes unique to the given installation, this report may be used to assist commanders in identifying crime trends and implementing crime prevention measures which address the specific criminal activity prevalent on a given installation.

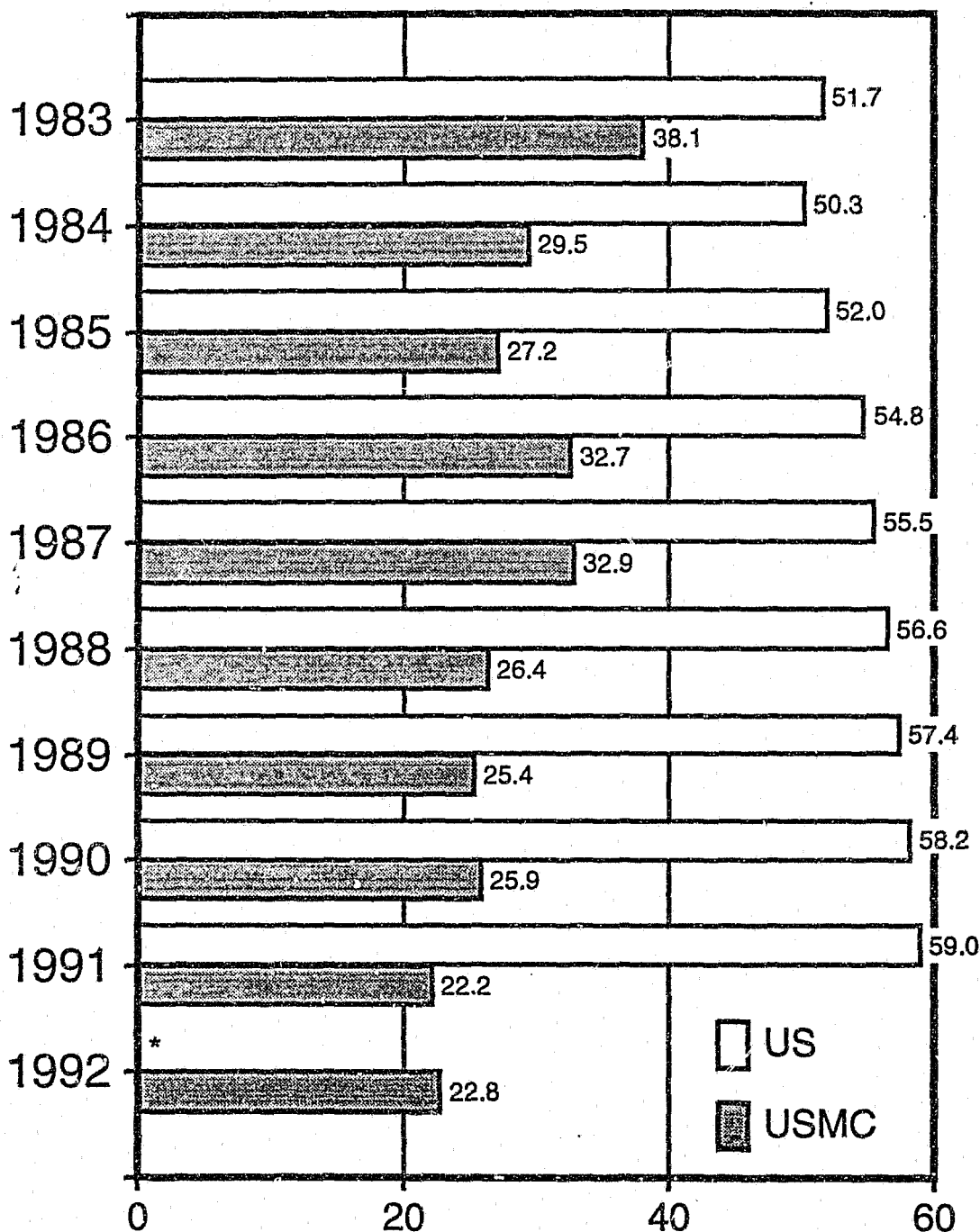

For the purpose of this report, an installation's population is defined in Section VIII of enclosure (3) to MCO 1630.4. Included are all military permanent personnel assigned (including those TAD) to a base in excess of 30 days, all dependents residing in base housing, and all civilian employees (appropriated, non-appropriated and non-government) aboard the installation.

INDEX CRIMES

Section 1 reports the seven index crimes, which include on-base homicide, rape, robbery, aggravated assault, burglary/housebreaking, larceny, and motor vehicle theft. Unique to this section is a chart reflecting the index crime rate per 1,000 people for the U.S. Marine Corps and the United States as a nation over the past ten years. The national crime rate is shown as presented in the FBI's Uniform Crime Report (UCR), which uses the same seven index crimes as the Marine Corps reports.

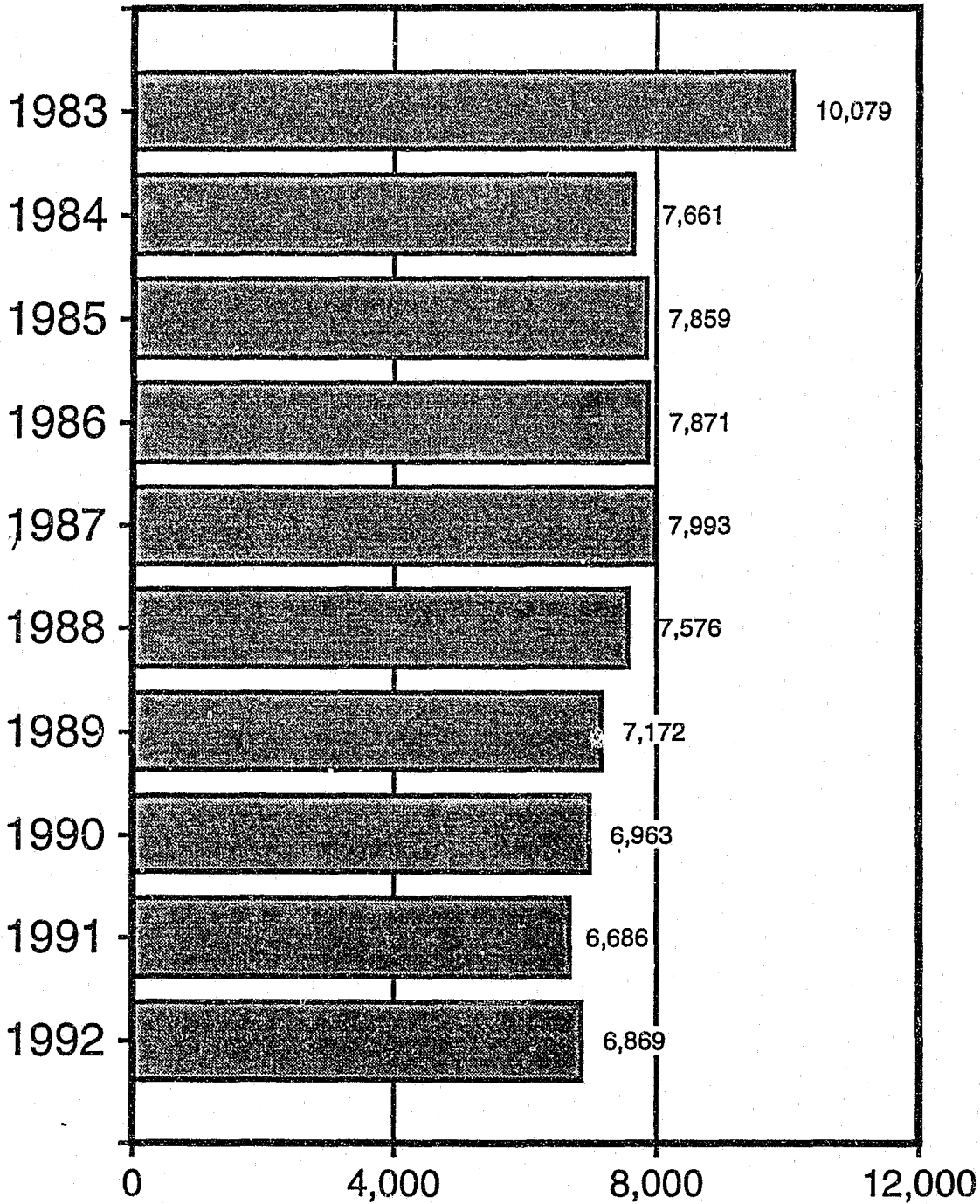
INDEX CRIME RATE DURING THE LAST TEN YEARS US vs USMC



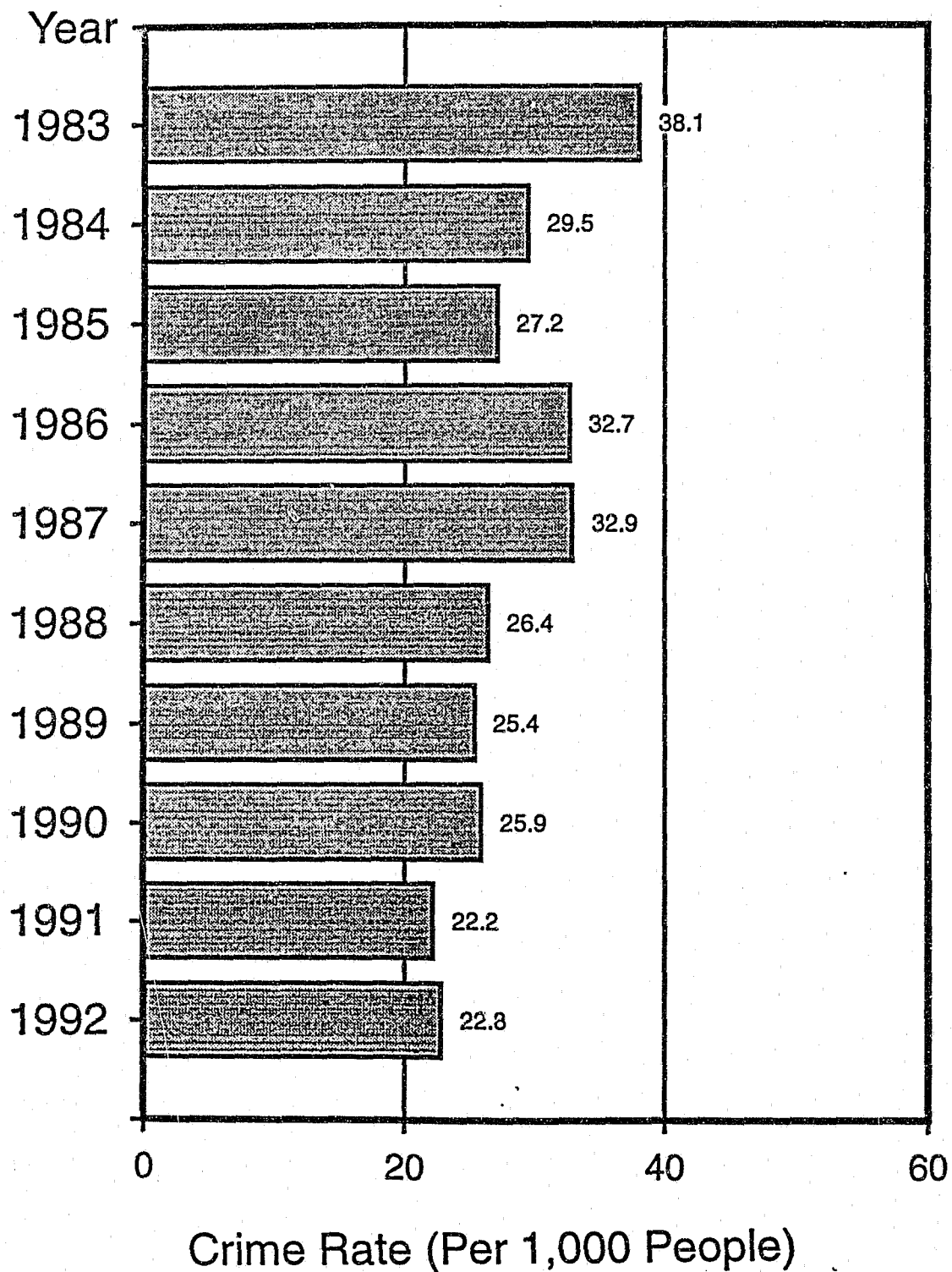

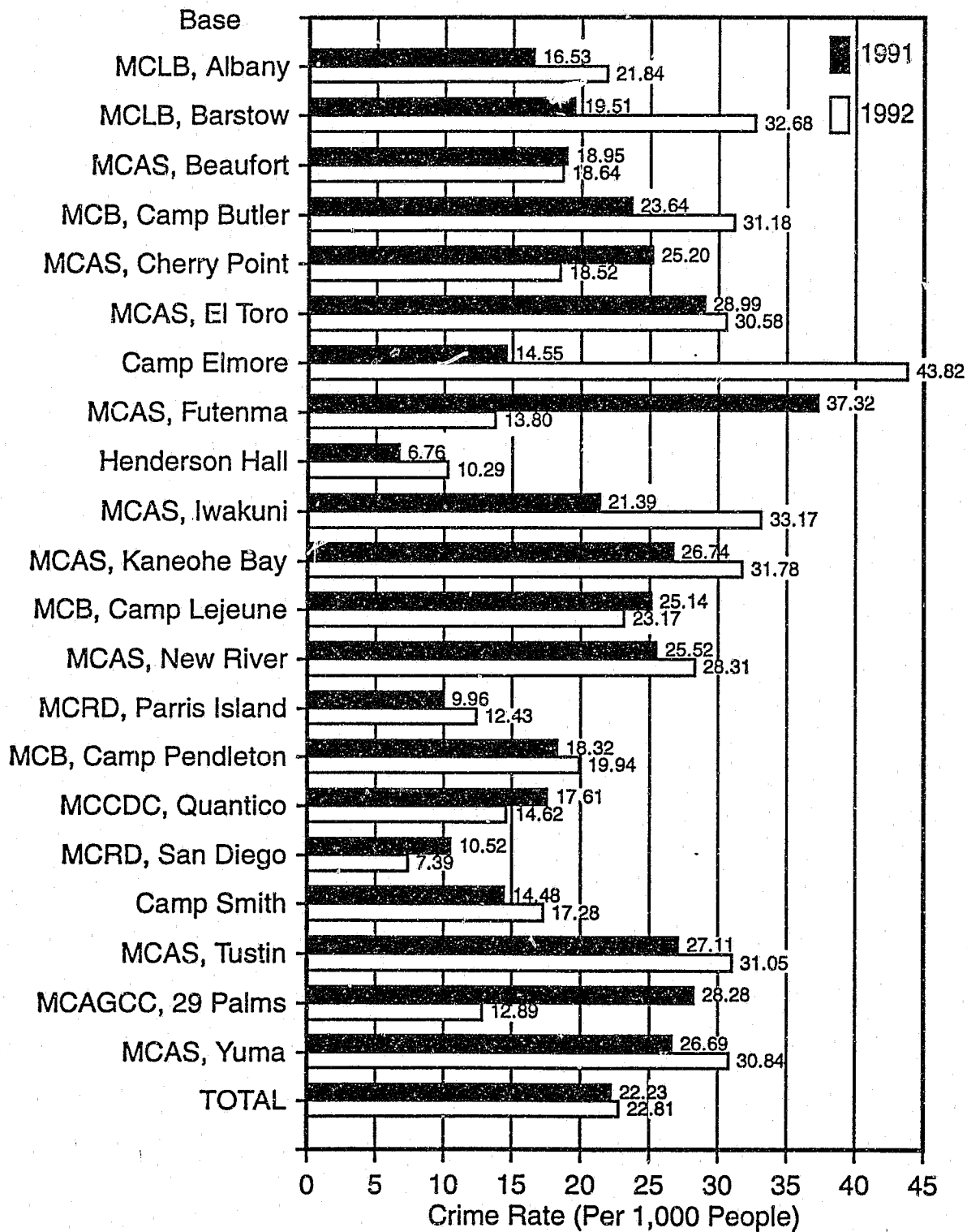

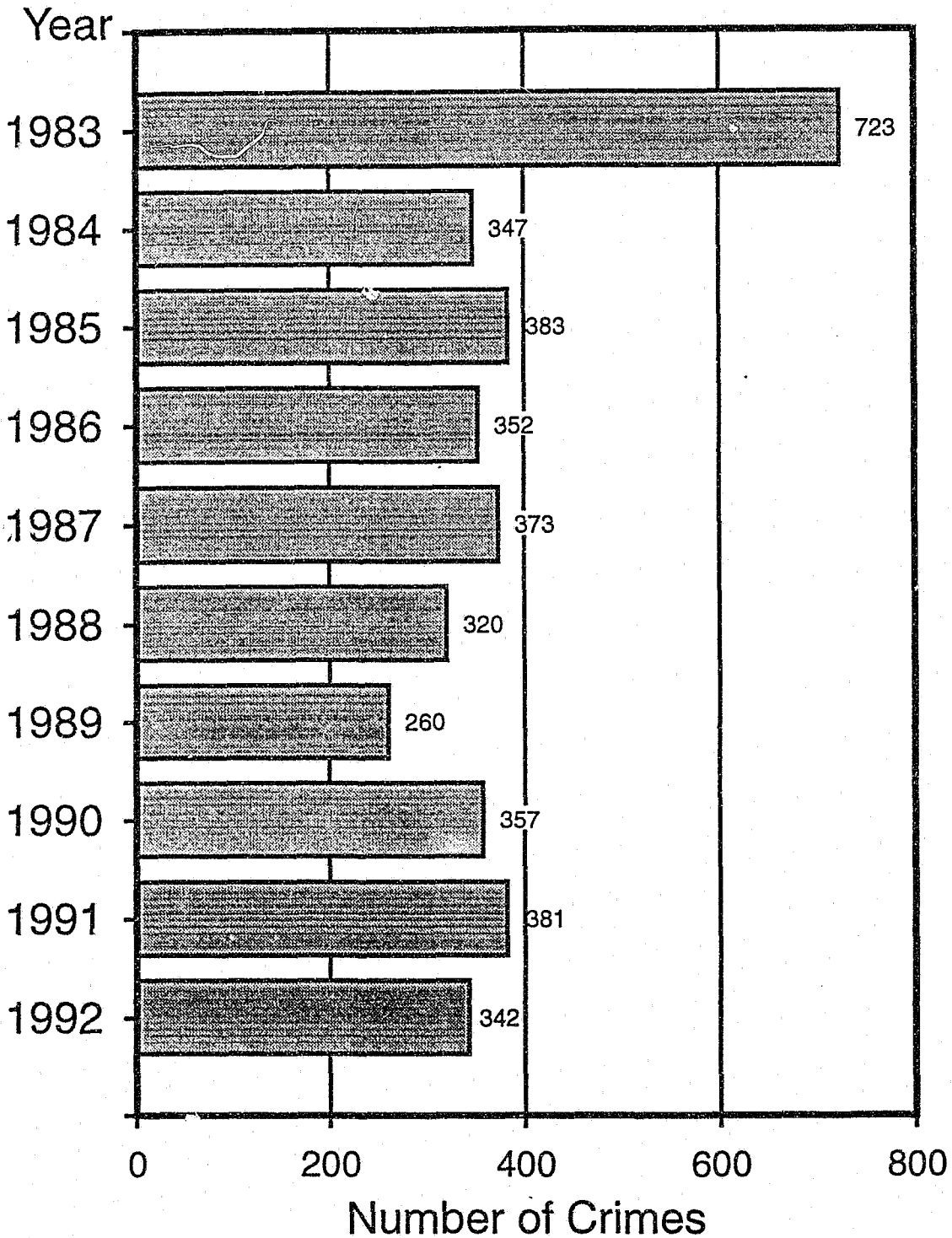
INDEX CRIME RATE BY BASE (PER 1,000) CALENDAR YEAR 1991 vs 1992



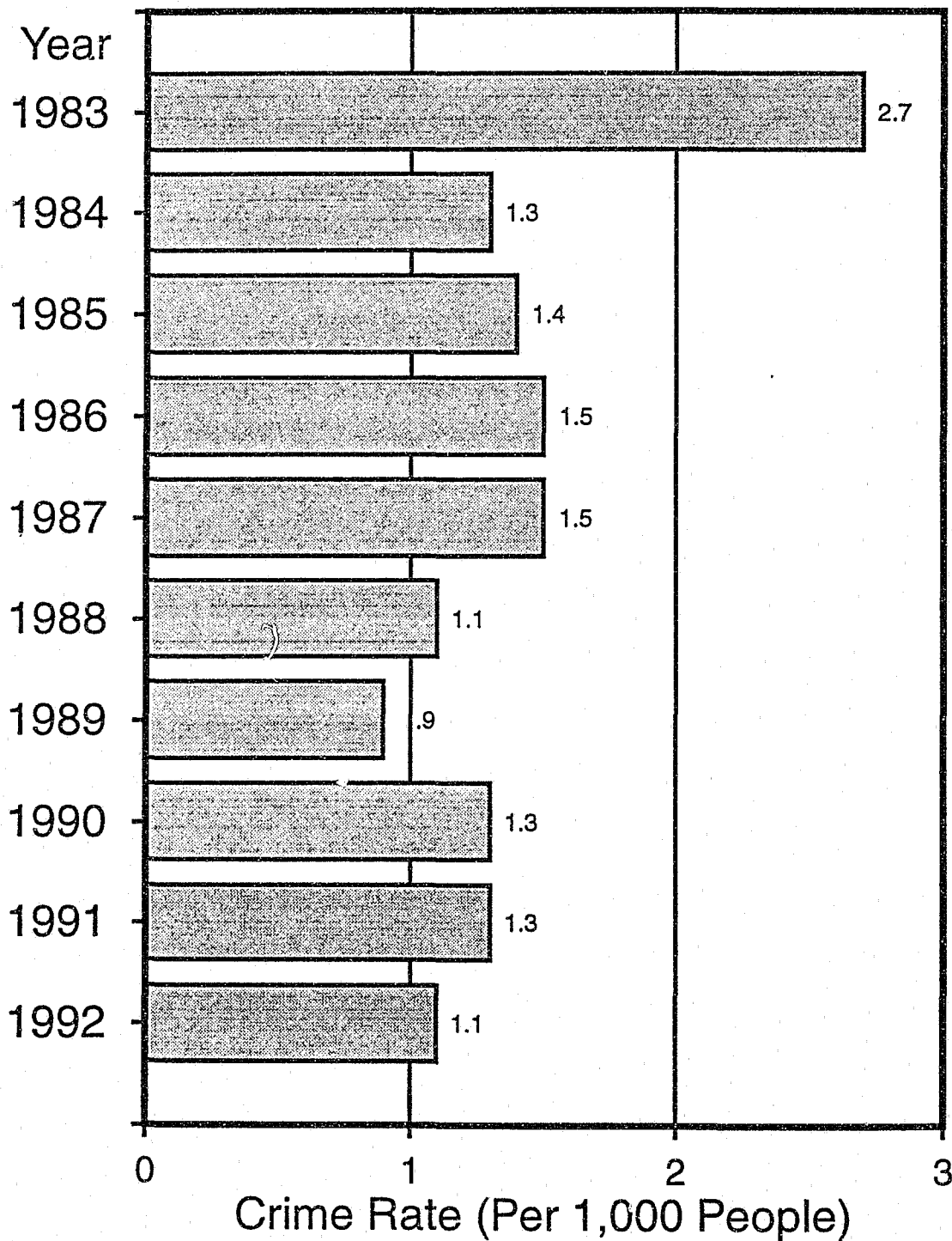
VIOLENT CRIMES

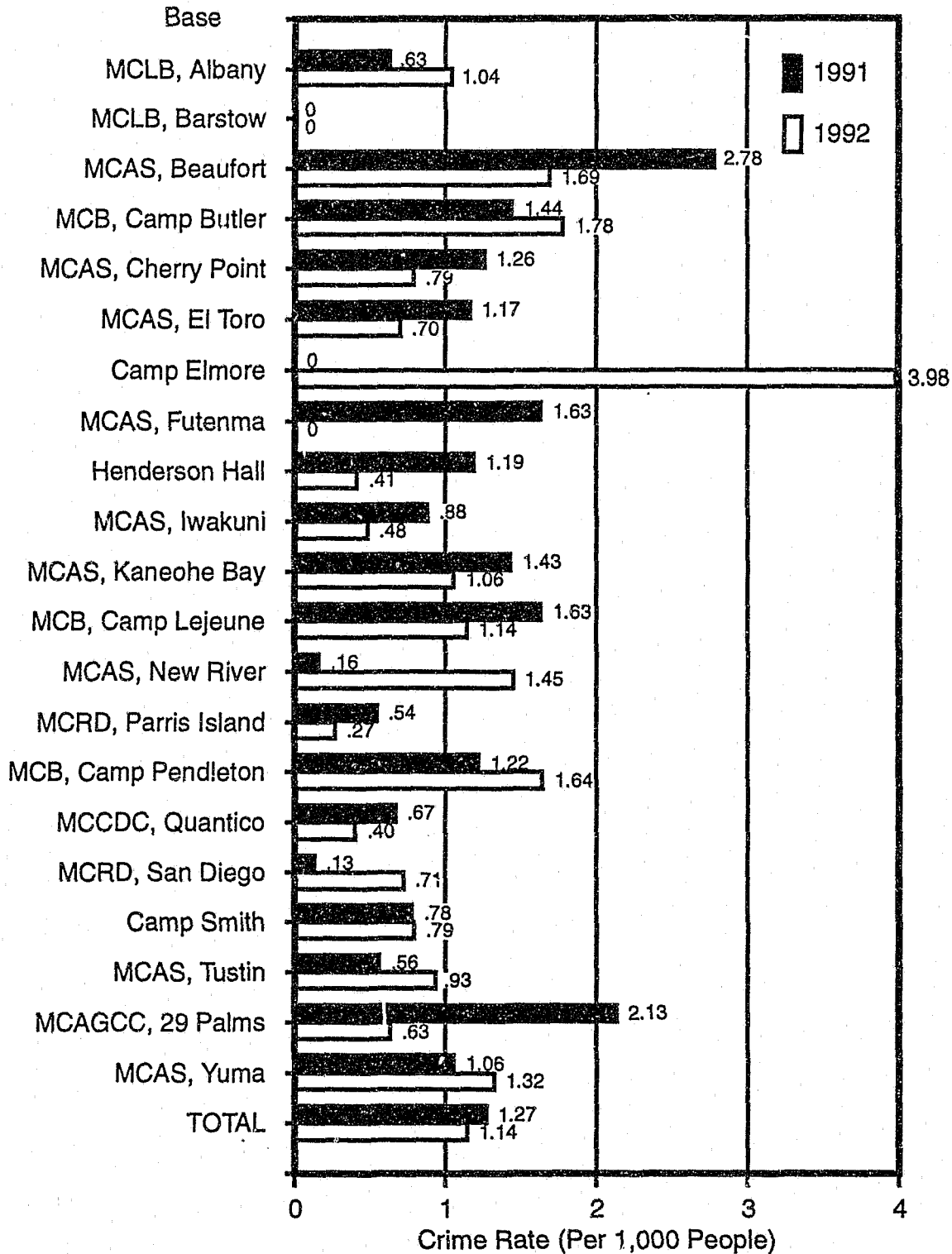

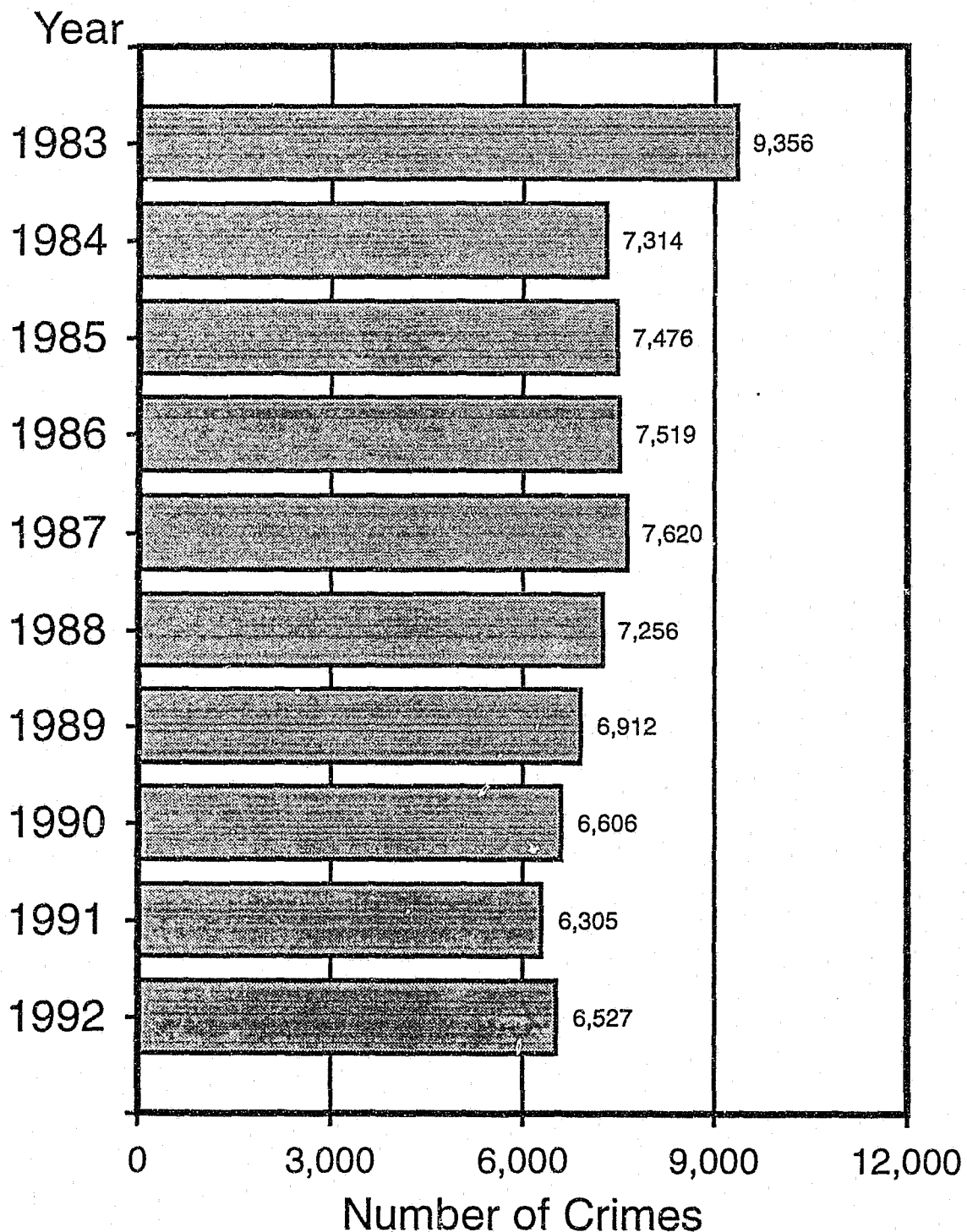

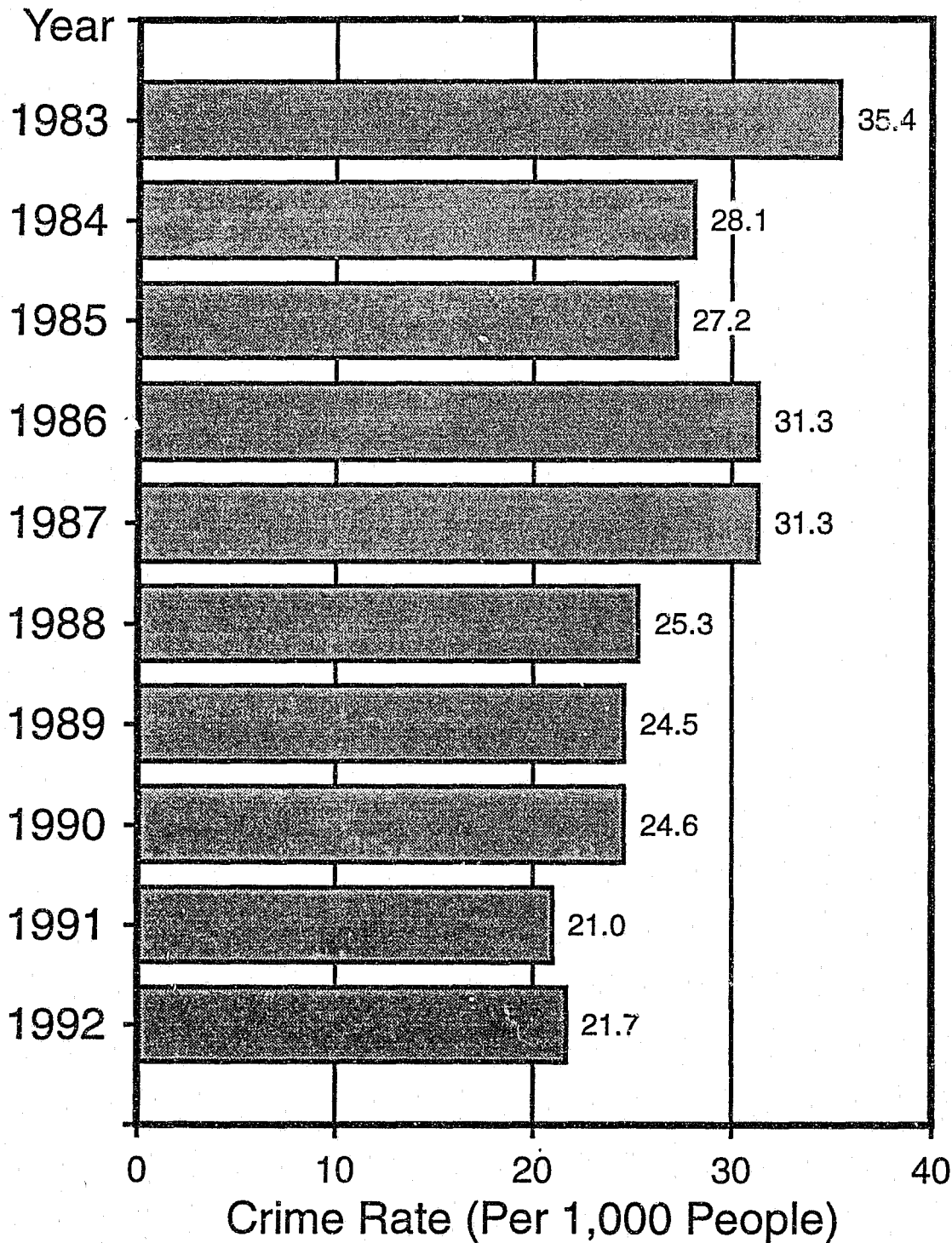
CRIMES AGAINST PROPERTY

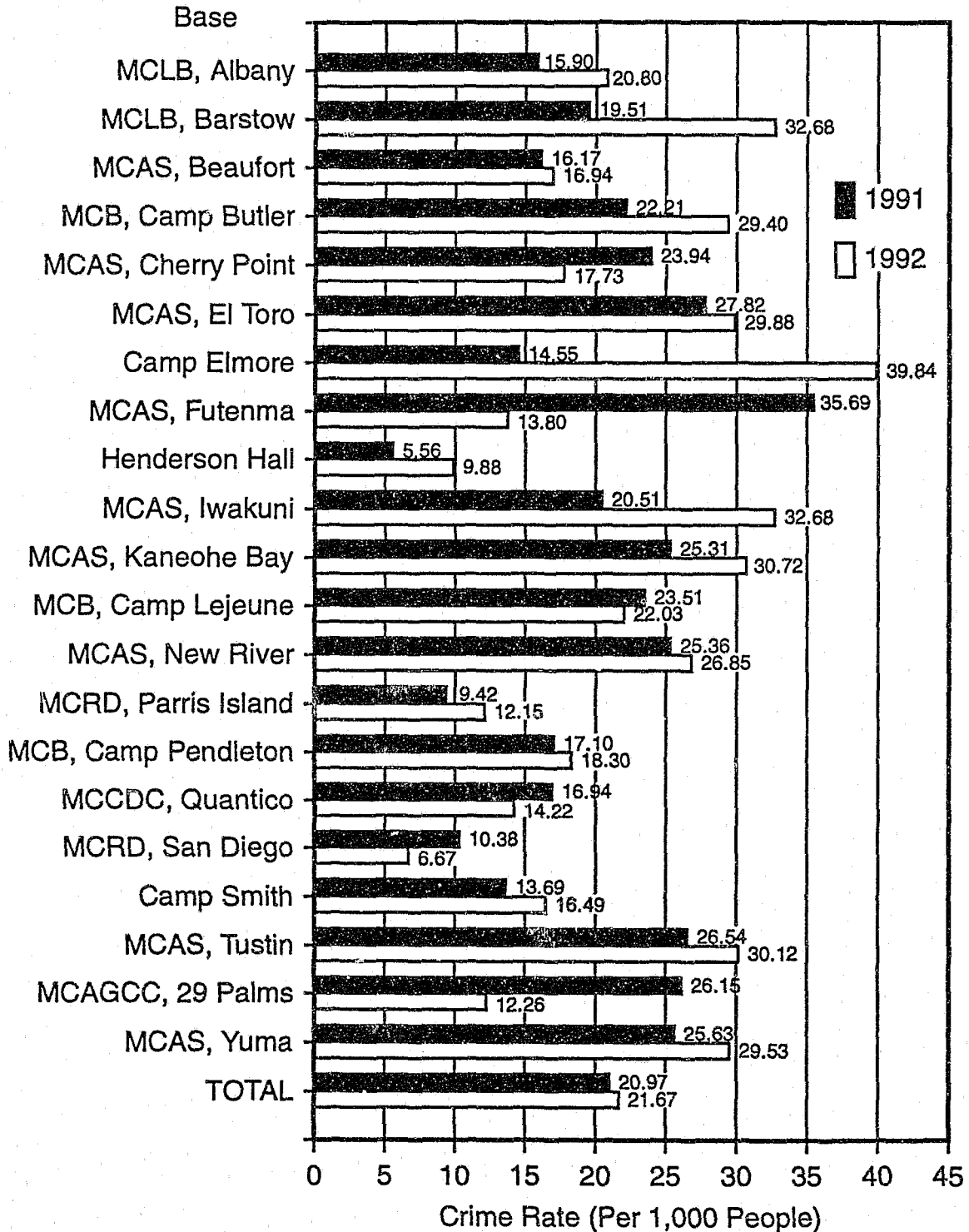

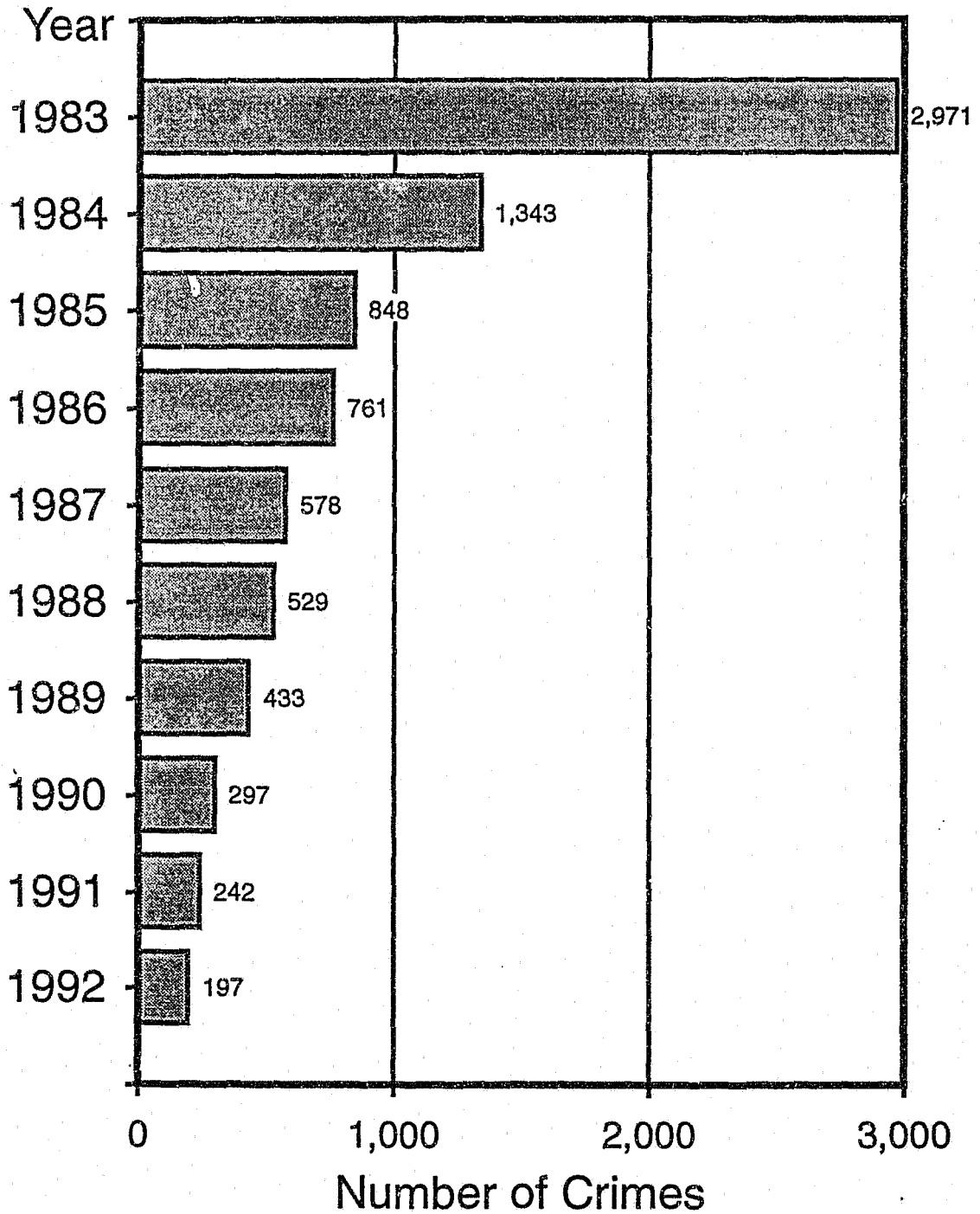

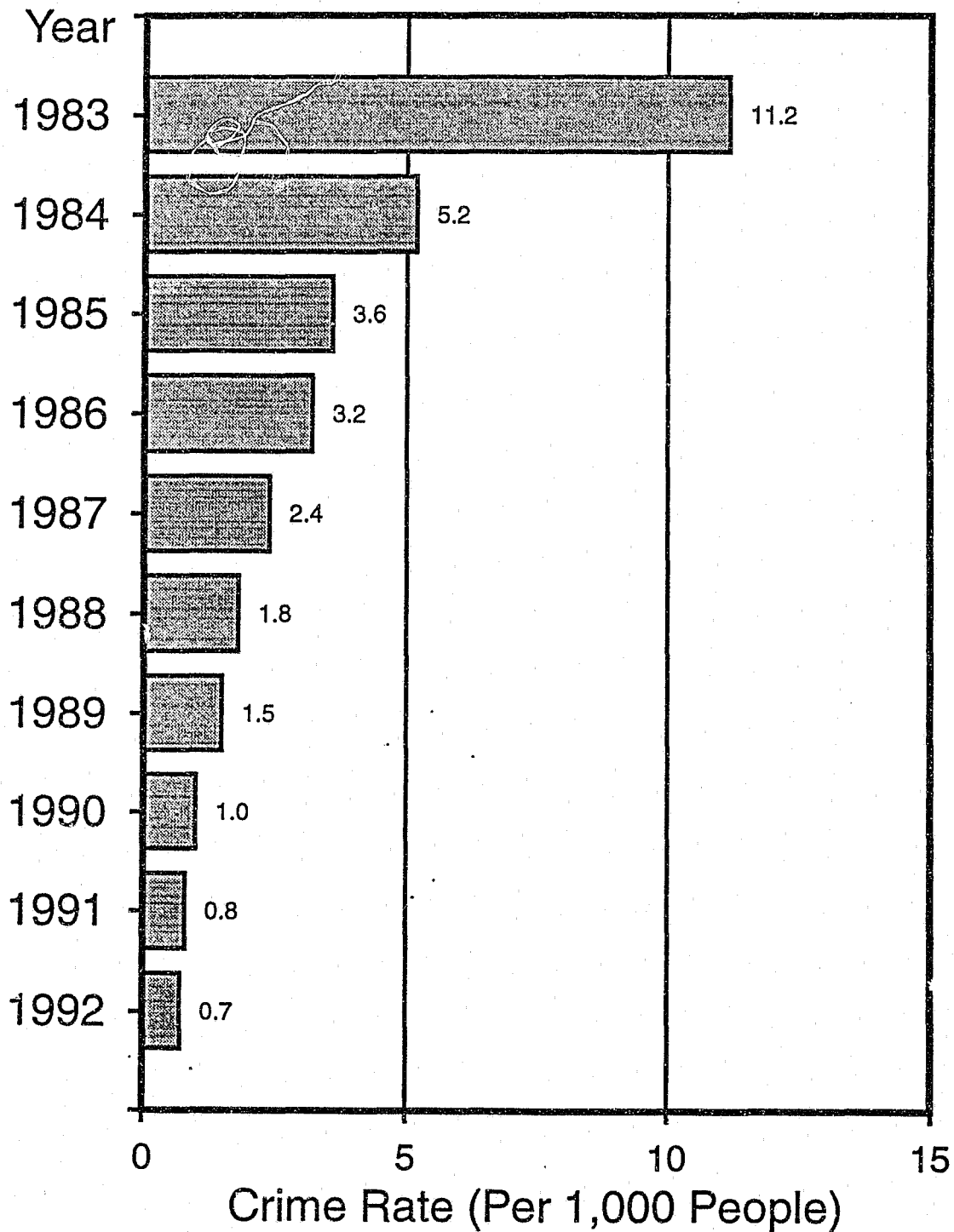
DRUG RELATED OFFENSES

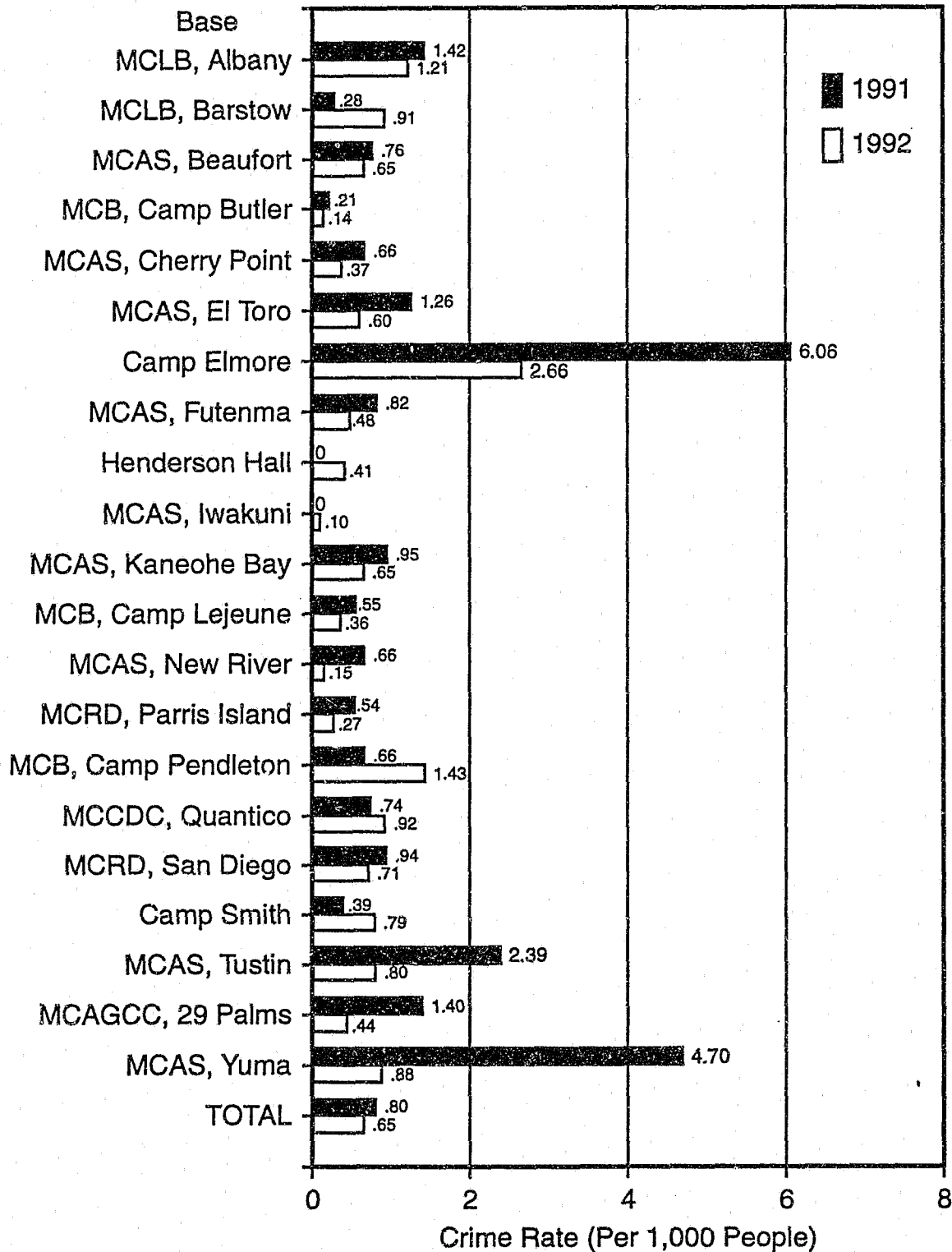

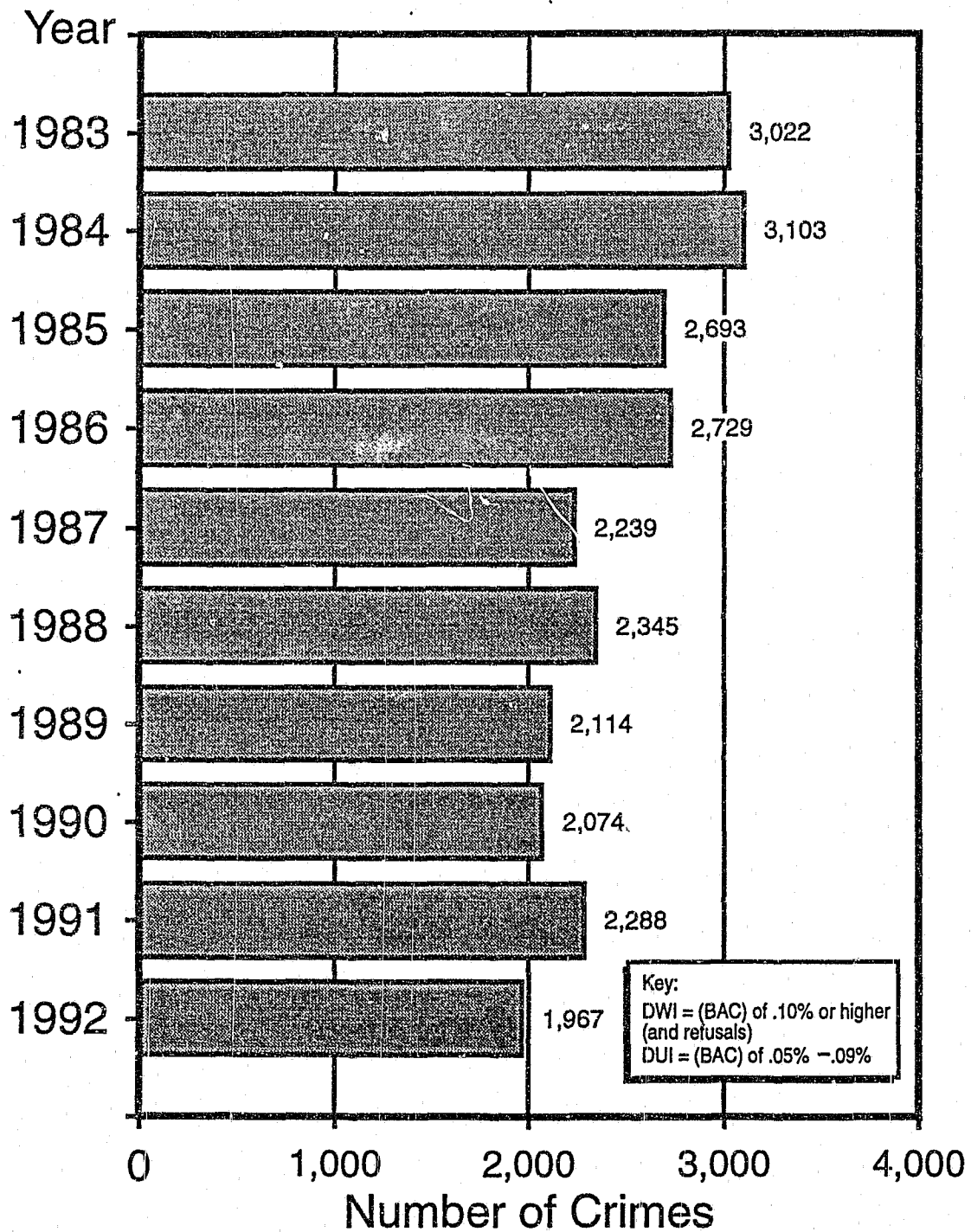

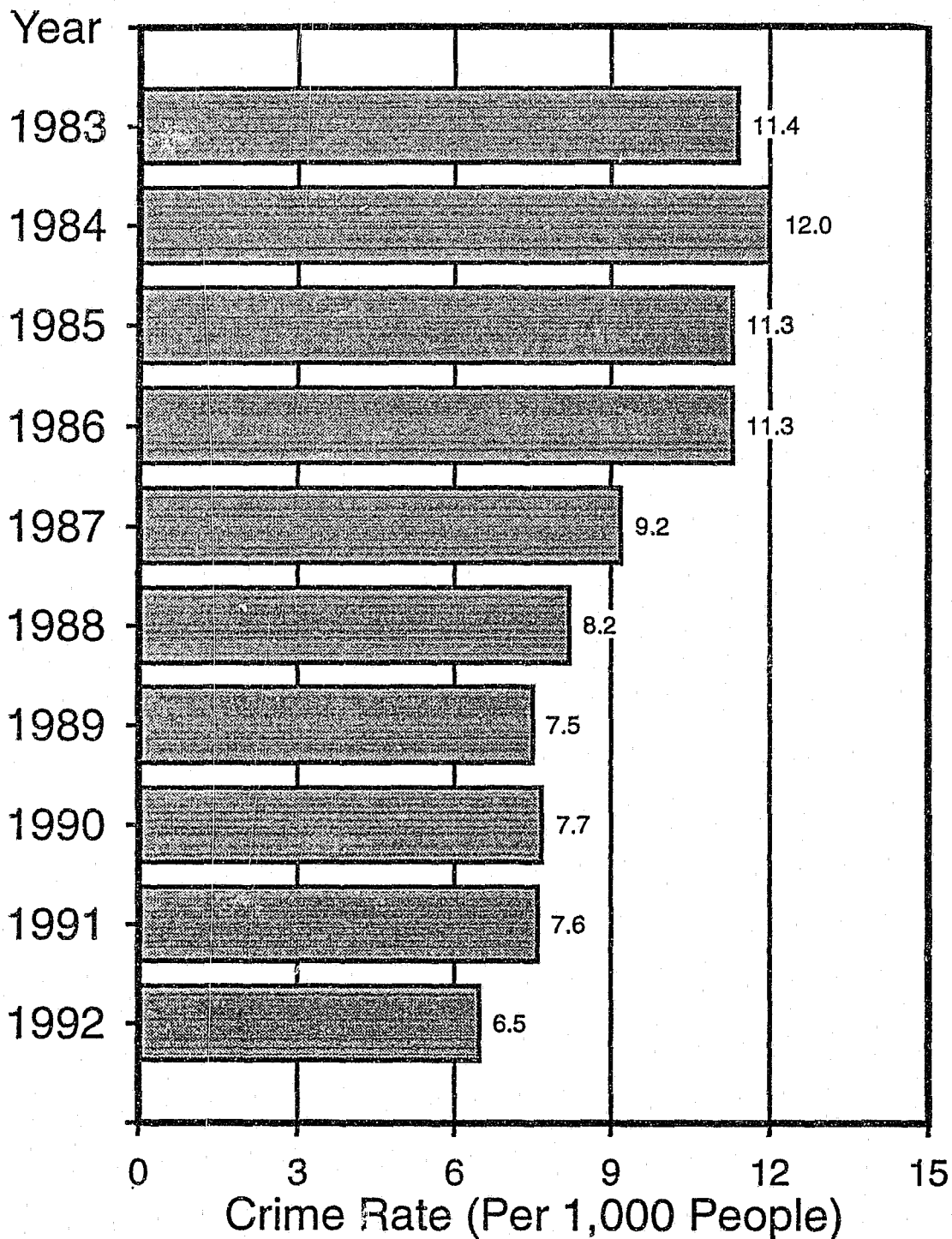
DRIVING VIOLATIONS RELATED TO ALCOHOL ABUSE

Section 5 addresses on-base driving violations related to alcohol abuse. For the purpose of this report, Driving While Intoxicated (DWI) represents all offenses in which the subject registered a blood alcohol content (BAC) of .10% or higher, as well as those individuals who refused to take a BAC test. Driving under the Influence (DUI) represents offenders who registered .05%—.09% BAC.

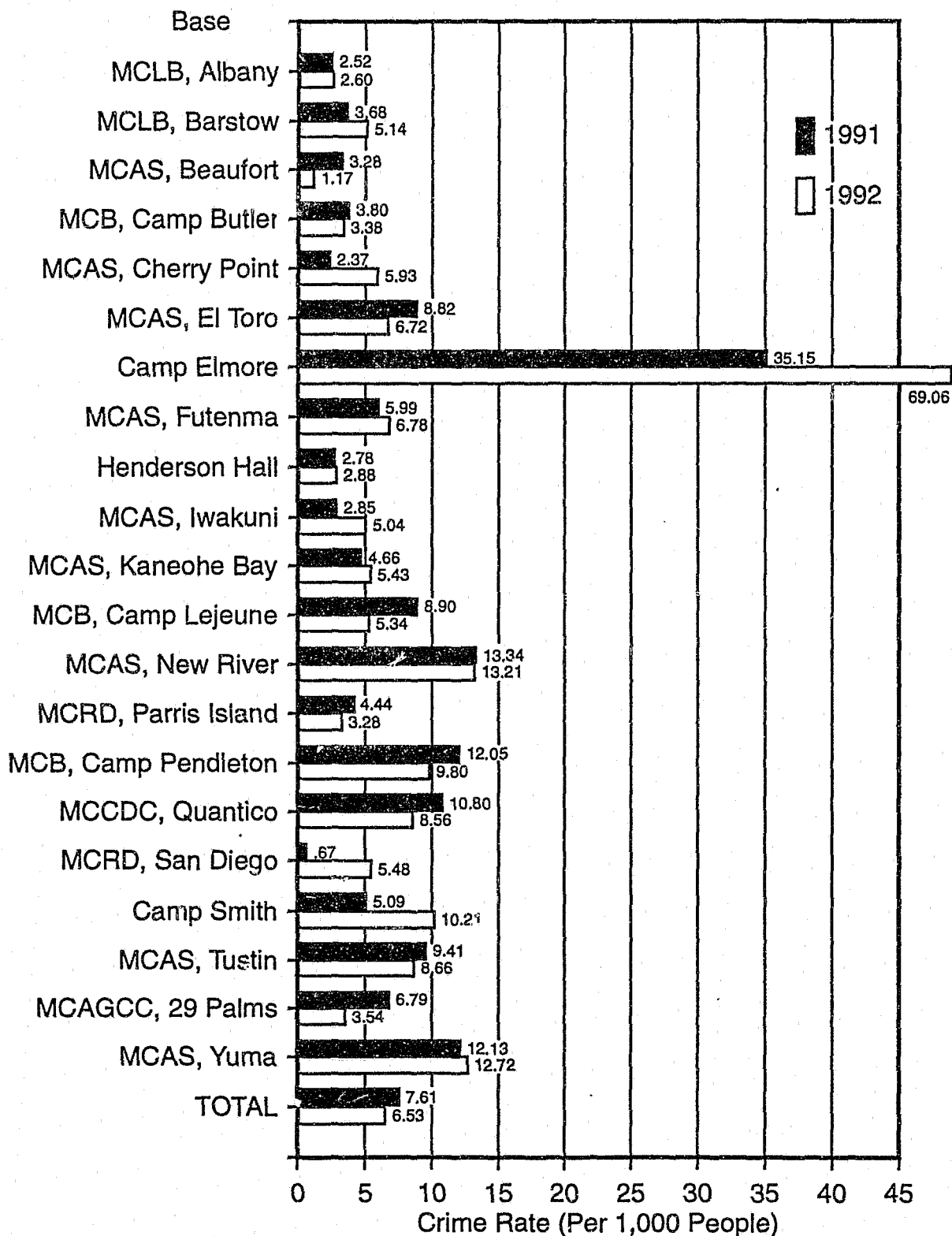
