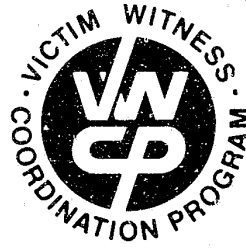

# Introduction

The Victim Witness Coordination Program of the NDAA is proud to publish this nationwide directory of prosecutor-based victim witness programs.

In 1975 the NDAA played a pioneer role in setting up the first victim assistance programs in eight prosecutors' offices with support from LEAA. The programs proved to be extremely useful and NDAA recommended that every prosecutor focus such attention on the needs of victims and witnesses in their respective jurisdictions. Numerous victim assistance programs were set up but lack of funding proved to be a great stumbling block to further expansion.

The eighties saw the growth of the movement for recognition of victims' rights in the criminal justice system and proposals for improvement in the victim's treatment. Increased government involvement financially and otherwise have led to a renewed expansion of prosecutor-based victim assistance programs as well as other victim service programs. Both the federal and the individual state governments have provided prosecutors with the support to set up and expand services for victims of crime.

The information contained in this directory was collected over the period February to June of 1986. The directory also provides, in addition to a listing of over 400 prosecutor-based victim assistance programs, a list of currently operated state victim compensation programs. Upon request, the V.W.C.P. can provide referrals for other types of victim services such as domestic violence and child sexual abuse.

This directory will be widely distributed to prosecutors and criminal justice agencies across the country. Prosecutors who operate programs not listed in this directory are urged to fill out the form in the back and send it to the V.W.C.P. Also, notification of any changes in programs already included would be appreciated, to update the directory. We hope that this directory will be a useful resource for prosecutors and other agencies working with victims. By improving assistance to victims of crime, prosecutors perform an important and valuable service to their jurisdictions and to our society as a whole.
