Over six years and twelve grant supplements the National Juvenile Court Data Archive has produced an extensive array of tangible and intangible products.

A summary of grant reports is presented on the accompanying presentation. These reports have become the primary source of national information on the activities of the juvenile courts. During this grant period OJJDP initiated its *Update* series. To date the National Juvenile Court Data Archive has prepared 10 *Update* bulletins. Based on the comments of the staff of the Juvenile Justice Clearinghouse and the volume of bulletins printed and distributed, the bulletins prepared by the Archive have been the most popular ones in the series. To facilitate access to the archived data files the project has also prepared and maintains over a score of User's Guides. These guides detail the structure and content of the archive files and are provided to researchers who are interested in archive data.

During this grant period the project established the Visiting Scholars Program. To date seven scholars have been in residence at the Archive and their products have been published in academic and professional journals.

During this grant period the project held the first Data Suppliers Conference. Representatives from 36 states attended. The conference was held to establish stronger relationships between the archive and its voluntary data suppliers. It was also designed to improve juvenile justice information systems by providing data processing professionals with the opportunity to learn and discuss problems with their counterparts from across the country. On both counts the conference was an unqualified success. OJJDP has decided to provide funds to hold another conference this year. It is hoped that the conference will become an annual event.

Finally, and most importantly, over the last six years the Archive has collected, documented and stored millions of automated cases records from the Nation's juvenile courts. The Archive is a unique information resource. Its value to the field has been acknowledged by policy makers, practitioners and researchers across the country. With the continuing support of OJJDP, the field of juvenile justice will continue to have detailed information on the youth that come to the attention of juvenile courts and the court's response to these cases.
