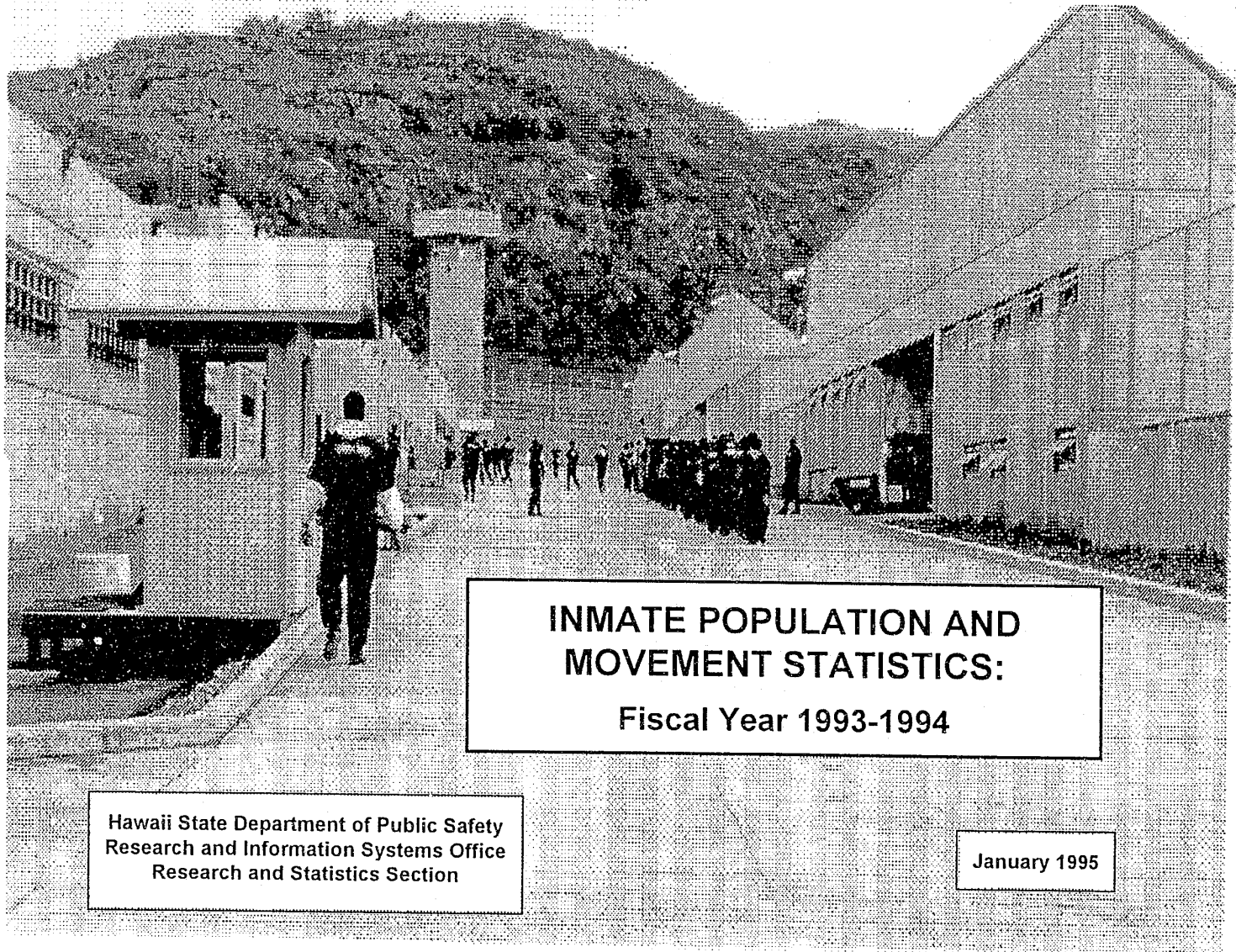

INTRODUCTION

This report, Inmate Population and Movement Statistics: Fiscal Year 1993-1994, provides end of month inmate population counts; and the monthly and annual number of admissions and releases during Fiscal Year 1993-94 for the facilities under the jurisdiction of the Hawaii Department of Public Safety, Corrections Division.

The report is intended to provide Departmental, division, facility, and inmate program administrators with information to identify past trends and plan for future needs.

In addition to statistical tables and charts, a narrative summary is presented for:

- Statewide - All Facilities
- All Community Correctional Centers
- Hawaii Community Correctional Center
- Kauai Community Correctional Center
- Maui Community Correctional Center
- Oahu Community Correctional Center
- Women's Community Correctional Center
- All Correctional Facilities

- Waiawa Correctional Facility

Statistics on the inmate population, number of admissions, and number of releases are presented for each inmate custody status.

The monthly and annual number of admissions are presented as new admissions, status change admissions, and transfers into the facility.

The monthly and annual number of releases are presented as discharges, status change releases, and transfers from the facility.

Annual percent change in the inmate populations, admissions, and releases from the previous fiscal year are also provided.

Executive Summary

During fiscal year 1993-94, the Corrections Division of the Department of Public Safety operated five community correctional centers and three correctional facilities on four islands

All facilities

Between June 30 of 1993 and 1994, the statewide assigned count increased by 3.6 percent from 3,133 to 3,246.

During the same period, the head count ranged from a low of 2,775 to a high of 2,930 and averaged 2,849. The head count of 2,834 on June 30, 1994 was a decrease of 0.6 percent from June 30, 1993.

The total number of new admissions of 8,306 represented a 9.0 percent increase over the previous fiscal year.

The total number of discharges increased by 9.5 percent to a total of 8,151.

The total number of status changes increased over the previous fiscal year by 2.3 percent to 2,120.

The 2,500 transfers between the facilities was about the same as the previous fiscal year.

During fiscal year 1993-94, the assigned count at the CCCs increased by 6.4 percent from 1,530 to 1,628.

Community Correctional Centers

During fiscal year 1993-94, the combined assigned count of the community correctional centers increased by 6.4 percent from 1,530 to 1,628.

The head count ranged from a low of 1,230 to a high of 1,375 and averaged 1,302. The June 30, 1994 head count in the CCCs was a decrease of 1.8 percent from the June 30, 1993 count.

During the fiscal year, the number of new admissions increased by 9.7 percent and reached a total of 7,957.

The total of 7,295 discharges represents an increase of 13.5 percent from fiscal year 1992-93.

The number of status changes increased slightly over the previous fiscal year by 3.3 percent from 1,957 to 2,021.

The number of transfers to the CCCs increased by 2.8 percent from 857 to 881.

The number of transfers from the CCCs decreased by 8.2 percent from 1,424 to 1,551.

Hawaii Community Correctional Center

On June 30, 1994, HCCC had an assigned count of 198 inmates--an increase of 25.3 percent over June 30, 1993.

The head count at HCCC during fiscal year 1993-94 ranged from a low of 103 to a high of 149 and averaged 128.

New admissions to the facility increased by 8.9 percent during fiscal year 1993-94 from 1,558 to 1,696.

The facility discharged 1,605 inmates during fiscal year 1993-94, an increase of 5.3 percent from fiscal year 1992-93.

The number of status changes increased over the previous fiscal year by 40.0 percent to 154.

Kauai Community Correctional Center

As of June 30, 1994, KCCC had jurisdiction over 105 inmates which represented a 59.1 percent increase from June 30, 1993.

During fiscal year 1993-94, the head count ranged from a low of 60 to a high of 84 and averaged 72. The head count of 79 on June 30, 1994 was an increase of 79.5 percent from June 30, 1993.

During fiscal year 1993-94, KCCC experienced an increase of 37.0 percent in the total number of new admissions to the facility from 424 to 581.

The total number of discharges increased by 27.3 percent from 400 to 509.

The total number of status changes of 114 was an increase of 37.3 percent from the previous fiscal year.

The total number of transfers to the facility increased by 1.8 percent from 56 to 57.

The total number of transfers from the facility decreased by 32.4 percent from 105 to 71.

Maui Community Correctional Center

The assigned count at MCCC was 240 on June 30, 1994.

The head count during fiscal year 1993-94 ranged from a low of 176 to a high of 200 and averaged 191. On June 30, 1994, the head count of 200 was an increase of 3.6 percent from June 30, 1993.

During fiscal year 1993-94, the number of new admissions to the facility increased by 18.3 percent and reached a total of 1,032.

The facility discharged 1,010 inmates during fiscal year 1993-94, an increase of 26.7 percent from fiscal year 1992-93.

The total number of status changes of 92 was the same as the previous fiscal year.

The number of transfers to the facility decreased by 2.0 percent from 98 to 96.

The number of transfers from the facility increased by 31.2 percent from 93 to 122.

Oahu Community Correctional Center

The assigned count of 918 on June 30, 1994 was a decrease of 0.6 percent from June 30, 1993.

The head count at OCCC during fiscal year 1993-94 ranged from a low of 734 to a high of 865 and averaged 807. From June 30, 1993 to June 30, 1994, the total head count decreased by 9.5 percent to 758.

With an increase of 5.2 percent during fiscal year 1993-94, the facility had a total of 4,572 new admissions.

The facility discharged 3,811 inmates during fiscal year 1993-94, an increase of 10.3 percent from fiscal year 1992-93.

The number of status changes decreased slightly by 1.7 percent to 1,549.

The number of transfers to the facility increased by 9.8 percent from 377 to 414.

The number of transfers from the facility decreased by 7.5 percent from 1,206 to 1,116.

Women's Community Correctional Center

The facility had an assigned count of 167 on June 30, 1994, an increase of 3.7 percent from June 30, 1993.

The head count at WCCC during fiscal year 1993-94 ranged from a low of 94 to a high of 119 and averaged 105. The facility had a head count of 103 on June 30, 1994, a decrease of 16.3 percent from June 30, 1993.

The total number of new admissions of 76 represented an increase of 33.3 percent from the previous fiscal year.

The facility discharged 360 inmates during fiscal year 1993-94, an increase of 41.7 percent from fiscal year 1992-93.

The total number of status changes of 112 during fiscal year 1993-94 was an increase of 15.5 percent from the previous fiscal year.

The number of transfers to the facility increased by 6.2 percent from 259 to 275. Most of the increase occurred for pretrial felons and for pretrial misdemeanants.

The number of transfers from the facility decreased by 5.7 percent from 53 to 50.

Correctional Facilities

Between June 30 of 1993 and 1994, the assigned count at the correctional facilities increased by 0.9 percent from 1,603 to 1,618.

The head count ranged from a low of 1,517 to a high of 1,560 and averaged 1,548. The head count of 1,545 on June 30, 1994 was an increase of 0.4 percent from June 30, 1993.

During the fiscal year, the number of new admissions decreased by 3.3 percent to 349.

The total number of discharges decreased by 15.4 percent to 856.

The number of status changes decreased by 14.7 percent from 116 to 99 during fiscal year 1993-94.

The number of transfers to the CFs decreased by 1.7 percent to 1,619.

The number of transfers from the CFs increased by 12.2 percent from 959 to 1,076.

Halawa Correctional Facility

On June 30, 1994, HCF had an assigned count of 1,240. This count represents a decrease of 0.4 percent from the assigned count on June 30, 1993.

During the 1993-94 fiscal year, the head count at HCF ranged from a low of 1,150 to a high of 1,191 and averaged 1,177. The head count on June 30, 1994 of 1,168 was a decrease of 1.2 percent from June 30, 1993.

The number of new admissions decreased by 3.3 percent from 361 to 349, primarily due to a decrease in the number of other jurisdiction inmates admitted to the facility.

Primarily due to a drop in releases of other jurisdiction inmates, the number of discharges decreased by 15.6 percent from 879 to 742.

The number of status changes decreased by 21.9 percent from 64 to 50.

The number of transfers to the facility decreased by 2.9 percent from 1,115 to 1,083.

The number of transfers from the facility increased by 9.9 percent from 616 to 677.

Kulani Correctional Facility

On June 30, 1994, KCF had an assigned count of 207.

The head count at KCF during the fiscal year ranged from a low of 199 to a high of 207 and averaged 203. The head count on June 30, 1994 was 207, an increase of 9.5 percent from June 30, 1993. All of the inmates were sentenced felons.

Because incoming transfers represented the only type of facility intakes, KCF did not process any new admissions.

A total of 14 inmates were discharged from KCF during fiscal year 1993-94, a 56.3 percent decline from the number of inmates discharged in fiscal year 1992-93.

Only one status change occurred at the facility during the fiscal year.

The number of transfers to the facility decreased by 14.9 percent from 181 to 154.

The number of transfers from the facility declined by 5.6 percent from 125 to 118.

Waiawa Correctional Facility

On June 30, 1994, WCF had an assigned count of 171.

During the fiscal year, the head count ranged from a high of 153 to a low of 172 and averaged 169. On June 30, 1994, the head count of 170 was an increase of 1.9 percent from June 30, 1993. All of the inmates at the facility were sentenced felons.

No new admissions to the facility occurred during the fiscal year.

A total of 100 inmates were discharged, a decrease of 1.0 percent from fiscal year 1992-93.

The number of status changes declined by 5.9 percent from 51 to 48.

Primarily because of more intakes in technical violators, the number of transfers to WCF increased by 8.8 percent from 351 to 382.

The number of transfers from WCF increased by 28.9 percent from 218 to 281.

Data Sources

The statistical information provided in this report was derived from inmate population reports submitted by each facility and from data available in the Correctional Information System (CIS) of the Department of Public Safety.

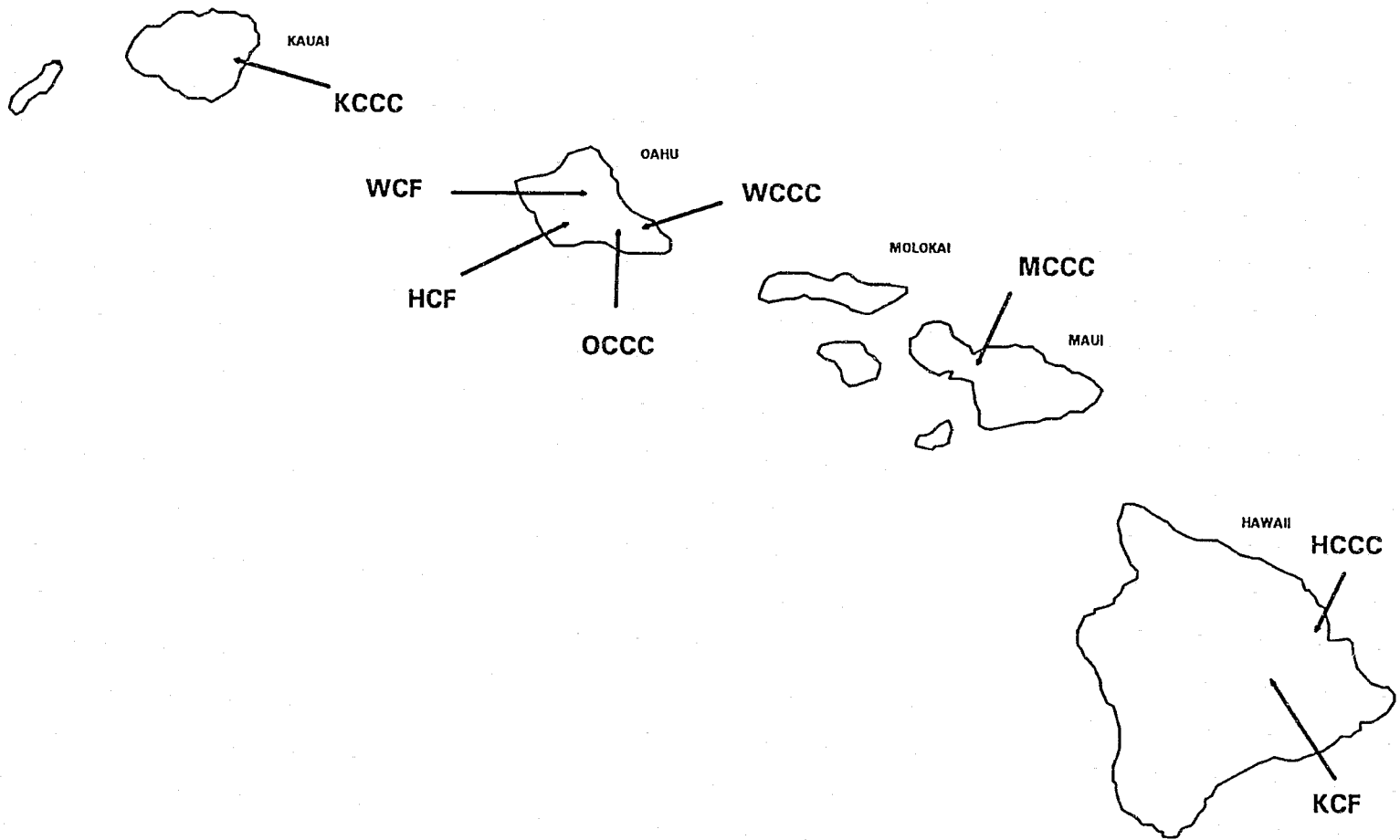
Both the head counts and assigned counts for each custody status was compiled from the Daily Population Movement Reports submitted once a week and at the end of the month by each facility. Information on inmate population were considered more accurate from these reports than from the CIS.

The number of new admissions, status changes (admissions), transfers (admissions), discharges, status changes (releases), transfers (releases) were tabulated from data available in the CIS. In this report, only transfers between actual correctional facilities were tabulated.

Caveats

The information in this report should be used and interpreted with the following caveats:

- Both the reports from the facilities and data from the CIS were not validated
- Gains and losses in the inmate population are not fully accounted by admission and releases due to errors in tabulations; reporting of inmates with intermittent sentences; double counting of inmates; and use of different data sources.
- The magnitude and distribution of the inmate populations, admissions, and releases provided in this report are consistent with past reliable tabulations.



ALL FACILITIES

Summary

During fiscal year 1993-94, the Corrections Division of the Department of Public Safety operated five community correctional centers and three correctional facilities on four islands

Total division expenditures for the fiscal year were \$78,939,525. Of this total, 22 percent was spent for program services to provide food, education, library, and health services for the inmates. Another 9.7 percent was spent for administrative services such as the general administration of the division and for the purchase of services.

Between June 30 of 1993 and 1994, the statewide assigned count increased by 3.6 percent from 3,133 to 3,246.

During the same period, the head count ranged from a low of 2,775 to a high of 2,930 and averaged 2,849. The head count of 2,834 on June 30, 1994 was a decrease of 0.6 percent from June 30, 1993. A little more than half of these inmates were sentenced felons. The second largest group was comprised of pretrial felons.

The total number of new admissions of 8,306 represented a 9.0 percent increase over the previous fiscal year. Pretrial misdemeanor admissions increased by 27.8 percent. Pretrial felons and misdemeanants accounted for about six of every ten of these admissions while sentenced misdemeanants about one out of every six of them.

The total number of discharges increased by 9.5 percent to a total of 8,151. Pretrial misdemeanor discharges increased by 37.0 percent. Sentenced and pretrial misdemeanants accounted for slightly more than one-half of these discharges while pretrial felons about one out of every five of them.

The total number of status changes increased over the previous fiscal year by 2.3 percent to 2,120. Sentenced misdemeanants accounted for about two out of every five status change admissions and sentenced felons comprised about one out of every five of them. Of every ten status change releases, slightly less than three were pretrial misdemeanants and about another three were pretrial felons.

The 2,500 transfers between the facilities was about the same as the previous fiscal year. Sentenced felons represented approximately six out of every ten transfer admissions and accounted for slightly more than four out of every ten transfer releases. Technical violators and pretrial felons each accounted for about two out of every ten of these releases.

Fiscal Year 1993-1994: All Facilities

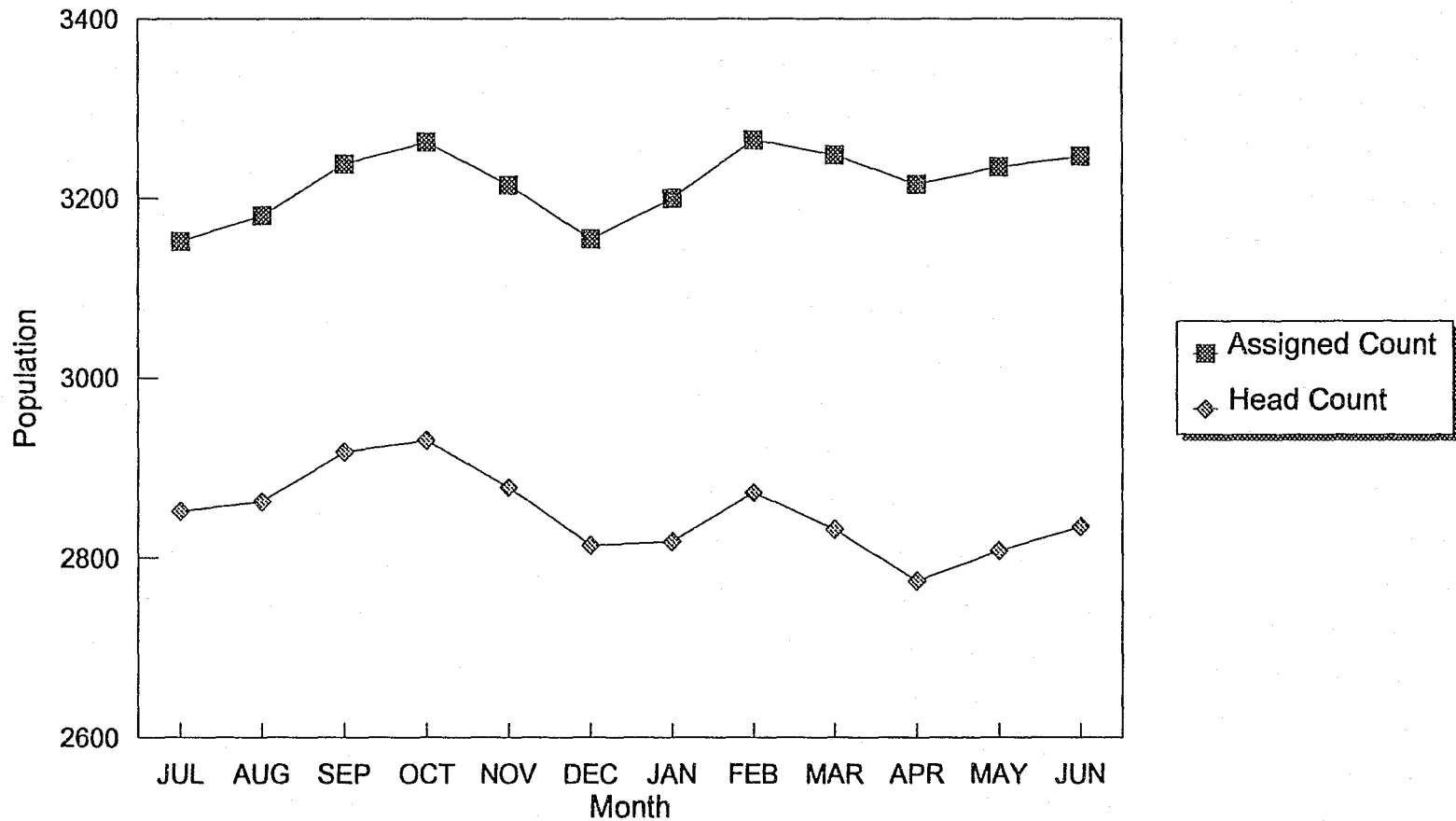

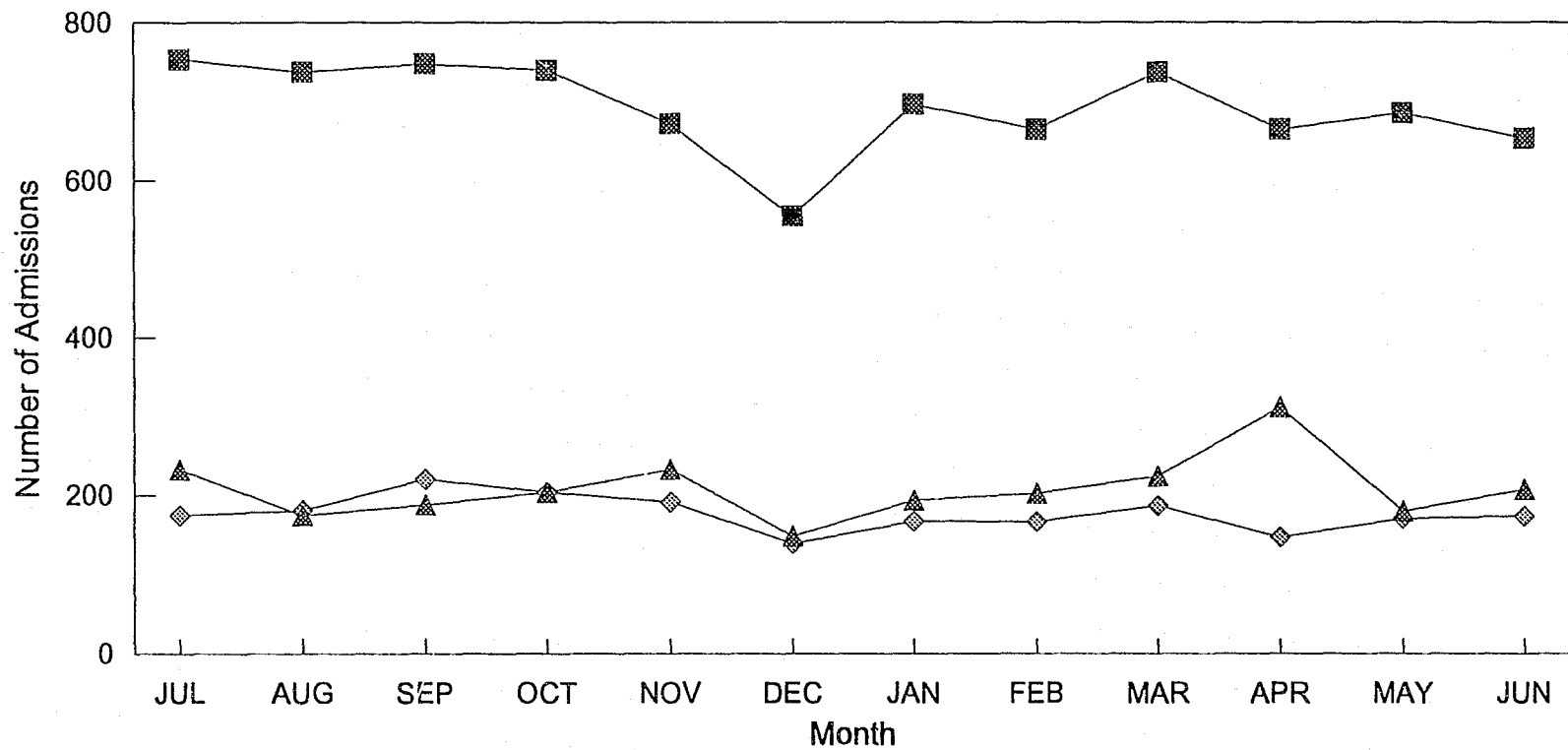

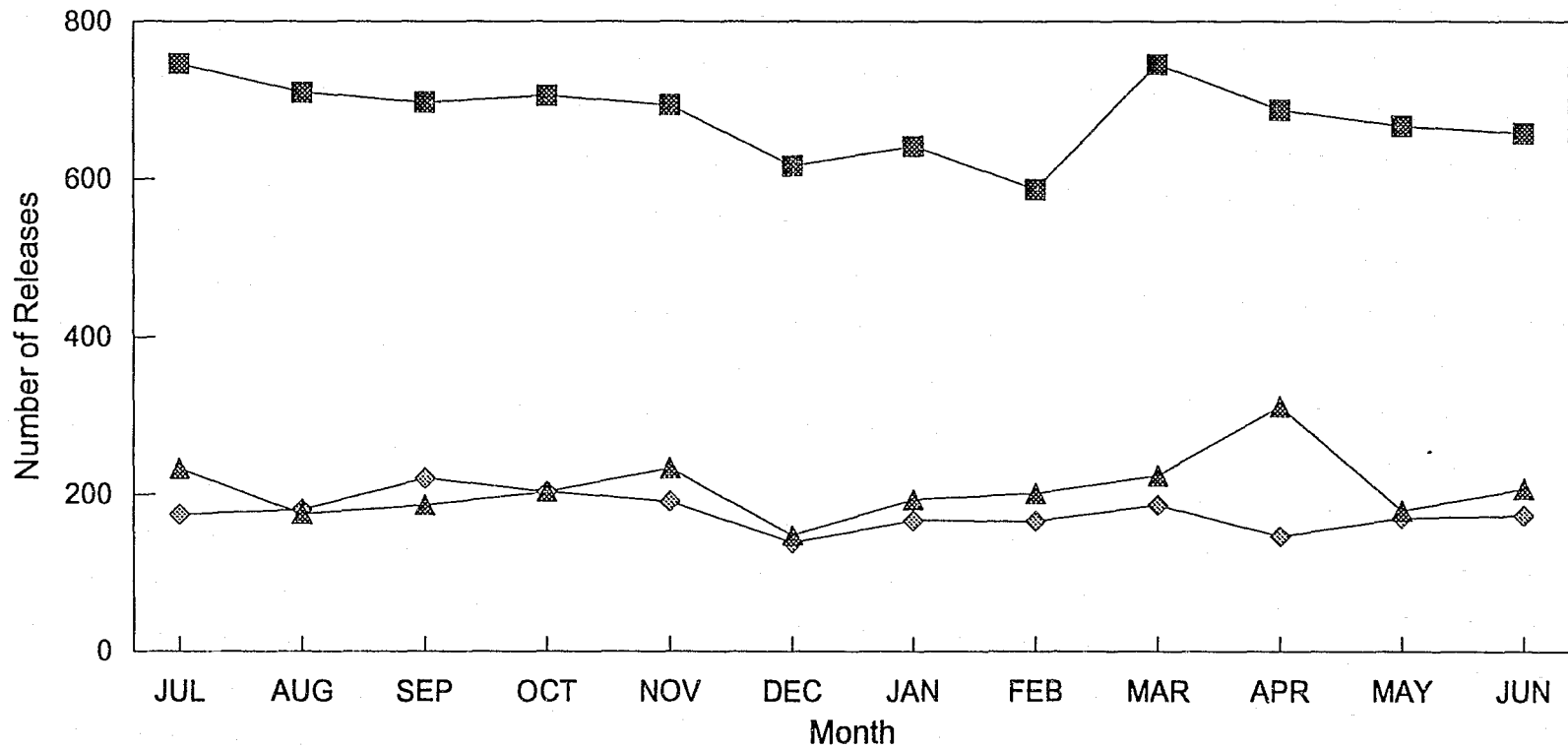

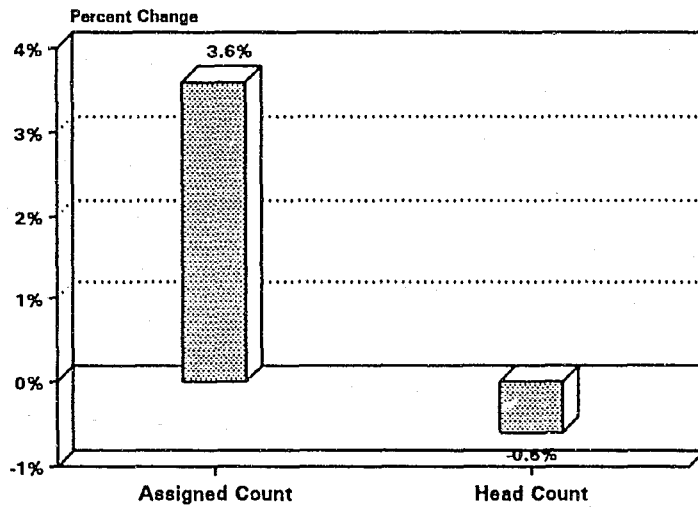

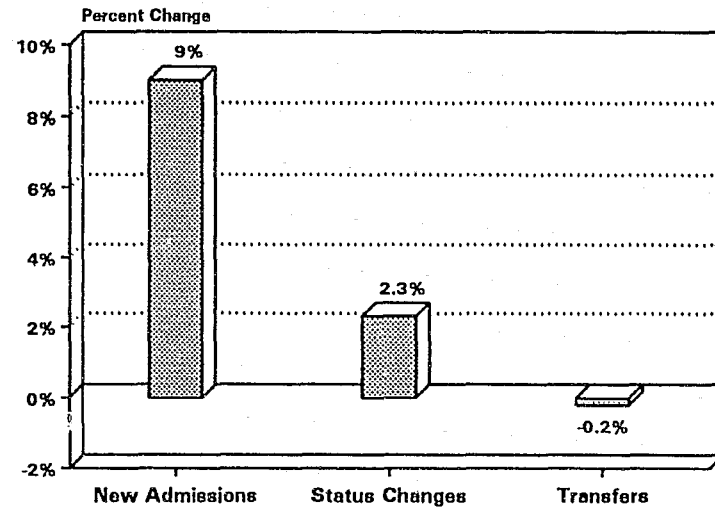
**PERCENT CHANGE IN POPULATIONS,

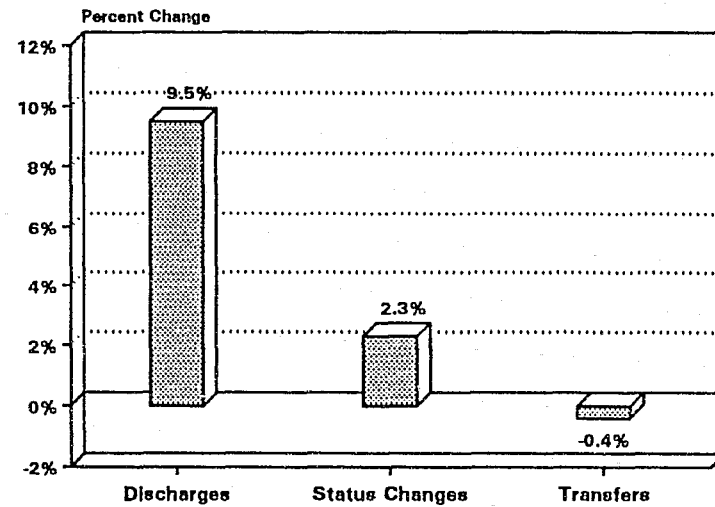
Percent Change in Populations

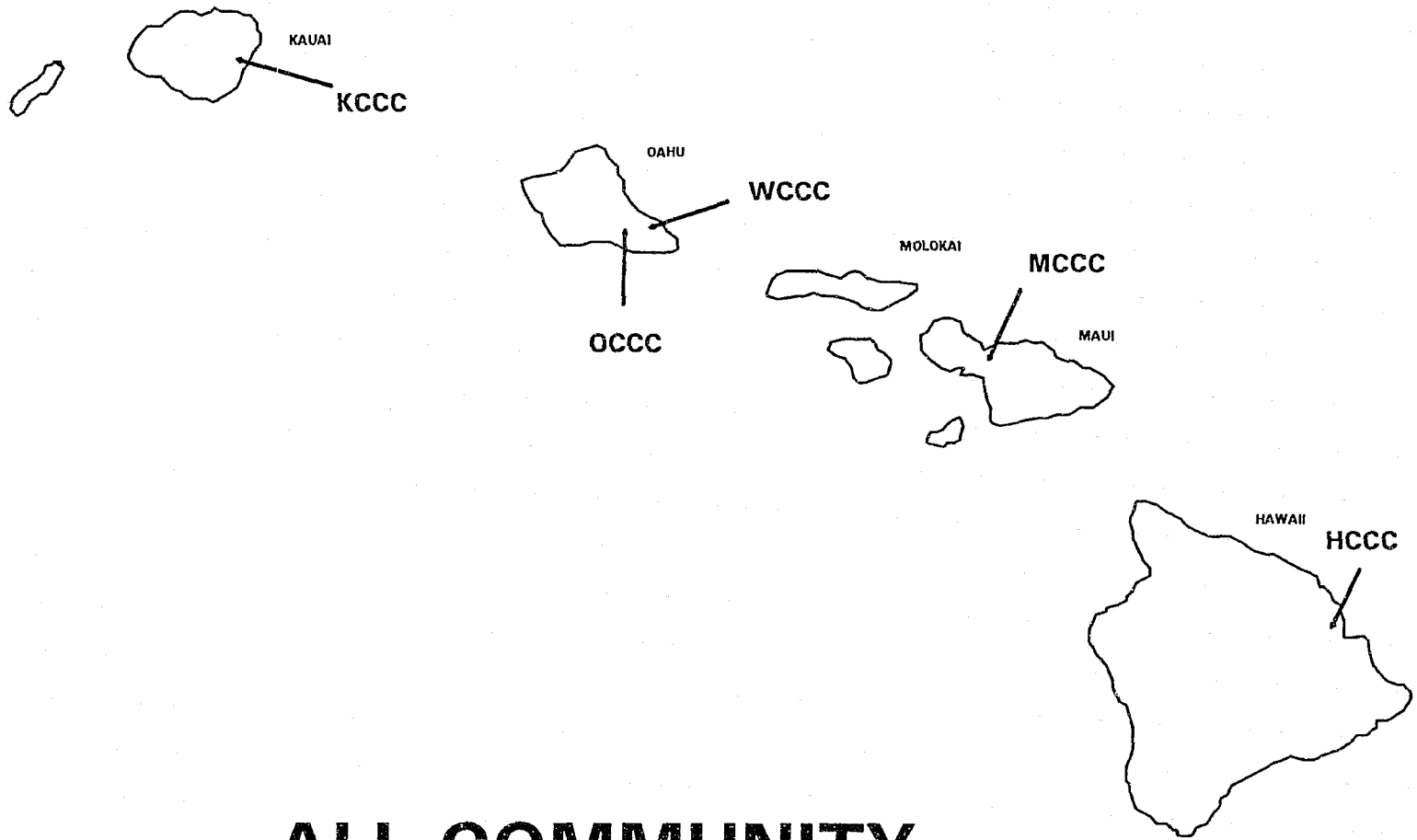


Percent Change in Number of Admissions

ALL COMMUNITY CORRECTIONAL CENTERS

Summary

The Division operated five Community Correctional Centers (CCCs) on four islands: the Hawaii Community Correctional Center, the Kauai Community Correctional Center, the Maui Community Correctional Center, the Oahu Community Correctional Center, and the Women's Community Correctional Center.

Total facility expenditures at the CCCs for the fiscal year were \$30,147,011.

During fiscal year 1993-94, the assigned count at the CCCs increased by 6.4 percent from 1,530 to 1,628.

The head count ranged from a low of 1,230 to a high of 1,375 and averaged 1,302. The June 30, 1994 head count in the CCCs was a decrease of 1.8 percent from the June 30, 1993 count. Approximately one-half of the inmate population were pretrial detainees. Sentenced felons accounted for slightly more than one-fourth of the population.

During the fiscal year, the number of new admissions increased by 9.7 percent and reached a total of 7,957. The number of admissions of pretrial misdemeanants increased by 27.8 percent. Approximately six out of every ten admissions were pretrial misdemeanants and felons and one out of every six were sentenced misdemeanants.

The total of 7,295 discharges represents an increase of 13.5 percent from fiscal year 1992-93. The number of pretrial misdemeanants discharged during the fiscal year increased by 37.3 percent. For every ten discharges, about three were sentenced misdemeanants, more than two were pretrial misdemeanants, and two were pretrial felons.

The number of status changes increased slightly over the previous fiscal year by 3.3 percent from 1,957 to 2,021. Approximately four out of every ten status change admissions were sentenced misdemeanants. Pretrial misdemeanants and pretrial felons together accounted for approximately two-thirds of the status change releases.

The number of transfers to the CCCs increased by 2.8 percent from 857 to 881. Approximately one out of every two transfer admissions was a sentenced felon.

The number of transfers from the CCCs decreased by 8.2 percent from 1,424 to 1, 551. Approximately one-third of the transfer releases were pretrial felons.

Fiscal Year 1993-1994: All Community Correctional Centers

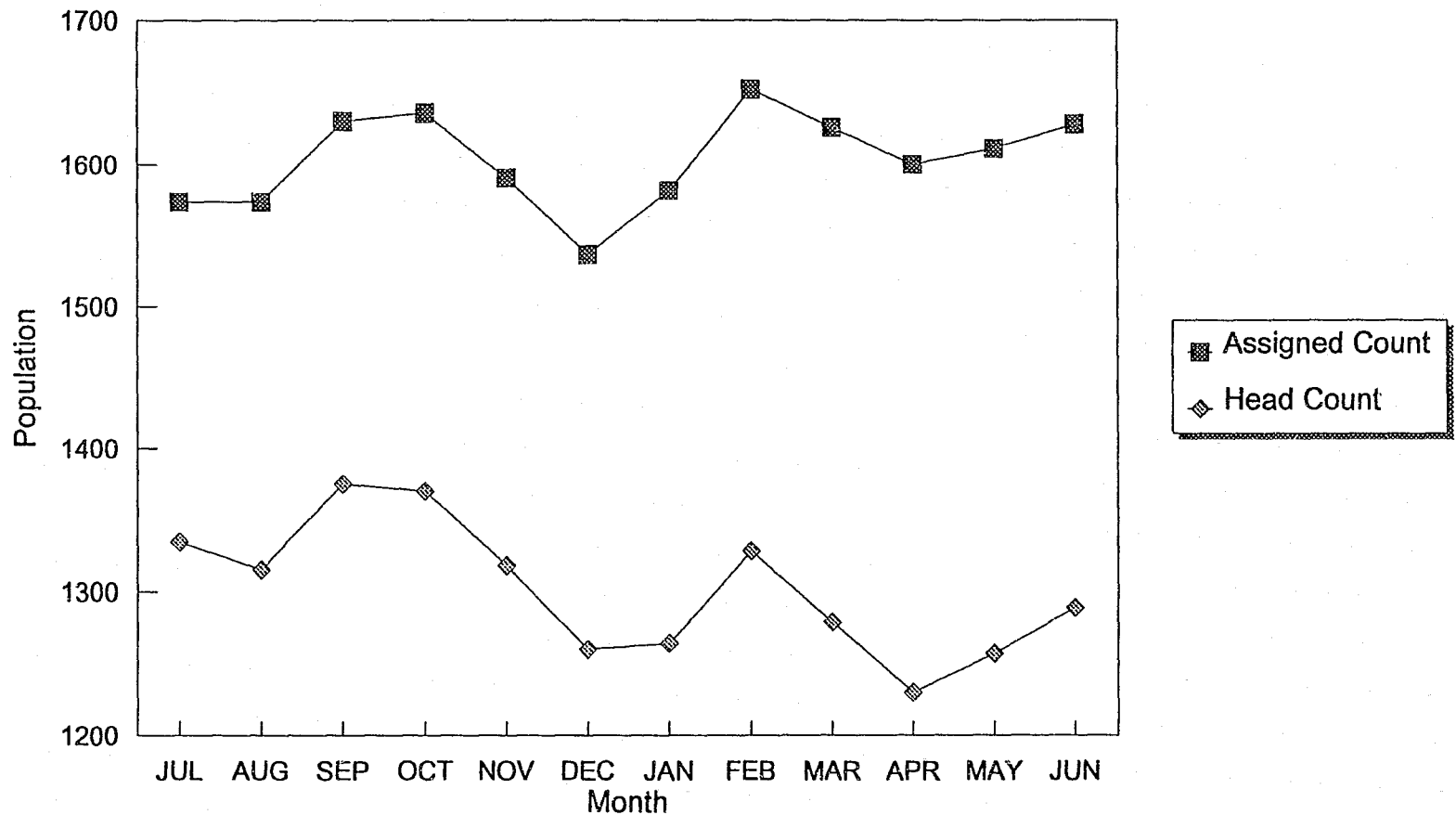

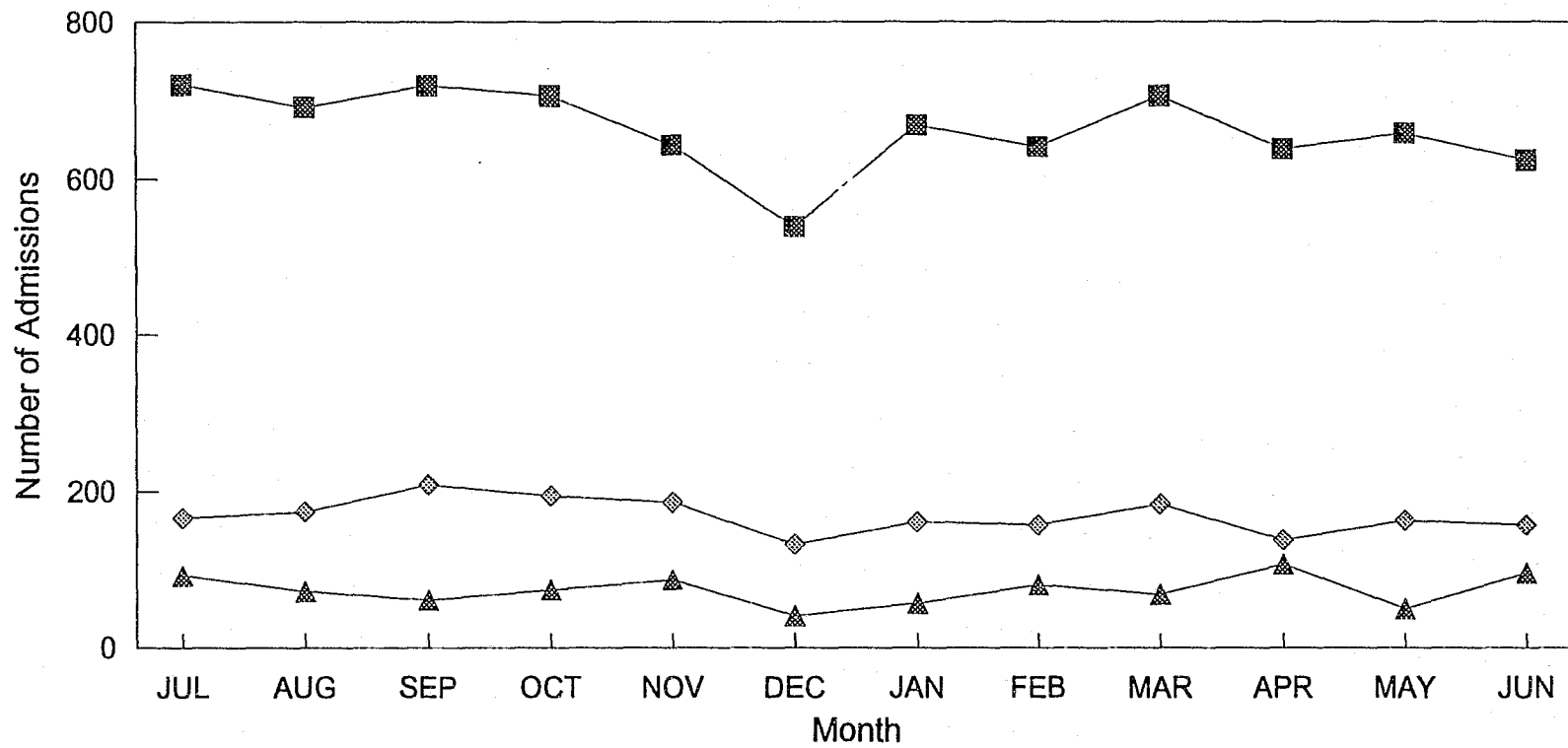

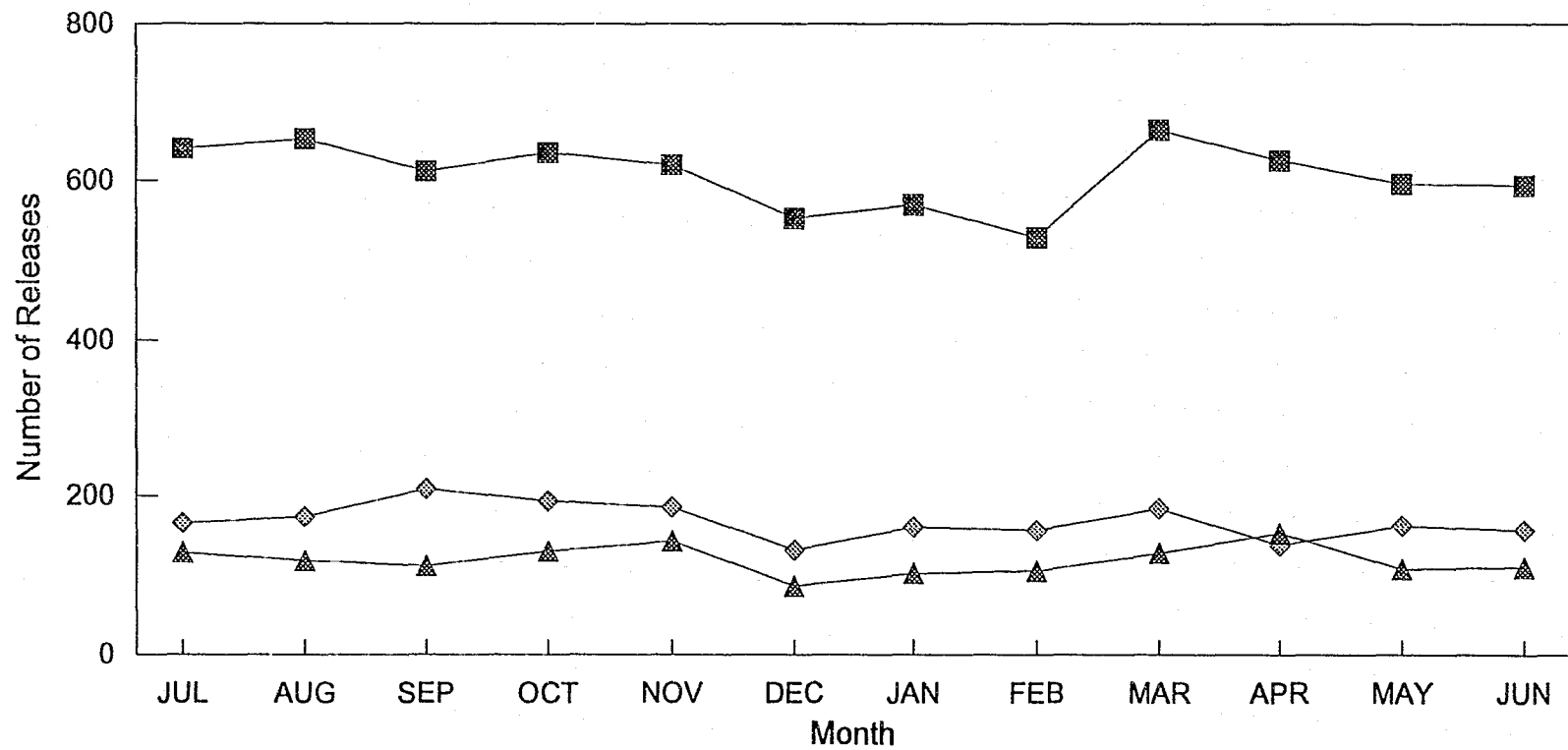

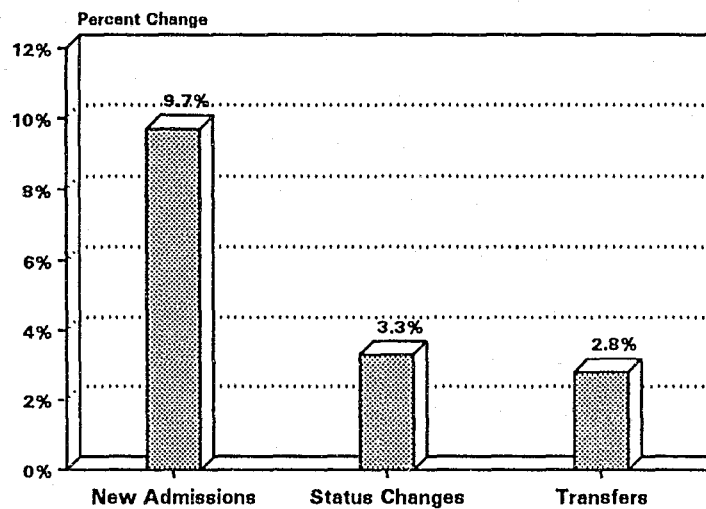

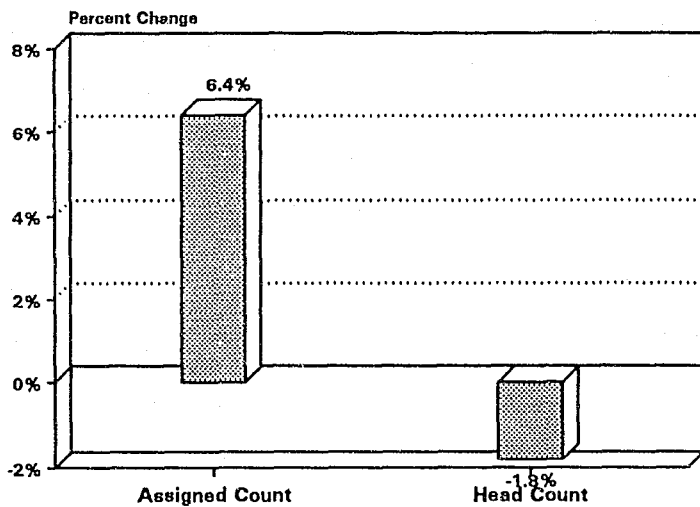
**PERCENT CHANGE IN POPULATIONS,

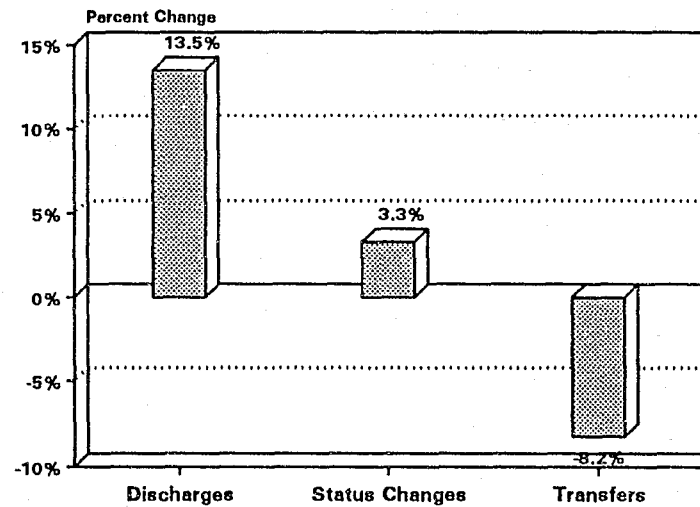
Percent Change in Number of Admissions

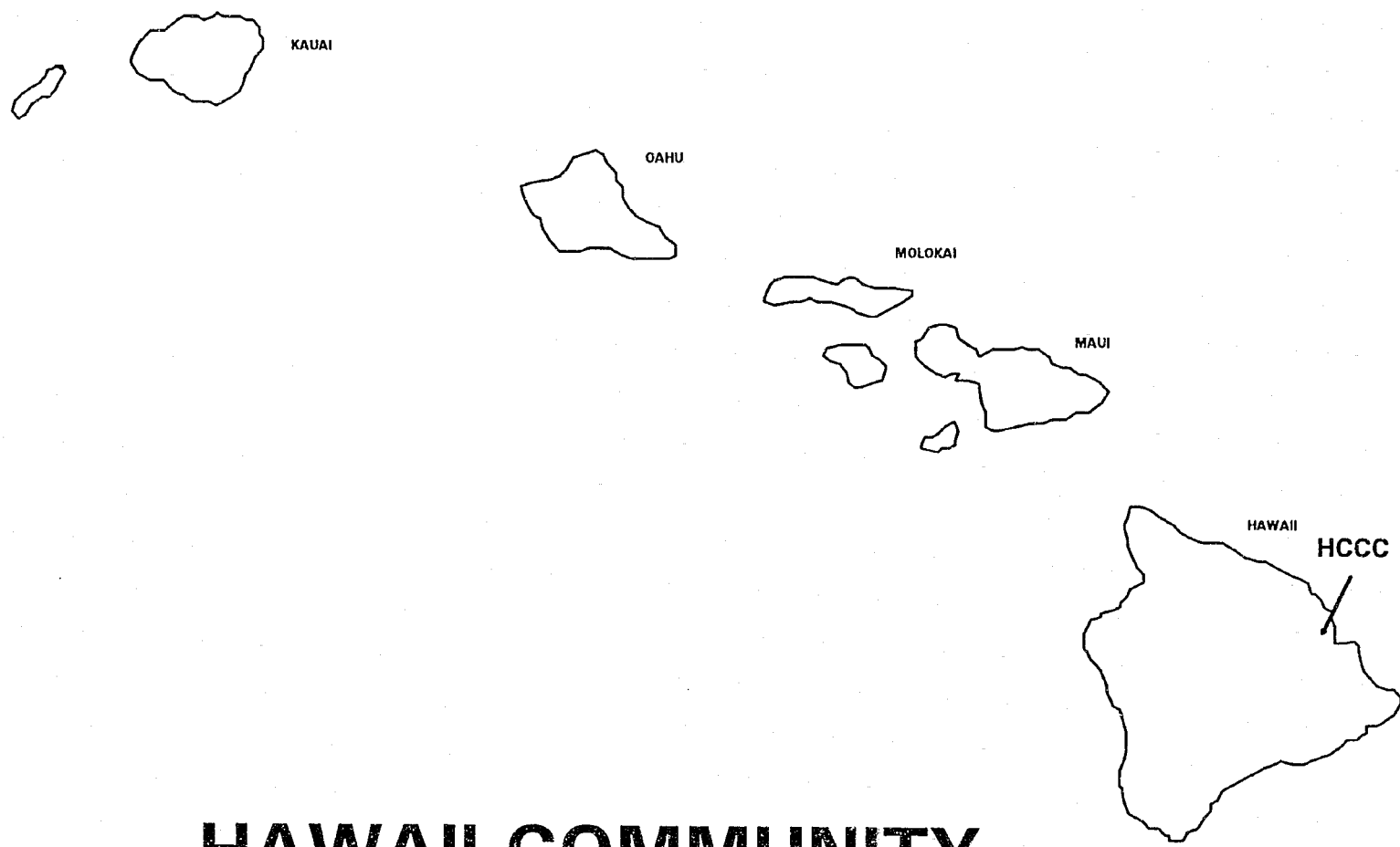


Percent Change in Populations

Summary

The Hawaii Community Correctional Center (HCCC) is located on the eastern side of the island of Hawaii and primarily serves as the jail facility for the County of Hawaii. Most of the inmates housed at HCCC are committed by the Third Judicial Circuit.

Total facility expenditures for fiscal year 1993-94 were \$2,903,777.

On June 30, 1994, HCCC had an assigned count of 198 inmates--an increase of 25.3 percent over June 30, 1993.

The head count at HCCC during fiscal year 1993-94 ranged from a low of 103 to a high of 149 and averaged 128. On June 30, 1994, approximately one-third of the inmate population were pretrial felons and one-third were sentenced felon probationers. Compared to June 30, 1993, the number of pretrial felons increased by 66.7 percent.

New admissions to the facility increased by 8.9 percent during fiscal year 1993-94 from 1,558 to 1,696. Two out of every three new admissions to HCCC were pretrial inmates.

The facility discharged 1,605 inmates during fiscal year 1993-94, an increase of 5.3 percent from fiscal year 1992-93. The number of sentenced misdemeanants released increased by 18.2 percent. Of every ten inmates released, more than three were pretrial misdemeanants, over two were sentenced misdemeanants, and two were pretrial felons.

The number of status changes increased over the previous fiscal year by 40.0 percent to 154. Compared to the previous fiscal year, increases in status change admissions occurred for sentenced misdemeanants, sentenced felons, and sentenced felon probationers. For every ten status change admissions, two were sentenced felons, three were sentenced felon probationers, and over two were sentenced misdemeanants. The number of status change releases for pretrial misdemeanants increased over the previous fiscal year by 53.6 percent. For every ten status change releases, six were either pretrial felons or pretrial misdemeanants.

The number of transfers to the facility decreased by 41.8 percent from 67 to 39. Almost one-half of all transfer admissions were sentenced felons.

The number of transfers out of the facility decreased from 94 to 65. Sentenced felons and pretrial felons each accounted for approximately three of every ten transfer releases.

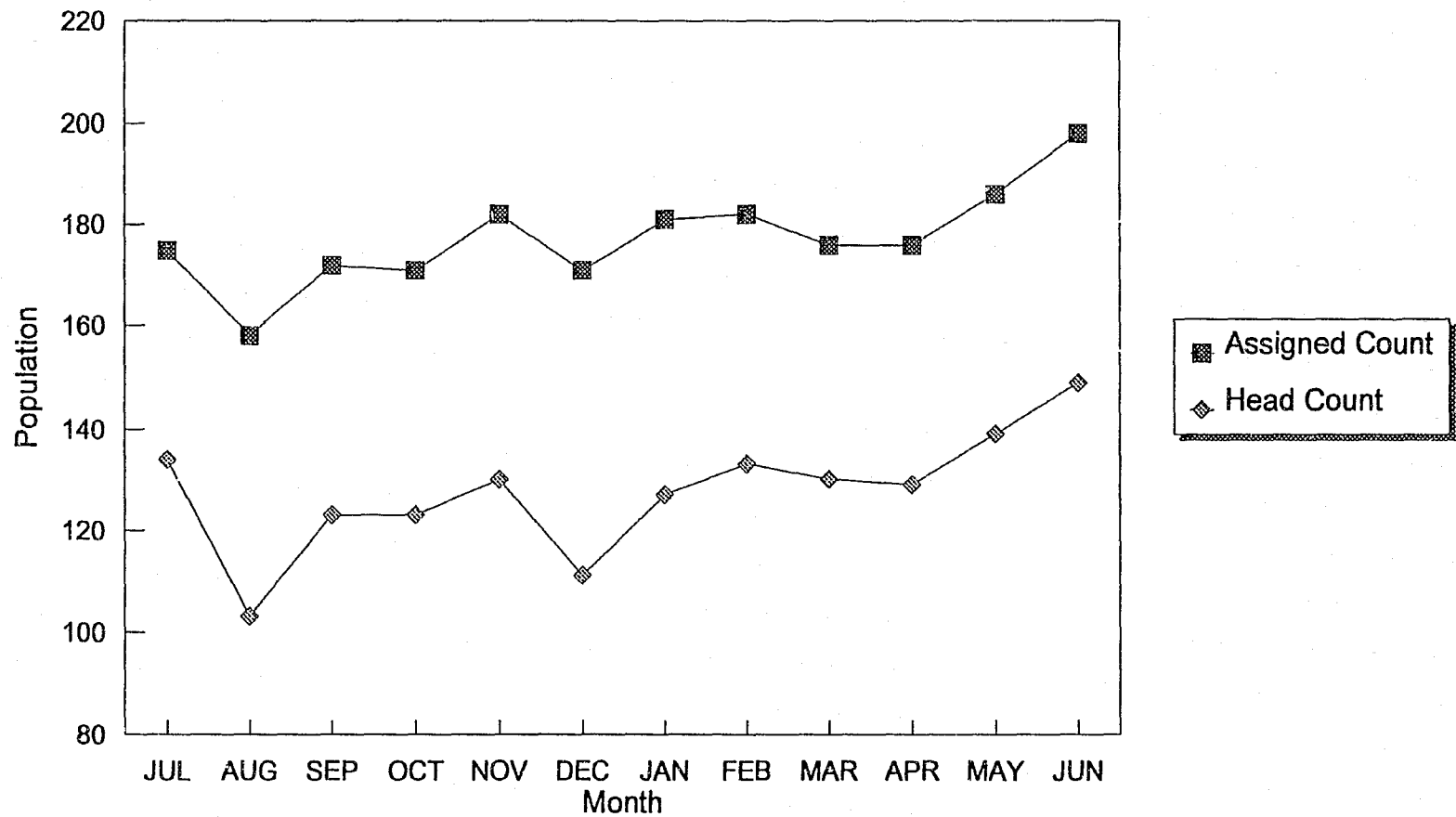

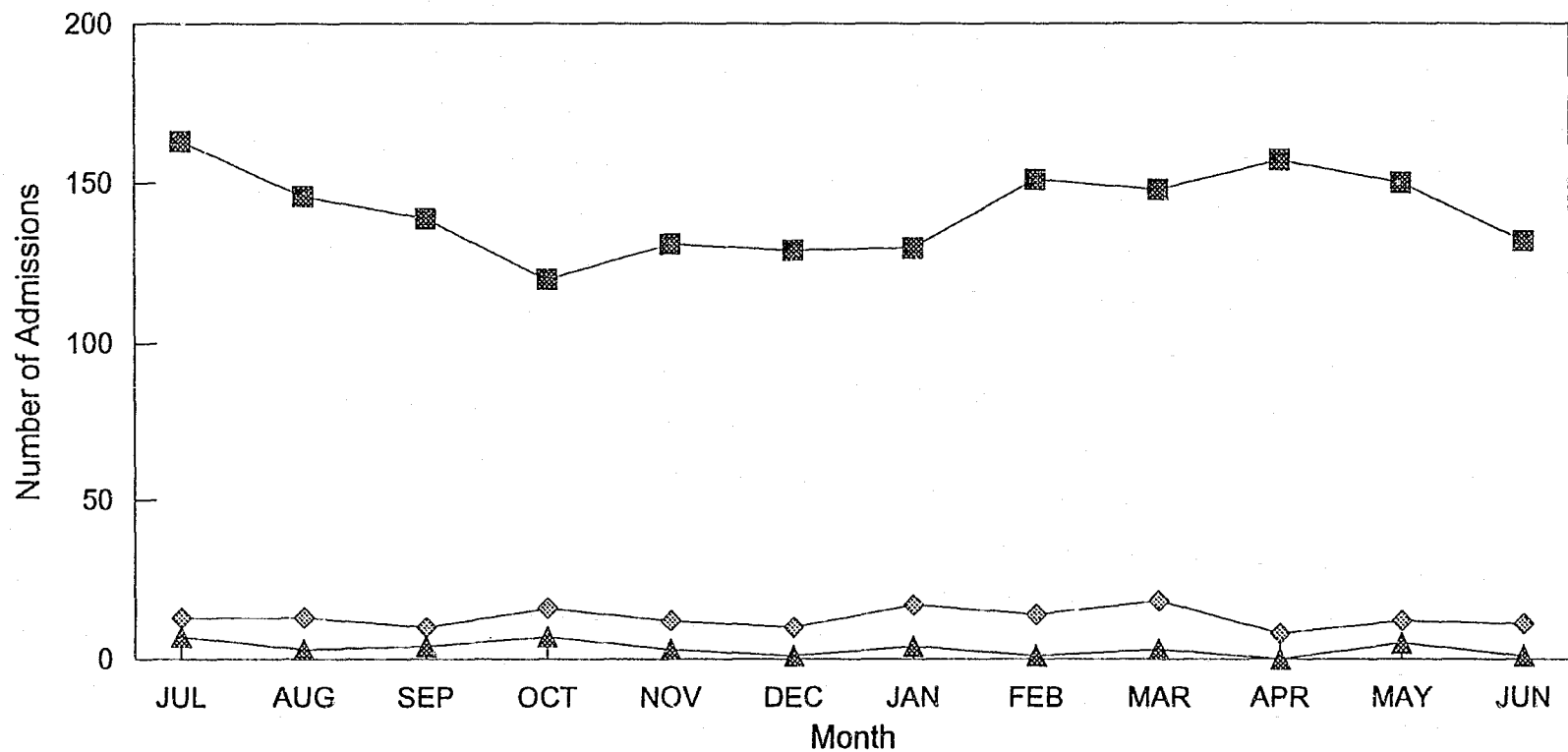

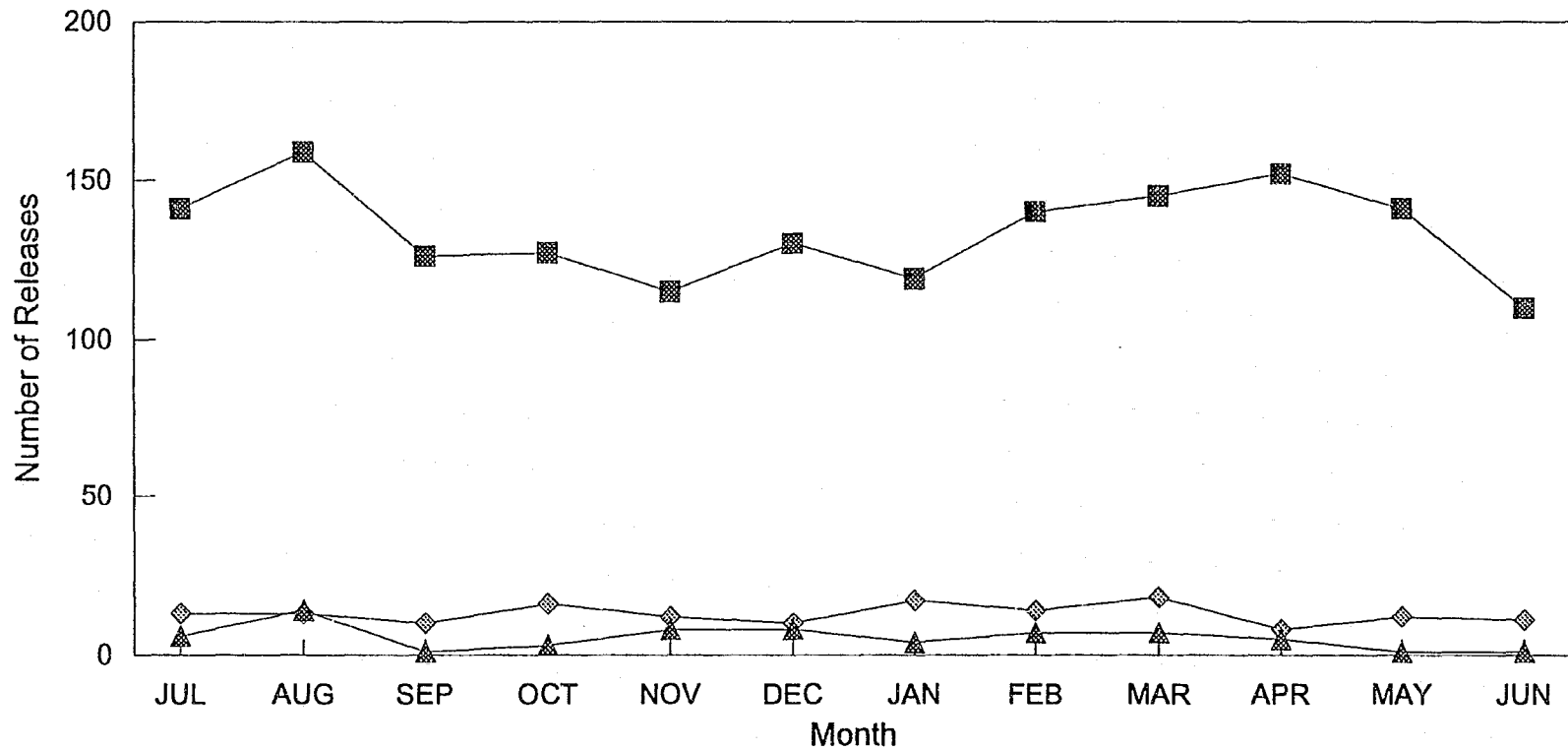

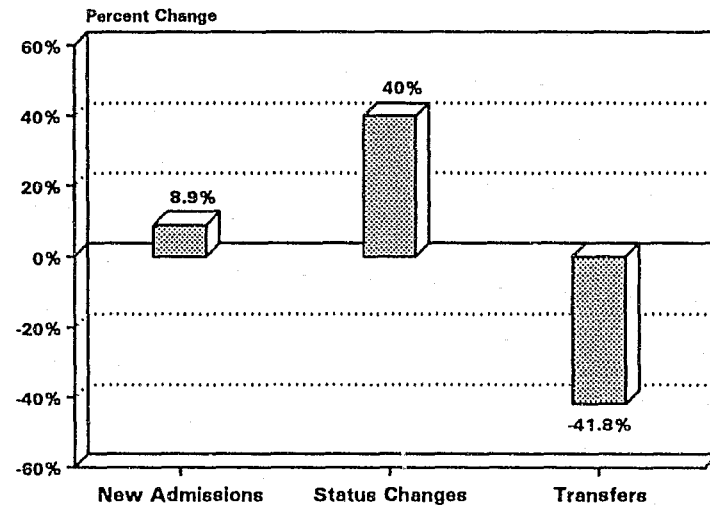
**PERCENT CHANGE IN POPULATIONS,

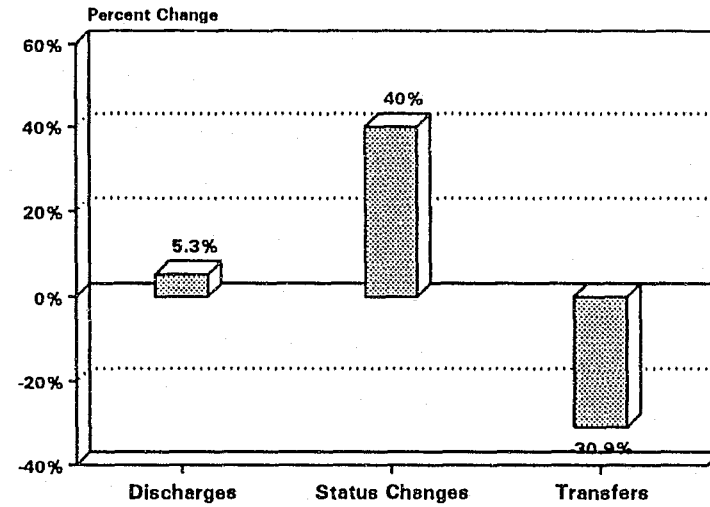

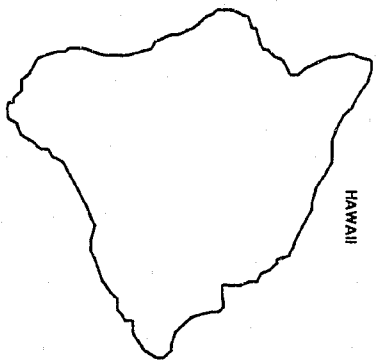
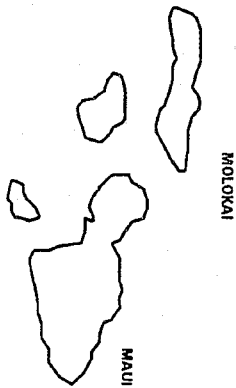
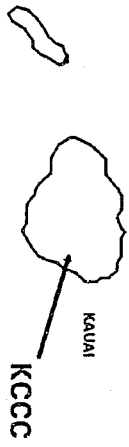


Percent Change in Number of Admissions

KAUAI COMMUNITY CORRECTIONAL CENTER

Summary

The Kauai Community Correctional Center (KCCC) is located on the island of Kauai approximately 5 miles outside of the county seat of Lihue. KCCC serves as the jail facility for the County of Kauai and most of the inmates are committed by the Fifth Judicial Circuit.

Total facility expenditures for fiscal year 1993-94 were \$1,540,988.

As of June 30, 1994, KCCC had jurisdiction over 105 inmates which represented a 59.1 percent increase from June 30, 1993.

During fiscal year 1993-94, the head count ranged from a low of 60 to a high of 84 and averaged 72. The head count of 79 on June 30, 1994 was an increase of 79.5 percent from June 30, 1993. Most of the increase occurred for sentenced felons and pretrial felons. Sentenced felons comprised about one-third of the population while pretrial felons accounted for slightly over one-fourth of the inmates at KCCC.

During fiscal year 1993-94, KCCC experienced an increase of 37.0 percent in the total number of new admissions to the facility from 424 to 581. The slight drop in the number of pretrial felon admissions was offset by significant gains in the number of pretrial misdemeanor and sentenced misdemeanor admissions. Pretrial misdemeanor admissions accounted for 31.5 percent of the admissions, pretrial felons for 27.5 percent, and sentenced misdemeanants for 22.7 percent.

The total number of discharges increased by 27.3 percent from 400 to 509. Similar to the admission statistics, the slight drop in the number of pretrial felon discharges was offset by significant gains in the number of pretrial misdemeanor and sentenced misdemeanor discharges. One-third of those released were sentenced misdemeanants, one-fourth were pretrial felons, and an additional one-fourth were pretrial misdemeanants.

The total number of status changes of 114 was an increase of 37.3 percent from the previous fiscal year. Sentenced misdemeanants accounted for most of the increase and approximately one-half of the status change admissions. Pretrial misdemeanants accounted for most of the increase and approximately one-half of the status change releases.

The total number of transfers to the facility increased by 1.8 percent from 56 to 57. Six out of every ten of the incoming transfers were sentenced felons.

The total number of transfers from the facility decreased by 32.4 percent from 105 to 71. Most of the decrease occurred in the number of sentenced felons and pretrial felons transferred from the facility. For every ten of these outgoing transfers, four were sentenced felons and three were pretrial felons.

Note: The impact of Hurricane Iniki on the KCCC facility operations during fiscal year 1992-93 had a substantial affect on the percent changes in the inmate population, the number of admissions, and the number of releases.

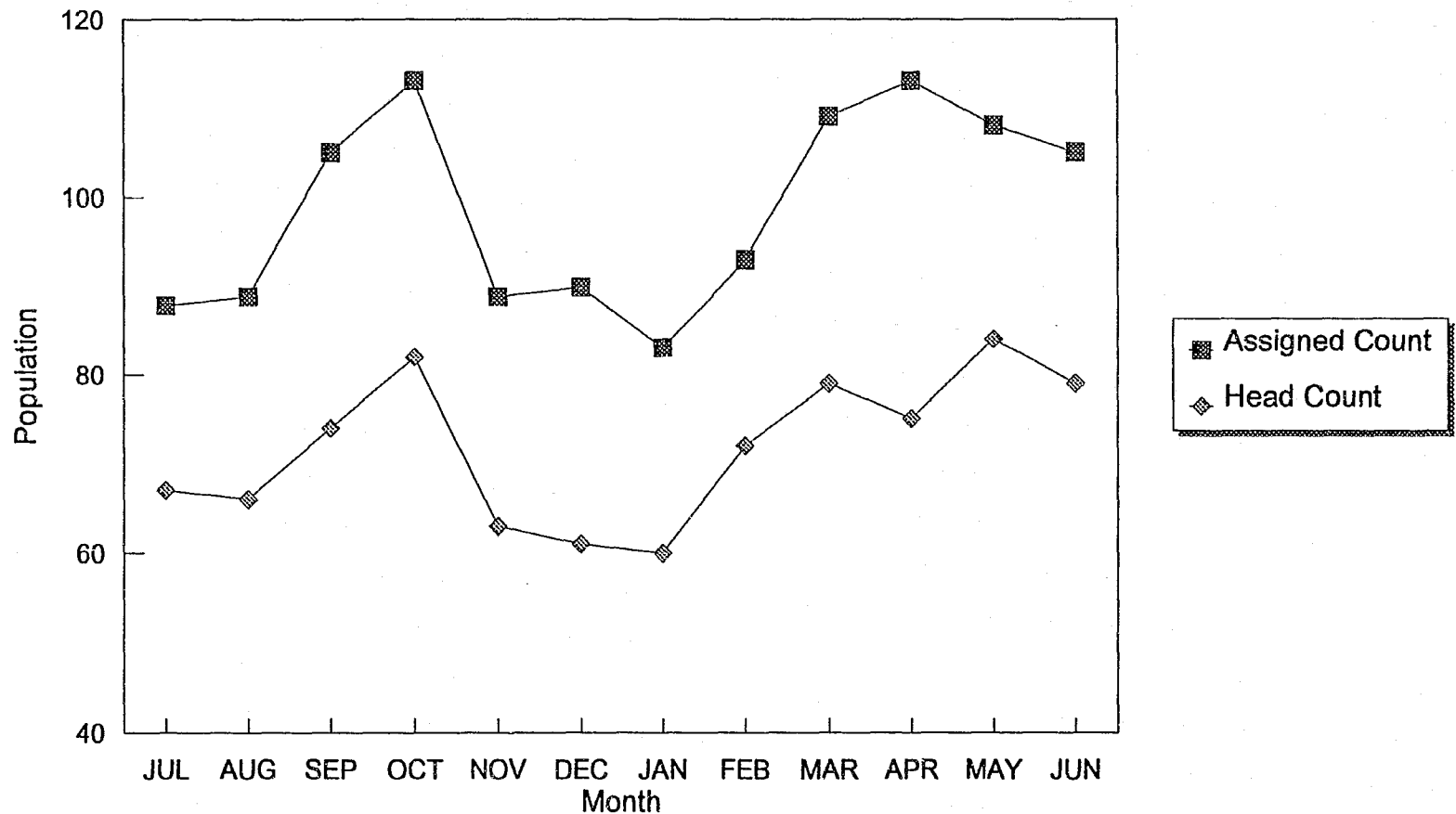

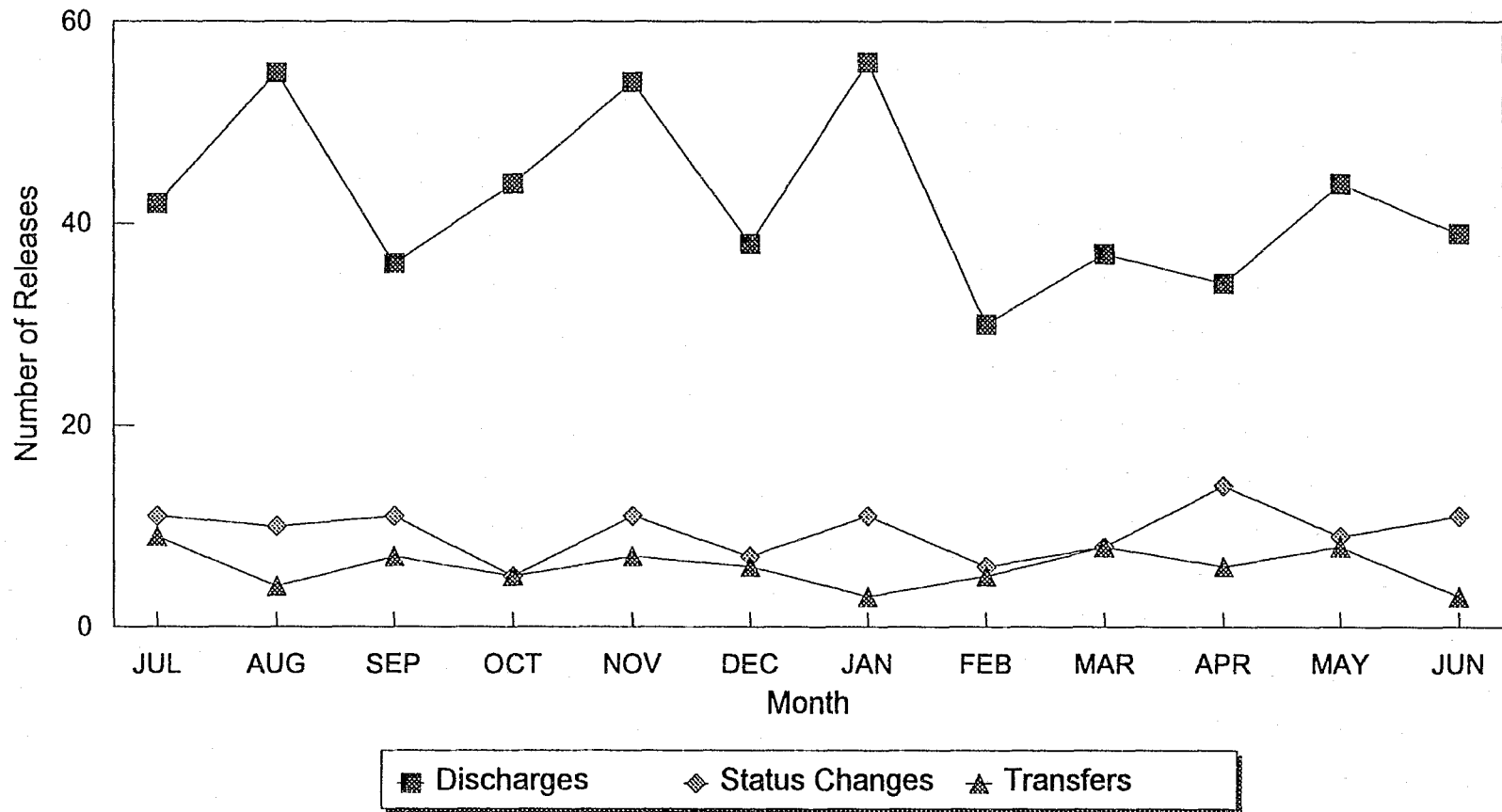

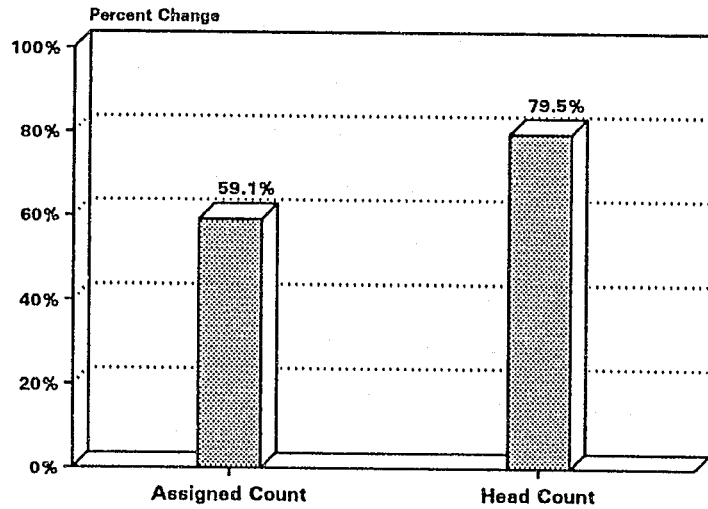
**PERCENT CHANGE IN POPULATIONS,

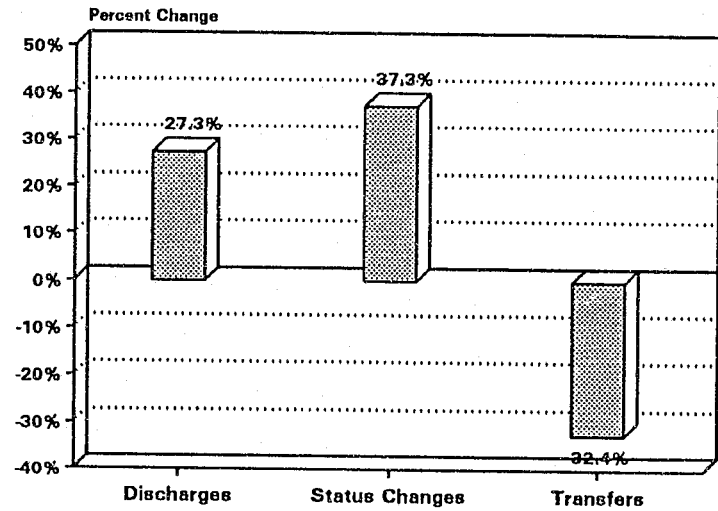
Percent Change in Number of Admissions



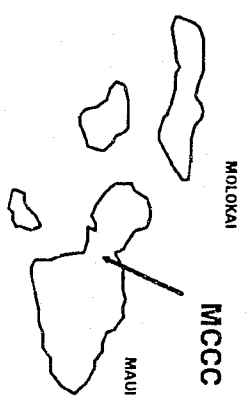
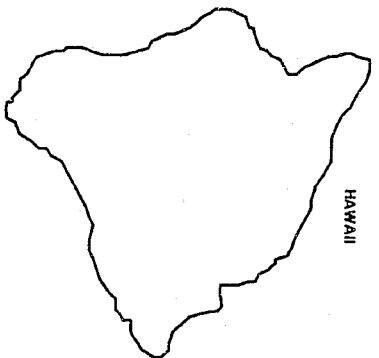
Percent Change in Populations



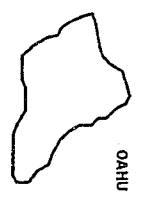
Percent Change in Number of Releases

Summary

The Maui Community Correctional Center (MCCC) is located in Wailuku, Maui. As the jail facility for Maui County, the facility primarily houses inmates who are committed by the Second Judicial Circuit.

Total facility expenditures for fiscal year 1993-94 were \$3,698,668.

The assigned count was 240 on June 30, 1994. This population represented an increase of 8.6 percent from June 30, 1993.

The head count during fiscal year 1993-94 ranged from a low of 176 to a high of 200 and averaged 191. On June 30, 1994, the head count of 200 was an increase of 3.6 percent from June 30, 1993. The facility population was comprised primarily of sentenced felons, pretrial felons, and sentenced felon probationers.

During fiscal year 1993-94, the number of new admissions to the facility increased by 18.3 percent and reached a total of 1,032. Sentenced misdemeanor admissions increased by 20.6 percent and accounted for approximately four out of every ten admissions.

The facility discharged 1,010 inmates during fiscal year 1993-94, an increase of 26.7 percent from fiscal year 1992-93. The number of sentenced misdemeanants increased by 28.1 percent while the number of sentenced felon probationers increased by 53.9 percent. Almost one-half of the discharges were sentenced misdemeanants. Pretrial felons accounted for 20.5% of the discharges and sentenced felon probationers 13.6% of them.

The total number of status changes of 92 was the same as the previous fiscal year. A decrease in status change admissions occurred for sentenced felon probationers offset by an increase of 142.9 percent for sentenced misdemeanants. A large proportion of the status change admissions were comprised of sentenced felons, sentenced felon probationers, and sentenced misdemeanants. A decrease in status change releases occurred for pretrial felons which was offset by an increase of 88.9 percent in pretrial misdemeanants. A large proportion of the status change releases were comprised of pretrial felons and pretrial misdemeanants.

The number of transfers to the facility decreased by 2.0 percent from 98 to 96. About seven of every ten of these transfers were sentenced felons.

The number of transfers from the facility increased by 31.2 percent from 93 to 122. Sentenced felons and pretrial felons accounted for most of the percentage increase and proportion of transfers.

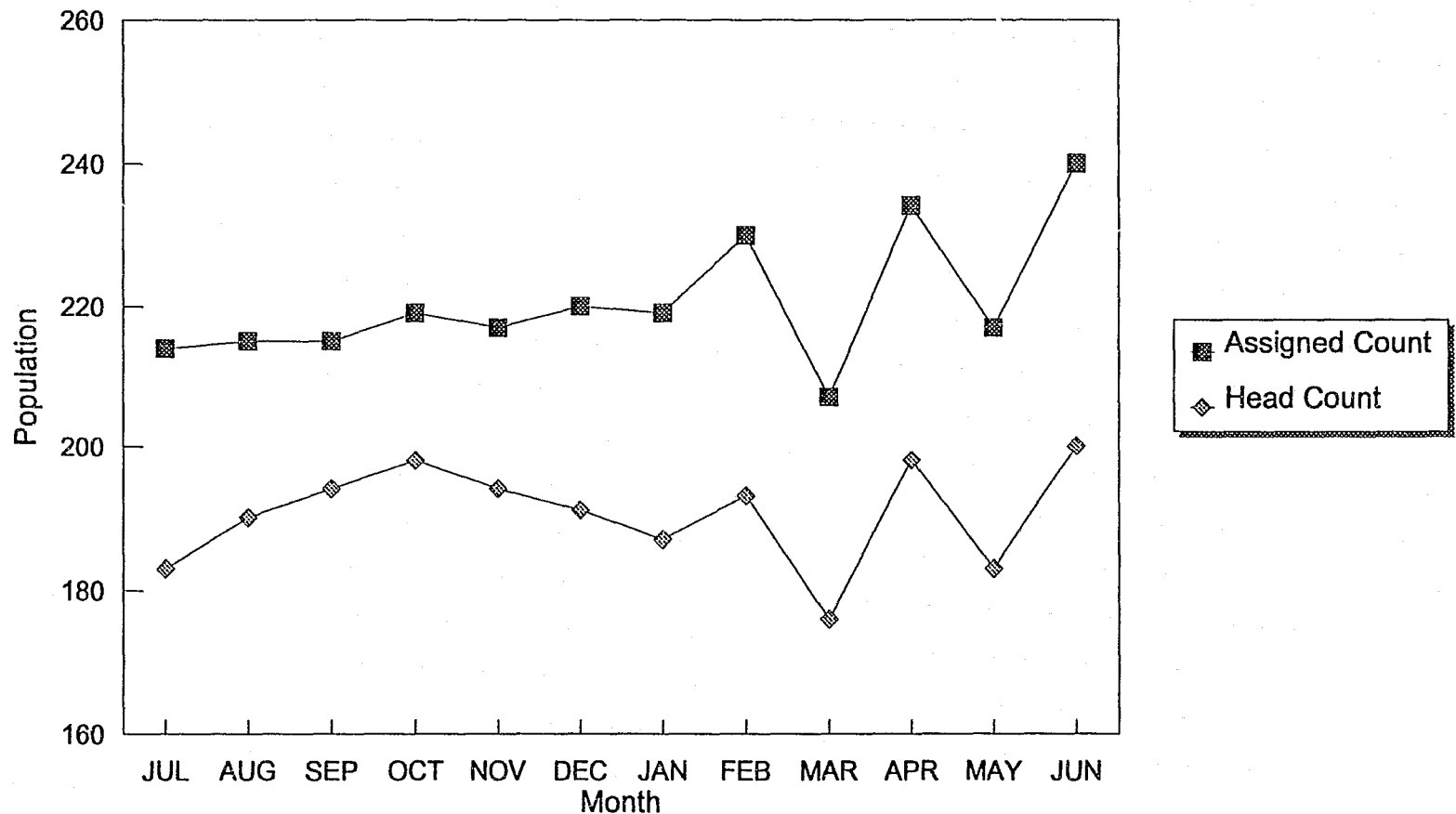

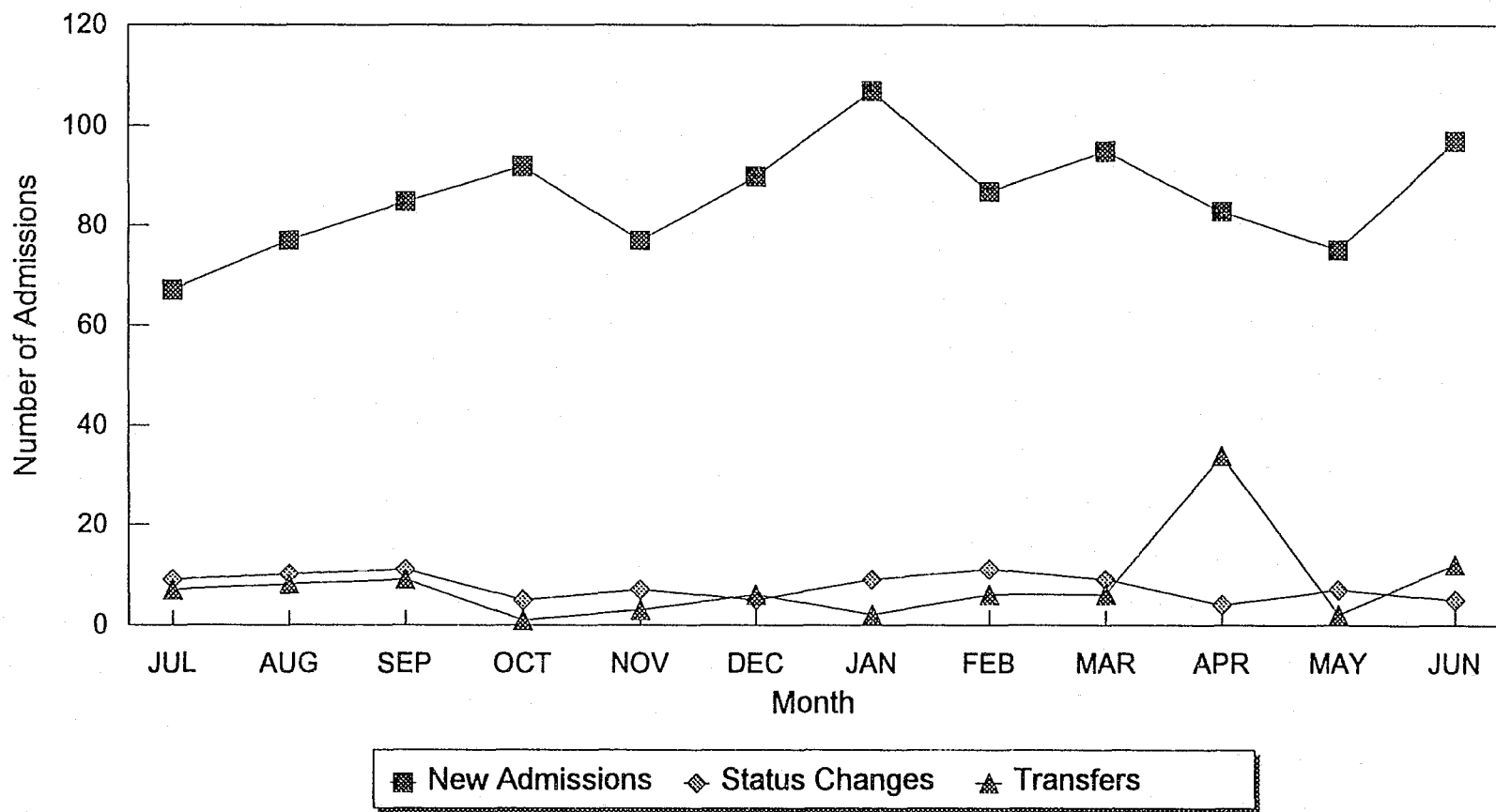

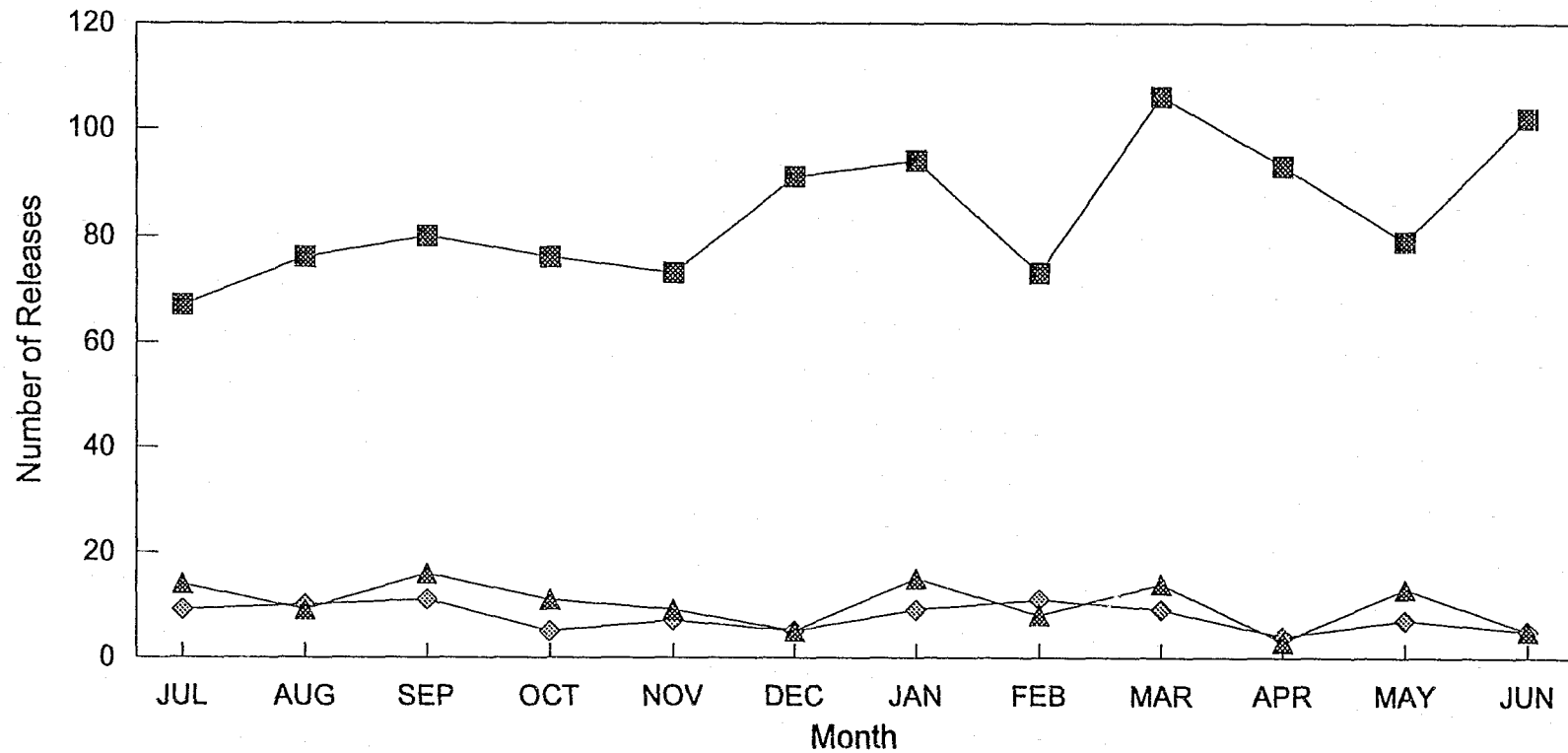

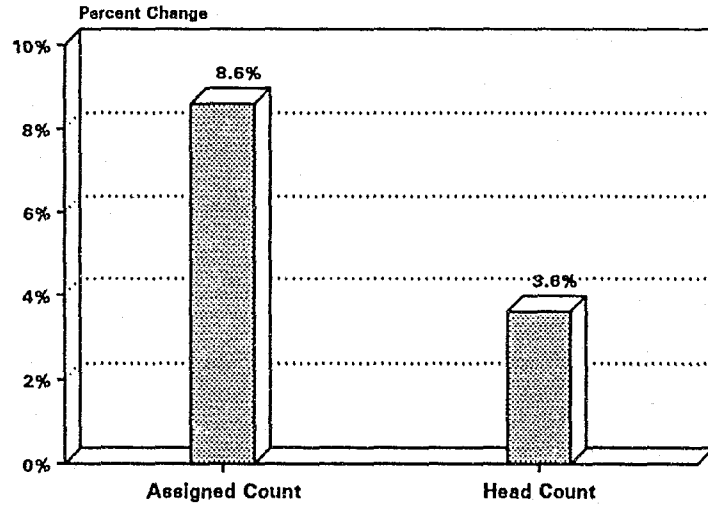
**PERCENT CHANGE IN POPULATIONS,

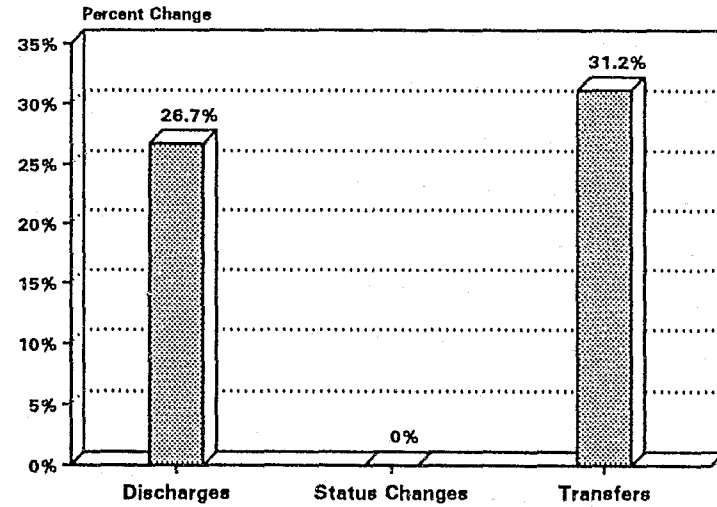
Percent Change in Number of Admissions



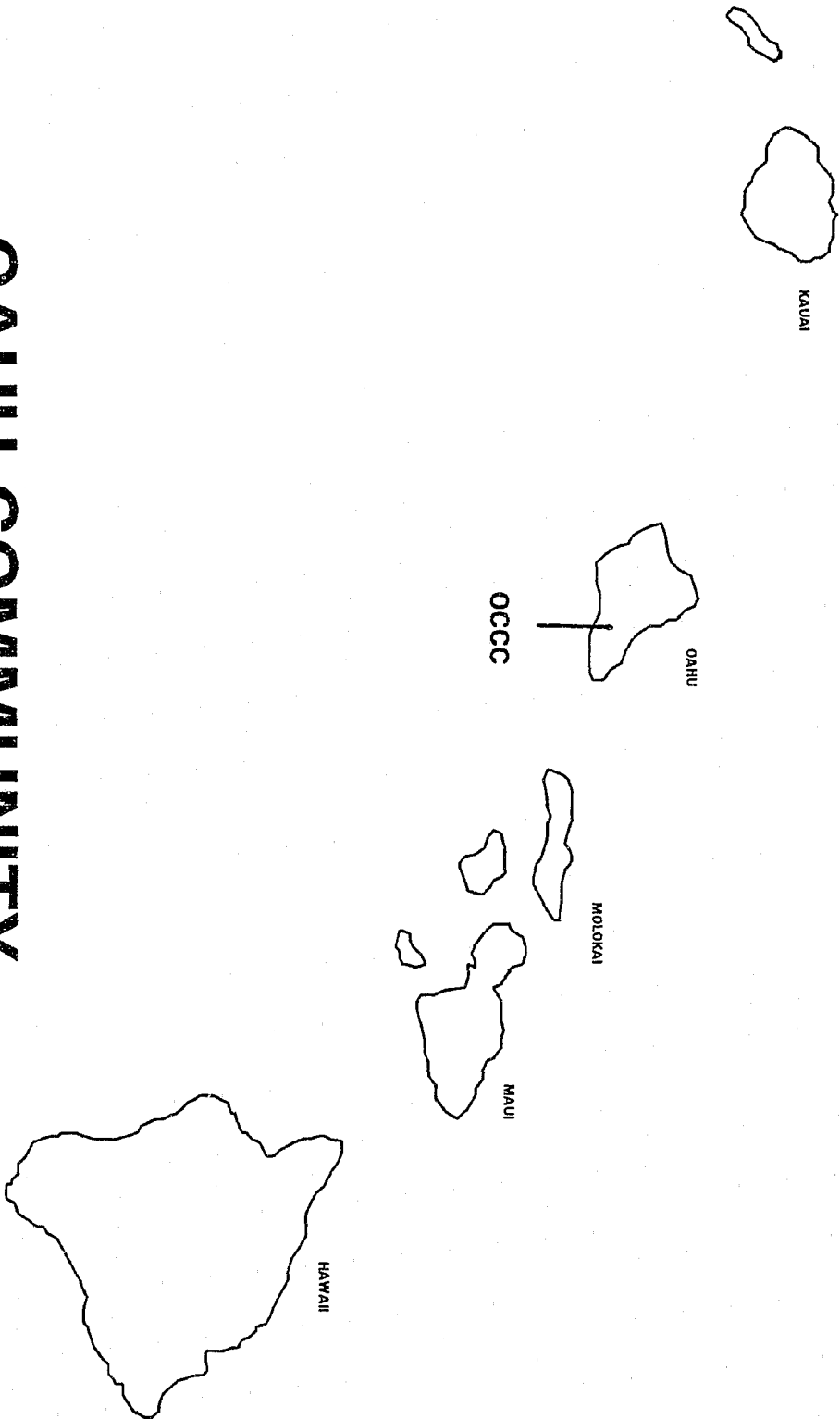
Percent Change in Populations

Summary

The Oahu Community Correctional Center (OCCC) serves primarily as the jail facility for the First Judicial Circuit. It also serves as the community service and work furlough program for sentenced felons prior to release back into the community.

Total facility expenditures for fiscal year 1993-94 were \$18,650,210.

The assigned count of 918 on June 30, 1994 was a decrease of 0.6 percent from June 30, 1993.

The head count at OCCC during fiscal year 1993-94 ranged from a low of 734 to a high of 865 and averaged 807. From June 30, 1993 to June 30, 1994, the total head count decreased by 9.5 percent to 758. The number of pretrial felons decreased by 12.5 percent and the number of sentenced felons fell by 9.5 percent. A large portion of the inmate population was made up of pretrial felons and sentenced felons.

With an increase of 5.2 percent during fiscal year 1993-94, the facility had a total of 4,572 new admissions. The number of pretrial misdemeanor admissions increased by 32.4 percent and the number of pretrial felon admissions rose by 9.1 percent. Pretrial felons and pretrial misdemeanants accounted for two-thirds of the new admissions during the fiscal year.

The facility discharged 3,811 inmates during fiscal year 1993-94, an increase of 10.3 percent from fiscal year 1992-93. Pretrial misdemeanor discharges increased by 56.9 percent from the previous fiscal year. Sentenced misdemeanants, pretrial misdemeanants, and pretrial felons together accounted for three-fourths of the discharges.

The number of status changes decreased slightly by 1.7 percent to 1,549. Sentenced misdemeanants, sentenced felon probationers, and sentenced felons made up large portions of the total number of status change admissions. Two-thirds of the status change releases were comprised of pretrial misdemeanants and pretrial felons.

The number of transfers to the facility increased by 9.8 percent from 377 to 414. Most of these transfers were sentenced felons.

The number of transfers from the facility decreased by 7.5 percent from 1,206 to 1,116. One-third of the transfers from OCCC were pretrial felons and another third of them were technical violators.

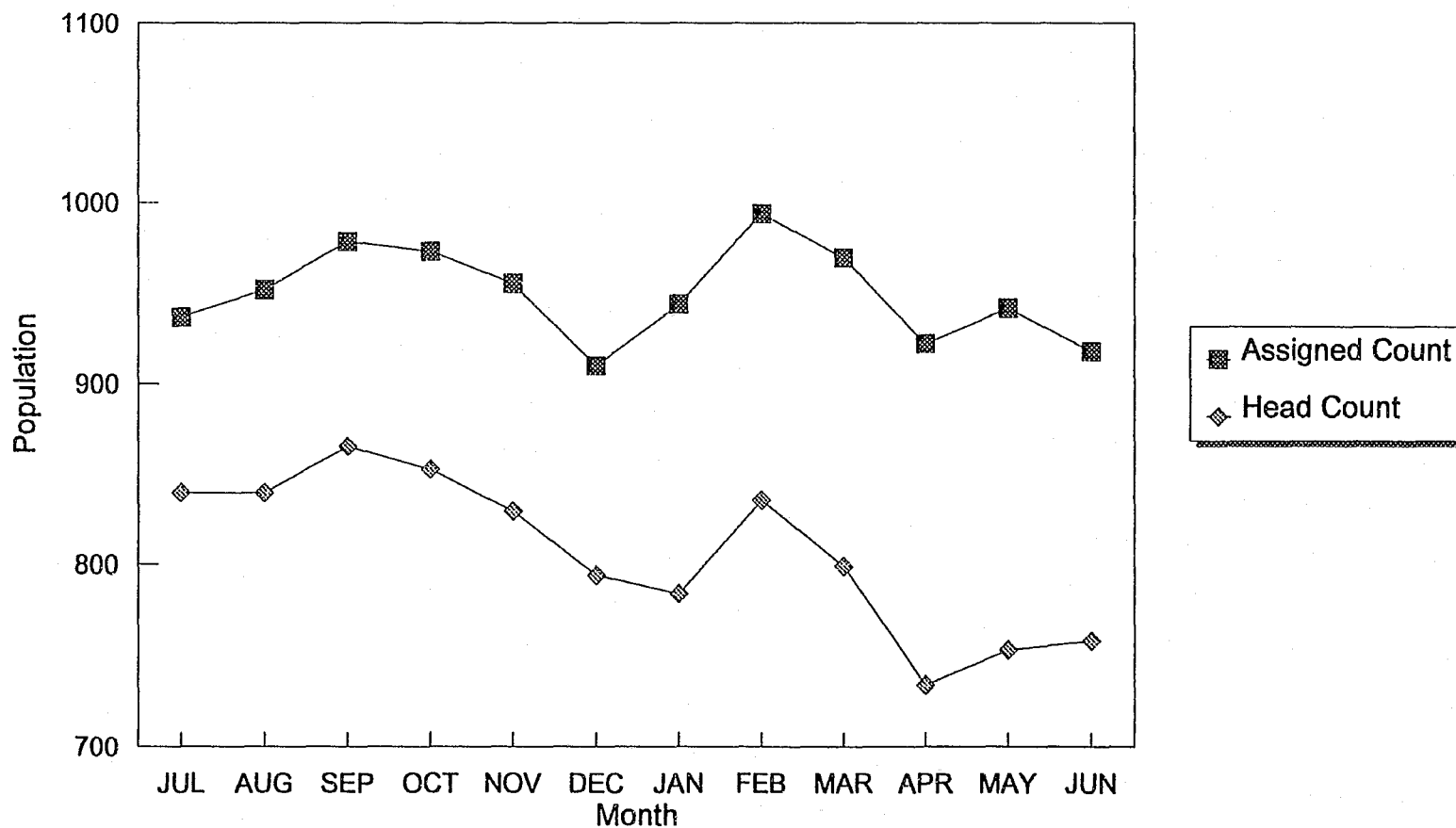

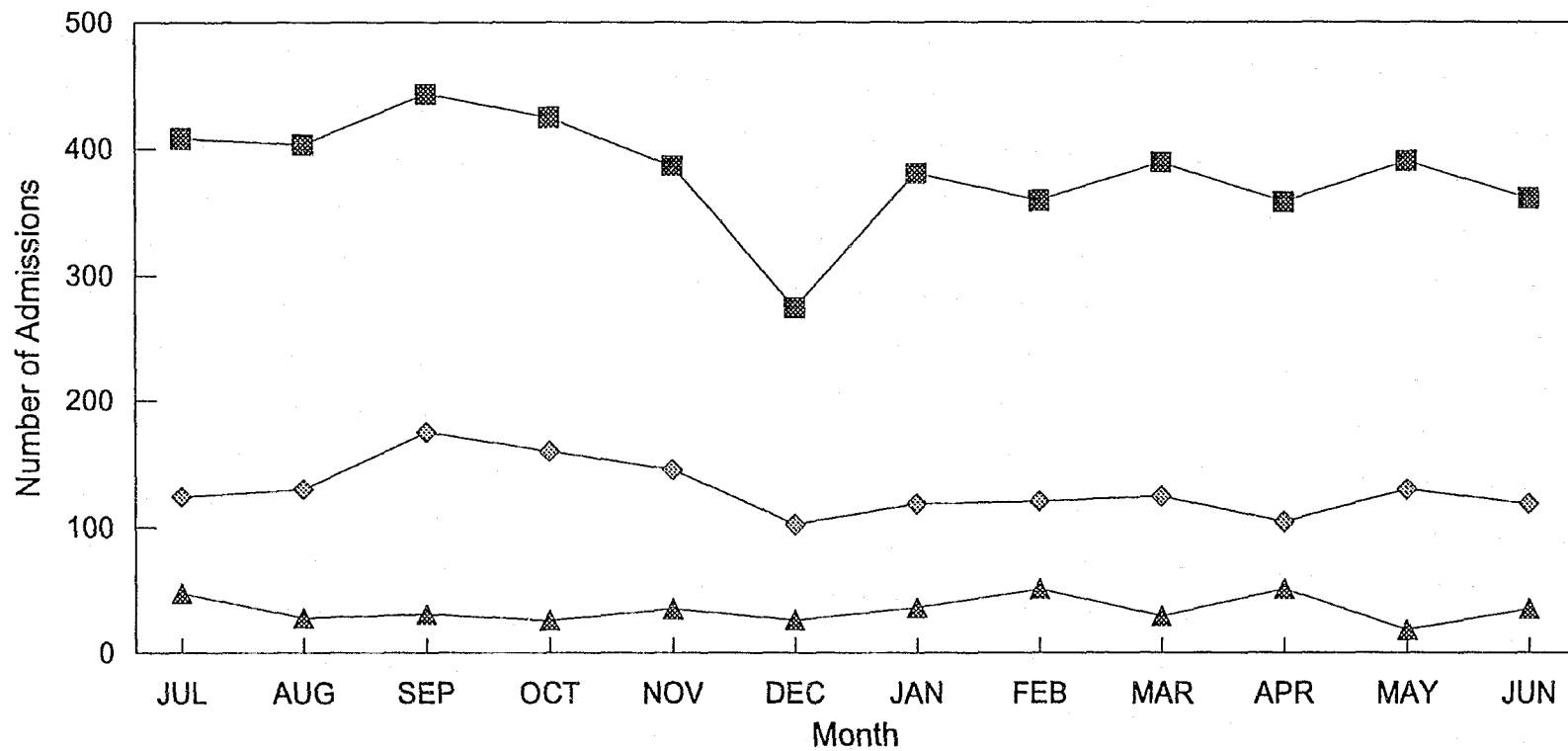

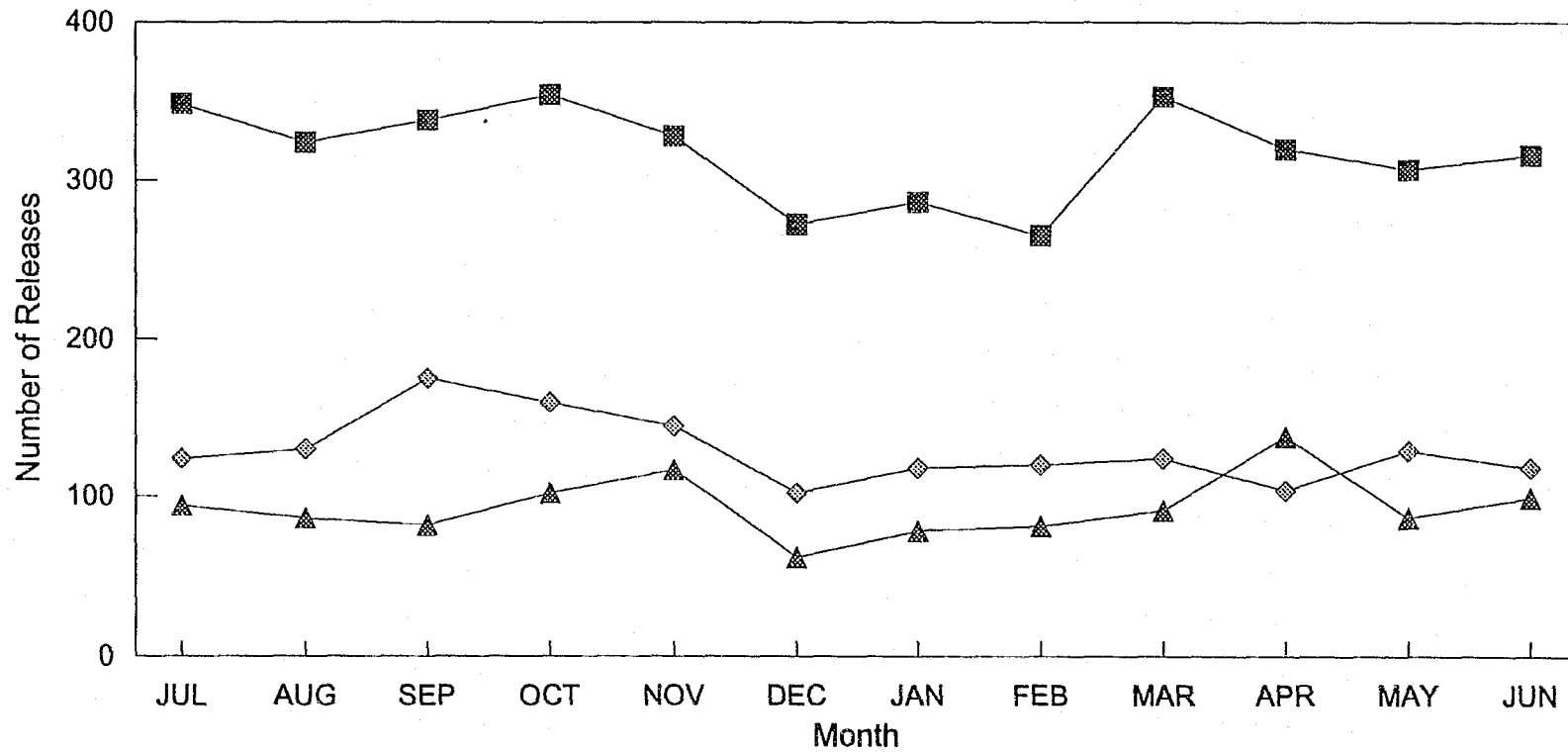

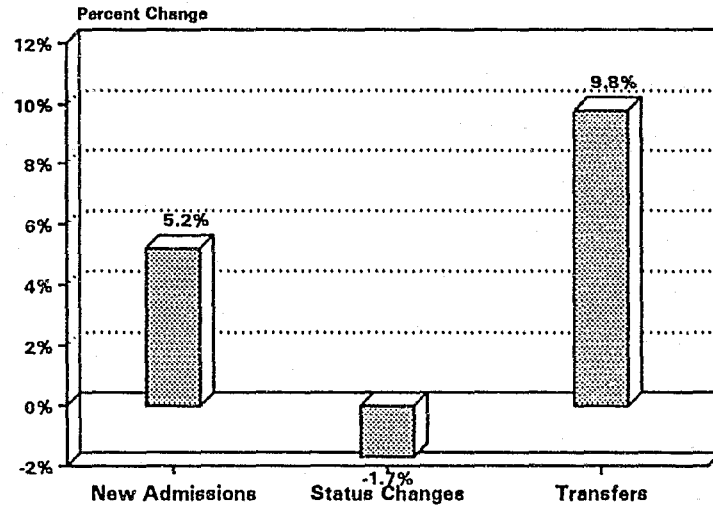

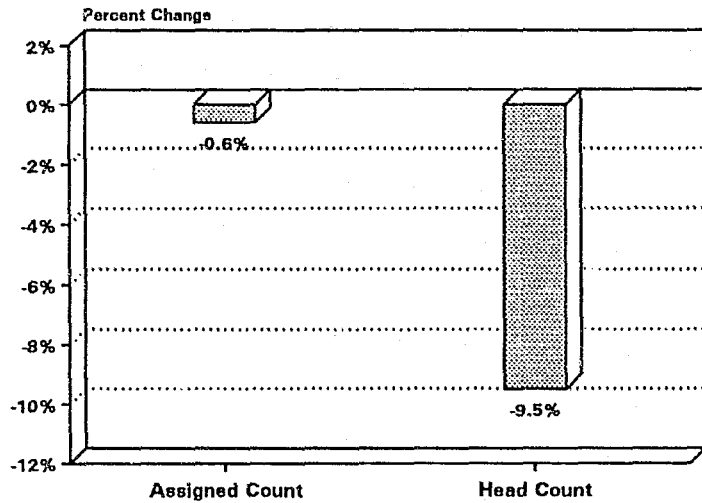

OAHU COMMUNITY CORRECTIONAL CENTER**

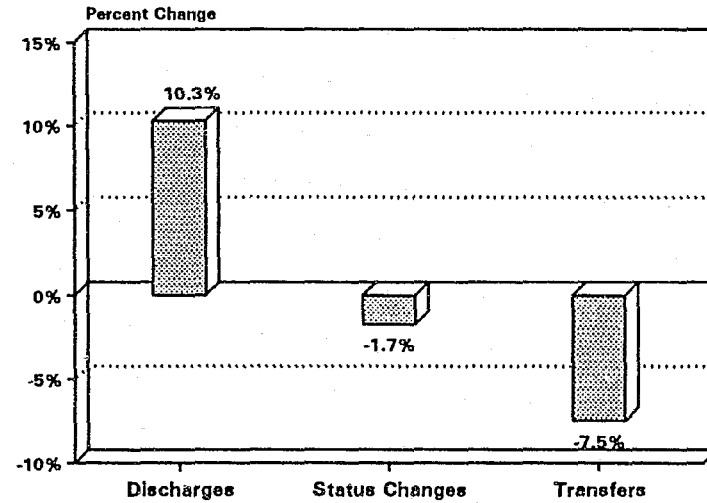
Percent Change in Number of Admissions



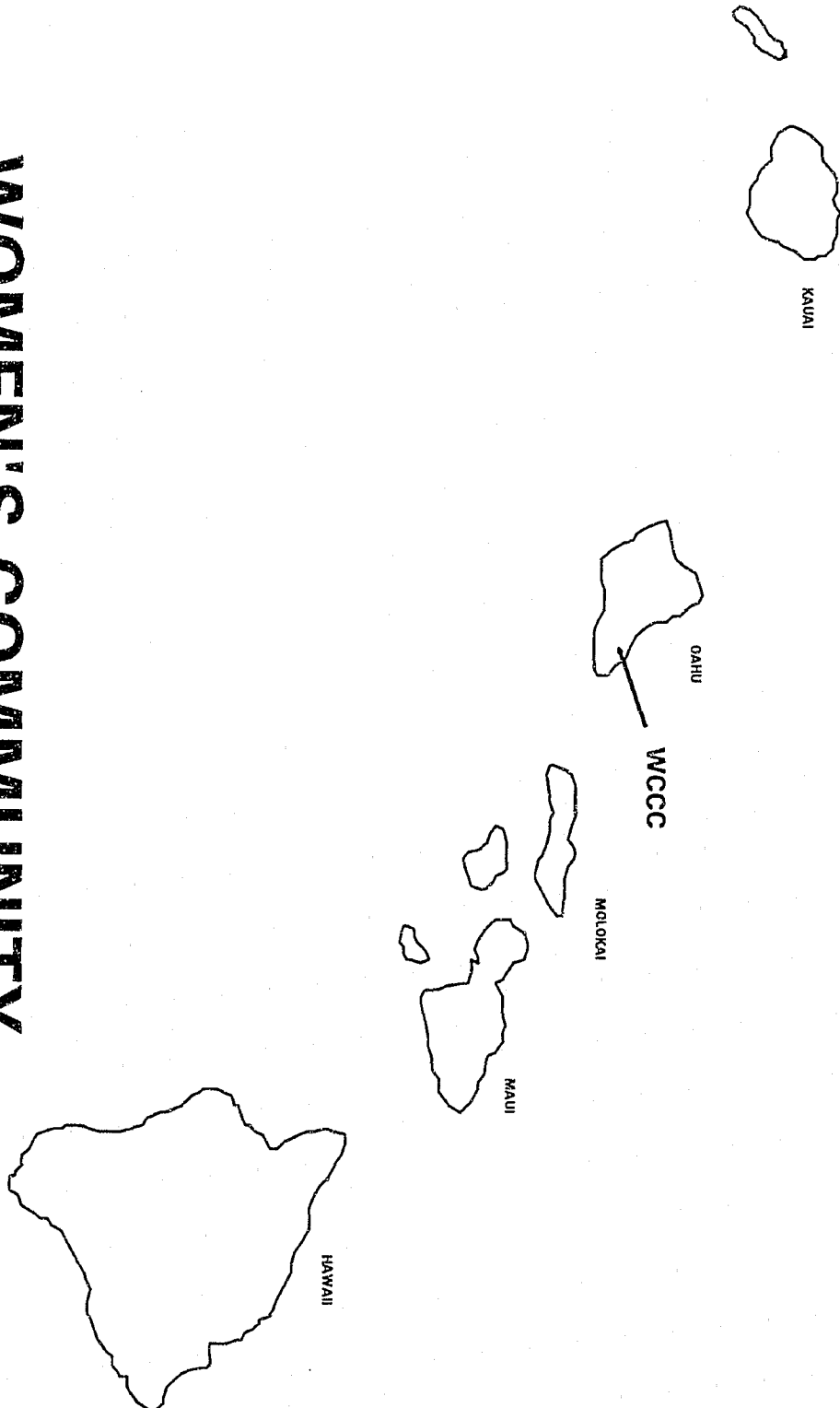
Percent Change in Populations

Summary

The Women's Community Correctional Center (WCCC) is located on the windward side of Oahu. The facility primarily held sentenced female offenders. The facility also housed female pretrial detainees when beds were unavailable at their respective community correctional center

Total facility expenditures for fiscal year 1993-94 were \$3,353,368.

The facility had an assigned count of 167 on June 30, 1994, an increase of 3.7 percent from June 30, 1993.

The head count at WCCC during fiscal year 1993-94 ranged from a low of 94 to a high of 119 and averaged 105. The facility had a head count of 103 on June 30, 1994, a decrease of 16.3 percent from June 30, 1993. Sentenced felons and pretrial felons accounted for most of the inmate population.

The total number of new admissions of 76 represented an increase of 33.3 percent from the previous fiscal year. Sentenced misdemeanants and technical violators had the largest increases and represented about one-half of the new admissions.

The facility discharged 360 inmates during fiscal year 1993-94, an increase of 41.7 percent from fiscal year 1992-93. Sentenced misdemeanants, sentenced felon probationers, and sentenced felons had the largest increases and represented about seven out of every ten inmates released.

The total number of status changes of 112 during fiscal year 1993-94 was an increase of 15.5 percent from the previous fiscal year. Sentenced felon and sentenced misdemeanant status change admissions increased while status change admissions for sentenced felon probationers decreased. Sentenced misdemeanants accounted for about two out of every five status change admissions, sentenced felons three out of every ten, and sentenced felon probationers one out of every five. Status change releases for pretrial felons and misdemeanants increased from the previous fiscal year and comprised about three out of every five status change releases.

The number of transfers to the facility increased by 6.2 percent from 259 to 275. Most of the increase occurred for pretrial felons and for pretrial misdemeanants. Pretrial felons and pretrial misdemeanants also comprised approximately one-half of the incoming transfers.

The number of transfers from the facility decreased by 5.7 percent from 53 to 50. A decrease in the number of transfers of 26.1 percent for pretrial felons was offset by an increase of 37.5 percent for sentenced felons. Over one-half of the outgoing transfers were pretrial felons and sentenced felons.

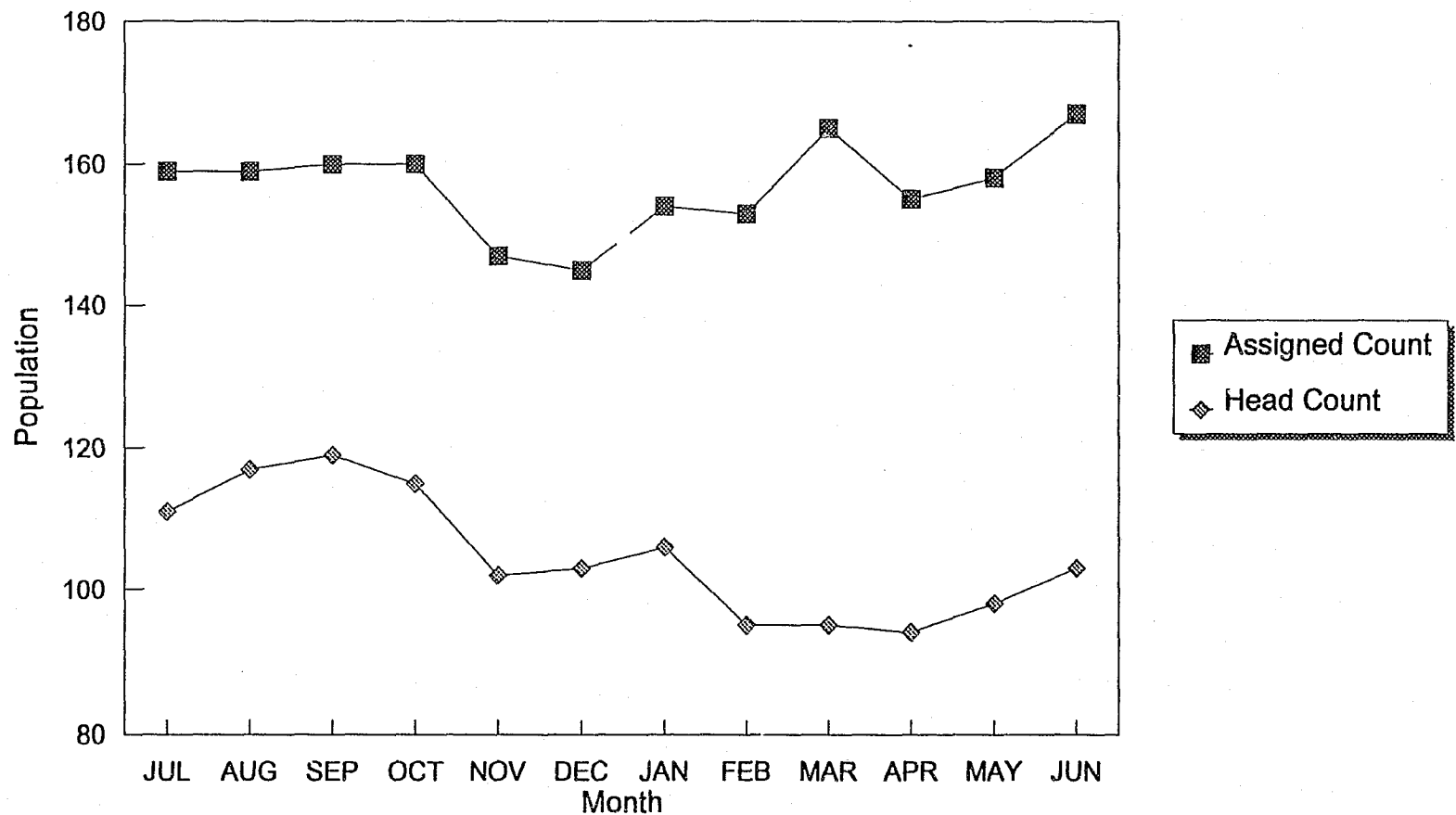

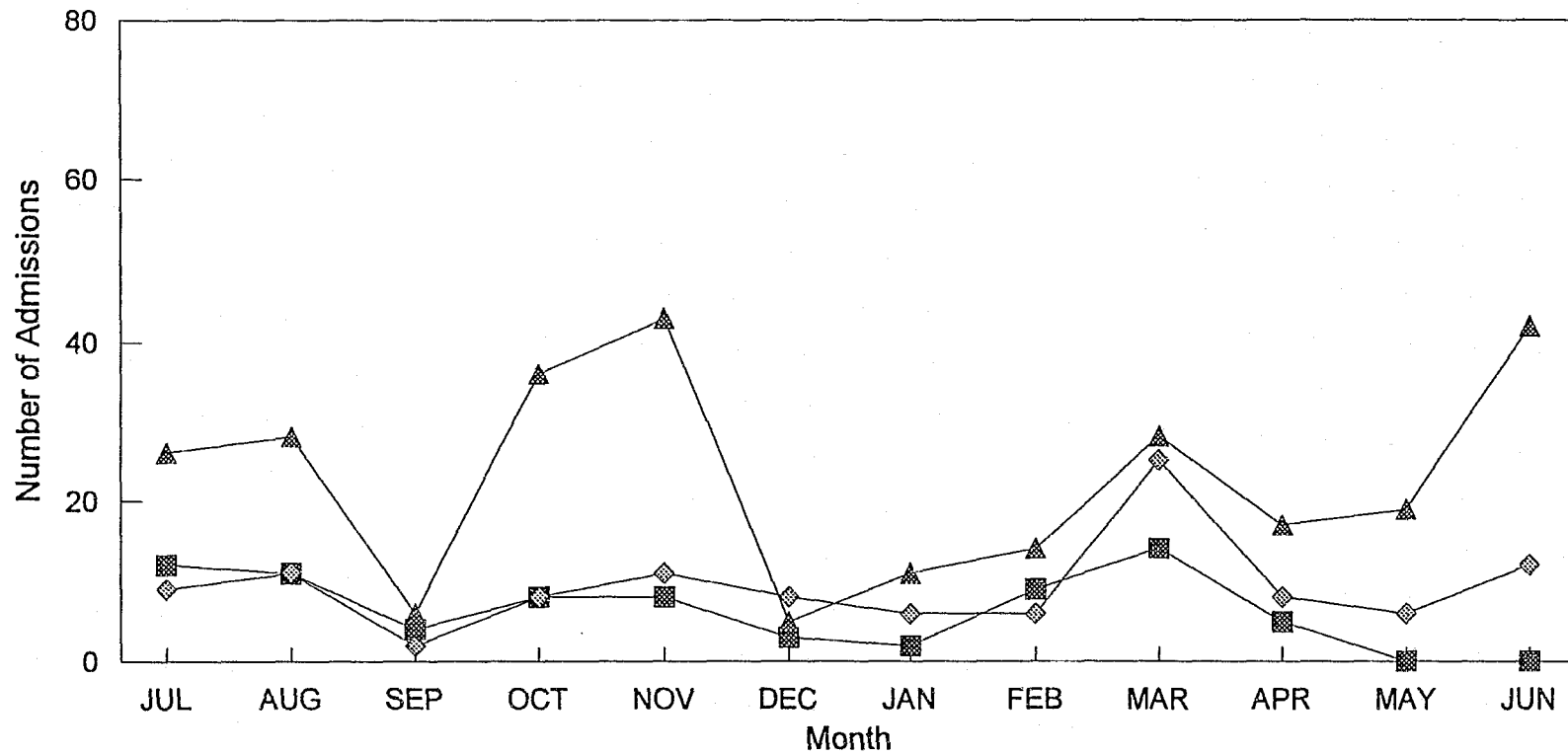

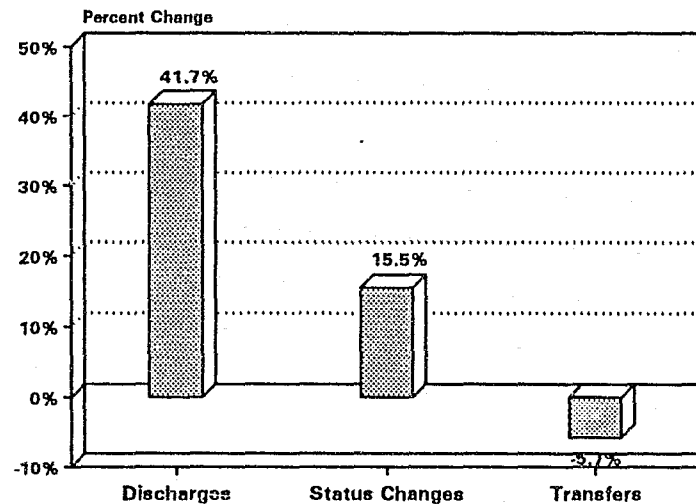
Percent Change in Number of Admissions



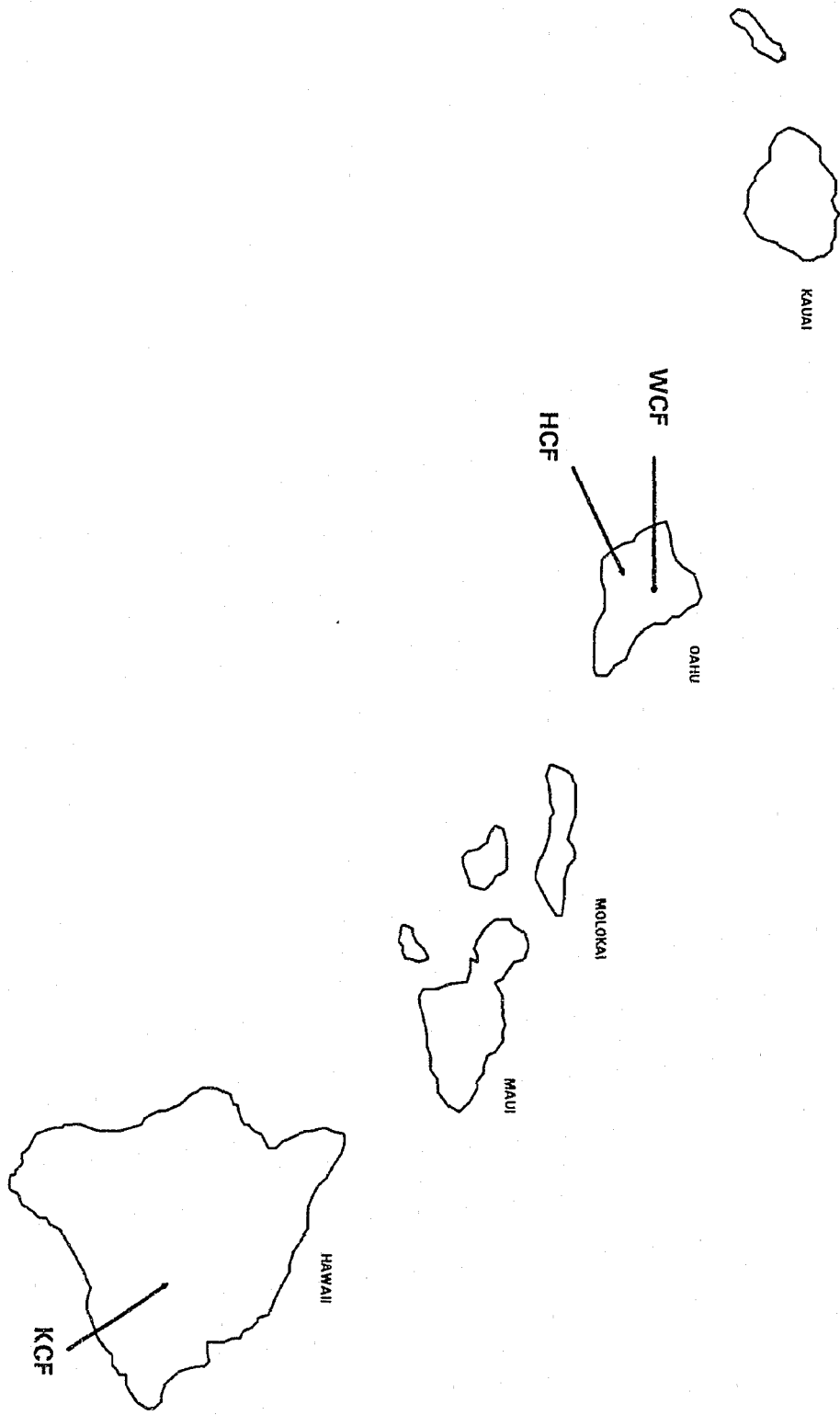
Percent Change in Populations

Summary

The Corrections Division operated three Correctional Facilities (CFs): the Halawa Correctional Facility, the Kulani Correctional Facility, and the Waiawa Correctional Facility located on two islands.

Total facility expenditures at the CFs for the fiscal year were \$23,849,299.

Between June 30 of 1993 and 1994, the assigned count at the CFs increased by 0.9 percent from 1,603 to 1,618.

The head count ranged from a low of 1,517 to a high of 1,560 and averaged 1,548. The head count of 1,545 on June 30, 1994 was an increase of 0.4 percent from June 30, 1993. Over three-fourths of the inmate population were sentenced felons.

During the fiscal year, the number of new admissions decreased by 3.3 percent to 349. Most of these new admissions were other jurisdiction detainees.

The total number of discharges decreased by 15.4 percent to 856. The number of other jurisdiction detainees decreased by 28.9 percent from the previous fiscal year. Of every ten discharges, four were other jurisdiction detainees, three were sentenced felons, and two were technical violators.

The number of status changes decreased by 14.7 percent from 116 to 99 during fiscal year 1993-94. Sentenced felon status change admissions decreased by 25.5 percent and comprised almost three-fourths of the status change admissions. Technical violator status change releases decreased by 21.9 percent and accounted for approximately three out of every five status change releases.

The number of transfers to the CFs decreased by 1.7 percent to 1,619. Increases in transfer admissions for pretrial felons and technical violators were offset by a drop in transfer admissions of sentenced felons. Most of the transfers to the CFs were either sentenced felons or technical violators.

The number of transfers from the CFs increased by 12.2 percent from 959 to 1,076. Significant growth in transfers occurred for technical violators and sentenced felons. Most of the transfers were also comprised of sentenced felons or technical violators.

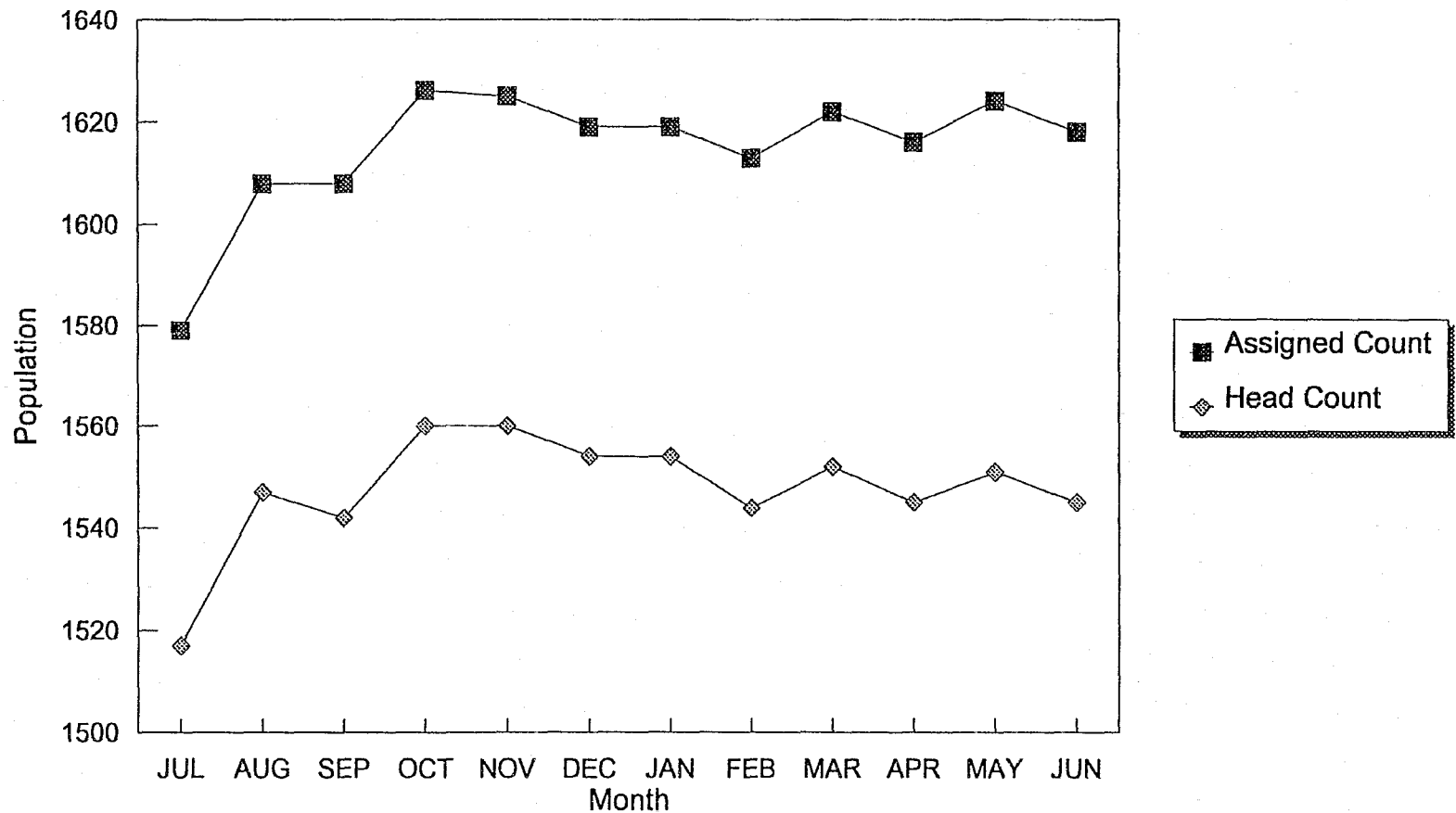

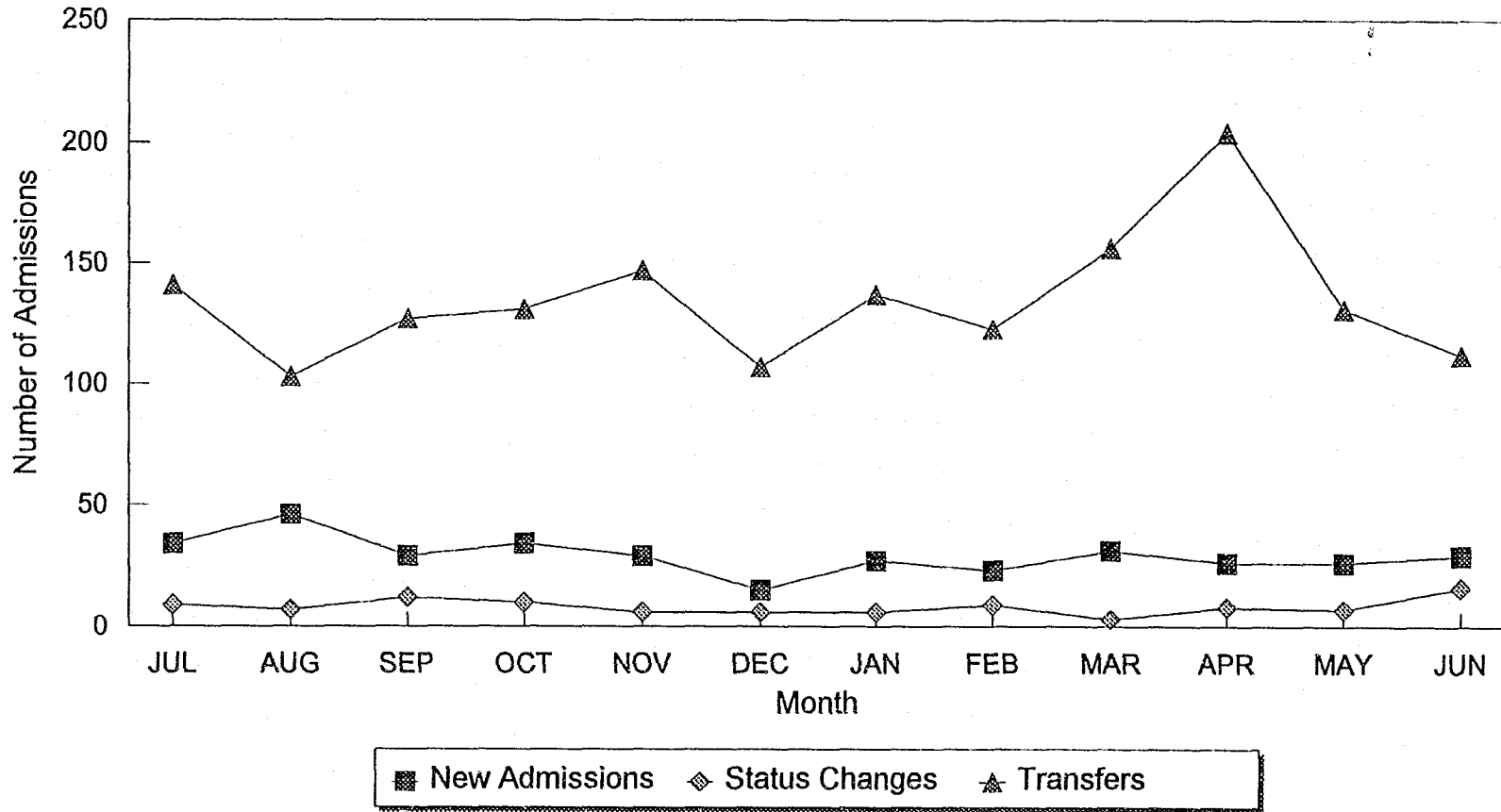

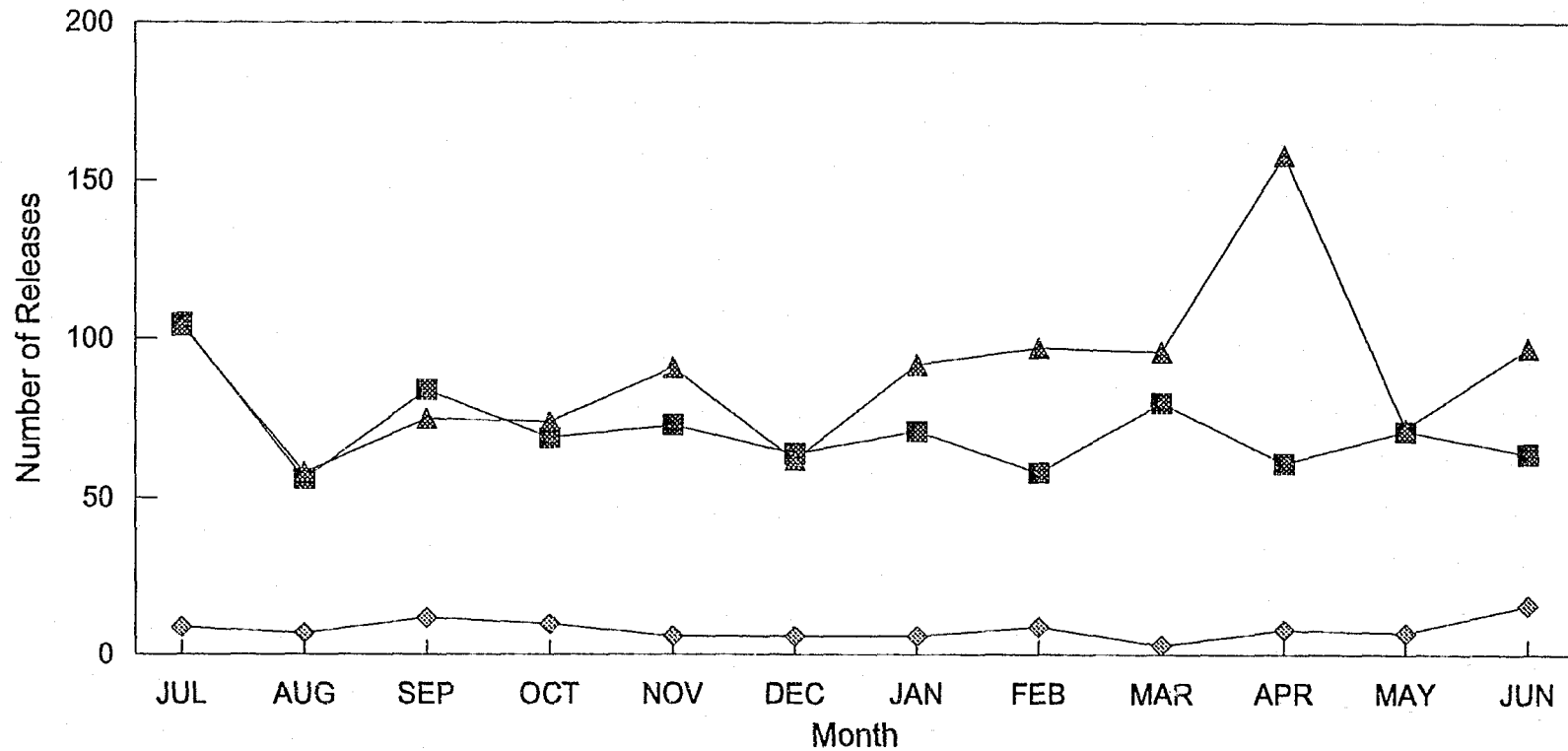

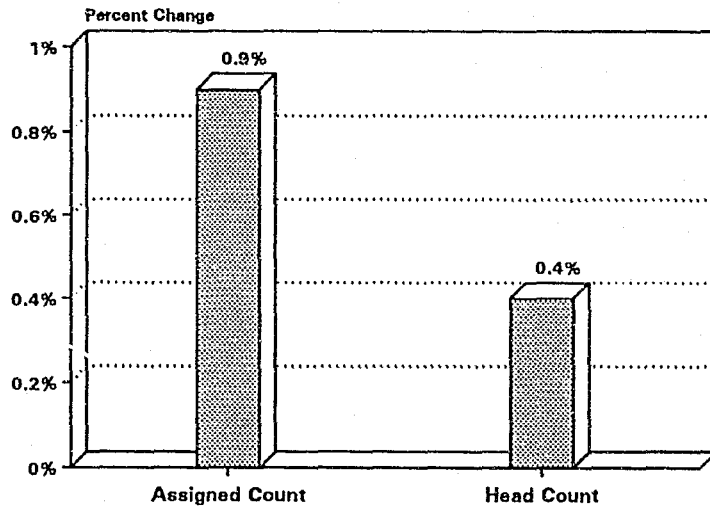

ALL CORRECTIONAL FACILITIES**

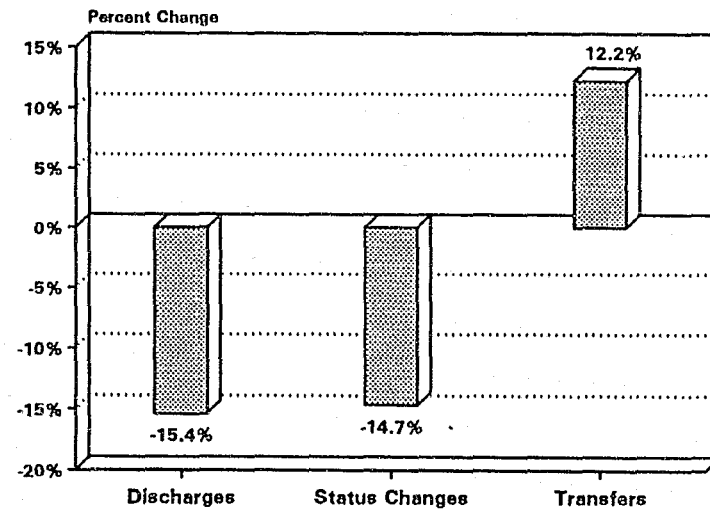
Percent Change in Number of Admissions



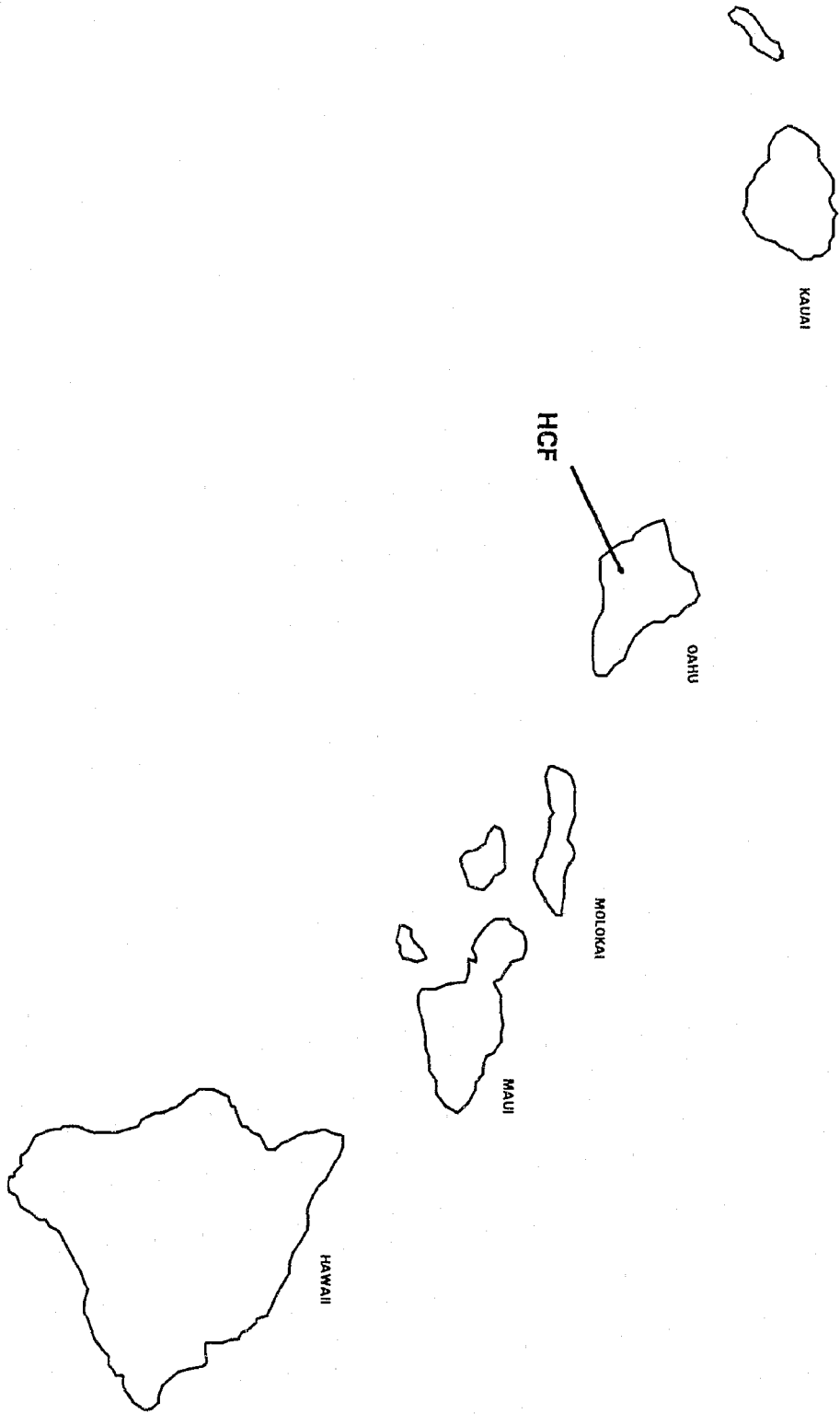
Percent Change in Populations

Summary

The Halawa Correctional Facility (HCF) is comprised of the Halawa Medium Security Facility (HMSF) and the Special Needs Facility (SNF). Located on the island of Oahu, the HMSF is the primary prison facility for male sentenced felons. The Reception, Assessment, and Diagnostic (RAD) unit, the Mental Health Unit, and Protective Custody cells are located at the SNF. Federal detainees are also held at the SNF.

Total facility expenditures for fiscal year 1993-94 were \$17,534,107.

On June 30, 1994, HCF had an assigned count of 1,240. This count represents a decrease of 0.4 percent from the assigned count on June 30, 1993.

During the 1993-94 fiscal year, the head count at HCF ranged from a low of 1,150 to a high of 1,191 and averaged 1,177. The head count on June 30, 1994 of 1,168 was a decrease of 1.2 percent from June 30, 1993. While a decrease of 11.9 percent in the number of sentenced felons occurred, it was offset by an increase in the number of technical violators and pretrial felons. The inmate population was comprised mainly of sentenced felons and technical violators.

The number of new admissions decreased by 3.3 percent from 361 to 349, primarily due to a decrease in the number of other jurisdiction inmates admitted to the facility. Other jurisdiction detainees accounted for most of the admissions during the fiscal year.

Primarily due to a drop in releases of other jurisdiction inmates, the number of discharges decreased by 15.6 percent from 879 to 742. Most of the discharges were other jurisdiction detainees, sentenced felons, and technical violators.

The number of status changes decreased by 21.9 percent from 64 to 50. Although most of the decline occurred for sentenced felons, it still represented nearly three out of every five status change admissions. Most of the decrease in status change releases occurred for pretrial felons and technical violators. Of the 50 status change releases, 19 were technical violators, 13 pretrial felons, and 11 sentenced felons.

The number of transfers to the facility decreased by 2.9 percent from 1,115 to 1,083. Transfers to HCF were mostly comprised of sentenced felons and technical violators.

The number of transfers from the facility increased by 9.9 percent from 616 to 677. These transfers were also comprised of sentenced felons and technical violators.

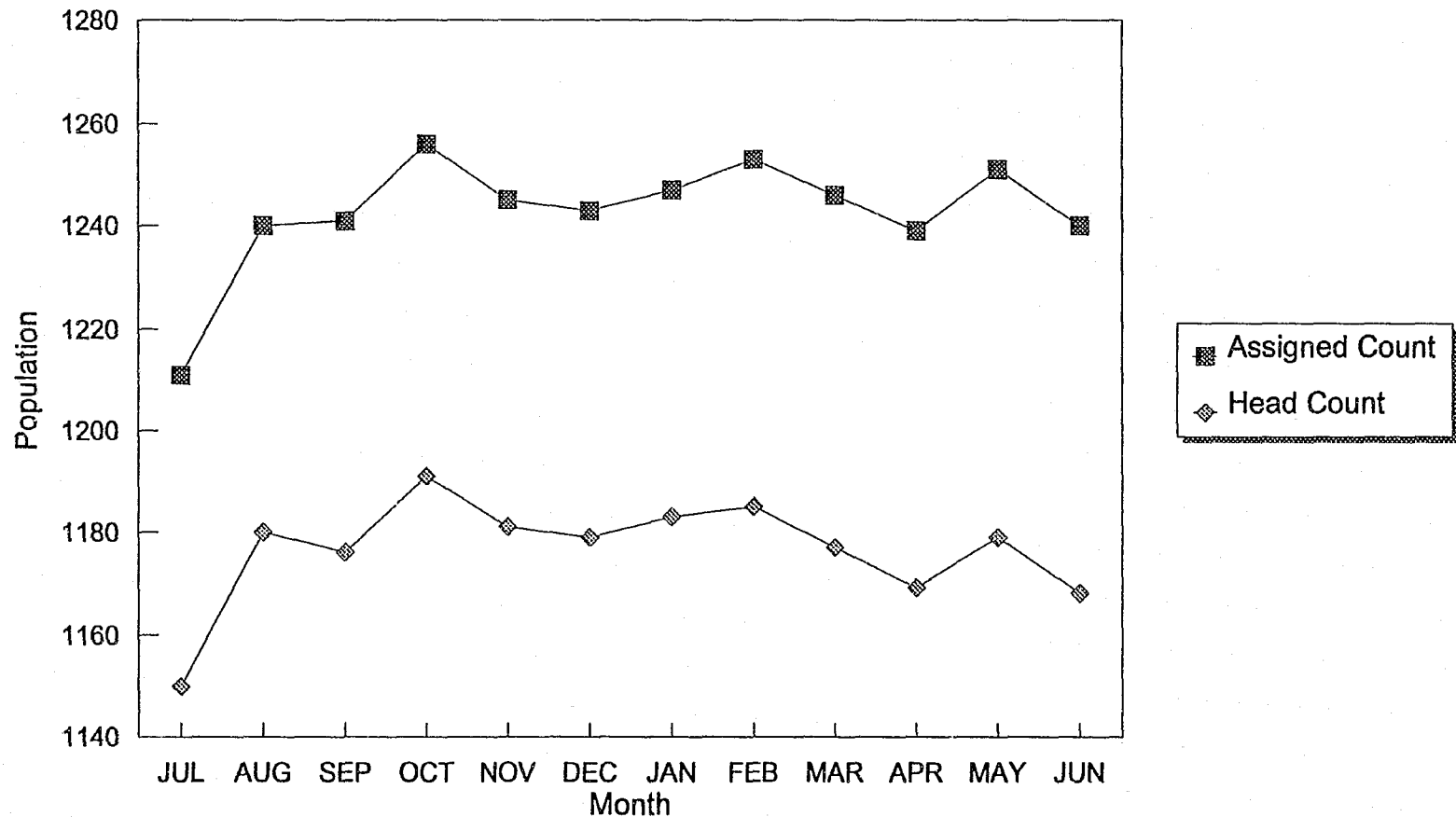

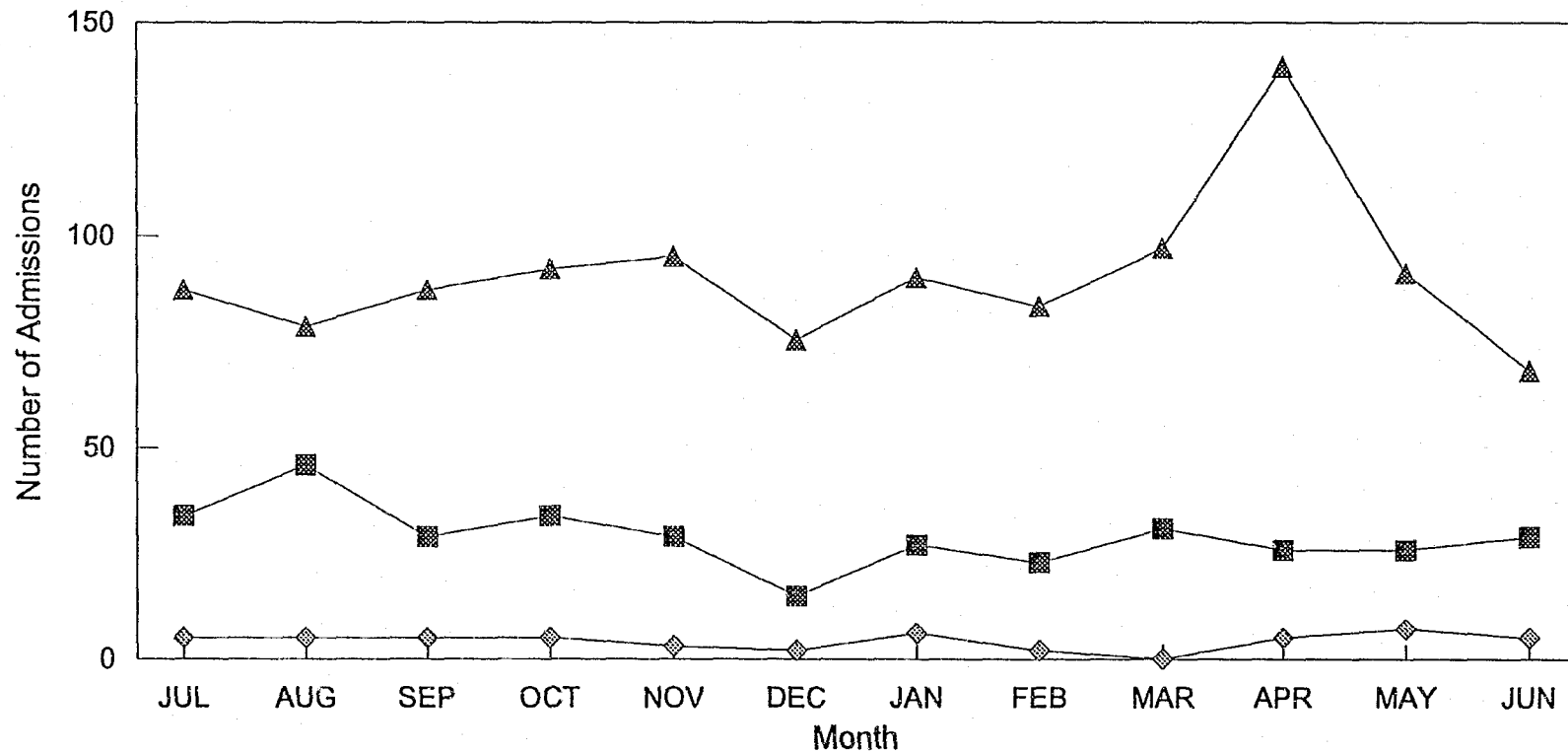

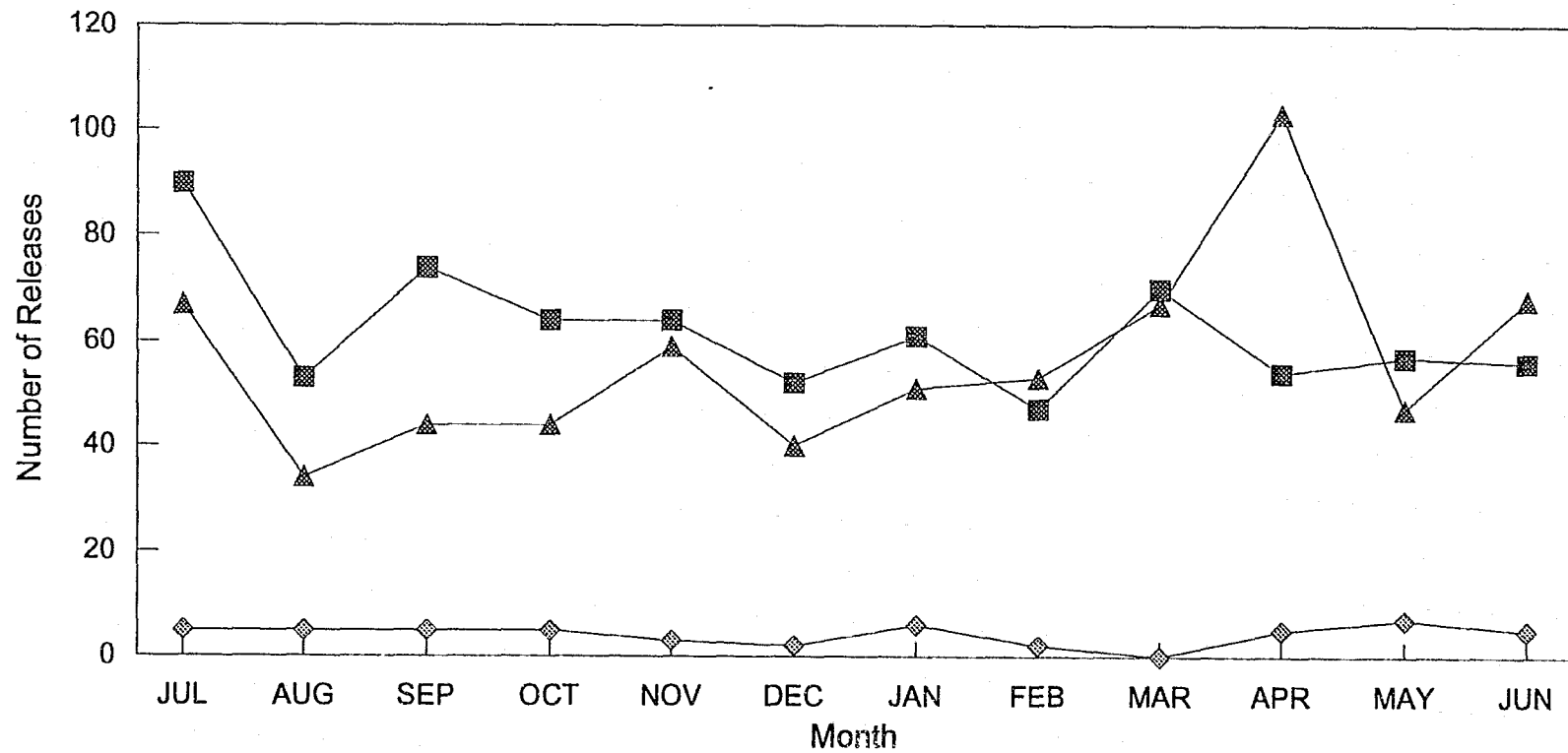

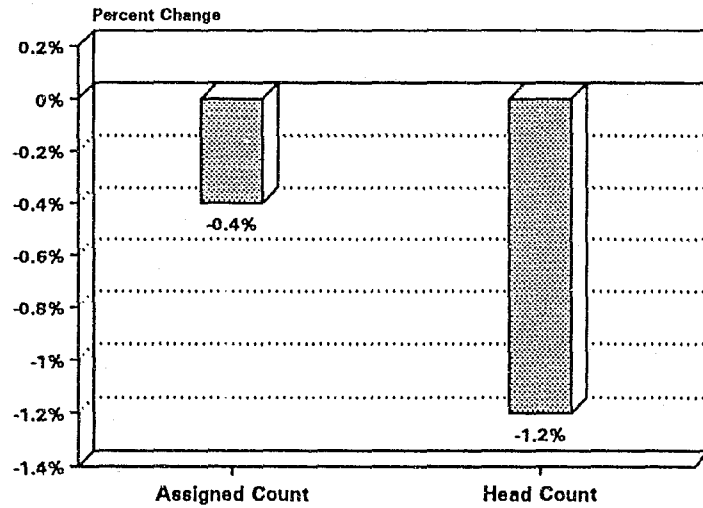

HALAWA CORRECTIONAL FACILITY**

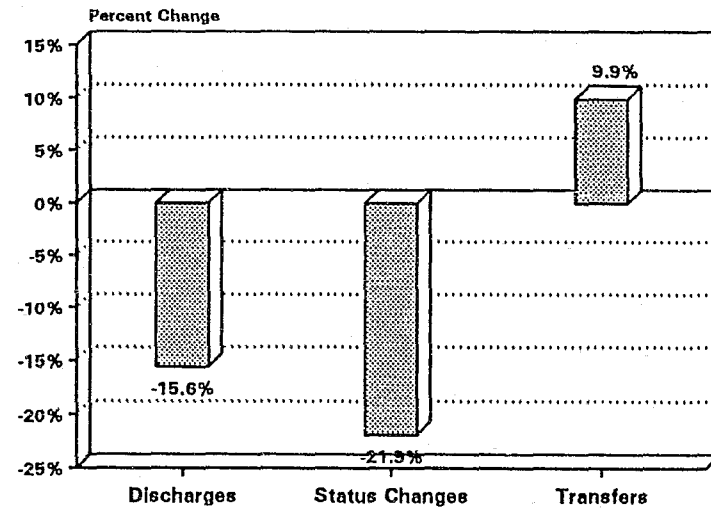
Percent Change in Number of Admissions



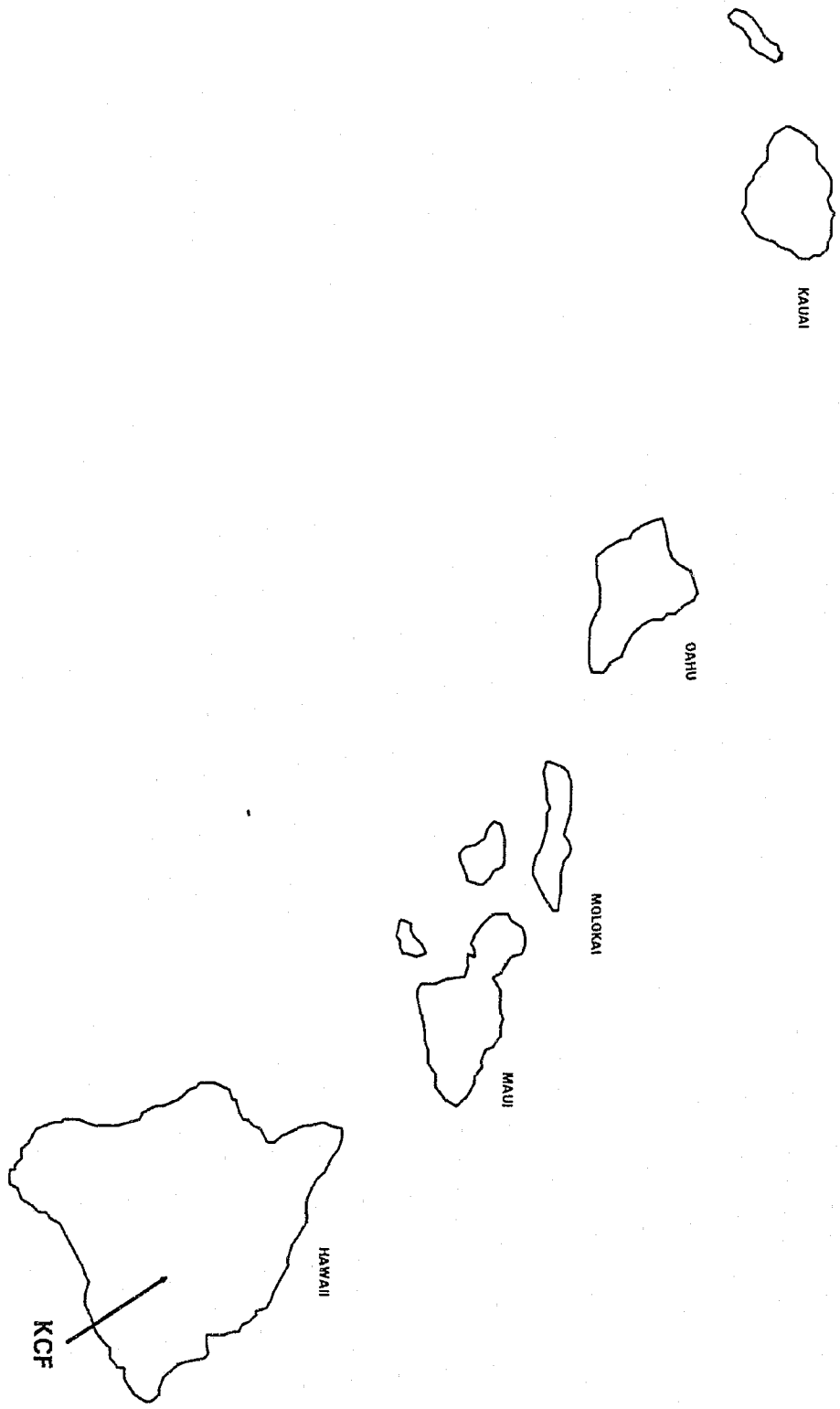
Percent Change in Populations

Summary

Located on the slopes of Mauna Loa on the island of Hawaii, the Kulani Correctional Facility (KCF) is a minimum security work camp for male sentenced felons.

Total facility expenditures for fiscal year 1993-94 were \$3,472,304.

On June 30, 1994, KCF had an assigned count of 207. The head count at KCF during the fiscal year ranged from a low of 199 to a high of 207 and averaged 203. The head count on June 30, 1994 was 207, an increase of 9.5 percent from June 30, 1993. All of the inmates were sentenced felons.

Because incoming transfers represented the only type of facility intakes, KCF did not process any new admissions.

A total of 14 inmates were discharged from KCF during fiscal year 1993-94, a 56.3 percent decline from the number of inmates discharged in fiscal year 1992-93.

Only one status change occurred at the facility during the fiscal year.

The number of transfers to the facility decreased by 14.9 percent from 181 to 154.

The number of transfers from the facility declined by 5.6 percent from 125 to 118.

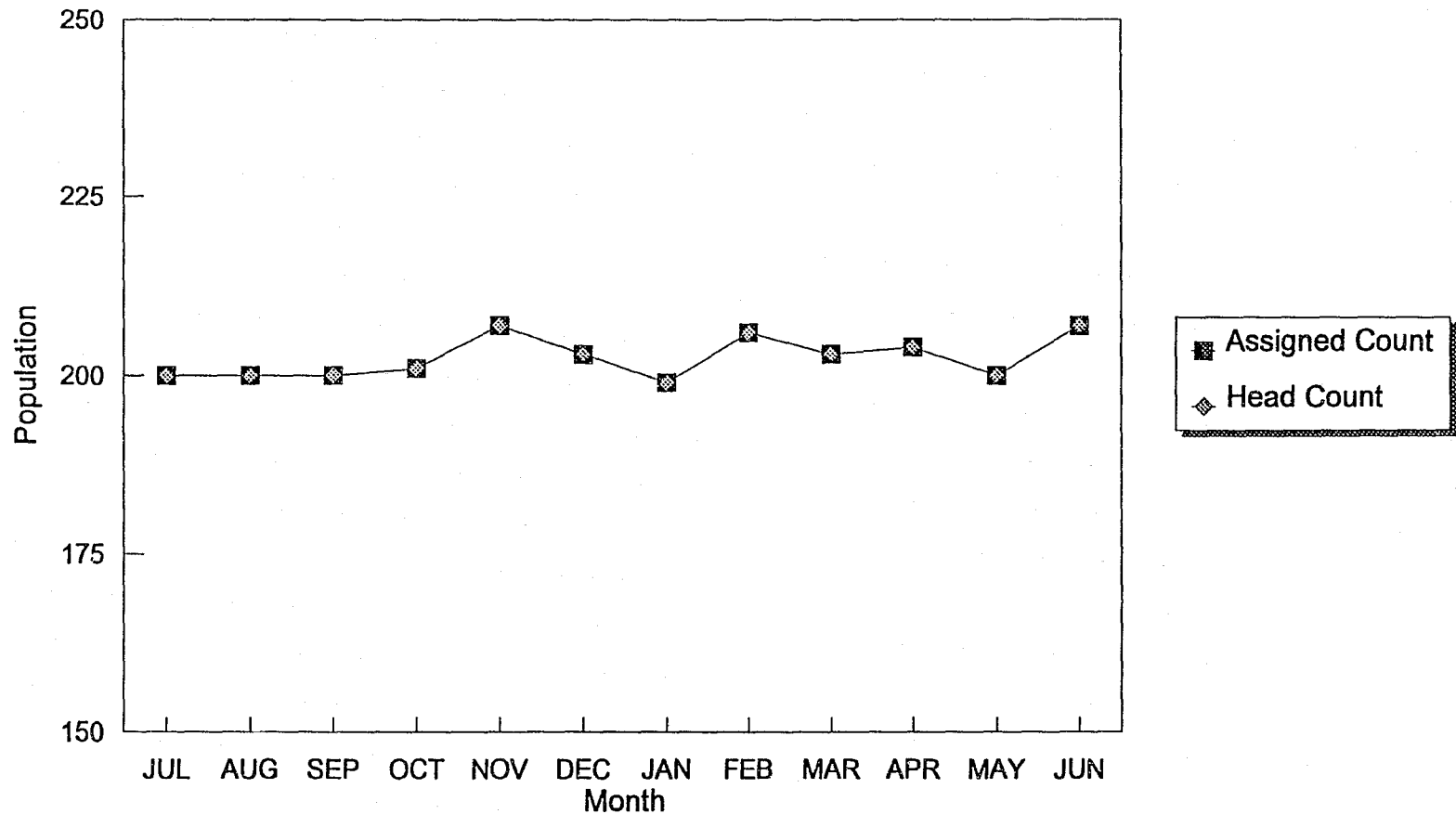

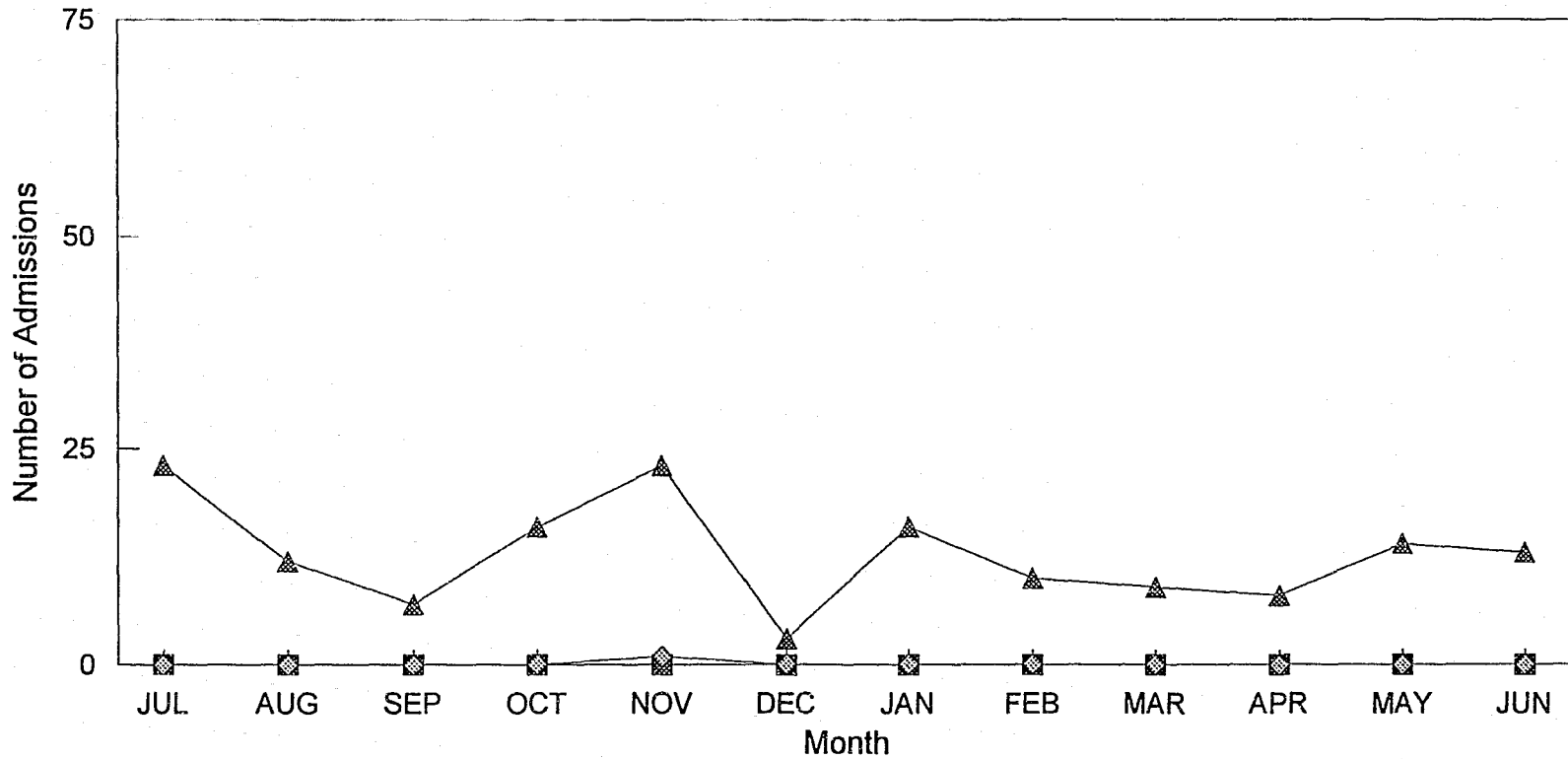

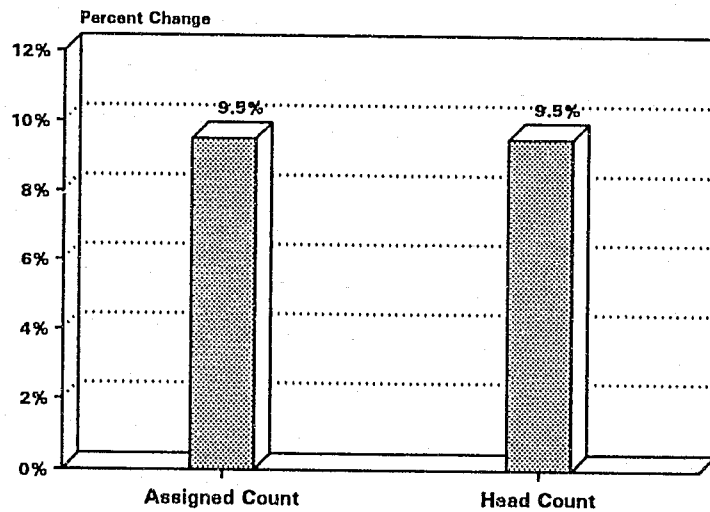

KULANI CORRECTIONAL FACILITY**

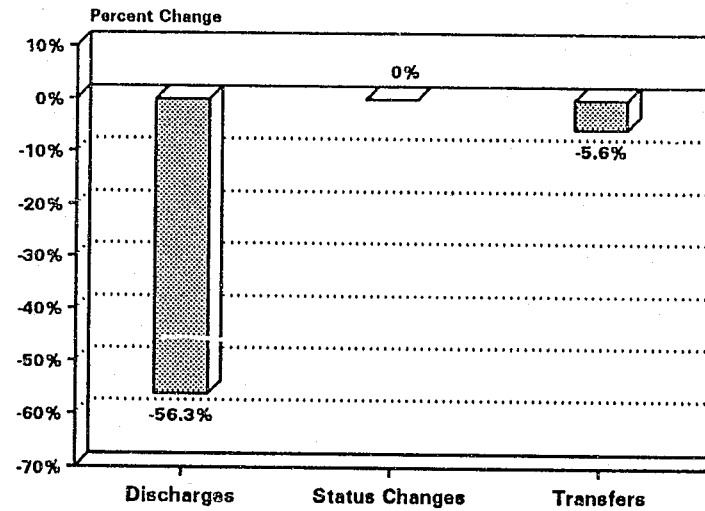
Percent Change in Number of Admissions



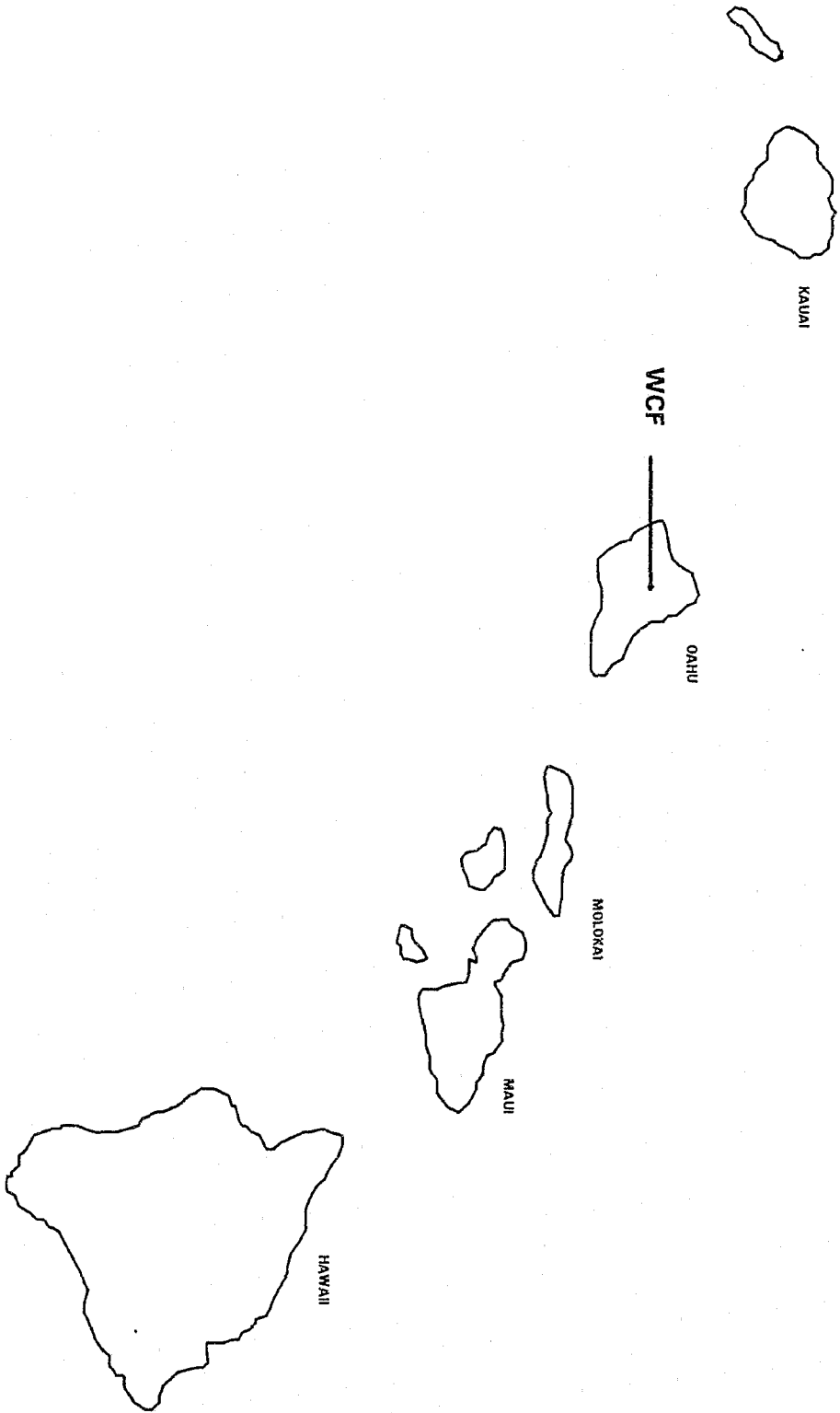
Percent Change in Populations

Summary

The Waiawa Correctional Facility (WCF) is a minimum security work camp located on the island of Oahu. WCF houses male inmates who are sentenced felons, sentenced misdemeanants, or sentenced felon probationers.

Total facility expenditures for fiscal year 1993-94 were \$2,842,888.

On June 30, 1994, WCF had an assigned count of 171.

During the fiscal year, the head count ranged from a high of 153 to a low of 172 and averaged 169. On June 30, 1994, the head count of 170 was an increase of 1.9 percent from June 30, 1993. All of the inmates at the facility were sentenced felons.

No new admissions to the facility occurred during the fiscal year.

A total of 100 inmates were discharged, a decrease of 1.0 percent from fiscal year 1992-93.

The number of status changes declined by 5.9 percent from 51 to 48. Most of the status change admissions occurred for sentenced felons. The status change releases were primarily comprised of technical violators.

Primarily because of more intakes in technical violators, the number of transfers to WCF increased by 8.8 percent from 351 to 382. Most of the incoming transfers were either sentenced felons or technical violators.

The number of transfers from WCF increased by 28.9 percent from 218 to 281. Most of the increase and number of transfers from WCF were comprised of sentenced felons.

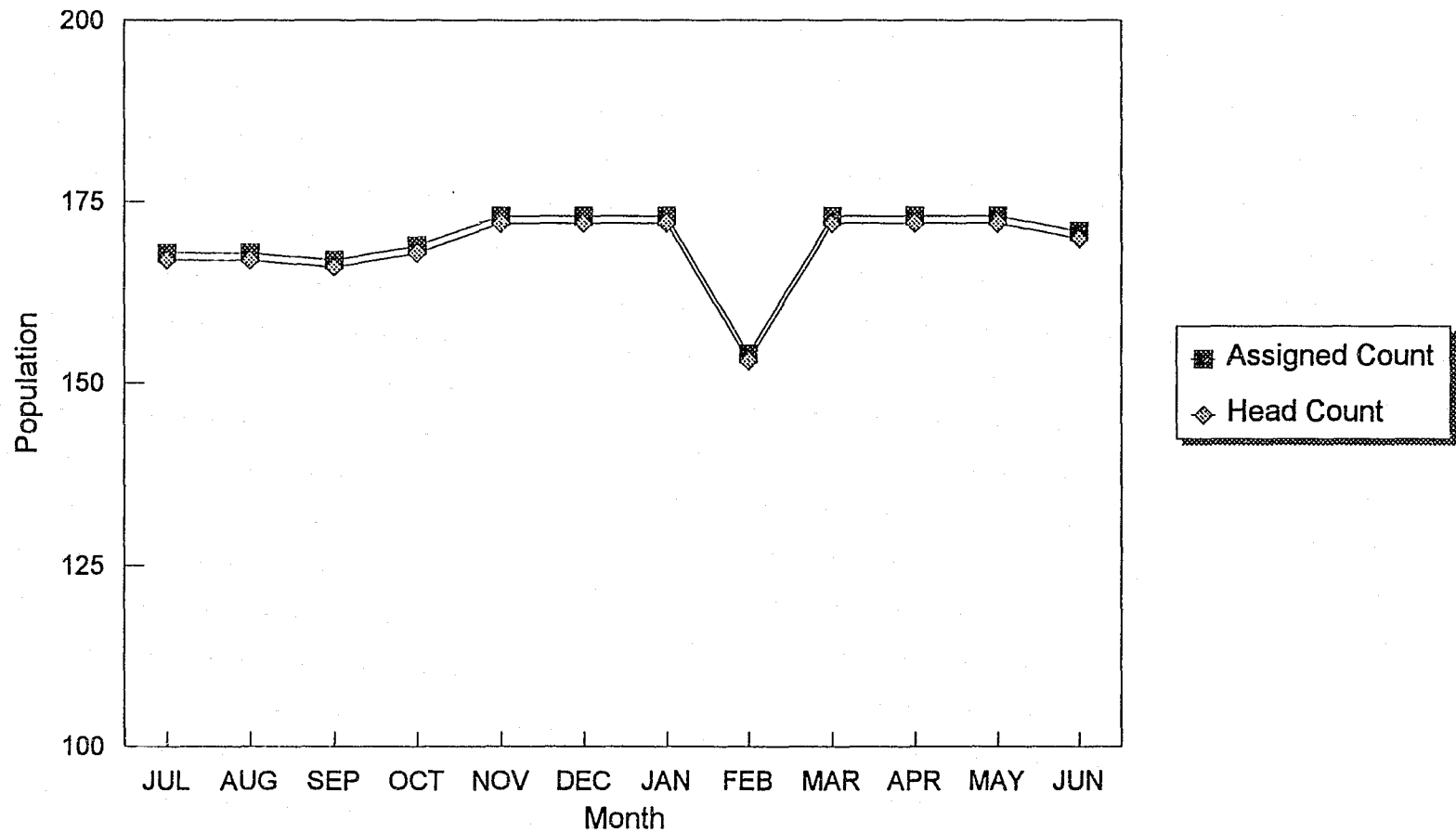

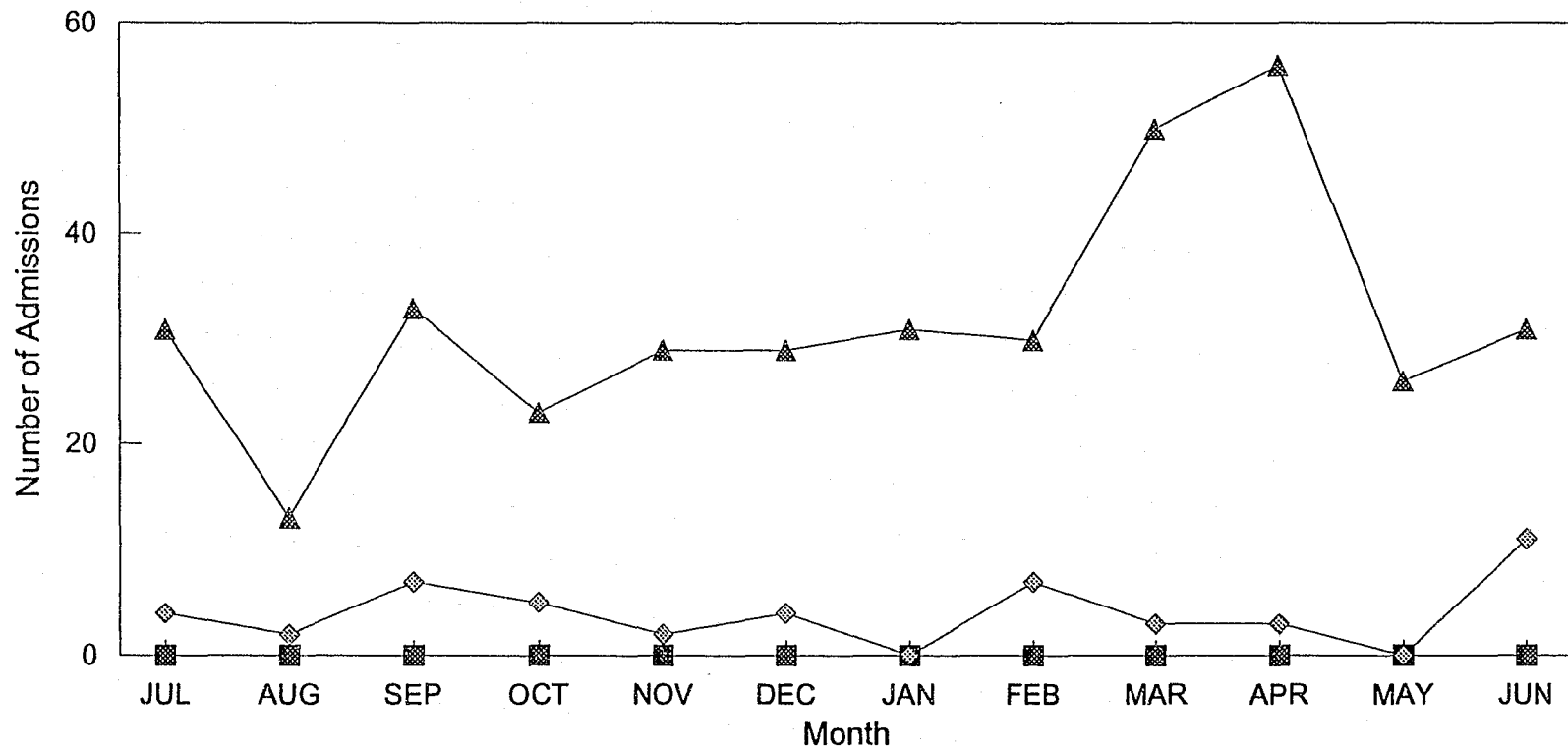

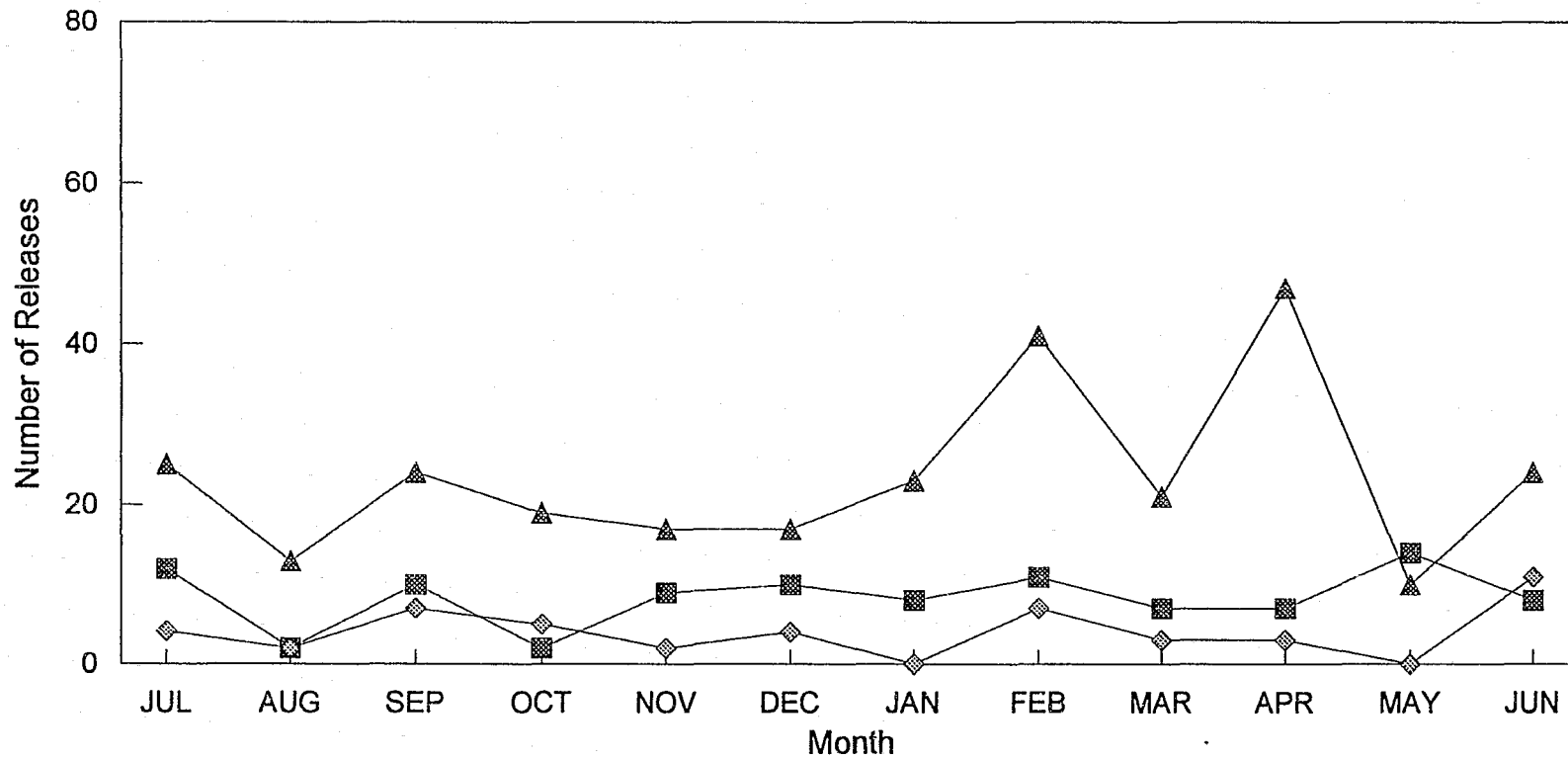

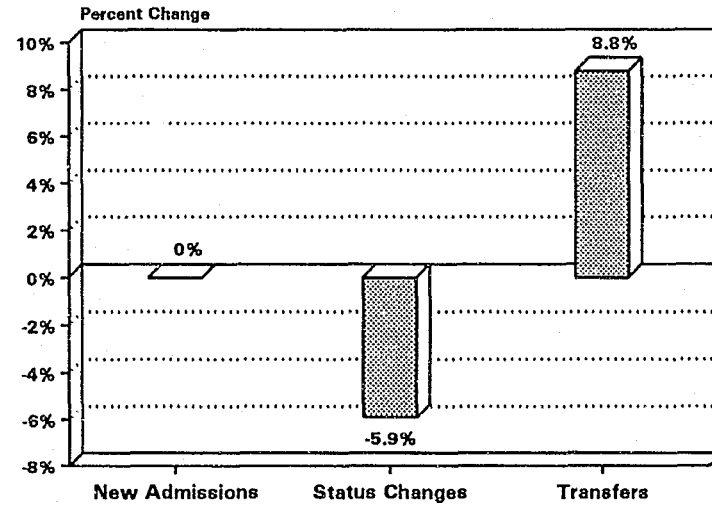

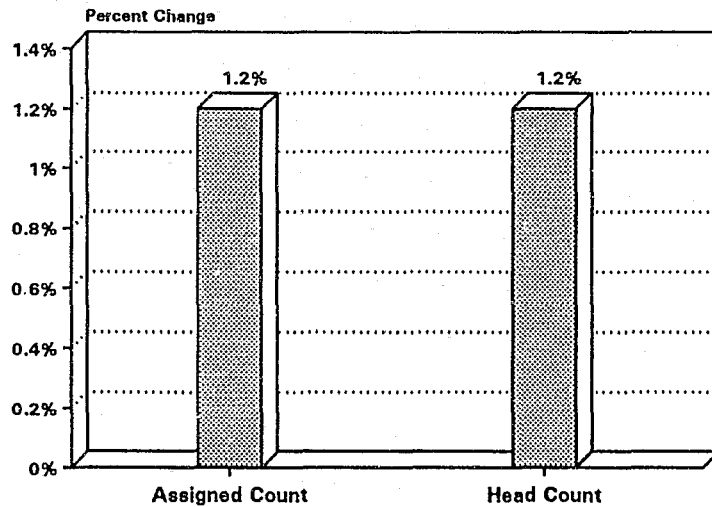

WAIAWA CORRECTIONAL FACILITY**

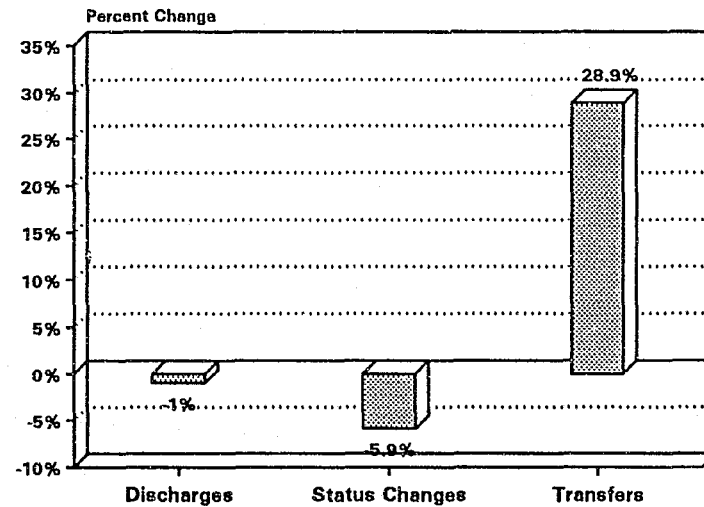
Percent Change in Number of Admissions

Glossary of terms

- Admissions:** Refers to persons who were counted as new admissions, transfers (admission), and status changes (admission). See definitions for each admission type.
- Assigned count:** Number of inmates under the jurisdiction of a state correctional facility on a specific date. It includes inmates physically housed in the facility and inmates who are placed on furlough, in a medical facility, or incarcerated in another state or out-of-state facility.
- Community correctional centers:** Refers to Hawaii Community Correctional Center (HCCC), Kauai Community Correctional Center (KCCC), Maui Community Correctional Center (MCCC), Oahu Community Correctional Center (OCCC), and the Women's Community Correctional Center (WCCC). With the exception of WCCC, these correctional facilities primarily incarcerates jail inmates, i.e. pretrial inmates and inmates sentenced to a jail term of less than one year. Sentenced felons who have served most of their sentence and expected to be released in a short time are also incarcerated at these facilities. Because WCCC is the only facility exclusively for female inmates, the facility incarcerates more sentenced felons than jail inmates.
- Correctional facilities:** Refers to the Halawa Correctional Facility (which includes the Halawa Medium Security Facility and Special Needs Facility), Kulani Correctional Facility, and Waiawa Correctional Facility. These facilities primarily incarcerate sentenced felons and technical violators.

Custody status: Designation of confined persons based on their type of commitment (sentenced, pretrial, or other jurisdiction) and/or type of offense (felony, misdemeanor, technical violation). The major categories use in this report are sentenced felons, sentenced felon probationers, sentenced misdemeanants, pretrial felons, pretrial misdemeanants, other jurisdiction, and technical violators.

Discharge: Release from the custody of a correctional facility upon completion of a jail or prison term or after being held as a pretrial detainee.

Head count: Number of inmates physically housed in a correctional facility on a specific date.

New admissions: Commitment of persons to the custody of the Department of Public Safety, Corrections Division. Refers to their entry into a correctional facility and start of their pretrial detention, jail sentence, or prison sentence resulting from a court order, parole or probation revocation, or interstate transfer.

Other jurisdiction: Refers to persons who are or were under the jurisdiction of the U.S. Marshalls Office, the Immigration and Naturalization Service, the county police, etc. and who are or were detained in a correctional facility.

Pretrial felon: Custody status of incarcerated persons who are or were awaiting adjudication or sentencing for felony offenses.

- Pretrial misdemeanor: Custody status of incarcerated persons who are or were awaiting adjudication or sentencing for misdemeanor or petty misdemeanor offenses.
- Releases: Refers to inmates who were counted as discharges, transfers (releases), and status changes (releases). See definition for each release type.
- Sentenced felon: Custody status of inmates convicted of felony offenses who were sentenced or incarcerated for more than one year.
- Sentenced felon probationer: Custody status of inmates convicted of felony offenses who were sentenced or incarcerated for less than one year, and subsequently will be or were released from custody and placed on probation.
- Sentenced misdemeanor: Custody status of inmates convicted of misdemeanors or petty misdemeanors who were sentenced or incarcerated for less than year. It includes inmates who received probation terms and/or intermittent sentences.
- Status change (admission): When the designation of inmates from pretrial or sentenced status or from sentenced to pretrial status occurs, the **latter** custody status is counted.
- Status change (release): When the designation of inmates from pretrial or sentenced status or from sentenced to pretrial status occurs, the **former** custody status is counted.

- Technical violator: Custody status of inmates who are or were held a result of violating the terms conditions of their parole or probation.
- Transfer (admission): When inmates are moved from one state correctional facility to another state correctional facility, the **receiving** or **latter** facility counts the moves as admissions.
- Transfers (releases): When inmates are moved from one state correctional facility to another state correctional facility, the **sending** or **former** facility counts the moves as releases.
