

# **HIGHLIGHTS**

---

---

## **TOTAL CRIME RATE:**

(Part I and Part II)

Delaware's crime rate rose slightly in 1994 after two consecutive years of declining rates. The state's total crime rate in 1994 was 240.3 reported crimes per 1,000 population, slightly higher than the 1993 rate of 235.9 per 1,000 population. Despite this increase, the 1994 crime rate still remains well below the 1991 rate of 252.4 per 1,000 population. A total of 169,588 crimes were reported to the police in 1994.

- **PART I OFFENSES**

(Violent and Property crime)

Part I offenses accounted for 23.7 percent of all reported crimes in 1994. Reported Part I offenses rose by 8 percent, from 37,190 in 1993 to 40,158 in 1994. The Part I crime rate in 1994 was 56.9 reported crimes per 1,000 population, up from 53.7 in 1993.

⇒ **PROPERTY**

(Burglary, Larceny, Motor Vehicle Theft, and Arson)

Most of the increase in Part I crimes was caused by an increase in reported property crimes, which rose by 9 percent in 1994.

⇒ **VIOLENT**

(Homicide, Forcible Rape, Robbery and Aggravated Assault)

Reported Part I violent offenses fell by less than 1 percent in 1994. The modest reduction in reported violent crimes in 1994 was due mainly to fewer reported rapes and robberies.

- **PART II OFFENSES**

(All offenses not listed under Part I Property or Violent crime, including drugs)


The Part II crime rate for Delaware rose from 182.2 reported crimes per 1,000 population in 1993 to 183.4 reported crimes per 1,000 population in 1994. The number of Part II offenses reported to the police in 1994 totaled 129,430, a 2.5 percent increase from the 1993 Part II total of 126,285 reported offenses.

- **ILLICIT DRUG CRIMES**

The Statewide number of complaints, arrests, and clearance rates for drug crimes has been dropping since 1991. The number of drug arrests for juveniles, however, has been increasing. In New Castle County, including all cities, drug arrests went down 35.3% since 1991. Between 1991 and 1993, Kent County drug arrest rates went down close to 20%, but then increased slightly in 1994. Sussex County drug arrest rates have increased by 26% since 1991.



## ***VIOLENT CRIME***

---

- Violent crimes include homicide, forcible rape, robbery and aggravated assault.
- The total number of reported violent crimes in Delaware declined slightly in 1994, although the overall trend in the past decade is an increase in the number of violent crime cases (the number of violent crimes have nearly doubled since 1986). The violent crime rate per 1,000 population did not increase, and has been fairly steady for the past 4 years.
- Sussex County reported the most violent crimes per 1,000 last year, with a violent crime rate of 7.43, mostly due to the high number of aggravated assaults, which accounted for over 75% of Sussex violent crime.
- New Castle County was next, with a violent crime rate of 7.35. New Castle County had the highest homicide rate. The robbery rate in New Castle County stands out, being more than double Kent's robbery rate, and nearly three times the robbery rate of Sussex County.
- Kent County had the least reported total violent crimes. Still, Kent had the most rapes per 1,000 and did not have the least violent crime in any of the specific reported areas.





Total Reported Part I Crime 1984 - 1994




Total Reported Violent Crime 1984 - 1994







### **Reported Aggravated Assault 1984 - 1994**







## ***PROPERTY CRIME***

---

- Property crime includes burglary, larceny, motor vehicle theft and arson.
- Motor vehicle thefts and arson crimes increased by large proportions in 1994. Motor vehicle theft was up 61% from 1993. All three counties reported an increase in motor vehicle theft, although the increase in Sussex was only 10%, as opposed to the 66% and 44% in New Castle and Kent respectively. Arson was up 62.8% Statewide (up 80% in New Castle County and 92% in Kent); arson complaints actually went down over 8% in Sussex County.
- Of the three counties, New Castle County has the highest crime rate for every property crime except burglary. Nearly 90% of motor vehicle thefts took place in New Castle County this year. The crime rate for motor vehicle theft was 8.56 in New Castle County, which is 366% the Kent County rate of 2.34, and 578% the Sussex County rate of 1.48.
- Sussex County had the least property crime per 1,000 in every area except burglary. Sussex County's crime rate was 16.5% lower than New Castle County's and 11.6% lower than the Statewide figures.





Total Reported Property Crime 1984 - 1994




Reported Burglary 1984 - 1994



**Reported Larceny 1984 - 1994**




**Reported Motor Vehicle Theft 1984 - 1994**



## ***REGIONAL CRIME***

---

- At 7.3, Delaware's violent crime rate for 1994 was higher than the Nation's (7.2) by a slight margin. Delaware has historically enjoyed a lower violent crime rate than the nation.
- Delaware's violent crime rate has been higher than the Region's since 1989. Maryland and Washington D.C. have more violent crime per capita; Washington D.C.'s violent crime is 264% of Delaware's. New Jersey, Pennsylvania, and Virginia each have lower violent crime rates.
- In 1994 Delaware had the lowest homicide and one of the lowest robbery rates in the Region, but showed the highest rape incidence.
- Delaware's property crime rate is higher than both the Nation's and the Region's property crime rates. Delaware has been higher than the Nation three of the last four years, and has always been higher than the region. This year, Delaware's is more than 30% higher than the Region's.
- Just as in violent crime, Maryland and Washington D.C. have more property crime than does Delaware; Washington D.C.'s property crime rate is 70% higher. New Jersey, Pennsylvania and Virginia have lower property crime rates.




### **Regional Crime Comparision Total Part I Crime Rate Per 1,000 Population**





Reported Part I Property Crimes (Excluding Arson) per 1,000 Population**












## 1994 UCR Part I Complaints Complaints Per 1,000 Population






## 1994 Violent Crime Complaints Per 1,000 Population

Statewide Average = 7.3 complaints per 1,000 pop.





## ***JUVENILE CRIME***

---

- Juvenile crime, after a steady increase in the late 1980's, did not change much from 1993. For *Violent Part I Crime*, there were 525 juvenile arrests in 1993, and 514 arrests in 1994, a 2.1% decrease. Just like the State, New Castle County juveniles were arrested 2.1% less for violent crimes; Kent County juveniles were arrested 10% less, but Sussex County youths were arrested 6.2% more.
- Juvenile arrests for *Part I Property* crimes increased slightly by just 2.4% from 1993, but Kent County juveniles were arrested 25.7% more than in 1993, going from 374 arrests to 470 in 1994. New Castle County did not change, and Sussex County juvenile property crime decreased by 8.5%.
- Part II juvenile arrests went down 2.4% Statewide, although it increased by 2.2% and 8.9% in Kent and Sussex, respectively. New Castle County arrests went down by 8.0%. The Part II juvenile arrest rate of 75.3 per 1,000 in Sussex is 63% higher than New Castle County's juvenile arrest rate of 46.1, and 31% higher than Kent County's rate of 57.3.



### **Juvenile Arrests for Part I Violent Crimes by County**




### **Juvenile Arrest Rates for Part I Violent Crimes by County** Arrests per 1,000 "At-Risk" Juveniles (Ages 10-17)







## ***ARRESTS AND CLEARANCES***

---

- A complaint reported to police is considered cleared or solved once the police have identified the offender. One arrest may clear several crimes; therefore, the clearance rate is often higher than the arrest rate.
- The overall number of Part I violent crime arrests remained about the same as last year. Juveniles were arrested 2% less in 1994 for violent crime, and adults were arrested 1% more.
- For violent crimes, complaints and clearances have been fairly steady the last several years. There also have been few changes in arrest rates in the 90's. Of the reported offenses in 1993, 48.9% resulted in arrest, while the average for the past fifteen years is 46.3%.
- The overall number of Part I property crime arrests decreased by less than 2%. Juveniles were arrested more frequently than last year by 2.4%, while adults were arrested 3.9% less than last year for property crimes.
- For property crimes, complaints are up from 1993 by 7.4%, and clearances are down (10% since 1992). There is a decreasing trend in arrests rates, down 11.4% since 1991. The percentage of arrests by the number of reported property offenses was 18.9%, just about average for the last 15 year period, but down from 21.1% in 1993.





Rate per 1,000 Population




**Number of Arrests, Part I, II and Total**



### **Arrests for Violent Crime 1984 - 1994**




### **Arrests for Property Crime 1984 - 1994**



Rate per 1,000 Population




**Clearance and Arrest Rates for Part I Property Crime**  
Rate per 1,000 Population



Crime in Delaware 1994





## ***ILLICIT DRUGS***

---

- Sussex County has the highest rates for illicit drug crimes, including complaints, arrests and clearances per 1,000 population. New Castle County has the least drug crime complaints, arrests and clearances per 1,000.
- Illicit drug complaint rates, clearance rates, and arrest rates have been dropping statewide since 1991. This decline is most easily recognized in New Castle County, where drug related complaints went down 22.6%, illicit drug clearance rates went down 21.6%, and arrest rates for drug offenders went down 35.3% since 1991.
- Within New Castle County, Wilmington's drug arrest have declined by nearly 46% since 1991 (1405 cases in 1991 to 759 in 1994), and 18.4% since 1993. Adult drug arrests have gone down faster and more steadily than juveniles, although there was a significant decrease in Wilmington juvenile arrests as well.
- There is a difference between adult and juvenile drug arrests. While the state arrest rates for drugs have generally been declining, the juvenile arrest rate for drugs has been increasing.

*Of those seven arrests daily, approximately 4.2 originate in New Castle County, 1.2 from Kent, and 1.3 from Sussex.*





**New Castle County**





Rate per 1,000 Population**




**Illicit Drug Complaint, Clearance, and Arrest Rates

Rate per 1,000 Population**









1985 - 1994**





## ***POLICE ACTIVITY***

---

- Statewide, the number of police officers went up by 10 from 1408 to 1418 officers. However, the number of officers in certain police departments has fluctuated, including Wilmington, Delaware State Police and New Castle County.
- Wilmington's police force numbered 235 in 1994, down from 283 in 1991. Wilmington had more police officers in 1982 than in 1994. Delaware State Police reduced their force from 517 in 1990 to 490 in 1994. New Castle County has increased their force from 274 in 1993 to 307 in 1994.
- Police officers Statewide were assaulted 429 times in 1994, with 33% of the assaults occurring during calls for domestic disturbances. Firearms and knives are used in only 6% of attacks, offenders more frequently using their hands, fists, or feet. Seventy-two percent of the assaults result in personal injury.

*Each Delaware police officer made approximately twenty-seven arrests in 1994.*



### **Uniform Crime Report (UCR) and Computer Aided Dispatch (CAD) Data**

Reporting of crime data in Delaware is based on Uniform Crime Report (UCR) data. While UCR data is detailed and accurate, there is often up to a year lag in UCR data availability. Accordingly, the last full year of UCR data for Delaware currently available is for 1994. In addition, Delaware's UCR year end data for 1995 may not be available until late 1996 or early 1997. As this time lag promotes significant delays in the measurement and analysis of crime activity in Delaware and accompanying criminal justice policies. The Statistical Analysis Center, in conjunction with the City of Wilmington Police Department, has begun to compare UCR data with the Computer Aided Dispatch (CAD) data collected by the Wilmington Police Department. The CAD data represents the number of calls received by the Wilmington Police Department for police assistance and the corresponding type of crime under which the calls were dispatched from headquarters to officers. For example, a call the Wilmington Police Department receives from a citizen for police assistance for an assault will be counted in the CAD data as one assault. The CAD data, therefore, reflects the

number of crime types for which officers were dispatched, whereas the UCR data, which is based on the officers written report, may report a different type of offense or possibly no offense at all after the officer completes an investigation of the call.

### **CAD Data as Early Indicator of Crime Trends**


Although UCR and CAD data differ in scope and definition, CAD data, which is collected daily, often corresponds well to UCR. CAD data may be used as an early indicator of crime trends in recent time periods with a reasonable degree of accuracy.

Between 1993 and 1994, for instance, in all categories except drugs, when CAD calls increased, UCR complaints increased for similar categories as well.


In the drug category, however, although CAD calls increased, there was a drop in UCR complaints. Several factors may explain the differences between related drug CAD calls and UCR complaints. First, there may be multiple CAD calls for one complaint event. Second, some CAD calls may not be substantiated. Finally, CAD calls may be reclassified by the investigating officer.

### **City of Wilmington UCR Complaints vs. CAD Calls Homicide**




### **City of Wilmington UCR Complaints vs. CAD Calls Rape**





### **City of Wilmington UCR Complaints vs. CAD Calls Robbery**




### **City of Wilmington UCR Complaints vs. CAD Calls Burglary**


