



Crime in Delaware 1996 Highlights

- Total reported Part I and II offenses reached a new high in 1996.** Delaware's 1996 crime rate of 251.7 per 1,000 population is also a new high. 182,449 crimes were reported in Delaware in 1996, a 2.8 percent increase over the 1995's previous record of 177,562 offenses. Despite the increase in reported crimes, the rate of increase in 1996 is lower than the previous year's increase of 4.7 percent.
- 6,010 Part I Violent Crimes were reported in Delaware in 1996, up 7.4 percent from the 1995 total of 5,598.** The rate of increase in reported violent crime is down compared with the 9.1 percent increase reported in 1995. Aggravated assaults, which rose by 11.1 percent in 1996, were responsible for much of the increase in violent crime. The number of reported homicides in Delaware also increased by 44.4 percent, from 36 in 1995 to 52 in 1996.
- The number of Part I Property Crimes reported in Delaware rose by less than 1 percent in 1996.** All three Delaware counties reported fewer burglaries, arsons, and larcenies in 1996. The only property crime category that increased in 1996 was motor vehicle theft, which rose by 35.8 percent.
- The number of juveniles arrested in Delaware increased by 6.7 percent overall in 1996.** This compares with a 9 percent increase in juvenile arrests in 1995. Juvenile arrests for Part I Violent Crimes increased by 7 percent. Aggravated assault, the most common violent offense that juveniles were charged with, rose by 12.2 percent in 1996. Eight juveniles were arrested for murder and non-negligent manslaughter in 1996, up from four arrests in 1995.
- Illicit drug complaints increased by 4.9 percent statewide in 1996.** Drug arrests fell by 3.4 percent, however this decrease was limited to adult arrests only. Juvenile drug arrests actually increased by 3.4 percent in 1996.


Delaware Total Crime Rate 1984 - 1996



Part I Violent Crime

- The number of violent crimes reported in Delaware increased in 1996, yet the rate of increase in reported violent crime is down compared with 1995. A total of 6,010 violent crimes were reported in Delaware in 1996, a 7.4 percent increase over the 1995 total of 5,598. The rate of increase in violent crime is declining—in 1995, violent crimes reported in Delaware rose by 9.1 percent. Delaware's Part I Violent Crime rate in 1996 was 8.3 crimes per 1,000 population.
- Reported Part I Violent Crime in New Castle County rose by 10 percent, from 3,683 in 1995 to 4,050 in 1996. Approximately two out of every three violent crimes reported in Delaware in 1996 occurred in New Castle County (67.4 percent). New Castle County had the highest violent crime rate of Delaware's three counties—8.6 crimes per 1,000 population. Of Delaware's three counties, New Castle County had the highest robbery rate and was the only county to report an increase in homicides in 1996.
- The number of reported Part I Violent Crimes in Kent County totaled 860 in 1996, only two less than the 1995 total of 862. Kent County had the lowest Part I Violent Crime rate of Delaware's three counties—7 crimes per 1,000 population—but led both New Castle and Sussex Counties in the number of reported rapes per 1,000 population. Kent County trailed both New Castle and Sussex Counties in homicides, robberies, and assaults per 1,000 population.
- Reported Part I Violent Crime in Sussex County rose by 4.5 percent in 1996. Sussex County had the highest aggravated assault rate of Delaware's three counties—three out of four reported violent crimes in Sussex County were assaults. Sussex County's homicide rate in 1996 equaled that of New Castle County—.08 per 1,000 population. Sussex County also reported the largest percent increase in robberies, from 124 in 1995 to 160 in 1996 (29 percent).
- Delaware's homicide rate in 1996 was .07 per 1,000 population. A total of 52 homicides were reported in 1996, a 44.4 percent increase over 1995's total of 36. Thirty-six of the 52 homicides reported in 1996 occurred in New Castle County (63.9 percent), 5 occurred in Kent County (19.8 percent), and 11 occurred in Sussex County (21.2 percent). Forty-six of the 69 homicide suspects knew their victim (66.7 percent) and 22 were either a partner or a relative of the victim (31.9 percent). Firearms were used in 23 of the 52 homicides (44.2 percent).
- Delaware's aggravated assault rate in 1996 was 5 crimes per 1,000 population. Aggravated assault was the most frequently reported Part I Violent Crime, accounting for 60.6 percent of all reported violent crimes. Aggravated assaults reported in Delaware rose by 11.1 percent overall, from 3,276 in 1995 to 3,640 in 1996.
- Aggravated assaults involving firearms increased by 27.2 percent statewide, from 648 in 1995 to 824 in 1996. The increase in firearm related violence was mostly limited to New Castle County. Reported aggravated assaults involving firearms increased by 47.3 percent in New Castle County, from 370 in 1995 to 545 in 1996. In comparison, Sussex County reported 4.9 percent increase in assaults involving firearms and Kent County reported a 6 percent decrease. About two out of every three aggravated assaults that involved firearms occurred in New Castle County (66.1 percent).


Total Reported Violent Crime 1984 - 1996


Part I Violent Crime in 1996 by Type



Reported Homicide 1984 - 1996





Reported Rape 1984 - 1996







Part I Property Crime


- The Part I Property Crime rate for Delaware in 1996 was 50.4 crimes per 1,000 population. A total of 36,563 property crimes were reported in Delaware in 1996, less than 1 percent higher than the 1995 total of 36,420.
- Reported burglaries in Delaware totaled 6,795 in 1996, 9.2 percent fewer than the 1995 total of 7,486. Nearly 2 out of every three reported burglaries in Delaware occurred in New Castle County (64.2 percent). Of the three categories of burglary (Forced Entry, Non-Forced Entry, and Attempted Entry), only Forced Entry burglary decreased in 1995. Non-Forced Entry and Attempted Entry burglaries both increased in 1996.
- Reported larcenies, the most frequently reported property crime, decreased by less than 1 percent in 1996. Reported arsons decreased by 23.5 percent in 1996.
- Reported motor vehicle thefts, the only property crime category that increased in 1996, rose by 35.8 percent in 1996. This increase follows a 32.5 percent decrease in motor vehicle thefts in 1995.
- New Castle County had the highest Part I Property Crime rate of Delaware's three counties in 1996— 54.6 crimes per 1,000 population. The number of Part I Property Crimes reported in New Castle County increased by 0.7 percent, from 25,572 in 1995 to 25,751 in 1996. This modest increase in reported property crime was mainly caused by an increase in motor vehicle thefts. Motor vehicle thefts in New Castle County rose by 37.6 percent in 1996 after decreasing by 32.5 percent in 1995. Reported burglaries, larcenies, and arsons in New Castle County, which all reported increases in 1995, fell by 10.8, 1.3 percent, and 16.6 percent respectively in 1996.
- Kent County had the lowest Part I Property Crime rate of Delaware's three counties— 43.2 crimes per 1,000 population. Reported Part I Property Crimes in Kent County totaled 5,304, just slightly higher than the 1995 total of 5,289. Motor vehicle thefts in Kent County rose by 42.2 percent in 1996, the largest percent increase of Delaware's three counties. Reported arsons in Kent County decreased by 61.2 percent in 1996 after increasing by 34.2 percent the previous year.
- The Part I Property Crime rate for Sussex County in 1996 was 42.3 crimes per 1,000 population. Sussex was the only county that reported a decrease in each category of property crime in 1996. Reported burglaries in Sussex County fell by 2 percent in 1996. Motor vehicle thefts fell by 0.6 percent and reported arsons fell by 8.8 percent.

Total Reported Property Crime 1984 - 1996




Part I Property Crime in 1996 by Type



Reported Burglary 1984 - 1996





Reported Larceny 1984 - 1996





Reported Arson 1984 - 1996




- Delaware's Part I Crime rate in 1996 (excluding arson) was 58.1 crimes per 1,000 population. Compared with other states in the region and Washington D.C., Delaware ranked 3rd in Part I Crimes per 1,000 population. Washington D.C. and Maryland had Part I Crime rates that exceeded Delaware's.
- Delaware's Part I Violent Crime rate in 1996 was 8.3 crimes per 1,000 population. Delaware's violent crime rate per 1,000 population has increased every year since 1994 while the national the violent crime rate has decreased every year since 1994. The rate of increase in reported violent crime statewide fell from 9.1 percent in 1995 to 7.4 percent in 1996.
- In 1996, Delaware led the region in the number of reported rapes per 1,000 population. Delaware also had the second highest aggravated assault rate per 1,000 population.
- Delaware's Part I Property Crime rate in 1996 was 50.4 crimes per 1,000 population. Delaware's property crime rate was exceeded by those of Washington D.C. and Maryland.
- Crime data reported in Delaware are a fully verified and accurate accounting of crime in the state. When comparing Delaware crime data with other states, it should be emphasized that criminal statute definitions vary by state. All states, however, comply with FBI crime definitions.

Part I Violent Crime Rates: State, Regional and National


Reported Part I Violent Crimes per 1,000 Population

Reported Part I Property Crimes (Excluding Arson) per 1,000 Population








1996 UCR Part I Complaints Per 1,000 Population






- The number of juveniles arrested in Delaware in 1996 totaled 7,723, a 6.7 percent increase over the 1995 total of 7,236. One out of every five persons arrested in Delaware in 1996 was a juveniles (20.1 percent).
- Statewide, the juvenile arrest rate in 1996 was 103.5 arrests per 1,000 population. Sussex County had the highest juvenile arrest rate—138.8 arrests per 1,000 population. Slightly more than half of all Delaware juvenile arrests in 1996 occurred in New Castle County (55.7 percent).
- Juvenile arrests for Part I Crimes increased by 4 percent in 1996. Of the 2,854 Part I arrests made in 1996, 629 were arrested for violent crimes (22 percent), and 2,225 were for property crimes (78 percent).
- The juvenile arrests rate for Part I Violent Crime in 1996 was 8.4 arrests per 1,000 population. Juvenile arrests for violent crime increased by 7 percent statewide, from 588 arrests in 1995 to 629 arrests in 1996.
- Approximately two out of every three juvenile arrests for violent crime occurred in New Castle County (65.8 percent).
- Nearly two-thirds of juvenile Part I Violent Crime arrests were for aggravated assaults (64.2 percent). The number of juveniles arrested for aggravated assaults rose by 12.2 percent in 1996.
- Juvenile arrests for Part I Property Crime increased by 3.2 percent statewide in 1996.

Total Juvenile Arrests by County 1984 - 1996





Juvenile Arrests for Part I Crimes 1984 - 1996






Juvenile Arrests for Part I Violent Crimes by County


Juvenile Arrest Rates for Part I Violent Crimes by County


Juvenile Arrests for Part I Property Crimes by County


Juvenile Arrest Rates for Part I Property Crimes by County


Juvenile Arrests for Part II Crimes by County



Arrests and Clearances

- Total arrests in Delaware decreased by 1.6 percent in 1996, from 39,065 in 1995 to 38,432 in 1996. The total arrest rate in 1996 was 53 arrests per 1,000 population. This is slightly lower than the 1995 arrest rate of 54.5 arrests per 1,000 population. Kent County had the highest arrest rate of Delaware's three counties—61.9 arrests per 1,000 population. About 60 percent of all Delaware arrests were in New Castle County.
- Clearances in Delaware totaled 107,326 in 1996, a 2.8 percent increase over the 1995 total of 104,403. The clearance rate in 1996 was 148.1 clearances per 1,000 population, an increase over the 1995 rate of 145.5 clearances per 1,000 population. Sussex County had the highest clearance rate of Delaware's three counties—152.4 clearances per 1,000 population.
- Arrests for Part I Crimes increased by 1.5 percent, from 9,505 in 1995 to 9,652 in 1996. The arrest rate for Part I Crimes was 13.3 arrests per 1,000 population, just slightly higher than the 1995 arrest rate of 13.2 arrests per 1,000 population. The arrest rate for adults was 12.4 arrests per 1,000 population, a slight decrease from the 1995 rate of 12.5 arrests per 1,000 population. The Part I arrest rate for juveniles was 38.2 arrests per 1,000 population, an increase over the 1995 arrest rate of 37.6 arrests per 1,000 population.
- The clearance rate for Part I Crimes was 15.3 clearances per 1,000 population, slightly lower than the 1995 rate of 15.5 clearances per 1,000 population. Clearances for Part I Crimes increased by less than 1 percent, from 11,093 in 1995 to 11,123 in 1996.
- Arrests for Part I Violent Crime increased by 2.8 percent in 1996, from 2,753 in 1995 to 2,829 in 1996. The arrest rate for violent crimes was 3.9 arrests per 1,000 population, just slightly higher than the 1995 rate of 3.8 arrests per 1,000 population. The violent crime arrest rate for juveniles was 8.4 arrests per 1,000 population, up slightly from the 1995 juvenile arrest rate of 8.1 arrests per 1,000 population.. The juvenile violent crime arrest rate was more than twice the adult rate of 4 arrests per 1,000 population.
- Clearances for Part I Violent Crimes increased by 7 percent, from 3,289 in 1995 to 3,518 in 1996. The clearance rate for Part I Violent crimes was 4.9 clearances per 1,000 population, an increase over the 1995 clearance rate of 4.6 clearances per 1,000 population.
- Arrests for Part I Property Crime increased by 1 percent, from 6,752 in 1995 to 6,823 in 1996. The arrest rate for Part I Property Crime was 9.4 crimes per 1,000 population. The juvenile arrest rate for property crimes was 29.8 arrests per 1,000 population, more than three times higher than the adult property crime arrest rate of 8.4 arrests per 1,000 population.
- The Part II Crime arrest rate in 1996 was 39.7 arrests per 1,000 population, down from the 1995 rate of 41.2 arrests per 1,000 population. Arrests for Part II Crimes fell by 4.6 percent, from 29,560 in 1995 to 28,780 in 1996. Nearly three out of every four Delaware arrests in 1996 were for Part II Crimes (74.9 percent).
- Clearances for Part II Crimes totaled 96,203 in 1996, a 3 percent increase over the 1995 total of 93,310 clearances. The 1996 Part II Crime clearance rate was 132.7 clearances per 1,000 population, up from the 1995 rate of 130.1 clearances per 1,000 population.


Total Arrests for Parts I and II 1984 - 1996


Clearance and Arrest Rates for Parts I and II


Arrests for Part I Violent Crime 1984 - 1996


Clearance and Arrest Rates for Part I Violent Crime


Arrests for Part I Property Crime 1984 - 1996


Clearance and Arrest Rates for Part I Property Crime


Arrests for Part II Crime 1984 - 1996



Illicit Drug Crime

- The number of illicit drug complaints statewide in 1996 totaled 7,074, a 4.9 percent increase above the 1995 total of 6,745 complaints. The statewide illicit drug complaint rate in 1996 was 9.8 complaints per 1,000 population.
- Delaware's illicit drug arrest rate in 1996 was 4 arrests per 1,000 population. A total of 2,921 illicit drug arrests were made in Delaware in 1996, a 3.8 percent decrease compared with 1995.
- The decrease in drug arrests in 1996 was limited to adult arrests. Juvenile drug arrests actually increased by 3.4 percent, from 597 in 1995 to 617 in 1996. About one out of every five persons arrested for drugs in 1996 was a juvenile (21.1 percent).
- The illicit drug complaint rate for New Castle County—9.2 complaints per 1,000 population, was the lowest of Delaware's three counties. Illicit drug complaints in New Castle County fell by 10.1 percent in 1996, and drug arrests fell by 4.1 percent.
- Kent County had the highest illicit drug complaint rate of Delaware's three counties—11.8 complaints per 1,000 population. Drug complaints in Kent County rose by 26.5 percent in 1996, and drug arrests increased by 7.9 percent.
- The illicit drug complaint rate for Sussex County was 10 complaints per 1,000 population. Drug complaints in Sussex County rose by 19.4 percent in 1996 and drug arrests rose by 11.2 percent.


Illicit Drug Complaints by County 1985 - 1996

Statewide Illicit Drug Complaint, Clearance, and Arrest Rates



Illicit Drug Complaint, Clearance, and Arrest Rates: New Castle County



Illicit Drug Complaint, Clearance, and Arrest Rates: Kent County




Illicit Drug Complaint, Clearance, and Arrest Rates: Sussex County

Rate per 1,000 Population





Arrests for Illicit Drug Crime 1985 - 1996





Arrests for Illicit Drug Crime by County 1985 - 1996





Adult Arrests for Illicit Drug Crime by County 1985 - 1996



Police Activity

- The number of law enforcement officers employed in Delaware totaled 1,650 in 1996, a two percent increase over the 1995 total of 1,617 officers.
- About one out of every three Delaware law enforcement officers worked for the State Police (32.7 percent). The number of officers employed by the Delaware State Police increased by 6.5 percent in 1996, from 507 in 1995 to 540.
- The New Castle County Police Department (NCCPD), the state's second largest law enforcement agency, employed 283 officers in 1996. This represents a 7.5 percent decrease below the 1995 total of 306 officers.
- The number of police employed by the Wilmington Police Department (WPD) fell by 5.7 percent in 1996, from 244 in 1995 to 230. Police staffing levels at WPD, which had reached its lowest point since 1982, was 18.7 percent below the 1991 total of 283 officers when staffing at WPD was at its highest.
- The number of officers employed in 18 of the state's smaller jurisdictions remained at the same levels as in 1995. Eleven jurisdictions reported an increase of one to three officers.
- 386 police officers were assaulted in Delaware in 1996. About one out of every three police officer assaults occurred when the officer(s) responded to a disturbance call (33.4 percent).



Type of Weapons Used in Assaults on Law Enforcement Officers



Crime Activity by Jurisdiction

Background Information on the Calculation of Clearance Rates as Reported in Crime in Delaware 1996.

Complaint and clearance data appear by agency in Crime in Delaware 1995 in the section entitled **Crime Activity by Jurisdiction**. A crime *clearance* by arrest or exceptional means is related to an original crime complaint. As defined in the glossary of the report, "A complaint report to the police is considered cleared or solved once the police have identified the offender. One arrest may clear several crimes; therefore, the clearance rate is often higher than the arrest rate."

The method of reporting clearances is by the date of the action. For example, a robbery occurs in December of 1996 and the offender is apprehended in August of 1997. This would be recorded in the State Bureau of Identification's (SBI) crime database as a 1996 reported crime or complaint, and it would be counted as case cleared after the 1996 end-of-year report.

Annual complaint statistics in crime in Delaware are for crimes reported in each respective year. clearance statistics for a given year show how many of that year's reported crimes have been cleared during that year. While it is recognized that more crimes will ultimately be cleared after the reporting year, clearance statistics are not updated in Crime in Delaware. This practice is consistent with that of the FBI's *Crime in the United States* reports; however, unlike the FBI reports, compilation of Crime in Delaware is delayed until the reporting year statistics are complete. Crime in Delaware data, therefore, should not be viewed as a year-end snapshot of each reporting year's law enforcement activity.

It is important to note that the snapshot is intended to provide a full account of a year's law enforcement activity, but there can be significant delays in conclusions and therefore the reporting of that activity. The SBI makes significant efforts to give all agencies the opportunity to have their year's activity entered into the state's information system. No agency is penalized for early, updated, or late reporting—in fact, SBI and the Center do not prepare the year-end summary and the annual analysis until the last jurisdiction reports.

Glossary

Note: This glossary contains the UCR federal definitions for crime categories. It also lists state statutes which should be viewed as examples of what statutes may fall into those crime categories. A good example is the federal crime category *Motor Vehicle Theft*. The statute listed below the federal definition is "Unauthorized use of a vehicle". There are also some motor vehicle thefts, however, that fall under Robbery, Aggravated Assault, or Burglary. Robberies, aggravated assaults, or burglaries, therefore, can fall under the UCR crime categories of *Robbery*, *Aggravated Assault*, *Burglary*, or *Motor Vehicle Theft*. The State Bureau of Identification determines which crime events fall into which UCR crime categories based on details not found in summary reportings.

Adult	A person 18 years of age or older.
Arrest Rate	The number of arrests per 1,000 population.
Clearance	A complaint reported to the police is considered cleared or solved once the police have identified the offender. One arrest may clear several crimes, therefore the clearance rate is often higher than the arrest rate.
Complaint	A criminal offense reported to the police.
Crime Rate	The number of crimes per 1,000 population.
Exceptional Clearances	An exceptional clearance refers to a clearance that does not result in an arrest. An offense can be cleared exceptionally only in cases where the identity of the offender has been established, enough information is available to support an arrest, and the exact location of the offender is known. For example, murder-suicides are cleared exceptionally, since the offender's death precludes their arrest.
Juvenile	A person under 18 years of age.
Part I Crime	Homicide, robbery, rape, aggravated assault, burglary, larceny, motor vehicle theft and arson.
Part II Crime	All crimes not included in the Part I Crime definition.
Population Data	Delaware population projection estimates are from the Delaware Population Consortium.
Property Crime	A subsection of Part I Crime including burglary, larceny, motor vehicle theft, and arson.
Reported Offenses	Crimes reported to or otherwise not known to police.
Violent Crime	A subsection of Part I Crime including homicide, rape, robbery, and aggravated assault.

Part I Crime: Violent Crime

These crimes are against persons and are counted per victim rather than per complaint.

1. **Criminal Homicide:** This includes Murder—the willful, non-negligent killing of one human being by another—and negligent Manslaughter.
