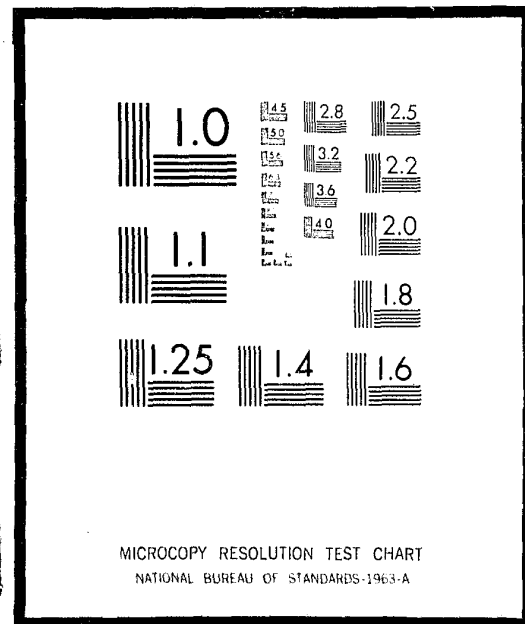

INTRODUCTION
