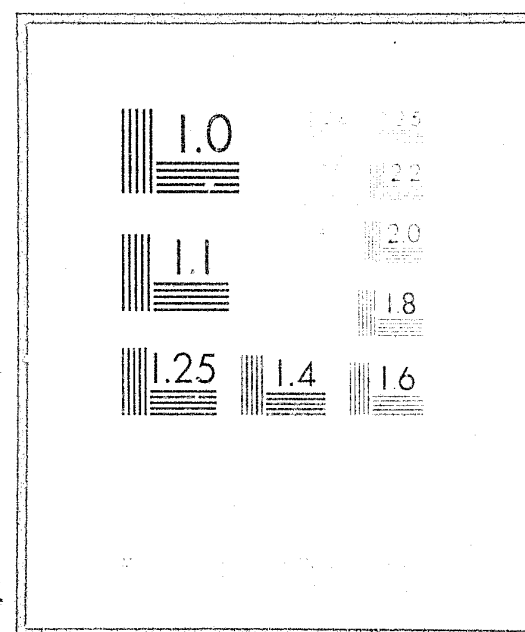

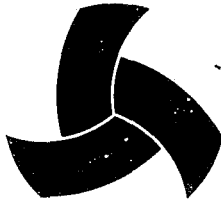

Background Information

This project represented an attempt to decrease the number of unsolved violent crimes, especially those of murder, rape, and robbery. In 1973, 8 percent of the murders, 63 percent of the robberies and 34 percent of the rapes were unsolved. These figures are especially troublesome because in almost all crimes of violence there is a face-to-face confrontation between the offender and the victim or witness; yet, in almost all cases the only description of the offender supplied to police officers is one which is often so broad or vague as to fit a substantial portion of the population. By putting a "face" with a description the possibility of effecting an arrest is increased.

The Police Artist grant allowed the Dallas Police Department to employ two civilian artists on an as-needed basis to make composites of offenders using descriptions provided by the victims or any witnesses.

The project had as goals:

1. A 1 percent increase in the clearance rate of murder in one year.
2. A 5 percent increase in the clearance rate of robberies in one year.
3. A 5 percent increase in the clearance rate of rapes in one year.

Project Utilization

The artists employed by this grant were used on only five cases. No criteria was established by the police department regulating the type of case in which the artists were used. The primary consideration for use was the ability or willingness of the victim or witness to describe the offender. In crimes involving a face-to-face confrontation it is often difficult for anyone to recall details about the suspect's description.

The following is a brief discussion of each of the cases in which the police artists were used, including the type of case, how the composite was made, the case's status and what effect the composite had on the clearance.

Case 1

On December 11, 1973, two men attempted to rob the Texas National Bank in Dallas. Although the robbery attempt was unsuccessful, a guard was killed during the attempt. About three hours after the robbery attempt, the suspect identified as the one who killed the guard was found, dead, in the car used in the attempt. From evidence gathered at the scene the police thought that murder was committed by the suspect's accomplice.

The bank's hidden camera got a picture of the remaining suspect, but due to the poor quality of the film the pictures were not suitable for circulation. Using one of the frames, one of the artists drew a clearer picture. A copy of the Information Bulletin, labeled Composite #1, using the artist's drawing is attached. It was distributed to police personnel only.

By finding one of the suspects dead, the murder of the bank guard was cleared but the robbery and other murder remain open and the second suspect unidentified.

Case 2

During a period from October, 1973, to April, 1974, there was a series of robberies of fast food restaurants and apartment complexes. During one of the robberies a cashier was raped. All of the offenses were committed by two young men, one white, one Mexican. After the first five offences, the victims were able to supply an artist with enough information about the white suspect for a composite to be developed using an Identity Kit. A copy of the Information Bulletin, labeled Composite #2, is attached. Distribution of the bulletin was limited to police personnel.

The robberies continued until April when two victims of a robbery saw the suspects in a grocery store. The police were called, arrests made, and 13 robberies and one rape were cleared.

Case 3

Between December, 1973, and February, 1974, there was a series of four robbery/shootings in Dallas and two robbery/murders in Dallas suburbs. Until the middle of January there were no witnesses and none of the victims were able to give the police any information to help them identify the suspects. On January 21, a witness was able to give one of the artists enough information for Composite #3 to be developed with the aid of an Identity Kit. Prior to distribution of the composites, the police checked with the other victims for their opinions about the resemblance of the composites to the suspects. There was no argument among the other victims about the resemblance although none could offer any suggestions for improvement. Because of their disagreement the police decided not to circulate the composites for fear that if the pictures did not look like the suspects the police might eliminate possible suspects.

Following two more robbery/shootings, the police did find a fingerprint of one of the suspects. Using the print and help from Austin, one suspect was identified. This led to the arrest of both suspects.

Case 4

During January to March, 1974, there were six rapes and other sexual abuses to teenaged girls in North Dallas and Richardson, a Dallas suburb. Four of the cases involved forcing the girls into the car in Richardson, then transporting them to Dallas where the rapes were committed. In late February, with information provided by two of the victims, one of the artists was able to draw the picture shown in Composite #4. Distribution was limited solely to the police.

In early March, 1974, following another rape in Richardson, the victim got the license number of the suspect's car. The Richardson police arrested the suspect the same day.

Since this case was the only one where a picture was drawn from a description, without using an Identity Kit, a copy of the suspect's picture, labeled as Picture #1, is attached.

Case 5

In February, 1974, a burglary of a Dallas residence resulted in the loss of a \$2,000 watch and a \$3,000 necklace. An artist was used to draw pictures of both items. Neither picture could be located for this evaluation.

This case is still open and neither of the items have been recovered.

Evaluation

The facts show the artists were used five times and in none of the instances did the composites contribute to the clearance of a case. This limited use did not generate sufficient data to justify any conclusions about the effectiveness of an artist to the police. Therefore, no analysis of goal achievement is undertaken by this evaluation. Instead it might be more meaningful to examine the possible reasons why the artists were not used to the fullest potential. Any analysis of this type is based upon the perceptions of the evaluator and should be viewed as such.

. This project apparently suffered from a lack of both administrative and staff support from the beginning. Greater care should have been taken to involve the C.A.P. staff in the preparation of the grant application. Some type of involvement in the development of the project would have given the officers a commitment in the success of the project. If, for some reason, the direct involvement of C.A.P. staff was not feasible, then some type of

direct concerted effort should have been made to promote the concept of a Police Artist. This type of effort could have conceivably enhanced the acceptance of the artist program by the police officers.

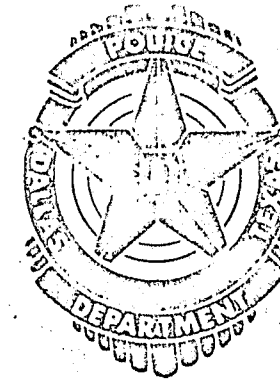
. More attention should have been paid to the preparation of the artists to pursue the project objectives. The employment of a graduate of a school that specializes in training police artists would have strengthened the program. Since this type of artist was not available, then special training should have been provided within the framework of the grant.

. The Identity Kit, used by the artists on two occasions, was not included in the grant application. If a Kit was to be used, then the artists should have received extensive instruction in its use. The artists were expected to use the kits after one practice session. In addition, a new Identity Kit should have been provided for the artist. The department's 10-year-old kit does not contain many of the features of the newer kits and lacks the latest hairstyles and beards.

Overall, it can be said that the police department did not pursue the alternatives presented by this grant. The department should examine the reasons for the lack of success of this project. The use of police artists may have merit. The identity and apprehension of criminal offenders is pursued through the use of a significant amount of police resources. Technology employed toward the improvements of these efforts should be utilized and should be complemented by the support of appropriate police staff.

If, in the future, the department decides to develop the use of police artists, it should be done with the problems of this project in mind.

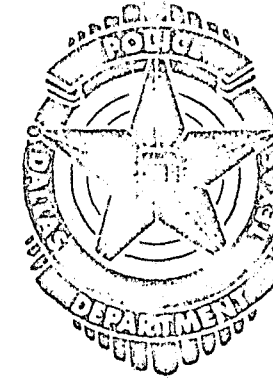

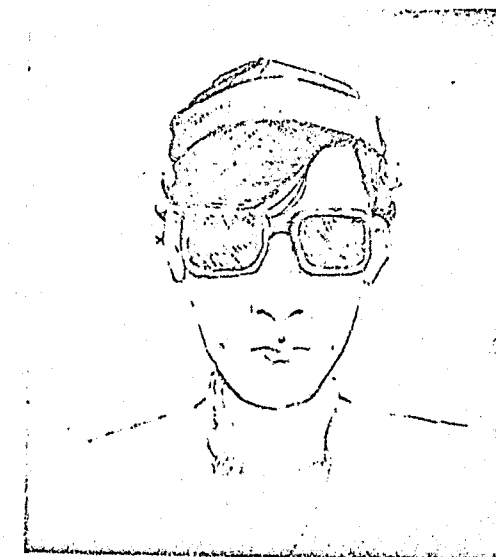

ACTIVE ARMED ROBBER

This is an artist composite drawing of an active armed robber. This subject is described as a white male, 5'6" to 5'10" Tall, 130 to 165 Pounds, 18-21 years old.

On 12-9-73, this subject robbed the Pizza Hut at 6632 E. Northwest Hwy., at 1:38 a.m., Service #365672-E and on 12-11-73 the Pizza Hut at 4436 Lemmon Avenue, at 11:57 a.m., Service# 368771-E. During both of these robberies the suspect was described as wearing a blue pull over type sweater with dark trousers, black horn rimmed glasses or sunglasses (may be a justo-light lens) and had a bandaid on his face, and wearing a black toboggan.

WANTED FOR AGGRAVATED RAPE

When the two girls walked over to the car, the suspect grabbed one of the girls by the hair and put a knife to her throat. The suspect then made the girls get into the back floorboard of the vehicle. The suspect then drove to the park at 7100 Valley View Lane. The suspect then raped both girls and made one of the girls committ sodomy. The suspect then gave the girls their clothes back and left.

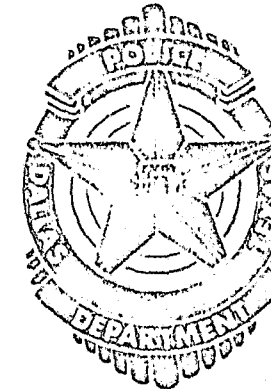

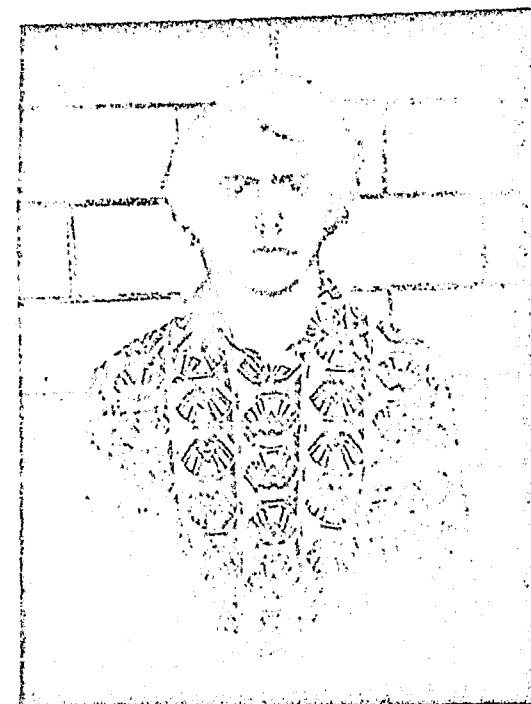
