

PREFACE

Appearing on the following pages in directory format are informational listings of criminal justice diversion programs under development and operational in the 50 States, the District of Columbia, Puerto Rico, and the U.S. Virgin Islands. Updated annually, the revised Bulletin attempts to keep pace with the remarkable growth of formalized diversion alternatives. Its coverage is expanded to include programs administered by police departments, prosecutors, public defender agencies, courts, probation, and community-based public service organizations. New service dimensions are added which feature pre-trial rehabilitation programs for drug and alcohol abusers and other "high risk" diversion cases.

Center publication of the Directory is intended to assist its users in the location and identification of sites planning diversion strategies, and characteristics of operational programs. In compiling these program listings, every effort was made to include diversionary sites known to us, yet by fault of either communication or oversight, there is apt to be slippage in the recording process. Supplements to the Directory will be issued periodically and we ask that any corrections or additions to this revised edition be called to our attention.

The National Offender Services Coordination Program is funded by the U.S. Department of Labor, Employment and Training Administration, and sponsored by the American Bar Association, Commission on Correctional Facilities and Services. NOSCP is a technical assistance effort to stimulate new and accelerated offender services through prime sponsor agencies designated under the Comprehensive Employment and Training Act of 1973, as amended.

NOSCP is an umbrella program with three functional units: the Clearinghouse on Offender Employment Restrictions, the Female Offender Resource Center, and the Pretrial Intervention Service Center. The programs address such subjects as the disabilities of conviction and incarceration, employer attitudes and perceptions, different treatment of male and female offenders, and alternatives to incarceration. In addition, NOSCP maintains a clearinghouse Information Exchange to compile data on all existing offender service programs.

Due to the increase in listings (from 57 projects in 1974 to 148 reported here) it was necessary to adjust our classification scheme to accommodate conceptual variations. Many programs have expanded their diversion jurisdiction and this growth factor is reported, where applicable. Also, a "point of diversion" characteristic was added and a "participant focus" descriptor included as definitive improvements.

The distinguishing characteristic shared by most programs features elements of contemporary diversion practice including: (1) formalized screening and placement criteria; (ii) structured delivery of services plan for job development assistance, counseling, vocational skills training, remedial education, and related employability resources; and (iii) dismissal of criminal charges and expungement or sealing of arrest records of successful participants.
