In 1972, the Massachusetts Department of Correction, in an attempt to provide alternatives to the traditional methods of correctional programming, began developing and implementing a system of community-based correctional programs. These programs (i.e. the Furlough Program, the Work and Educational Release Programs, the Special Impact Programs and the Community Rehabilitation System Programs), had all been made possible through the passage of the Correctional Reform Act (Chapter 777) by the Massachusetts Legislature in 1972.

The most far-reaching of these community programs, the Community Rehabilitation System (CRS), began operations in August of 1972. CRS is a network of small, separately operated community based correctional facilities that handle both "post-release" (individuals on parole) and "pre-release" (persons soon expected to merit parole) clients. Some of these centers are operated directly by the Department of Correction (Boston State and Shirley) while others are sub-contracted by the DOC to be run by private agencies. At the time of this writing, there are three such agencies: The Massachusetts Halfway Houses Inc. (Brooke House, Coolidge House, and Temporary Housing Project), Roxbury Multi-service Center (Roxbury CRC) and the Friends of Framingham (Charlotte House). The main objective of this system, as well as the other Community Programs, is to provide the offender with a smooth transition from the total institutionalized correctional facility to the nearly complete freedom of a parole.¹ It is the feeling of the Department of Correction that through a carefully and responsibly run

system of community based correctional programs, the incarcerated individual can make the very difficult adjustment back into society in a more positive and productive way.

Residents at these facilities participate in either work or educational programs and may receive counseling and other supportive services. While the methods of treatment and program structure may vary, it is expected that certain services will be common to all. These services include: (1) counseling services, i.e. individual, group and family counseling; (2) vocational counseling; (3) arrangements for pre-vocational and vocational training; (4) job development and job placement; (5) arrangement for education, to include remedial education, G.E.D. certification and higher education; (6) financial planning and management; (7) arrangements for medical and legal services; (8) recreational activities and (9) participation in interagency programs (A.A., Drug Programs, etc.). For specific data regarding work and educational release programs, Tables III, IV, and VII are produced below.

The data included in this section of the report covers a period beginning December 31, 1973 and concluding on December 31, 1974. During this period, four of the seven participating facilities began receiving pre-release clients for the first time. It is important to note that during 1974, Roxbury Community Rehabilitation Center, Brooke House and Coolidge House all went from a residency population made up entirely of post-release clients to a population consisting of 75 to 77% pre-release residents (Table VIII). This reflects a departmental policy change in that the Community Rehabilitation system is now being used primarily to assist individuals still on pre-release status.

Other statistical information to be found in this section of the report include movement of population data, program termination data, and program data.

Boston State Pre-Release Center

Admission/Release Data

On the last day of December, 1973, the Pre-Release Center at Boston State Hospital reported a total of 38 male residents', there were 139 residents admitted to Boston State during 1974 and a total of 128 were released. During that year, Boston State averaged about 12 admissions and 11 releases per month and had an average daily population of 47. Thus, we may note a slight increase in population at the Boston State Pre-Release Facility during the course of 1974. The number in residence on the last day of 1974 was 49.

Source of Admissions

By looking at the Boston State column of Table I, we may note that 127 (91%) of the 139 total admissions for 1974 were received from various Massachusetts Correctional Institutions. 5 (4%) were received from various other Community Rehabilitation Centers, 2 (1%) from Jails and Houses of Correction as well as 2 (1%) which returned from escape. The remaining 3 (2%) residents admitted to Boston State were recorded in the monthly reports in a category entitled "other". During 1974, we ceased using this category in an effort to make our reporting process more specific. Jails and Houses of Correction, Temporary Custody, other Community Rehabilitation Centers, etc., were among the kinds of areas covered by that category. In reading the remainder of this report, the reader is advised to consult this explanation to avoid undue confusion with regard to this admittedly vague category. Obviously then, this would apply to the sections dealing with releases as well.

Types of Releases

In Table I we may note that of the men released in 1974 from Boston State 60 (47%) were released by permit of the Parole Board. Further, 2 (2%) received Good Conduct discharges and 1 (1%) was released due to sentence expiration. Thus, 63 or 49% of the total released from Boston State during 1974 were returned to the community. Of the remaining 51%, 30 (23%) were returned to various M.C.I.'s, 14 (11%) were reported escapes, 5 (4%) were transferred to other Community Rehabilitation Programs, 3 (2%) were transferred to Jails and Houses of Correction and 13 (10%) were reported released in the "other" category.

Shirley Pre-Release Center

Admission/Release Data

On December 31, 1973, the Pre-Release Facility at Shirley had 55 men in residence. During the course of 1974, Shirley P.R.C. accepted a total of 170 clients all on Pre-Release status. Also during that year, 182 residents were released in a various number of ways to be touched upon in the following paragraphs. The average monthly admission total was 14 while the average number of residents released was higher by one. The average daily population at Shirley during 1974 was 48 and on the last day of December 1974 the number in residence was slightly lower at 43.

Source of Admissions

Table I shows that 160 (94%) of the 170 total admissions for 1974 were received from various Massachusetts Correctional Institutions. We can observe further that 139 (87%) of the aforementioned 160 were transfers from MCI Concord. Shirley then, received 82% of their 1974 residents from MCI Concord. Four other residents were received from the Reception Diagnostic Center lo-

cated at MCI-Norfolk [2(1%)], Coolidge House [1(1%)], and Temporary Custody [1(1%)]. The remaining 6 (4%) residents were listed in the "other" category.

Type of Releases

Table I also shows that of the 182 men released from Shirley P.R.C.; 71 (39%) were returned to the community by permit of the Parole Board, 51 (28%) were returned to various MCI's, 18 (10%) were recorded as escapes and 15 (8%) were transferred to other Community Rehabilitation Centers. An additional 27 (15%) were recorded released in the "other" category.

Charlotte House

Admission/Release Data

On the last day of 1973, Charlotte House reported 7 women in residence. In 1974, Charlotte House admitted a total of 19 women and released 18. There was a monthly average of 2 admissions and 2 releases during that year and the average daily population for 1974 was 9. On December 31st, 8 women were in residence at the Charlotte House Facility.

Source of Admissions

All of the 19 admissions were received from MCI-Framingham.

Type of Releases

Table I shows that of the 18 women released from Charlotte House during 1974, 12 (67%) were released by permit of the Parole Board and 1 (6%) was discharged by a Good Conduct Certificate. Thus, an impressive 73% of the Charlotte House women released during 1974 returned to society. Of the remaining 5 women released, 2 (11%) were returned to MCI-Framingham, 2 (11%)

were reported escaped and 1 (6%) individual was reported in the "other" category.

Roxbury Community Rehabilitation Center

Admission/Release Data

A total of 6 residents were reported to be residing at Roxbury C.R.C. on the last day of December, 1973. All 6 were on Post-release status as no Pre-release clients were admitted until January of 1974. During the course of the year, Roxbury became primarily a Pre-release oriented facility in that only 3 Post-release clients were admitted as opposed to 64 pre-release admissions. Two of those three post-release admissions were persons who had been living at Roxbury on Pre-release status and had switched to Post-release status upon receiving Parole. Thus, only one resident (who entered the program in January) was admitted in the usual sense as the other two had already been in residence. The remaining 7 Post-release clients (the original 6 plus the January admission) had all been released by the end of April, 1974. Fifty-one (80%) of the 64 admitted to the Facility on Pre-release status were also released during the course of the year.

The average number of Pre-release individuals admitted to Roxbury during 1974 was 5 and the average released was 4. Roxbury's average daily population for that year was 17, a sizable increase over the stating figure of 6. It is also a slight increase over the average daily population for the first quarter of 1974 (or when the Facility was housing both pre and post-release clients), which was 13. Thus, we may note that during the course of 1974, Roxbury more than doubled its clients in residence over the previous year.

Source of Admissions

Due to the small number of post-release admissions, we refer you to

Table II for a breakdown as it will not be supplied here.

Of the 64 pre-release clients admitted to Roxbury C.R.C. during 1974, 47 (73%) were received from various Massachusetts Correctional Institutions. Fourteen (22%) were received from other Community Rehabilitation Centers and the 3 (5%) remaining were reported in the "other" category.

Types of Release:

Post-Release

Four (57%) of the 7 Post-release residents that left Roxbury C.R.C. during 1974 were considered successful program completions. The remaining 3 (43%) left the program due to a failure to adjust.

Pre-Release

Of the 51 Pre-release clients released from Roxbury Community Rehabilitation Program; 25 (49%) were returned to society by permit of the Parole Board, 14 (27%) were returned to various MCI's 2 (4%) each were either transferred to other Community Rehabilitation Centers, Jails or Houses of Correction, released from Temporary Custody or reported escape. An additional 4 (8%) were reported in the "other" category.

Massachusetts Halfway Houses Inc.

Brooke House

Admission/Release Data

As in all of the Mass. Halfway Houses, no pre-release clients were in residence at Brooke House until March, 1974. Therefore, all 13 clients in residence on December 31, 1973 were on post-release status. During the course of 1974, a total of 57 men were admitted to the Brooke House Facility. Of that number, 37 were on Pre-release status and 20 were Post-release clients. The monthly average for Post-release admissions to Brooke House for that year was 2. This is half the monthly average of Pre-release clients admitted to

that facility during the ten month period between March and December. As you can see Brooke House has shifted in emphasis to a pre-release oriented facility.

In 1974, 58 men were released from Brooke House. Of that total, an equal number of clients were released from the pre and post-release programs. However, the monthly averages differ somewhat due to the differing time variables discussed above. Therefore, the average monthly number of residents released from Brooke House on pre-release status was 3 and the post-release average was 2.

The average daily population for Brooke House in 1974 consisted of 8 pre-release clients and 4 residents on post-release status. Similarly, these same figures apply to the number of residents living at Brooke House on the last day of December, 1974. By noting the 12/31/73 figure of 13 and the 12/31/74 total of 12, we may observe no significant change in the total number of residents living at Brooke House during 1974.

Source of Admissions

Pre-Release

Twenty-five (68%) of the total number admitted to Brooke House in 1974 were received from various Massachusetts Correctional Institutions. Ten (27%) came from other Community Rehabilitation Programs, 1 (3%) was received from a House of Correction and 1 (3%) was reported in the "other" category.

Post-Release

Twelve (60%) of the residents admitted on post-release status arrived directly from the various MCI's. Two (10%) were received from Community Rehabilitation Centers, 2 (10%) were admitted directly off the street and 4 (20%) were listed in the "other" category.

Type of ReleasePre-Release

Of the total residents released from Brooke House on pre-release status, 16 (55%) were released by permit of the Parole Board and 1 (3%) was released due to sentence expiration. Thus, 59% of the 29 residents released on pre-release status were returned to the community. Eight (28%) were reported escaped, 3 (10%) were returned to MCI's and 1 (3%) individual was transferred to the Reception Diagnostic Center.

Post-Release

Seventeen (59%) of the total 29 post-release clients that left Brooke House during 1974 were considered successful program completions. Three (10%) left the program due to a failure to adjust, 2 (7%) were arrested and 7 (24%) were listed in the "other" category.

Temporary Housing ProjectAdmission/Release Data

On December 31, 1973, one Post-release client was in residence at Temporary Housing Project. During the course of 1974, 13 Post-release and 7 Pre-release clients were admitted to the program, averaging 2 admissions per month. All 7 of the Pre-release residents were released at an average of one a month. Of the 14 Post-release clients in residence during the year, 12 were program terminations. The monthly Post-release program terminations also averaged at one. The 1974 average daily population at Temporary Housing consisted of one resident on Pre-release and one client on Post-release status. On December 31, 1974, T.H.P. had 2 Post-release clients in residence.

Source of AdmissionsPre-Release:

Of the 7 residents admitted to the program on Pre-release status, 4 (57%) were received from Massachusetts Correctional Institutions and 3 (43%) were

transferred from the Shirley Pre-Release Center.

Post-Release:

Table VI shows that 3 (23%) of the 1974 Post-release clients were received from Jails and Houses of Correction, 2 (15%) came from MCI's and 8 (62%) were listed in the "other" category.

Type of Releases

Pre-Release:

By looking at Table V we can observe that 4 (57%) of the total number of Pre-release clients returned to the community by Permit of the Parole Board. Of the remaining 3 released during 1974, 2 (29%) were returned to Massachusetts Correctional Institutions and 1 (14%) was listed in the "other" category.

Post-Release:

Of the 12 Post-release clients terminated; 9 (75%) were considered to be successful program completions, 1 (8%) left the program due to a failure to adjust and 2 (17%) terminations were listed in the "other" category.

COOLIDGE HOUSE

On the 31st of December, 1973, Coolidge House reported a total of 7 people in residence, all on post-release status. During the course of 1974, a total of 76 clients were admitted to the facility of an average of 7 per month. Of that total, 41 (54%) were admitted on a pre-release status and 35 (46%) entered the program on a post-release basis. During the aforementioned ten-month period (March to December) in which pre-release residents were admitted to the facility, 31 of those who entered the program were released. Thus, on December 31, 1974, 10 pre-release residents remained at Coolidge House. On the other hand, 40 post-release residents were released

leaving only 2 in residence on that date. It is clear then that during 1974 Coolidge House also shifted towards a residency made up primarily of pre-release clientele.

The average daily population at Coolidge House during 1974 consisted of 11 pre-release clients and 4 residents on post-release. There was a monthly average of 4 pre-release and 3 post-release admissions during that year. Further, Coolidge House averaged 6 releases a month dividing them evenly between pre and post-release.

Source of Admissions

Pre-Release

Coolidge House received 25 (61%) of their 41 pre-release admissions from various Massachusetts Correctional Institutions. Of the remaining number, 13 (32%) came from other Community Rehabilitation Centers and 3 (7%) admissions were listed in the "other" category.

Post-Release

Of the 35 post-release admissions to Coolidge House during 1974; 15 (43%) came directly from various MCI's, 4 (11%) were received from Jails and Houses of Correction, 2 (6%) were from other Community Rehabilitation Programs and 14 (40%) were listed in the "other" category.

Type of Release

Pre-Release

Table V shows that 17 (63%) residents returned to the street by Permit of the Parole Board during 1974. The remaining releases went either to Massachusetts Correctional Institutions [5(19%)], other Community Rehabilitation Programs [1(4%)] or they escaped [4(15%)].

Post-Release

Of the post-release clients who terminated their stay at Coolidge House during 1974; 23 (58%) were considered successful completions, 5 (13%) left

due to a failure to adjust, 5 (13%) were parole violations and 7 (18%) were listed in the "other" category.

Also, it should be noted that two additional pre-release clients, who were admitted and released from Project Overcome during 1974, are not included in the above data.
