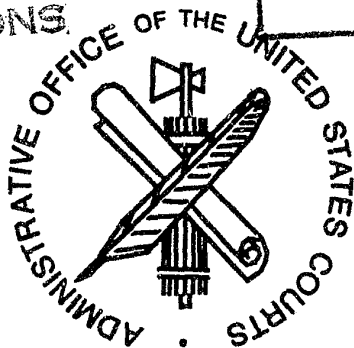

Message to our readers:



We invite you to share with us your ideas on these reports and look forward to your comments.

## INTRODUCTION

This third quarter report for the statistical year ended June 30, 1977 represents a nine months report for the period July 1, 1976 through March 31, 1977. The accompanying special table compares these nine months with the 12 months ended June 30, 1976. Generally, the figures indicate that where the nine months proportion is lower than 75% the volume of filings or terminations are at a lower pace than a year ago. Where the proportion is greater than 75%, a faster pace than last year is indicated.

In the annals of the publication of quarterly reports, this should represent the last one which is based on nine months. In its May 1977 meeting the Subcommittee on Judicial Statistics of the Judicial Conference Committee on Court Administration approved the publication of 12 months reports at the end of each quarter of the year. Such publications will permit readers to enjoy twelve full months of data which will be compared to the previous twelve months of information. Thus the regular report for the 12 months period ended June 30, 1977 will comply with the Director's responsibilities under Title 28 U.S.C. 604 (3)(a) to have in the hands of the Judicial Conference of the United States two weeks before its fall meeting an annual report on the activities of the federal judiciary.

The second report for the 12 months ended September 30 will conform to the requirement for workload statistics and related matters for the use of the various Committees of the Judicial Conference in providing the budget for the federal judiciary.

The third 12 months report for the period ending December 31 will be similar to a calendar year report and provide comparable data for the use of statistical systems in state court administrations. The fourth report will round out the set of reports and encompass the 12 months ending March 31.

The value of these reports, aside from the relative ease in providing them on a 12 months basis instead of four different time periods, can be listed as follows:

1. More currency in statistical information at both national and district levels.
2. Quicker identification of trends.
3. More flexible reporting periods to handle varied requirements for information in the federal judicial system.
4. More helpful to judges, circuit executives, U.S. magistrates, bankruptcy judges, probation officers, public defenders and clerks of court, all of whom contribute to these reports - the latter providing upwards of 60% of the data presented herein.

Along with the move to the 12-month type of report each quarter, modifications in tables are anticipated. Our readers are always invited to comment on the material and the analysis. The value of the report is in its use as well as its record of the accomplishments of the federal judiciary.

#### UNITED STATES COURTS OF APPEALS

Nationally, filings in the courts of appeals are up, with terminations also climbing. However, the increased terminations did not offset filings, thus resulting in a 9.2% increase in the volume of pending appeals on March 30, 1977 over June 30, 1976.

Civil appeals from the district courts during the 9-month period were 78.0% of last year's civil filings in the courts of appeals. Criminal appeals for the 9-months comprised 77.1% of the previous 12 months.

Among civil appeals from the district courts, appeals from decisions arising out of Social Security litigation where the government was named as the defendant rose to 357 in the first nine months compared to 293 such cases filed in all of the 12 months ended June 30, 1976. Already, there are 22% more cases filed in 9 months than in the previous 12 months.

Under federal question, suits by private parties rising out of suits involving the Labor Management Relations Act in the first nine months numbered 170 or 79.8% of the 213 recorded 12 months earlier.

Appendix Tables B-1 and B-7 provide additional information on the caseload of the courts of appeals.

#### CASES UNDER SUBMISSION IN THE COURTS OF APPEALS AND IN THE COURT OF CLAIMS

As of March 31, 1977 there were 369 cases reported held under submission in the courts of appeals which had been heard or submitted more than three months before that date, with the Third Circuit, the Court of Claims, and the Temporary Emergency Court of Appeals reporting no cases held over three months. Of these, 369 cases have been held under submission from 3 to 6 months, 55 from 6 to 9 months, 37 from 9 to 12 months, and 32 for more than one year. The accompanying table shows, by circuit, the distribution of these cases.

#### UNITED STATES DISTRICT COURTS

##### CIVIL CASELOAD

Nationally, civil filings continue to run slightly below the overall filings last year. Civil rights litigation is up slightly, while suits by prisoners made a modest downturn and suits for black lung benefits for the nine months represented only 39% of all of last year's overall filing figure.

Returning to prisoner petitions, parole board reviews in 9 months represented only 36% of such filings a year ago. Motions to vacate sentence by federal prisoners climbed slightly compared to a year ago. For state prisoners, civil rights suits made a strong gain over a year ago.

Terminations of civil cases in the district courts was up proportionately compared to a year ago. But the downturn in filings and the increase in civil cases closed was not enough to make a decided impact on the pending caseload. Indeed, the 150,556 civil cases pending on March

31, 1977 was greater by 10,367 (or 7.4%) than the 140,189 pending on June 30, 1976. Stated another way, there were 26 more cases pending per authorized judgeship than nine months earlier when there were 351 civil cases pending per judgeship. Thus, the civil workload alone measured 377 cases per judgeship.

#### CRIMINAL CASES AND DEFENDANTS

Nationally, the number of criminal cases filed in the district courts is lower than a year ago. The decrease is more a result of a change in statistical counting which, as noted in previous reports, will require about two years before comparable caseload data for criminal activity can be provided. The factors which create the lack of harmony with previous years' data and criminal statistics beginning with the implementation of the reporting procedures created under the provisions of the Speedy Trial Act of 1974 (P.L. 93-619, approved January 3, 1975) can be summed up as follows:

1. Minor offenses, generally not previously recorded in the district court caseload since most of them are handled by U.S. magistrates, are now recorded in the criminal workload of the district court. Therefore, in the appendix of this report and in all future reports great pains have been taken to show all criminal cases (felony, misdemeanors, and minor offenses as well as petty offenses appealed to the district court) and separately felony and misdemeanor cases.

2. Under the provisions of the Speedy Trial Act superseding indictments or informations are now excluded where the government seeks to dismiss the original indictment. Because the procedural clock for counting time under the Speedy Trial time intervals begins with the original indictment (the arrest actually begins the clock), any subsequent indictment or information is not counted.

The effect of this change is most noticeable for drug law prosecutions, since it was a general practice in some districts to proceed with an indictment on such prosecutions only to withdraw it later upon filing of an information on a lesser drug charge.

3. Though criminal filings are still case oriented and several defendants may be indicted together, the accounting of criminal defendants has been aided substantially by the revised reporting system. Therefore, it is now possible at time of filing and closing of cases to show the volume of defendants. It may come as some surprise to our readers to discover that the defendant per case figure varies substantially among the districts.

Having this information is most helpful for workload studies because mere criminal case accounting did not reflect the defendant workload which, though averaging 1.4 per case, may vary from slightly more than 1 defendant per case to a high level of more than 2 defendants per case.

4. Because the Speedy Trial Act criteria for the accounting of time in the criminal justice process does not apply to all defendants, such as juveniles proceeded under the provisions of the Criminal Justice Act, the criminal statistical series will be enhanced by additional tables prepared specifically to show the district court experience with the implementation of the Act.

For these reasons, readers are cautioned in using these criminal statistics for direct comparisons with data for previous time periods. Though every care will be made to define the tables and to provide useful analysis, we are aware that time comparisons will be difficult for some time to come.

The generally downward movement of the criminal case filings can be best illustrated in appendix table D-2 which provides, for selected offenses, comparisons between the nine month period ended March 31, 1977 and that of March 1976. As shown in this table drug law violations dropped 21.3%, while drunk driving and traffic offenses, which are usually tried as minor offenses before U.S. magistrates, increased 81.3%.

Data for each district court by major offense classification for all cases reported and for felony and misdemeanor cases only are provided in tables D-3AC and D-3FMC, respectively. By comparing the two tables it is possible to isolate those districts with a large volume of minor offense filings.

## BANKRUPTCY CASES

There has been a marked nationwide decline in filings of bankruptcy cases. If filings continue at the pace observed during the nine-month period, the estimated decline by June 30, 1977 may be as much as 35,000 cases compared to a year ago. The deceleration of such filings and the continuing effort to terminate bankruptcy cases reduced the overall pending bankruptcy caseload by almost 5%, down to 258,252 on March 31, 1977 compared to 271,039 nine months ago.

Tables F-1, F-2 and F-3 provide, by district, information on the bankruptcy workload for the nine months period, July 1, 1976 through March 31, 1977.

## FEDERAL PROBATION SERVICE

The number of persons received for supervision by the Federal Probation Service is lagging slightly behind last year and closings are also running the same pace. The number of persons under supervision on March 31, 1977 (64,204) is almost unchanged since June 30, 1976 when there were 64,246 persons under supervision.

Appendix tables E-1 and E-2 provide additional information on the workload of the Federal Probation Service.

## CASES AND MOTIONS UNDER ADVISEMENT IN THE DISTRICT COURTS

Reports have been received from 455 district judges (including 90 senior judges) concerning cases and motions held under advisement for more than 60 days as of March 31, 1977. Of these, 286 reported having no matters held under advisement more than 60 days. There were 13 district judges who did not report.

The remaining 169 district judges reported a total of 600 cases and 559 motions held under advisement more than 60 days. These figures represent a 50% and a 63% increase, respectively, over those reported as of March 31, 1976.

There were 356 cases and 362 motions which had been held under advisement more than 60 days but less than six months, 126 cases and 115 motions which had been held more than six months but less than one year, and 118 cases and 82 motions held more than one year.

The following summary shows, by circuit, the number of district judges with no cases or motions held under advisement for more than 60 days on March 31, 1977 and the number reporting matters held over 60 days.

APPENDIX OF  
DETAILED STATISTICAL TABLES  
JULY, 1976 - MARCH, 1977

Due to the reporting requirements of the Speedy Trial Act of 1974, data for the criminal statistical series includes all cases and all defendants prosecuted in the U.S. district courts and separate tables on defendants charged with felony or misdemeanor level offenses. This latter group therefore, excludes minor offenses as well as petty offenses appealed to the district courts.

The appendix tables are labeled with letters which indicate the type of defendants or cases as shown below:

AC - all cases

AD - all defendants

FMC - cases reported as felonies and misdemeanors; i.e.,  
any offense for which the penalty exceeds one year  
in prison or where the fine is greater than \$1,000  
or both.

FMD - defendants in felony and misdemeanor cases; i.e.,  
any offense for which the penalty exceeds one year  
in prison or where the fine is greater than \$1,000  
or both.

---

Petty offense - any misdemeanor for which the penalty does not exceed 6 months imprisonment or a fine of not more than \$500, or both. (18 U.S.C. §1)

Other minor offense - any misdemeanor, other than a petty offense, for which the penalty does not exceed one year's imprisonment or a fine of not more than \$1,000, or both. (18 U.S.C. §3401)

Other misdemeanor - any criminal offense where conviction could result in no more than one year's imprisonment and/or a fine greater than \$1,000, or any offense specifically excepted under 18 U.S.C. §3401(f)

Felony - a criminal offense punishable by imprisonment for a term exceeding one year. (18 U.S.C. §1)
