HIGHLIGHTS

- * Burglary and auto theft accounted for 63.2 percent of juvenile male offences. (Table 10)
- * About two-thirds (64.1 percent) of the juvenile males returned to institutions from aftercare and committed law violations, while about one-half (47.1 percent) of the juvenile females in this category were returned for "absconding or running away." (Table 11)
- * Decrease (31.1 percent to 22.2 percent) from 1976 to 1977 in the percentage of newly-admitted juvenile males functioning at below normal intelligence level. (Table A)
- * Decrease (81.8 percent to 64.3 percent) from 1976 to 1977 in the percentage of newly-admitted juvenile females having prior official probation experience. (Table B)
- * Significant increase from 1976 to 1977 in the total number (from 7 to 84) of newly-admitted juvenile females. (Table B)
- * Marked increase (22.7 percent to 64.7 percent) from 1976 to 1977 in the percentage of re-admissions from aftercare of non-White juvenile females, although the trend in total numbers of juvenile females in this category continues its downward trend. (Table D)
- * Substantial decrease (57.2 percent to 18.2 percent) from 1976 to 1977 in the percentage of newly-admitted juvenile females who are state probation violators. (Table E)
- * Increase from 1976 to 1977 of 11.5 percentage points in Black juvenile male new admissions from Milwaukee County, while there is a decrease of 29.1 percentage points for Black juvenile females in the same category. (Table 8)
- * Decrease from 1976 to 1977 of 42 percentage points in White juvenile females and an increase of 42 percentage points in Black juvenile females in the re-admission from aftercare category. (Table 9)

This bulletin contains descriptive data regarding male and female juveniles admitted to Wisconsin juvenile correctional institutions during calendar year 1977.

Tables A through D report selected characteristics for the period 1973 through 1977. Table E reports on selected characteristics for newly admitted state probation violators for 1973 through 1977. Tables 1 through 18 contain data relating only to 1977 admissions.

Percentage of re-admissions of non-White juvenile females increased substantially, resulting in the highest percentage in at least the last five years. The overall trend regarding the decrease in numbers of juvenile females re-admitted has continued.

New admissions of juvenile male state probation violators remained relatively constant from 1976, although it remains significantly higher than five years ago. The percentage of non-White juvenile males increased notably over 1976. New admissions of juvenile female state probation violators increased by 63.6 percent, although the total number remains relatively low. There was a significant decrease in the percentage of non-White juvenile females in this category. Although fluctuating, the percentage of juvenile females functioning at below normal intelligence levels continues its downward trend.






