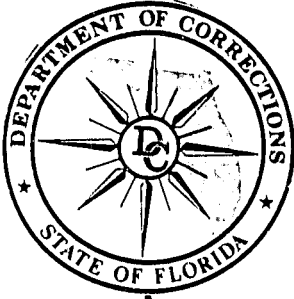

NOTE:

Some caution should be exercised in interpretation of the data presented in this report. In processing inmate commitment documents submitted by the circuit courts, the Department records only the primary offense (for automated data purposes) where there are multiple convictions, and the total term of confinement is entered as the length of sentence (ie., a fifteen year length of sentence may be the result of a single count of armed robbery, for instance, or the product of three five-year convictions of which armed robbery represented the primary offense). Therefore, this report should not be used in the context of examination of length of sentences given for specific offense types. Its intended use is to assist the Department in assessing needs for fixed capital outlay.

ANALYSIS OF THE RESIDUAL FLORIDA PRISON POPULATION
BY OFFENSE AND LENGTH OF SENTENCE
FY 1973-74 THROUGH FY 1977-78

The Florida prison population is changing. The potential for violence within the inmate population is increasing as a result of significant increases in the number of offenders in custody who have been sentenced for serious/violent offenses and for relatively long terms of confinement. This fact is borne out by examination of tables presented in this report and points to the need for greater capacity in medium to close custody facilities than is currently available within the Florida system.

The changes in the inmate population documented in this report do not represent any significant changes in sentencing or release policies by Florida criminal justice officials. Rather, they are the result of the fact that the rate of release of those admitted with long sentences does not equal the rate at which they are being committed. This in turn, is a reflection of the dramatic increase in the numbers of offenders admitted to DC over the past five years.

This report is primarily concerned with the "residual" population or the net difference between the annual admissions and losses. Table 1 enumerates the annual admissions by length of sentence, Table 2 the annual losses by length of sentence and Table 3 the annual net loss or gain, that is, the residual.

During the first four years of this study the residual of inmates receiving shorter sentences (less than ten years) was 4,817 and the residual of those receiving longer sentences was 3,800. Therefore, there was a need for increased capacity in all types of institutions (i.e., minimum, medium and close). However, during FY 1977-78, the number of losses of inmates with shorter sentences was almost equal to the number of admissions in this category. The shorter sentence residual was only 90 while the longer sentence residual was 741. Virtually all of the increase during FY 1977-78 required housing in medium to close custody institutions. The portion of the inmate population with shorter sentences should remain fairly stable during the next ten years so that most of the growth in the inmate population should be inmates with longer sentences. Thus, the continuing need is for more medium to close custody facilities.

As indicated in Table 4, "A Distribution of the Status Population by Primary Offense", a dramatic 5-year increase is seen in several of the more serious or violent crimes including: Homicide, 103.1%; Sexual Battery, 105.4%; Armed Robbery, 95.1%; and Aggravated Assault, 44.6%.* Since the numbers of these serious/violent offenses continue to increase in the residual population, a need for more medium to close custody facilities is indicated.

*The Appendices in this report offer a more detailed breakdown of the offenses by length of sentence for each year including admissions, losses and net gain or loss.
