

## SUMMARY

Believing that farm theft in Iowa warranted regular examination, the Department of Public Safety in 1979 revised its annual Uniform Crime Report to include more information on farm-related theft.

An analysis of this new information revealed that farm-related theft accounted for only 4.9 percent of the total dollar loss from thefts in the State. An average of one farm in 61 reported losses to theft in 1979.

Counties suffering the highest percentages of dollar loss due to farm theft tended to be the smaller, rural counties primarily located along the southern border and in the western portion of the State. The farm property most frequently stolen included livestock, other farm supplies, and farm machinery. Other farm supplies included such items as farm machinery parts, seed grain, commercial livestock feed, livestock feeders, confinement materials, etc. While livestock and farm machinery (tractors, plows, cultivators, rakes, discs, etc.) are stolen because of their high value and easy marketability, other farm supplies are most likely stolen because they are easily stolen (with low risk of apprehension) and have high usability.

Few geographic patterns emerged in examining farm losses. The major concentration of cattle theft occurred in the south central and northeastern areas of the State. Thefts of hogs and other livestock had slightly heavier concentrations in the central portion of the State. Theft of farm machinery was distributed fairly evenly throughout the State, while grain theft was concentrated along the southern border. Farm chemical losses were most noticeable in the north central area, with thefts of other farm supplies heaviest in eastern Iowa.

Overall, about 17.5% of the property (value) stolen was recovered. Farm machinery and other livestock were the most often recovered items -- in terms of value -- possibly due to the fact that machinery and livestock may be tagged for identification purposes. No striking geographic patterns were found in examining recovery rates.

While losses due to farm theft do not comprise a large percentage of Iowa's theft loss, collection of data on farm-related theft should continue to help in identifying methods and programs to assist in reducing losses due to farm-related theft.

## INTRODUCTION

Because of the agricultural character of much of the State, there has been considerable concern voiced in Iowa in recent years about the nature and magnitude of farm-related theft. Until recently, however, discussion of this problem was speculative, at best, because of the lack of any reliable statewide information on the subject.

As a first step to remedy this situation, the Iowa Department of Public Safety in 1977 initiated a pilot project to collect some basic data pertaining to farm implement and supply theft. Data were received from law enforcement agencies in the course of this study, resulting in the 1978 publication of a report entitled "Farm Implement and Supply Theft in Iowa."

As this project was underway, the Department was also taking steps to modify its annual Uniform Crime Report to include more information than previously available on farm-related theft. The result was the collection and presentation of the first systematic data relating to farm implement and supply theft in the 1979 Iowa Uniform Crime Report, released in October, 1980. Credit is due the Department for the foresight it demonstrated in making Iowa the first state to regularly include examination of farm-related crime as a routine part of its annual report on crime.

## METHODOLOGY

Data on crimes and arrests are submitted monthly on standardized reporting forms to the Department of Public Safety by 224 law enforcement agencies in Iowa. Included in these data are reports of the number of farm thefts, the value of farm property stolen, and the value of farm property recovered for each of seven categories: cattle, hogs, other livestock, farm machinery, grain, farm chemicals, and other farm supplies. After publication of the 1979 Iowa Uniform Crime Report, the Department made the data files relating to farm theft available to the Statistical Analysis Center. This report is the result of computer analysis of these data, and includes examination of data at the agency, county, and state levels.

## RESULTS

Since Iowa is one of the major agricultural states in the United States, it was thought that the farmers in the State might suffer substantial losses due to farm implement and supply theft. However, when the data were scrutinized, it was discovered that farm thefts accounted for only 4.9% of the total dollar loss from thefts in the State. Considering the degree to which Iowa's economy is dependent upon agriculture, this percentage is surprisingly small. Put another way, when the 1,989 reported farm thefts are distributed among Iowa's 121,000<sup>1</sup> farms, one farm in 61 reported victimizations. Using dollar losses, the \$2,185,615 stolen divides up as \$18.06 per farm.

Table 1 lists the dollar amount of farm property stolen for each county, ranked in descending order. Figure 1 is based upon Table 1, and identifies the 15 counties<sup>2</sup> suffering the greatest loss to farm-related thefts. The populations of these 15 counties range from 8,221 (Taylor) to 166,919 (Linn). Six of the counties are under 20,000 population, while the other nine are over 20,000 population. Most are located in either the western portion of the state or close to the eastern border.

IOWA, 1979



While there thus does not appear to be any striking patterns in the geographic distribution of dollar losses, when the amount of farm property stolen is compared to the amount of total property stolen, a pattern begins to emerge.

Table 2 lists the ten counties with the highest percentage of farm property stolen. These counties range in size from a population of 6,216 (Adams) to 23,559 (Carroll), with six having populations under 10,000. These counties, for the most part, consist of small, rural farming communities. They all experienced farm theft percentages in excess of 30 percent, with Taylor County reporting that over three-fourths of their total thefts involved farm implements and supplies. Figure 2 shows that seven of these counties are located in the southwestern and west central portion of the state. Figure 3 displays the percentage of farm property stolen for each county in the state. A pattern similar to that in Figure 2 emerges.

Table 3 lists the average dollar loss per farm theft incident for each county, in descending order. Eight of the top ten counties have populations under 20,000. Geographically, the counties are located in the southwestern and southeastern portions of the State, as evidenced in Figure 4. It is evident from these tables and figures that the majority of Iowa's farm implement and supply thefts are occurring in smaller counties located primarily in the southern half of the State where farming is the major economic activity.

Data were collected on seven categories of farm-related theft. Cattle, hogs, and other livestock comprise the first three categories; the others are farm machinery, grain, farm chemicals, and other farm supplies. Figures 5 through 11 display the counties which experienced dollar losses due to theft for each category.

Figure 5 shows that the major concentration of cattle theft is in the south central and northeastern areas of the state. Thefts of hogs occur in all areas of the state, with a slightly heavier concentration existing in the central portion of the State, as evidenced in Figure 6. Figure 7 shows that the majority of other livestock stolen came from the central area of the State, with the exception of Osceola County in the northwest and Scott County in the southeast. Farm machinery theft is distributed evenly throughout the State except for a block in the center, as shown in Figure 8. The major concentration of grain theft is found in four counties on the southern border of Iowa, with the exception of Mitchell County on the northern border, where the highest percent value of grain loss occurred (Figure 9). The largest percent of dollar loss due to the theft of farm chemicals occurred in the north central counties (as shown in Figure 10), while the majority of thefts of other farm supplies occurred in the eastern section of Iowa, (Figure 11).

While Figures 5 through 11 show the geographical distribution of individual types of farm theft, Tables 4 and 5 provide information on the magnitude of those thefts. When looking at just the number of thefts, Table 4 shows that other farm supplies ranked first with 570 reported incidents. Cattle and farm machinery ranked second and third respectively. Each of these types of theft accounts for at least one-fifth of all the farm thefts. Together, they account for 71 percent of all farm theft incidents.


Table 5 presents a clear picture in terms of the impact of farm theft, displaying the value of property stolen for each category, and their percentages. Farm machinery clearly ranks first here, accounting for almost one-third of all monetary loss due to farm theft.

IOWA, 1979









IOWA, 1979



IOWA, 1979



IOWA, 1979



Cattle ranked second, claiming nearly one-fourth of the monetary loss. The three livestock categories, when considered together, account for almost one-half of the dollar loss. It is evident from this table that the items with the highest value (farm machinery, cattle, & hogs) logically account for the greatest dollar loss among farm implement and supply categories, even though "other" thefts account for more actual thefts than any of the other individual categories.

Table 6 reports farm thefts for livestock, farm machinery and other farm supplies for the SMSAs, cities, and rural areas. Note that the SMSAs and cities experience higher theft rates for farm machinery than for either livestock or other farm supplies. This may be due to thefts from farm implement dealers and manufacturers, who are frequently located in cities.

On the brighter side of the picture is the analysis of stolen farm property which was recovered. Table 7 lists the percent of property recovered (based on the value of property stolen) for each county, in descending order.

Counties under and over 20,000 in population are equally represented among the ten highest ranked, and there appears to be no striking geographic pattern of recovery (Figure 12). Figure 13 shows the percent of recovered property for each county in the state, and contains several slight patterns: strips along the southern border and down the western and eastern sides of the state show a slight concentration of higher recovery percentages.

Figures 15 through 21 geographically display the percentage of recovered property (based on the value of property stolen) for each of the seven farm theft categories: cattle, hogs, other livestock, farm machinery, grain, farm chemicals, and other farm supplies. None of these figures shows any demonstrable patterns of recovery. Figure 18 does show a slight pattern of recovery along the southern border, but several other counties scattered across the state also show substantial recovery percentages.

Table 8 indicates that more farm machinery was recovered -- in terms of property value -- than any other farm item. Cattle were the second most likely property to be recovered in terms of value, but were substantially below farm machinery. Grain was the least likely item to be recovered in terms of value for obvious reasons: it is difficult to trace due to its uses and marketability, and accounts for a small portion of the total thefts.

Table 9 reports the percentage of farm property recovered based on the value of property stolen and the value of property recovered. Farm machinery ranked first as the most likely farm property to be recovered. This may be due to the fact that farm machinery is easily recognizable and may be marked with some type of identification. Other livestock is the second most likely farm item to be recovered. Again, animals are often tagged for identification purposes, and the animals that comprise this category (horses, sheep, goats, etc.) are not as marketable as cattle or hogs. Figure 14 graphically displays the percentages reported in Table 9.

Appendix A contains three tables which were used in evaluating farm implement and supply theft in Iowa. Table A-1 lists the values of property stolen and recovered both for farm thefts and total thefts, and reports the percentages

for farm thefts by county. Table A-2 lists the value of farm property stolen and recovered, and the recovery percentages for each county. Table A-3 reports the number of thefts, the values of farm property stolen and recovered by UCR reporting agency for each of the seven farm theft categories. Table A-4 lists the definitions for each of the farm theft items.

IOWA, 1979




Property Recovered By Category**










IOWA, 1979





IOWA, 1979



1. Cattle
2. Hogs
3. All Other Livestock
4. Farm Machinery - defined as all machinery that is used specifically for agricultural/farm purposes. This category includes tractors, plows, cultivators, planters, discs, farm wagons, combines, balers, rakes, elevators, etc. It does not include riding lawn mowers/garden tractors, garden roto tillers, etc.
5. Grain - defined as all grains such as corn, soybeans, oats, wheat, etc. This category does not include seed grains used for planting purposes.
6. Farm Chemicals - defined as fertilizers, insecticides, and herbicides.
7. Other Farm Supplies - defined as parts from farm machinery, supplies or equipment used specifically for agricultural/farm purposes. This category includes seed grain for planting purposes, commercial livestock feeds, livestock feeders and confinement materials and parts from farm machinery. It does not include tools, chain saws, welders, air compressors, saddles, etc.
