






FOREWORD

This publication which is produced annually by the Research Section of the Law Department has a particularly useful function in conveying statistics on court decisions in a complete and unbiased manner to all who are interested.



It also provides the judiciary with a complete record of sentences imposed to assist them in determining appropriate and fair sentences for people before the courts.

The collection of sentencing statistics for the Higher Criminal Courts in Victoria was commenced in 1975 and the tables were first printed for publication in 1981. The 1980 collection and a five year compilation for the period 1976-80 were printed and also made available in microfiche.

Already the circulation of this publication has grown to include a wide variety of recipients including journalists, researchers, librarians and law reformers within Australia and overseas.

The United States Federal court administration have seen the publication and are investigating the establishment of a similar system of sentencing data along the lines of the Victorian model.

There is no doubt that statistical publications are more relevant the earlier their release coincides with the end of the year in question. The 1981 statistics were ready early in the year and the Law Department should be congratulated for this achievement.

The Government would like to see an improvement in the public's access to information in documentary form and steps are being taken for similar information to be produced for the Magistrates' Courts.

SENTENCING STATISTICS FOR HIGHER CRIMINAL COURTS

(VICTORIA)

EXPLANATORY NOTES:

1. The information is summarized by two methods of indicating the sentence, viz:
  - (a) that for the principal offence on which a person was convicted;

(Note: The sentence for the principal offence is for one type of count only and need not reflect the final and total sentence imposed by the Court after all counts have been taken into consideration).

  - (b) that for the effective sentence

(Note: The effective sentence is the actual sentence for all counts and is the total sentence imposed by the Court after taking into account terms to be served concurrently and cumulatively. Note, however, that the effective sentence is recorded only under one offence - viz, the principal offence).
2. The table headed "Statistical Measures of Penalties (VIC) 1981" relates only to the sentence for the principal offence. It does not take into account non-parole periods.
3.
  - (a) Persons found unfit to plead are not sentenced and are therefore excluded from relevant tables until such time as they are fit to stand trial.
  - (b) Persons acquitted on the grounds of insanity are not included in the tables.
4. The rules used to select the principal offence are as follows -
  - (i) Imprisonment including Youth Training Centre
  - (ii) Alcoholic and Drug Dependence Persons Bureau or Attendance Centre
  - (iii) Probation or Probation and Fine
  - (iv) Bond or Bond and Fine
  - (v) Fine
  - (vi) Other

5. Where two or more offences are involved the following rules have been applied in the order listed -
  - (i) The offence for which the heaviest sentence is imposed (within the above categories).
  - (ii) Where the same penalty has been imposed for two or more offences, the Principal offence is that one which has the heaviest maximum penalty under the Act.
  - (iii) If two or more offences carry the same maximum penalty the number of counts has been taken into consideration.
  - (iv) The Offence which appears to be the key offence.
  - (v) The first-mentioned offence.
6. Details of sentences are not recorded if the case has been presented by the Commonwealth Crown Solicitor.
7. Information in the tables has come from collated daily reports of the Criminal Law Branch Preparation Officers. A cross check is made with the Daily List for Melbourne and the Circuit Section Register to ensure that all reports are received. However no attempt is made to edit or check the description of the offence recorded by the Preparation Officer.
8. Details are not recorded until sentences have been passed on those persons convicted. No attempt has been made to reconcile the number of persons sentenced with the number of persons convicted, as shown in Tables 3.9 and 5.3 "Persons Whose Case was a Receipt or a Disposal of a Criminal Matter in the Supreme or County Court Victoria", since different counting procedures are followed and separate sources of information are utilized.
9. The results of appeals and hearings of breaches of Bonds and Probation have not been taken into account.
10. Unlike previous years attempts are shown separately.
11. This year categories have been expanded into constituent offences in order that more detail concerning sentences is available. Whether or not this form of display will continue will depend on the response from users.


