

ACQUISITIONS

PROGRAMME DESCRIPTION

The Legislation

The legislation under which the Board functions is The Compensation for Victims of Crime Act, which came into force on September 1, 1971 superseding The Law Enforcement Compensation Act, 1967.

The Board is required by the Act to find the commission of a crime of violence (in the principal class of applications coming before it). A basic qualification for the consideration of an award is that there must be adequate and reliable evidence in this regard. In addition, the Board is required to consider all relevant circumstances including the behaviour of the victim at the time of the incident and the cooperation given by the victim to the law enforcement agencies.

Section 6 of the statute prescribes a one-year limitation period for filing an application for compensation, but the Board may extend the time as it considers warranted. During the year, 139 requests for extension of the limitation period were received, of which 123 were approved.

Subrogation

The Board is subrogated to all the rights of any person to whom payment is made under this Act, to recover damages from the offender by civil proceedings in respect to injury or death. \$30,982.76 was recovered during the fiscal year, compared to \$12,660.66 in the previous year.

Hearings

The members of the Board, of whom thirteen are on a part-time basis, usually sit in panels of two.

During the fiscal year, hearings, in addition to those held in Toronto, took place in Fort Frances, Thunder Bay, Sudbury, Sault Ste. Marie, Windsor, London and Ottawa. This is done to facilitate applicants, and to generate a better understanding of the work of the Board across the province. In addition this practice results in reduced costs to the board.

Documentary Evidence Hearings

A total of 107 cases were dealt with by documentary evidence during the fiscal year compared to 118 in the previous fiscal year.

Cases of this nature are relatively clear-cut. They are generally dealt with by the Chairman of the board, after having received agreement from the applicar manner.

Dealing with cases on documentary evidence reduces the inconvenience of both the applicant and/or solicitor with regard to travel time to location of hearing as well as to the applicants' and witnesses' loss of work time. The board also benefits substantially by an overall reduction in its administrative costs, vis-a-vis staff and board members' travel time, accommodation, rental costs, fees, etc.

Child Abuse

Having regard for the degree of public concern about the apparent prevalence of a large number of child abuse cases, the Board is at a loss to understand why there have been so few applications resulting from such crimes.

This is particularly puzzling in that the Board has made every effort to publicize its readiness to consider such applications. In October 1980, the Chairman wrote to every Childrens' Aid Society in the province outlining its program as it affects child abuse. In spite of this, we must report that only one such application was made in 1980, and two in 1981.

Administration and Productivity

The administrative staff of the Board is comprised of the Registrar, the Chief of Investigation and three investigators, in addition to a clerical, stenographic and secretarial staff of eight. This small staff has been most dedicater' in its efforts to maintain a high standard of service to the Board and to the public.

In this fiscal year the Board heard 980 applications as against 985 in the previous year. Awards ordered rose from 918 to 979 or by almost 7%. The total value of awards increased by 14% from \$2,434,343.92 to \$2,780,496.74, while the average award rose from \$2,132.14 to \$2,303.02 or by 8%.

The number of applications received declined slightly from 1274 in 1980-81 to 1250 in this fiscal year, but this is not considered to be of any particular significance.

Public Awareness

Large posters and explanatory pamphlets are supplied to hospital emergency wards and staff lounges, court houses and other public buildings, supermarkets, etc.

Police forces throughout the province have been provided with wallet-size cards which are designed to be handed out to draw to the attention of the victims of crime of violence that they may be eligible for compensation and advising how to apply to the board. The daily hearing agenda and a sel/ction of typical board orders are provided to the news media.

Cost Sharing

Awards made under The Compensation for Victims of Crime Act are cost shared between the Federal Government and the Government of Ontario. The contribution by the Federal Government amounts to 50% of the awards (net of any recoveries) to a maximum of ten cents per capita of the population of Ontario. For the fiscal year 1980-81 this share amounted to \$857,040.00.





The volume of cases dealt with by the Board is such that to prevent this report from becoming unduly long, every second Board Order has been summarized.

200-1793 A 53 year old woman was shot in her leg by her husband. The leg was amputated above the knee following complications. The alleged offender died of natural causes before he was brought to trial. Award: \$10,950.00 (incl. pain and suffering \$10,000.00)

200-2701 A 25 year old truck driver was shot in the stomach by an unknown offender, and underwent surgery to remove the bullet from his left abdomen. Award: \$2,095.00 (incl. pain and suffering \$1,500.00)

probation respectively. Award: \$635.05 (incl. pain and suffering \$500.00)

200-3665 A 33 year old taxi driver was stabbed with a butcher knife while working. He sustained wounde to the lungs, diaphragm and liver. The offender was convicted of wounding a entenced to 5 years imprisonment. Award: \$10,456.00 (incl. pr and suffering \$4,000.00)

200-3697 A 20 year old labourer was assaulted in a restaurant and sustained a fractured jaw. The offender was convicted of assault causing bodily harm and fined \$200.00 or 21 days in jail. Award: \$1,075.27 (incl. pain and suffering \$1,000.00)

200-3846 An unemployed 36 year old man was shot by an unknown offender from a passing car. The bullet damaged his hip and both small and large intestines. He is now permanently unemployable. Award: \$5,513.60 (incl. pain and suffering \$5,000.00)

200-3922 A 54 year old cook was assaulted by her intoxicated son-in-law. She sustained a badly broken hip. The offender was convicted of assault causing bodily harm and fined \$500.00. Award: \$6,380.16 (incl. pain and suffering \$4,500.00)

200-4101 A 21 year old labourer was slashed across the chest and stabbed in the back while intoxicated at a party. He sustained injuries to his diaphragm and an artery. The alleged offenders were acquitted due to problems of identification. The award was reduced under Section 17(1) of the Act. Award: \$1,109.40 (incl. pain and suffering \$800.00)

200-3093 A 58 year old field specialist was assaulted without provocation. He sustained a minor stab wound to the chest. The two offenders were convicted of weapons dangerous and sentenced to three years imprisonment and two years 200-4270 A 60 year old visitor from Detroit was attacked without provocation and severely beaten. He sustained cerebral contusions, fractured facial bones and other head injuries, resulting in permanent brain damage. The offender was convicted of assault causing bodily harm and sentenced to 4 years imprisonment. Award: \$15,700.00 (incl. pain and suffering \$15,000.00)

200-4363 A 28 year old painter was tied up and tortured by two men. He sustained fractures of the nose and mandible, multiple bruises and swelling all over his body and cigarette burns on his arms. One offender was convicted of assault causing bodily harm and illegal confinement, and sentenced to 18 months imprisonment plus 2 years probation. The other offender is unknown. Award: \$4,670.19 (incl. pain and suffering \$2,500.00)

200-4703 An unemployed 20 year old man was struck in the mouth while trying to prevent a police officer from searching his car. No charges were pressed against the alleged offender. The award was reduced pursuant to Sections 17(1) and 17(1a) of the Act.

Award: \$435.00 (incl. pain and suffering \$250.00)

200-4831 A 31 year old police constable sustained gunshot wounds in an incident where another officer was killed. He claimed compensation for lost salary, lost overtime, and loss of opportunities for advancement because of emotional trauma. The Board made an award only for pain and suffering and expenses, as job related claims were not substantiated. The offender was found not guilty by reason of insanity.

Award: \$2,850.00 (incl. pain and suffering \$2,500.00)

200-4870 + 19 year old mechanic was assaulted without provocation, losing two teeth and sustaining lacerations of the lip. The offender was convicted of assault causing bodily harm and given a conditional discharge with 1 year probation.

Award: \$862.55 (incl. pain and suffering \$500.00)

200-4947 A 21 year old heater installer was struck on the back of the head with a club by an unknown offender while leaving a bar. He sustained a fractured skull, localized cerebral disturbance and hearing loss in the right ear. As the applicant was intoxicated at the time of the assault, the Board invoked Section 17(1) of the Act and reduced the award. Award: \$2,397.30 (incl. pain and suffering \$2,240.00)

200-5032 A 29 year old secretary was assaulted by her boyfriend after rejecting his marriage proposal. She sustained severe facial bruises and abrasions. The offender was convicted of common assault and sentenced to a fine of \$200.00 or 10 days imprisonment.

Award: \$886.88 (incl. pain and suffering \$500.00)

200-5163 A 24 year old labourer was assaulted without provocation, and sustained a fractured nose and facial bruises. The offenders were convicted of common assault. Award: \$500.00 (incl. pain and suffering \$500.00)

200-5192 A 32 year old policeman was assaulted while off-duty. He sustained lacerations of the face and mouth, and a contusion in his neck. The offender was convicted of assault causing bodily harm, and sentenced to one day in jail and a \$750.00 fine or 30 days in jail. Award: \$958.00 (incl. pain and suffering \$700.00)

200-5252 A 28 year old facialist was kicked to the ground without provocation by an unknown assailant. She sustained a fractured femur, which caused permanent disability and pain. This has reduced her ability to earn income in her profession drastically. Award: \$15,460.00 (incl. pain and suffering \$15,000.00)

200-5282 A 27 year old machine operator was walking with his girlfriend when he was struck on the face and arm with a broken hockey stick. He sustained contusions and abrasions to his face and arm. The offender was convicted of weapons dangerous to the public peace and sentenced to a fine of \$200.00 or 20 days in jail. Award: \$701.45 (incl. pain and suffering \$400.00)

200-5306 A 29 year old student was shot and clubbed with a rifle butt by his brother in an unprovoked attack. He sustained gunshot wounds to his abdomen and liver. The offender was convicted of attempted murder and sentenced to 5 vears imprisonment. Award: \$3,745.00 (incl. pain and suffering \$3,000.00)

200-5415 A 45 year old T.T.C. driver sustained an injury to his knee while chasing a juvenile who was attempting a robbery. The injury aggravated an osteoarthritic condition which required several operations and which left permanent discomfort. The juvenile was found to be delinguent. Award: \$3,368.49 (incl. pain and suffering \$2,500.00)

200-5443 A 32 year old police constable was punched in the face by the offender, whom he was arresting. The applicant sustained severe contusions on the left side of the face. The offender was convicted of assaulting a police officer and sentenced to a fine of \$750.00 or 4 months imprisonment. Award: \$500.00 (incl. pain and suffering \$500.00)

200-5506 A 34 year old nurse was struck on the back of the head by a psychiatric patient. She was unable to work for 3 years, lost 75 pounds, developed a stutter and suffered from extreme vertigo, nausea, headaches and anxiety. The alleged offender was not charged as he was a psychiatric patient. Award: \$11,018.50 (incl. pain and suffering \$5,000.00)

200-5523 A 37 year old restaurant manager was assaulted by a man he was evicting for breaking beer bottles. He sustained a severely fractured nose. The offender was convicted of assault causing bodily harm and sentenced to 60 days imprisonment.

Award: \$2,035.03 (incl. pain and suffering \$800.00)

200-5610 A 27 year old police constable was assaulted while off duty while attempting to detain three men until other police arrived. He sustained a posttraumatic nasal deformity. The offenders were convicted of assault causing bodily harm and causing a disturbance by fighting, and sentenced from 40 to 60 davs each.

Award: \$750.00 (incl. pain and suffering \$750.00)

200-5647 A 20 year old prison inmate was beaten by fellow inmates. He sustained a cerebral contusion and suffers from bilateral incoordination and spasticity, poor co-ordination in his left hand, mental retardation, and aggravation of a pre-existing spastic condition. The offenders were convicted of wounding and sentenced from 2 years and 2 months to $4\frac{1}{2}$ years imprisonment. Award: \$5,292.70 (incl. pain and suffering \$5,000.00)

200-5712 A 29 year old teacher was assaulted after a dance. He sustained a laceration on his face, a fractured nose, and bruised ribs. The offender was convicted of assault causing bodily harm and sentened to 6 months imprisonment. Award: \$865.00 (incl. pain and suffering \$750.00)

200-5754 A 34 year old grocery store owner was struck in the stomach during a robbery by an unknown offender. Award: \$545.72 (incl. pain and suffering \$300.00)

200-5808 A 32 year old housewife was assaulted by a neighbour. She sustained a fractured nose and facial abrasions and contusions. The offender was convicted of assault causing bodily harm and fined \$100.00. Award: \$671.75 (incl. pain and suffering \$500.00)

200-5837 A 42 year old grocery store owner was assaulted and kicked by two youths in his store. He suffered bruises, lacerations, and the loss of five front teeth. The offenders were convicted of assault, one being sentenced to 15 days imprisonment and 2 years probation and the other to 30 days imprisonment. Award: \$3,603.75 (incl. pain and suffering \$1,500.00)

200-5856 A 16 year old student was accosted by some other youths. He sustained a fractured nose and dental damage. The offender was convicted of assault causing bodily harm and sentenced to a fine of \$300.00 or 15 days imprisonment.

Award: \$2,603.00 (incl. pain and suffering \$2,500.00)

200-5863 A 21 year old aircraft construction worker was assaulted at a party by a man who was upset by the applicant flirting with his girlfriend. The applicant sustained major brain damage after having his head banged against the wall. The offender was convicted of assault causing bodily harm and given a suspended sentence with 2 years probation. Award: \$8,204.50 (incl. pain and suffering \$7,500.00) plus continuing monthly payments of \$500.00

200-5915 A 49 year old mechanic was assaulted by a tenant on his farm, and sustained a moderately severe fracture of the right ankle. The offender was convicted of assault causing bodily harm and sentenced to a fine of \$300.00 or 30 davs imprisonment. Award: \$4,435.25 (incl. pain and suffering \$2,500.00)

200-5953 A 39 year old sales representative was assaulted by the friend of a tenant who became abusive during a party. He sustained a fractured nose and multiple contusions. The offender was convicted of assault causing bodily harm and sentenced to six months imprisonment. Award: \$2,000.00 (incl. pain and suffering \$2,000.00)

200-5972 A 49 year old typist sustained several large bruises on her leg when her purse was snatched. No offenders were charged. Award: \$300.00 (incl. pain and suffering \$300.00)

200-5985 A 26 year old mechanic was shot and stabbed by his wife's former boyfriend. He sustained gunshot wounds to his left hand, groin and right loin. and a stab wound in his chest. The offender was convicted of attempted murder and sentenced to 6 years imprisonment. Award: \$3,740.00 (incl. pain and suffering \$3,500.00)

200-5999 A 47 year old ambulance driver was assaulted by a group of youths in a shopping mall. He sustained a mild head injury, bruises and dental damage. The offender was convicted of common assault and sentenced to a fine of \$125.00 or 7 days imprisonment. Award: \$2,205.00 (incl. pain and suffering \$500,00)

200-6012 A 69 year old estate broker was struck in the face by an unknown offender while investigating a disturbance outside his home. Award: \$1,189.00 (incl. pain and suffering \$750.00)

200-6031 A 23 year old auditor was struck in the face by an unknown offender while sitting in his car at a red light. He sustained multiple facial lacerations, including one by his eye which required surgery. Award: \$2,562.96 (incl. pain and suffering \$1,800.00)

200-6046 A 26 year old waiter was hit over the head with a beer glass while trying to calm down a noisy customer. He sustained a deep scalp laceration. The offender was convicted of assault causing bodily harm and sentenced to 15 months imprisonment. Award: \$2,288.00 (incl. pain and suffering \$2,000.00)

200-6067 A 61 year old retired man was upset with the way a drinking partner was playing with his grandchild, and made his objections known. A shoving match ensued, in which the applicant was punched in the face, sustaining multiple bruises. The offender was convicted of common assault and sentenced to a fine of \$300.00 or 2 months imprisonment. Since the applicant had been drinking and had hit the offender first, the Board invoked Section 17(1) of the Act to reduce the award.

Award: \$514.00 (incl. pain and suffering \$500.00)

200-6107 A 50 year old unemployed man was assaulted by an unknown offender and sustained a laceration of the scalp. Award: \$250.00 (incl. pain and suffering \$250.00)

200-6194 A 36 year old electrician was punched during an argument with the offender, and then kicked during the ensuing fight. He sustained a severe fracture of the nose, lacerations inside the mouth and contusions to the face and jaw. The offender was convicted of assault causing bodily harm and sentenced to 30 days imprisonment. The Board cited Section 17(1) of the Act to reduce the award because of the applicant's conduct in the argument. Award: \$1,947.85 (incl. pain and suffering \$1,200.00)

200-6220 A 21 year old waiter was hit in the eye with a pellet fired by the offender, and suffered permanent damage to his left eye. The offender was convicted of dangerous use of a weapon and sentenced to a fine of \$250.00 or 13 days imprisonment plus 9 months probation.

Award: \$6,286.00 (incl. pain and suffering \$3,500.00)

200-6243 A 24 year old nurse was beaten by a former boyfriend who had broken into her home. She sustained bruises and abrasions, and a continuing back problem. The alleged offender was found unfit to stand trial and sent to a psychiatric hospital.

Award: \$2,085.28 (incl. pain and suffering \$2,000.00)

200-6262 A 24 year old student was beaten by her former common-law husband. She sustained a fractured nose and severe soft tissue injuries to her face. as well as emotional trauma which required psychiatric therapy. The offender was convicted of assault causing bodily harm and sentenced to sixty days imprisonment.

Award: \$2,016.80 (incl. pain and suffering \$2,000.00)

200-6292 A 45 year old disability pensioner was beaten by four alleged offenders. He sustained bruises and abrasions on his hands, arms, chest, abdomen, upper back, ribs and head. The Justice of the Peace would not accept the applicant's information against the alleged offenders, Award: \$1,817.34 (incl. pain and suffering \$1,500.00)

200-6325 A 25 year old salesman was assaulted without provocation outside a discotheque and sustained superficial lacerations and bruising to the head. The discharge.

200-6333 A 21 year old hot melt operator was assaulted without provocation near his apartment. He sustained a double fracture of the jaw, as well as dental damage. The offender was convicted of assault causing bodily harm and sentenenced to 2 months imprisonment. Award: \$2,478.26 (incl. pain and suffering \$1,500.00)

200-6342 A 40 year old restaurant worker was attacked by the offender with a hammer, and struck on the head several times. She sustained several scalp wounds requiring hospitalization for 10 days, and suffered from emotional trauma. The offender was convicted of wounding with intent and sentenced to 2 years less a day imprisonment and three years probation. Award: \$2,460.27 (incl. pain and suffering \$2,000.00)

Award: \$1,821.00 (incl. pain and suffering \$1,500.00)

200-6364 A 22 year old cashier was walking her dog when it got into a fight with the offender's dog. He punched her in the mouth when she attempted to break up the fight. She sustained dental damage and a laceration to her lip which left permanent damage. The offender was convicted of assault causing bodily harm and given a conditional discharge. Award: \$3,574.58 (incl. pain and suffering \$2,000.00)

200-6367 A 29 year old bar bouncer was assaulted while attempting to evict the unknown offender. He sustained lacerations to the neck, chest and forehead. Award: \$560.00 (incl. pain and suffering \$350.00)

200-6377 A 21 year old letter carrier was with some friends when they were assaulted by two men, one of whom was an escaped convict. The applicant sustained lacerations to his face and ear. The first offender was convicted of wounding and the second of assault causing bodily harm. They were sentenced to 12 and 3 months imprisonment respectively. Award: \$1,313.10 (incl. pain and suffering \$1,000.00)

200-6386 A 26 year old attendant at a mental institution was assaulted by an inmate, and sustained a severe fractured dislocation of the middle joint of the left ring finger. This finger was eventually amputated. Award: \$5,011.10 (incl. pain and suffering \$2,500.00)

offender was convicted of assault causing bodily harm and given an absolute

Award: \$650.00 (incl. pain and suffering \$650.00)

200-6360 A 26 year old student was struck in the face by a thrown beer bottle after confronting a group of people, who had made racial slurs. He sustained dental damage and extensive facial lacerations. The offender was convicted of causing a disturbance and given a suspended sentence plus 18 months probation. 200-6392 A 21 year old clerk was assaulted in a discotheque parking lot by the offender, who was drunk and rowdy. He sustained lacerations on two fingers from the offender's knife. The offender was convicted of assault causing bodily harm and sentenced to a fine of \$100.00 or 30 days in jail plus 18 months probation.

Award: \$650.00 (incl. pain and suffering \$650.00)

200-6394 A 61 year old apartment manager was assaulted by the offender when she and her husband were cleaning out the offender's uncle's apartment, obtaining his bags to hold until the rent was paid. She sustained lacerations, bruises and swelling of the face. The offender was convicted of assault causing bodily harm and sentenced to a fine of \$300.00 plus 12 months probation. Award: \$1,253.15 (incl. pain and suffering \$1,000.00)

200-6421 A 19 year old cleaner was pushed through a plate glass window as he escorted the offender from the restaurant where his wife worked. He sustained lacerations to the left elbow, chest and back. The offender was convicted of assault causing bodily harm and given a conditional discharge and six months probation.

Award: \$786.22 (incl. pain and suffering \$500.00)

200-6441 A 27 year old airline employee attempted to prevent the offender from driving off with a stolen stereo, and was thrown off the side of the offender's truck in the process. He sustained a fractured jaw, a pneumothorax, multiple broken ribs, fractures of the upper end of the humerus and right clavicle, and severe dental damage. The offender was convicted of assault causing bodily harm by criminal negligence and was sentenced to 90 days imprisonmetit. Award: \$11,368.99 (inci. pain and suffering \$7,500.00)

200-6453 A 24 year old student was pushed down by the offender while preventing him from throwing a cat at a wall. She was knocked unconscious for a short time, and a pre-existing back problem was exacerbated. The offender was convicted of common assault and fined \$200.00. Award: \$500.00 (incl. pain and suffering \$500.00)

200-6483 A 33 year old prison inmate was assaulted without provocation by an unknown offender, and sustained a contusion and laceration over one eye. Award: \$650.00 (incl. pain and suffering \$500.00)

200-6496 A 14 year old girl was sitting in a car with some friends when it was attacked by 3 youths with baseball bats. Glass flew into her eye and she sustained deep lacerations of the globe of the left eye. Some permanent loss of sight occurred, and there was the possibility of future visual difficulties. One offender was convicted of weapons dangerous and given a suspended sentence with 3 years probation.

Award: \$2,225.00 (incl. pain and suffering \$1,500.00)

200-6521 A 59 year old labourer was knocked down by an unknown offender when her purse was snatched. She sustained a dislocation of the right shoulder, bruises and abrasions. Award: \$1,437.20 (incl. pain and suffering \$800.00)

200-6543 An 18 year old student was tortured by the offender, who tried to get him to confess to a crime the offender himself had actually committed. The applicant had staples shot in his arms and shoulders from a staple gun, was slashed 9 times on the back with a knife, and was choked with a wire hanger. The offender was convicted of wounding and sentenced to 4 years imprisonment. Award: \$4,014.00 (incl. pain and suffering \$3,500.00)

200-6548 A 22 year old labourer was assaulted without provocation by an unknown offender at a music festival. He sustained facial lacerations and loss of sight in his right eye. Award: \$4,902.80 (incl. pain and suffering \$4,500,00)

200-6558 A 19 year old donut baker was assaulted by a customer who was creating a disturbance in her place of work. She sustained a fractured clavicle and a muscle sprain to her neck and back. The offender was convicted of assault causing bodily harm and sentenced to 30 days imprisonment. Award: \$2,100.00 (incl. pain and suffering \$1,500.00)

200-6614 A 38 year old security investigator in a department store attempted to apprehend a shoplifter, who assaulted her. She sustained a whiplash injury and contusions to her lower back. The offender was convicted of assault causing bodily harm and given an absolute discharge. Award: \$2,500.00 (incl. pain and suffering \$2,500.00)

200-6624 A 30 year old punch press operator was assaulted by her boyfriend after she accepted an invitation to go to a party with another man. She lost the sight of her right eye in the incident. The offender was convicted of assault causing bodily harm and sentenced to 3 months imprisonment and 1 year probation. Award: \$8,497.49 (incl. pain and suffering \$5,000.00)

200-6646 A 52 year old businessman was assaulted by the offender when he came to the aid of a woman the offender was beating. The offender knocked the applicant unconscious, and continued to beat him as he lay on the floor. He sustained a fractured zygoma, bruised ribs, and trauma to the left kidney. The offender was convicted of assault causing bodily harm and sentenced to 2 years imprisonment. Award: \$8,360.00 (incl. pain and suffering \$6,000.00)

200-6650 A 40 year old meat clerk was assaulted by a man he had sold a tire to. There appears to have been no provocation. The applicant sustained lacerations to the face, a laceration of the right eye and dental damage. The offender was convicted of assault causing bodily harm and given a suspended sentence and 18 months probation. Award: \$1,700.00 (incl. pain and suffering \$1,500.00)

200-6654 A 27 year old housewife received second degree burns to her back and left shoulder when an unknown arsonist set her apartment on fire. Award: \$1,000.00 (incl. pain and suffering \$1,000.00)

200-6663 A 34 year old machine operator was the victim of an unprovoked assault. His arm was broken, and required six months to heal. As well, he developed problems with his left shoulder. The offender was convicted of assault causing bodily harm and given a suspended sentence and 18 months probation. Award: \$6,528.16 (incl. pain and suffering \$2,000.00)

200-6672 A 22 year old lumber saleswoman was hit over the head by an unknown offender who had broken into her house. She sustained contusions and multiple abrasions to the head.

Award: \$660.50 (incl. pain and suffering \$500.00)

200-6684 A 37 year old police constable was punched in the face and bitten on the thumb while investigating a domestic dispute. The offender was convicted of assault police and given conditional discharge. Award: \$200.00 (incl. pain and suffering \$200.00)

200-6693 A 41 year old television repairman was assaulted when he tried to take the licence number of a man who had scratched his van. However, some doubt exists as to who started the fight, and the alleged offender's conviction was overturned on appeal. The applicant sustained a fractured nose, bruised eyes, and dental damage, as well as having his glasses broken. The Board citing Section 17(1) of the Act gave no award for pain and suffering. Award: \$2,464.50

200-6732 A 25 year old clerk was assaulted without provocation by unknown offenders. The applicant sustained a fractured jaw, dental damage, and an aggravation of a pre-existing epileptic condition. Award: \$4,261.05 (incl. pain and suffering \$2,500.00)

200-6748 The applicant is the sister of a murdered woman. The applicant and her husband adopted the victim's children and incurred expenses in doing so. The Board awarded these expenses under Section 7(a) of the Act. Award: \$2,505.00

200-6754 A 66 year old labourer was assaulted and robbed by an unknown offender while returning home from his night shift. He sustained a fractured zygoma, and bruises and lacerations to the face. Award: \$1,015.48 (incl. pain and suffering \$800.00)

200-6757 A 64 year old secretary was injured when she attempted to prevent a juvenile from stealing her purse. She sustained a fracture and dislocation of her shoulder, and was left with a permanent disability. The offender was found delinguent. Award: \$3,453.06 (incl. pain and suffering \$2,000.00)

200-6773 A 54 year old unemployed man was struck in the face by a stick thrown by an unknown offender. His glasses broke, and a piece of glass embedded in his eye, causing it to lose almost all sight. The applicant was previously blind in the other eye, complicating the situation. Award: \$6,026.00 (incl. pain and suffering \$6,000.00)

200-6777 A 22 year old unemployed woman was injured when trying to break up a fight between her husband and the alleged offender. She sustained a perforation of the eardrum, which resulted in a slight loss of hearing. No charges were laid.

200-6785 A 25 year old woman was assaulted during an argument with the offender in a bar. She sustained lacerations of her eyelids and lips, and her partial denture had to be replaced. The offender was convicted of assault causing bodily harm and sentenced to a fine of \$300.00 or 15 days imprisonment. Award: \$1,146.00 (incl. pain and suffering \$800.00)

200-6809 A 30 year old collection clerk was assaulted by her former commonlaw husband, who threatened to cut her throat with a knife. She sustained contusions to her face and chest, a perforated eardrum and required a cervical support for her neck. The offender was convicted of common assault and given a conditional discharge and 8 months probation. Award: \$3,552.64 (incl. pain and suffering \$2,500.00)

200-6815 A 33 year old mechanic was beaten with a tire iron by the offender who wanted the applicant not to act as a witness of an accident the offender had caused. The applicant sustained a fracture of the distal ulna and deep lacerations to his head. The offender was convicted of assault causing bodily harm and sentenced to six months imprisonment plus two years probation. Award: \$4,199.08 (incl. pain and suffering \$2,500.00)

200-6818 A 34 year old police constable and his partner were assaulted while in plain clothes by a group of men while escorting one of them out of a restaurant. The applicant sustained a concussion, a sprained ankle, multiple bruises and abrasions, and serious dental damage. The offenders were convicted of assault causing bodily harm and sentenced to 60 and 10 days imprisonment respectively and one year probation each. Award: \$1,000.00 (incl. pain and suffering \$1,000.00)

Award: \$920.00 (incl. pain and suffering \$850.00)

200-6822 A 50 year old brakeman was beaten by two men during an argument with them. He sustained a fractured jaw and ribs, bruises and abrasions. The offenders were convicted of assault causing bodily harm and given suspended sentences and one year probation. The Board reduced the award for pain and suffering because of the applicant's actions, citing Section 17(1) of the Act.

Award: \$3,326.89 (incl. pain and suffering \$1,000.00)

200-6825 A 36 year old clerk was cut in the face with a beer bottle while trying to break up an argument. He sustained extensive facial lacerations. The offender was convicted of assault causing bodily harm and sentenced to a fine of \$300.00 or 30 days imprisonment.

Award: \$2,710.38 (incl. pain and suffering \$2,500.00)

200-6843 A 50 year old payroll administrator was attacked by the estranged husband of her daughter, while he was on parole. She received multiple stab wounds to her chest, abdomen and left arm, and came close to death. A country wide warrant is outstanding against the alleged offender. Award: \$15.049.72 (incl. pain and suffering \$8,000.00)

200-6853 A 27 year old unemployed woman was shot by a shotgun through a window by an unknown offender. She sustained multiple pellet wounds to her head, left chest, arm and knee.

Award: \$3,600.39 (incl. pain and suffering \$3,000.00)

200-6860 A 41 year old psychiatric nursing assistant was assaulted by a patient while working. He sustained a multiple fracture of his nose. The offender was convicted of assault causing bodily harm and received a suspended sentence and one year's probation.

Award: \$1,605,20 (incl. pain and suffering \$1,200.00)

200-6863 A 54 year old seaman was assaulted by a drunken neighbour while taking him home. He sustained a broken hand and rib, cuts and bruises. The offender was convicted of assault causing bodily harm and sentenced to 90 days imprisonment.

Award: \$3,350.00 (incl. pain and suffering \$3,000.00)

200-6867 A 27 year old police constable was injured while arresting a man for causing a disturbance. He sustained a fractured nose and a lower back injury. The offender was convicted of assault causing bodily harm and sentenced to 60 days imprisonment.

Award: \$1,170.00 (incl. pain and suffering \$800.00)

200-6871 A 25 year old police constable was injured by a suspect who resisted arrest and fell on the applicant's leg. The applicant sustained severe damage to cartilage and ligaments in his left knee, which will probably cause complications in the future. The offender was convicted of assault with intent to resist arrest and was sentenced to three months imprisonment.

Award: \$3,495.50 (incl. pain and suffering \$3,000.00)

200-6885 A 22 year old ambulance dispatcher was assaulted without provocation and sustained minor soft tissue injuries. However, subsequently he experienced memory lapses and seizures. 200-8635 A 30 year old police constable was assaulted while attempting to arrest the offender for causing a disturbance. He sustained a badly broken ankle, and was bedridden for a month. The offender was convicted of assault with intent to resist arrest and sentenced to a fine of \$150.00 or 15 days imprisonment plus 18 months probation. Award: \$4,300.00 (incl. pain and suffering \$3,500.00)

200-8647 A 63 year old asphalt worker was assaulted by the husband of a woman he had been drinking with. He sustained bruises and a small laceration to the left side of his head. The offender was convicted of common assault and sentenced to a fine of \$50.00 or 5 days in jail. Award: \$812.01 (incl. pain and suffering \$500.00)

200-8656 A 17 year old mover and his partner feared that they would not be paid by the offenders, and called the police, who arrived as the offenders were assaulting the applicant. He sustained a laceration of his upper eyelid, a swollen nose, two chipped teeth and the loss of an upper incisor. One offender was convicted of assault causing bodily harm and sentenced to 90 days imprisonment, and a bench warrant is outstanding for the other. Award: \$1,600.00 (incl. pain and suffering \$750.00)

200-8660 A 44 year old truck driver was mugged while returning home intoxicated from a bar. He sustained facial bruises, abrasions to his right elbow and left fourth rib. No offenders have been apprehended. The Board invoked Section 17 (1) of the Act to reduce the award. Award: \$174.26

200-8668 A 28 year old sales representative was assaulted when he admonished the offender for kicking someone's car. He sustained black eyes, and a laceration over the left eye. The offender was convicted of assault causing bodily harm and given a suspended sentence with 18 months probation. Award: \$833.66 (incl. pain and suffering \$350.00)

200-8671 A 21 year old secretary was forced to stop her car suddenly, and the offender, who was directly behind her, assaulted her. She sustained a bruised mandible, a laceration inside her mouth, and dental damage. The offender was convicted of assault causing bodily harm and sentenced to 29 days imprisonment and six months probation. Award: \$892.00 (incl. pain and suffering \$500.00)

200-8675 A 22 year old labourer was severely beaten and robbed. He was hit with pieces of wood, and sustained severe head lacerations, two fractured ribs,

and a contused lung. Charges against the alleged offenders were dismissed due to lack of identification.

Award: \$3,176.80 (incl. pain and suffering \$2,500.00)

200-8688 A 23 year old stock person was injured when he came to the assistance of a friend being assaulted by seven unknown offenders. He sustained several facial lacerations requiring sutures. Award: \$395.40 (incl. pain and suffering \$300.00)

200-8892 A 21 year old mental health worker was attacked without provocation at a party, and bitten on the arm and ear. Part of the applicant's ear was bitten off. The offender was convicted of assault causing bodily harm and sentenced to a fine of \$300.00 or 30 days imprisonment plus three years probation.

Award: \$1,752.87 (incl. pain and suffering \$1,500.00)

200-8698 A 15 year old student was assaulted at a party, when the offender thought that the applicant was interested in his girl-friend. The victim sustained facial lacerations and bruising, and swelling of the nose. Award: \$410.00 (incl. pain and suffering \$300.00)

200-8715 A 42 year old woman was assaulted without provocation by her estranged common-law husband. She sustained a fractured nose and multiple bruises about her face and body. The offender was convicted of assault causing bodily harm and sentenced to five months imprisonment, and one year probation.

200-8718 A 21 year old insurance assistant was assaulted in a bowling iley, and one of his front teeth was broken. The offender was convicted of iommon assault and fined \$200,00. Award: \$522.00 (incl. pain and suffering \$200,00)

200-8734 A 31 year old legal secretary was knocked down by an unknown person robbing her hotel room. She sustained a two inch cut to her forehead. Award: \$250.00 (incl. pain and suffering \$250.00)

200-8742 A 30 year old police constable was assaulted by a man stopped for impaired driving. He sustained a contusion of the left eyelid, gross subconjunctival hemorrhage, and transient myopia. The offender was convicted of assaulting a peace officer and sentenced to 14 days imprisonment and two years probation.

200-8780 A T.T.C. driver was assaulted by a man who was creating a disturbance on a subway train. He sustained a swollen knee and soft tissue injury in his hand. The offender was convicted of common assault and given a suspended sentence. Award: \$902.85 (incl. pain and suffering \$300.00)

200-8820 An 18 year old student was punched in the mouth by the offender, a juvenile, without provocation. She sustained lacerations to her mouth and dental damage. The offender was found delinquent and ordered to pay \$50.00 restitution. Award: \$1,179.00 (incl. pain and suffering \$700.00)

200-8826 A 71 year old retired man was assaulted without provocation by the driver of a taxi he was in. He sustained a large laceration over one eye, facial bruises, and a fractured nose. 200-8853 The applicant is the brother of the victim who was murdered in a prison. The claim was for funeral expenses. Award: \$1,020.03

200-8879 A 21 year old salesman was hit in the eye by a rock thrown through his car window by an unknown offender. He sustained a corneal tear resulting in a permanent partial loss of vision. Award: \$3,641.07 (incl. pain and suffering \$3,000.00)

SUMMARY OF DISALLOWED APPLICATIONS

200-4747 The applicant was the 19 year old common-law wife of a murder victim. Her application was denied as no evidence of her having been supported by the victim was given.

200-5017 The applicants were brothers aged 16 and 19 years, whose parents were murdered. Their application was denied when it was found that they had not suffered any pecuniary loss.

200-5324 An 18 year old student was involved in a brawl, in which he was injured in an indeterminate manner. The Board cited Section 17 (1) of the act to deny the award.

200-5530 A 24 year old unemployed woman was stabbed by a woman with whom she was drinking and having an argument over a man they were both dating. The offender was convicted of wounding and placed on two years probation. The Board took into account the applicant's drinking and arguing and cited Section 17 (1) of the Act to deny the application.

200-5582 A 35 year old taxi driver was struck on the back of the head by the lid of his taxi's trunk, which had been pushed down by the alleged offender. The alleged offender claimed he was just trying to help, and the applicant told the police he was not sure the injury was intended. As the Board was unable to conclude the injuries resulted from the commission of a crime of violence within the meaning of Section 5 of the Act, the application was denied.

200-5625 The applicant is the wife of the victim, who was murdered during a robbery. Only funeral expenses were claimed. This claim was denied as the applicant received a Canada Pension Plan death benefit and a substantial amount of life insurance.

200-6063 A 30 year old woman applied for compensation for the murder of her estranged husband. As the Act makes no provision for pain and suffering in this case, and no documentation was produced regarding loss of support or out of pocket expenses, the application was denied.

200-6129 A 26 year old truck driver claimed he was beaten unconscious by an unknown assailant in a hotel bar. However, records from the hospital which date from two days after the event show that he stated that he had slipped at home. Further, the incident was not reported to the police for ten days. Therefore, the Board found that it was not proven that the applicant was a victim of a crime of violence within the meaning of Section 5 (a) of the Act, and that Section 17 (2) of the Act also justified the denial. 200-6352 A 53 year old maintenance man was assaulted in a restaurant and sustained a severely depressed displaced fracture of the left zygoma and a laceration to his left eyebrow. However, the applicant was very intoxicated at the time, and apparently had provoked the alleged offender. No charges were laid. The Board invoked Section 17 (1) of the Act and denied the application, although costs for medical reports, mileage and legal fees were allowed.

200-6443 An 18 year old student sustained lacerations to the ear and throat while involved in a brawl. The Board cited Section 17 (1) of the Act to deny the application.

200-6538 A 23 year old electrician on parole at the time was picked up while hitch-hiking, and agreed when the driver suggested they use tw. rifles in the car for an armed robbery. The offender first shot at a house. It was only after this that the applicant attempted to leave the offender, who thereupon shot him. The Board felt that the applicant was the author of his own misfortune, and cited Section 17 (1) of the Act to deny the application.

200-6594 A 24 year old labourer was involved in a fight with a co-worker. Since there was provocation on both sides, the Board invoked Section 17 (1) of the Act to deny the application.

200-6794 A 39 year old professor was involved in an altercation with his neighbour. The applicant claimed he was struck without provocation with a board. The alleged offender also had a wound which he claimed was inflicted by the applicant. Both the applicant and the alleged offender laid charges against one another, which were subsequently dropped. The Board cited Section 17 (1) of the Act to deny the application.

200-6830 A 28 year old woman was found wandering partially clothed and injured in the early morning. As she had no recollection of how she was injured, it could not be proven that she was a victim of a crime of violence as set out in Section 5 of the Act and the application was denied.

200-6958 The application was made on behalf of the children of a murder victim. The victim had been helping a woman to leave her husband, and realizing the danger stayed and argued with the husband, who had a gun. The Board cited Section 17 (1) of the Act to deny the application because the victim realized the danger he was in and had opportunities to leave.

200-6972 A 47 year old maintenance man was beaten and robbed by a man he had become drunk with. He sustained facial and scalp lacerations. Because the applicant was unco-operative, the offender could only be convicted of possession of stolen property. Due to the applicant's action, the Board cited Section 17 (1) and 17 (1a) of the Act to deny application.

200-6982 A 31 year old bus driver was involved in an argument with a fellow worker over a private matter. He did not lay charges until three weeks after the event, when he found that the W.C.B. would not consider his case. The Board invoked Section 17 (1a) of the Act to deny the application.

200-7014 A 55 year old clerk was involved in an argument at a social function. While fighting with the offender, he slipped and fell, sustaining a compound fracture to his leg. The offender was convicted of common assault and fined \$250.00. The Board, noting that the two men had been drinking and arguing throughout the evening, cited Section 17 (1) of the Act to deny the application.

200-7016 The applicant's wife and step-daughter were murder victims. He applied for compensation for financial losses. Although the Board sympathized with the applicant, it could find no proof of financial loss, and therefore denied the application.

200-7063 A 65 year old man was assaulted and robbed when be brought the offender and a girl home from a bar after agreeing to pay for sexual relations with the girl. The Board cited Section 17 (1) of the Act to deny the application.

200-7095 A 22 year old unemployed man was struck over the head with a beer bottle sustaining a concussion. Witnesses of the event claim that he was drunk and abusive. Therefore, the Board cited Section 17 (1) of the Act to deny the application.

200-7110 A 49 year old woman on a disability pension claimed she was assaulted in her apartment. As there was no evidence of such an assault, the Board found that the applicant was not a victim of a crime of violence as defined in Section 5 of the Act. Costs for obtaining medical reports were allowed.

200-7191 A 59 year old woman claimed she was assaulted by three women in an elevator. However, charges laid against the alleged offenders by private informations were dropped, and contradicting evidence from reliable witnesses and irregularities in the applicant's testimony led the Board to conclude that she was not a victim of a crime of violence within the meaning of Section 5 of the Act. The application was therefore denied.

200-7200 A 30 year old security guard was punched in the face while he was walking with his mother. Although police had witnessed the incident, he did not wish to press any charges at the time, nor did he pursue the matter later. The Board cited Section 17 (1a) of the Act to deny the application.

200-7262 A 20 year old construction worker instigated a fight with another driver by first refusing to let the offender pass him, and then by ramming the back of his car. It also appeared that the applicant began the actual fight. The Board therefore cited Section 17 (1) of the Act to deny the application.

200-7299 A 17 year old unemployed man alleged that he was punched and struck with a rifle butt without provocation while collecting a debt. It appears, however, that he struck the alleged offender first. Furthermore, he did not report the incident to the police. The Board therefore cited Section 17 (1) and 17 (2) of the Act to deny the application.

200-7343 A 16 year old maintenance helper was involved in a fight with a friend over a case of beer. Charges against the alleged offender were dismissed. Because of the circumstances, the Board invoked Section 17 (1) of the Act to deny the application.

200-7367 The applicant is the mother of the victim, a 13 year old boy who was punched in the face in a school yard incident. The victim had thrown away the alleged offender's ball, and refused to retrieve it. The alleged offender then hit him, fracturing his jaw. No charges were laid. The Board cited Section 17 (1) of the Act to deny the application.

200-7426 A 55 year old woman claimed she had been beaten on several occasions by the alleged offender. She claimed that she had returned to the alleged offender's home several times, and was beaten each time. Although she claimed that she called the police on each occasion, no records existed of these calls. Charges brought against the alleged offender by a private information were dismissed. The Board cited Sections 17 (1) and 17 (2) of the Act to deny the application.

200-7496 A 53 year old man was assaulted in a bar. He sustained a fractured nose and jaw and minor lacerations. The police reported that the victim had been intoxicated and unco-operative, and that he did not want an investigation carried out. The Board cited Section 17 (1) and 17 (2) of the Act to deny the application.

200-7542 A 21 year old folding operator was shot in the shoulder. He knew of the offender's violent nature, but stayed with friends in the offender's house, even though the offender had a knife and ordered them out. Even when the offender got a gun, the applicant only retreated to the porch. The Board therefore invoked Section 17 (1) of the Act to deny the application.

200-7560 A 42 year old unemployed man was drinking at a bootlegger's when he was slashed on the nose with a knife by a man he had insulted. He returned in a little while for revenge, and after starting a fight was stabbed in several places. The applicant himself was too drunk to remember what had happened. The Board cited Section 17 (1) of the Act to deny the application.

200-7611 A 17 year old student was struck in the mouth in a class, sustaining dental damage. It appears that the applicant instigated the incident, although no positive conclusions could be made. On the balance of the evidence, the Board cited Section 17 (1) of the Act to deny the application.

200-7727 A 21 year old construction worker and a friend took two women to their home from a liquor store. The women later returned with the two men and robbed and assaulted the applicant. The applicant appears to have refused to identify the offenders. The Board cited Sections 17 (1) and 17 (2) of the Act to deny the application.

200-7744 A 21 year old unemployed man was hit by glass shattered from his windshield by a thrown beer bottle. He had collided with another car, and had almost driven over two men who were trying to flag him down. The applicant laid a charge of assault causing bodily harm against one of the men who was convicted and given a conditional discharge. The Board cited Section 17 (1) of the Act to deny the application.

200-7818 A 54 year old houseman stated that he had been robbed and assaulted. The investigating officer claimed the applicant had fallen while drunk. The Board was of the opinion that the applicant was not a victim of a crime of violence as defined in Section 5 of the Act.

200-7864 A 20 year old clerk claimed he was assaulted while in a bar, sustaining a fractured jaw. The hospital report stated that he claimed it was an accident, and that he was intoxicated. The incident was not reported to the police for 5 days. The Board therefore cited Sections 17 (1) and 17 (2) of the Act to deny the application.

200-7876 A 29 year old administrator claimed he was assaulted. However, he told the police at the time of the occurrence that he had slipped on some snow. The Board therefore found that no evidence supported his claim of being a victim of a crime of violence as defined by Section 5 (a) of the Act.

200-7921 A 30 year old draftsman was involved in an altercation' with his neighbour. The applicant had apparently slapped the offender's son, and later pulled a knife on the offender. When they met a few days later, they began to fight, and the applicant was injured. The Board cited Section 17 (1) of the Act to deny application.

200-7935 A 50 year old auto mechanic was involved in an argument with a neighbour. It appears that the applicant began the argument by spraying grass clippings from a lawnmower over the alleged offender's car, and then by spraying the alleged offender with a hose. Only then was he struck by a beer bottle, which appears to have been thrown accidentally. The alleged offender was acquitted in court. The Board cited Section 17 (1) of the Act to deny application.

200-7973 A 30 year old unemployed woman was shot by a man she moved in with after knowing him for just one day. She was intoxicated at the time of the occurrence, two days after having moved in. As she failed to appear before the Board on two dates, the Board used the documentary evidence and cited Section 17 (1) of the Act to deny the award.

200-7981 A 27 year old construction worker was assaulted after a minor car accident. At the time he told the police that he knew who had assaulted him, and told them that he was going to handle it in his own way. He went to the police three months later when he learned that a police report was required by the Board. The Board cited Section 17 (2) of the Act to deny the application.

200-7997 A 35 year old unemployed man was stabbed by a woman he was drinking with when he refused to leave her apartment. He was unco-operative with the police, and told them that he did not want to press charges. The Board therefore cited Section 17 (2) of the Act to deny the award.

200-8031 A 28 year old factory worker was assaulted in a shopping plaza parking lot, sustaining black eyes, and bruises. He was unco-operative with the police, and although he told them that he could identify the offender he missed a scheduled appointment at the identification bureau. Even after being notified by the Board that this was an issue, he did not contact the police. The Board cited Section 17 (1a) of the Act to deny the application.

200-8093 A 19 year old student was stabbed with a knife during a fight. He was unco-operative with police, changing his account of the events several times. It appears, however, that he instigated the fight. The alleged offender was acquitted on all charges. The Board cited Section 17 (2) of the Act to deny the application.

200-8099 A 32 year old car salesman claimed he was assaulted by a man he had won some money from in a pool game, and then invited home. However, he did not go to the hospital until three days after the alleged incident, and then claimed his injuries were from playing hockey. The incident was not reported to the police for 19 days, and even then the applicant was not consistent in what he said. The Board therefore invoked Section 17 (1) and 17 (2) of the Act to deny the application.

200-8130 The applicant is the mother of a 19 year old woman who was murdered. It appears that the victim was involved in an illegal drug smuggling or trafficing dispute, and she had ammunition and 20 bags of marijuana in her car. She also had a past criminal record for drug offenses. The Board cited Section 17 (1) of the Act to deny the award.

200-8202 A 33 year old clerk went drinking with her former common-law husband, whom she had left a week before. At some point during the night, while the offender was in bed with her, he assaulted her. The Board felt that the applicant was the author of her own misfortune, and cited Section 17 (1) of the Act to deny the application.

200-8327 A 53 year old clerk was assaulted and robbed by a man he invited up to his apartment after meeting him on the street. He sustained some bruises. The offender was convicted of robbery and forceable confinement and sentenced to three years imprisonment. Taking into account the applicant's imprudent actions, the Board cited Section 17 (1) of the Act to deny the application.

200-8443 A 44 year old unemployed woman claimed that she had been pushed down a set of stairs by her son-in-law while she was intexicated. There was no proof of this, and the police felt that it was likely that she fell down the stairs. A warrant for the alleged offender's arrest is outstanding. The Board felt that a crime of violence within the meaning of Section 5 of the Act had not been proven, and denied the application.

200-8532 A 39 year old welder was involved in a family brawl in which all participants were slightly wounded, and in which all four parties laid charges. These charges were all withdrawn. The Board cited Section 17 (1) of the Act to deny the application.

200-8566 A 33 year old taxi-driver alleged that he was assaulted in a pool hall. He did not report the inciden, to the police for six weeks. He gave them a false address, and refused to contact the police again. The Board cited Section 17 (1) of the Act to deny the application.

200-8575 A 50 year old dishwasher was threatened with assault by a fellow boarder if he fell asleep and dropped a cigarette while watching television, as he had already done several times. The applicant then feigned sleep and dropped a cigarette, and was assaulted. The Board felt that because of this, he was the author of his own misfortune, and cited Section 17 (1) of the Act to deny the application.

200-8772 A 28 year old unemployed man was shot in the leg. He claimed that he had been hit from behind, taken away in a van, shot in the leg, and dumped in a parking lot. His account of events to the police was different, and, it changed several times. He was very intoxicated at the time, and although he indicated that he knew who had shot him, he would not identify the offenders to the police. The Board cited Section 17 (1) and 17 (2) of the Act to deny the award.
