Introduction

The following research report is a statistical description of characteristics of offenders released to the streets from Massachusetts Correctional Institutions during 1980 with corresponding recidivism rates. For the purposes of this report, all drug programs and pre-release facilities are collapsed into the category "pre-release." A subsequent report will provide the information for all the specific individual pre-release facilities. The statistics are available for men released from MCI's Walpole, Concord, Framingham, Norfolk, SECC (Southeastern Correctional Center), Minimum Security (Northeastern Correctional Center), Bay State Correctional Center, Plymouth, and Warwick), five drug programs (Concilio, Meridian, Share, Third Nail, and Project Turnabout), thirteen pre-release centers (577 House, 699 House, Temporary Housing, Shirley, Boston State, Coolidge House, Brooke House, South Middlesex Pre-Release, Park Drive, Lancaster, Charlotte House, Hillside, and Norfolk Pre-Release), and two other facilities (Lemuel Shattuck Hospital and Bridgewater State Hospital). Statistics are also available for women released from MCI-Framingham and three pre-release centers (Charlotte House, Brooke House, and Lancaster).

A total of 941 offenders (779 males and 162 females) were released from the correctional facilities listed above. The follow-up period is one year from the date of the individual's release to the community. A recidivist is defined as any offender who returns to a state or federal correctional institution, or to a house of correction or jail for 30 days or more.

Information contained in this report includes statistics on recidivism rates associated with individual characteristics with regard to release variables, nature of present offense variables, personal background characteristics, criminal history variables, furlough participation variables, and release follow-up variables. The tables which follow contain two types of information: (1) statistical data describing characteristics of individuals released from each correctional facility during 1980; and (2) the rates of recidivism cross tabulated with each of the categories of the statistical data for these individuals.

In reading tables in this report, the reader should note the following: (1) the release population is divided according to the institution of release. (2) N represents the number of offenders who fall into the corresponding category in the table. (3) p represents the percentage of the number of individuals in a particular category to the number of individuals released from that institution (column percents). (4) RR (Recidivism Rate) represents the rate of recidivism of the number of individuals in that category who have recidivated.

For example, upon referring to the first table on page 9 , the variable "Type of Release" is presented and the following kinds of information may be obtained: (1) The total number of releases broken down by the institution or security level of release is labeled and presented horizontally across the head of the table. Note: the sum of the totals for each institution will not equal the total of 941 under the TOTAL column. The total column includes two offenders released from Lemuel Shattuck Hospital and Bridgewater State Hospital. (2) The type of release (parole or discharge or release by the court) is labeled and presented vertically. (3) Of the 941 released during 1980, 788 were released on parole (84%), 147 were released on a discharge (16%), and 6 were released by the court (1%). (4) Those offenders released from Walpole who were released on a parole had a recidivism rate of 42%, whereas those offenders released from Walpole on a discharge had a recidivism rate of 25%.

The material was derived from the computerized data base developed by the Correction and Parole Management Information System (CAPMIS) and was produced on the Massachusetts State College Computer Network (MSCCN).
