INTRODUCTION

The following research report is a statistical description of characteristics of offenders under the supervision of the Department of Correction who were released from pre-release facilities during 1980 with corresponding recidivism rates. The statistics are available for offenders released from five drug programs (Concilio, Meridian, Share, Third Nail, Project Turnabout), thirteen pre-release centers (577 House, 699 House, Temporary Housing Project, Shirley, Boston State, Coolidge House, Brooke House, South Middlesex, Park Drive, Lancaster, Charlotte House, Hillside, and Norfolk Pre-Release), and eleven non-pre-release institutions (Walpole, Concord, Framingham, Norfolk, Southeastern Correctional Center, Northeastern Correctional Center, Bay State Correctional Center, Plymouth, Warwick, Lemuel Shattuck Hospital, and Bridgewater State Hospital). A total of 941 offenders (779 males and 162 females) were released from the correctional facilities listed above. The follow-up period is one year from the date of the individual's release to the community. A recidivism is defined as any offender who returns to a state or federal correctional institution, or to a house of correction or jail for 30 days or more.

Information contained in this report includes statistics on recidivism rates associated with individual characteristics with regard to release variables, nature of present offense variables, personal background characteristics, criminal history variables, furlough participation variables, and release follow-up variables. The tables which follow contain two types of information: (1) statistical data describing characteristics of individuals released from each pre-release facility during 1980, and (2) the rates of recidivism cross tabulated with each of the categories of the statistical data for these individuals.

In reading tables in this report, the reader should note the following: (1) the release population is divided according to the pre-release facility of release. (2) N represents the number of offenders who fall into the corresponding category in the table. (3) P represents the percentage of the number of individuals in a particular category to the number of individuals released from that pre-release center (column percents). (4) RR (Recidivism Rate) represents the rate of recidivism of the number of individuals in that category who have recidivated. For example, upon referring to the first table on page 9, the variable "Type of Release" is presented and the following kinds of information may be obtained: (1) the total number of releases broken down by the specific pre-release center is labeled and presented horizontally across the head of the table; (2) the type of release (parole or discharge or release by the court) is labeled and presented vertically; (3) of the 941 released during 1980, 788 were released on parole (84%), 147 were released on a discharge (16%), and 6 were released by the court (1%).

(4) Those offenders released from South Middlesex who were released on parole had a recidivism rate of 11% whereas those offenders released from South Middlesex on a discharge had a recidivism rate of 33%.

The material was derived from the computerized data base developed by the Correction and Parole Management Information System (CAPMIS) and was produced on the Massachusetts State College Computer Network (MSCCN).
